#### NARRATIVE SUMMARY

- 1. During this reporting period, Supply Company (Rein), Force Logistic Support Group-Bravo, continued to provide the necessary logistic support and limitted maintenance support for units located within the Chu Lai Combat Base.
- The U.S. Army retains the responsibility of producing and providing baked goods for units in the Chu Lai TAOR.
- 2. During the month of April 1-30, 1968, the Aid Station treated two hundred and thirty nine (239) persons and administered four hundred and twenty two (422) immunizations.

The Civil Affairs Section treated one hundred and fourty three (143) Vietnamese personnel.

3. The building program within Supply Company continues with the first increment of the current construction at the new Ammunition Supply Point, which is sixty five percent complete due to heavy rains and the moving of the back row of sperms.

In addition, the centralized Officer's shower, the new beach cabana for the life guards, and three heads have been completed.

## k. Community Relations

- (1) During the reporting period, this Command assisted the incoming refugees of Thanh Tam hamlet in the following ways:
  (a) Bistribution of 500 cakes of soap

  - (b) Provision of lumber to build homes for 25 families
  - (c) Provision of 10,000 pounds of rice (obtained from USAID)

In recognition of these activities, the Catholic pastor of Chu Lai presented the Civil Affairs Chief with a commemorative plaque.

- (2) This Command assisted in the construction of three hamlet schools and offices. These will consist of a first-grade classroom and an office and meeting room for each hamlet.
- (3) Some 30 bags of cement were provided to the Buddhists of Chu Lai together with eight truckloads of lumber for their grammar school and the office for the monk. The school opened last month, although more work will be done on it during the school vacation period. The office is 80 percent completed.

- (4) This Command's support of the Ly Tin District Medical Center took the following forms during the reporting period:
  - (a) 250 patients were treated by the Corpsman

- (b) A new deep well was dug with cement provided by USAID
  (c) Three rooms were painted
  (d) Five civilian victims of artillery fire were evacuated to Quang Ngai.
- (5) Swill was provided from the FISG-B messhall for the Chu Lai Village cooperative pig farm, which now has 11 hogs.
- (6) This Command currently employs, through the Industrial Relations Office, 121 Vietnamese civilians on Organizational Maintenance funds and 21 on nonappropriated funds.

#### 1. Communications.

- (1) Maintenance Section. During the reporting period 36 work orders were received by this facility; 11 were forwarded to a higher echelon: 22 were completed locally, and 3 are presently in the shop awaiting parts. This facility has maintained a constant surveillance over the Supply Company switchboard, teletype, and data circuits as well as performing second and third echelon preventative maintenance on all communications equipment.
- (2) Wire Section. The section continued to man the Company switchboard on a 24 hour a day basis as well as manning the Sub-Sector switch-board nightly. Trouble-shooting services and the preventative maintenance program were continued throughout the month.
- (3) Radio Section. The section maintained its continuous guard of the Force Logistic Command Net and the nightly guard of the Chu Lai Defense Net as well as activating the Sub-Sector alert radio net during all Green or higher alerts. The preventative maintenance program continued on a weekly basis.
- (4) Message Center Section. During the month the section processed a total of 980 messages; 826 incoming and 118 outgoing. Additionally a total of 14,351 cards were handled on the autodin circuit; 5,936 outgoing and 8,415 incoming. Down time during the month amounted to 404 hours and 30 minutes, the majority of time attributed to power failures and equipment trouble. The section assumed communication guard on the autodin circuit for the 507 Medical Supply Detachment, USA and the 23rd Admin Company, Americal Division,
