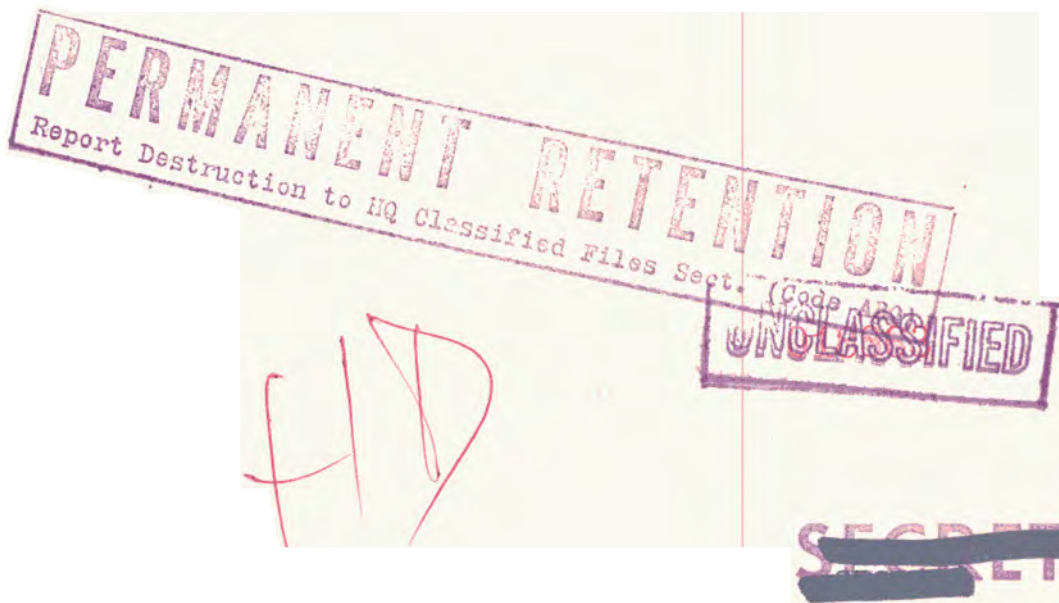



NARRATIVE SUMMARY

1. During July, a plan was developed for the phaseout of FLSG Bravo and transfer of LSU missions to the Commanding Officer, Supply Battalion. This plan was developed by G-3 in coordination with Bravo, Supply Bn, Maintenance Bn, and cognizant staff sections.

2. On 1 July the following ISSA's for continuing Army support of Marines in I Corps became effective:

3. G-3/S sent a representative to a MACV conference in Saigon on 20 July to discuss control procedures for CONEX containers in RVN. Major problem areas discussed were: Lack of adequate control, submission of reports, transfer procedures and general maintenance and upkeep of the container. It was noted that FLC was not a violator of any problem area discussed.

4. On 21 July the Force Logistic Command shipped 325 bundles of AM-2 matting to Iwakuni. To date, a total of 7,253 bundles of this matting has been retrograded for use as future SATS airfields.

5. G-3/S sent representatives to MACV conference in Saigon, 25-27 July to finalize and publish the procedures under which the Interservice Excess Screening System (IESS) would operate. The IESS is designed to be an interim procedure to screen excesses prior to the implementation of Pura "Quick Fix".

s. Training

(1) During the month of July 1970, the Command Training Section was responsible for normal staff cognizance of the Command Training Program which included administrative coordination of quotas to seven formal schools and three internally conducted courses of instruction for a combined total of 77 students. (2) Significant Events

(a) Technical assistance for NBC was furnished to Maintenance Battalion and Headquarters and Service Battalion for a combined total of 8 hours.

(b) One formal staff visit was made to 3rd Military Police Battalion for liaison on training completion matters.

(c) Headquarters and Service Battalion received a Commanding General's Inspection in Training and NBCD functional areas.

(d) Headquarters and Service Battalion (Transit Facility) received one hour's drug abuse presentation presented by a lecturer from the III MAF Drug Abuse Section. A total of 78 Marines attended this training.

(e) Instructional support to the Provisional Rifle Company was provided by the Command NCO Leadership School Instructor Staff. A total of 17 hours of instruction for newly joined personnel was conducted and a total of 1343 man hours of instruction was realized.

Encl: (1) Instructions for the FLC Package Inspector

1. Purpose. To promulgate instructions for inspection of parcels prior to introduction into the U. S. Postal System.

2. Cancellation. FLCO 2700.6.

3. Information

a. References (a) and (b) require officer/SNCO certification on packages introduced into the U. S. Mail that the package contains no nonmailable matter as defined in current postal regulations. This requirement has resulted in many productive man-hours lost by officers/SNCOs accompanying an individual mailing a package.

b. A package wrapping concession has been established adjacent to the Camp Books Post Office. This concession will operate as a central point for personnel to have packages wrapped to include items to be sent through the U. S. Mails out of country.


c. To preclude the necessity for an officer or SNCO to accompany each individual Marine who desires to have a package wrapped for mailing out of country, a SNCO will be assigned to the package-wrapping concession for the purpose of inspecting package contents prior to wrapping. After wrapping and certification by the SNCO, the package will be delivered immediately to the post office for mailing. The assignment of this SNCO will be on a weekly basis and will be rotated among the organizations stationed at Camp Books. Assignments to this duty will be published separately by this Headquarters.

4. Action

a. Organizational commanders of battalion and group size organizations stationed at Camp Books will provide to this Headquarters (G-1), when requested, the names of SNCO's selected for assignment to duty as mail parcel inspectors.

b. Assigned mail parcel inspectors will be guided in the performance of their duties by the instructions contained in enclosure (1).

INSTRUCTIONS FOR THE FLC PACKAGE INSPECTOR

1. Staff non-commissioned officers assigned duties as package inspector in accordance with the basic order will insure the following actions are accomplished prior to the introduction of a package into the U. S. Mail.

a. The inspector will insure that no nonmailable matter, as defined by current postal regulations, is included in the package. Such items include, but are not limited to:

- (1) All kinds of poison or matter containing poison.
- (2) All explosives, flammable material, infernal machines, and mechanical, chemical, or other devices which may ignite or explode.
- (3) Certain categories of firearms
- (4) Intoxicating liquors.
- (5) Obscene and indecent matter
- (6) Lotteries, frauds, and libelous matter.
- (7) Disloyalty and threats to the President
- (8) Copyright violations.
- (9) Any item belonging to the U. S. Government and not the property of the individual. Such items include jungle utilities, 782 equipment, foul weather clothing and other items which may have been issued to the Marine as individual or organizational property.

b. Should nonmailable matter be discovered, the material will be confiscated by the inspector who will obtain the name and organization of the individual attempting to mail the material. The name of the individual along with the confiscated material will be delivered to the FLC Postal Officer for final disposition, as appropriate.

c. The SNCO will insure that the return address is verified by comparison with the mailer's ID Card. The service number (Social Security Account Number for Army and nonmilitary), as well as the name, will be verified.

d. In the case of a parcel being mailed by a person other than the individual whose name appears in the return address, the notation "MAILED BY", followed by the name and service number/SSAN of the agent will be printed on the parcel. The inspector will verify the data by comparison with the agent's ID Card.

e. The SNCO will print his name, in addition to his signature, rank and service number below the required certification. The

certification will be placed on all parcels by means of a rubber stamp or may be hand-written. The certification will read: "I CERTIFY THAT THE CONTENTS OF THIS PACKAGE/PARCEL HAVE BEEN INSPECTED AND CONTAIN NO NONMAILABLE ITEMS AS OUTLINED IN CURRENT POSTAL REGULATIONS."

f. To insure that nothing is added to the package after inspection, the inspecting SNCO will affix his signature across at least three seams of the wrapping. Postal clerks have been instructed not to accept a package if these signatures appear to have been disturbed.

2. The tour of duty for inspectors assigned under this order will be from Saturday to Saturday. The relieving SNCO will report to the Camp Books Exchange Officer at 1300 on the Saturday beginning his tour of duty. The Exchange Officer will thoroughly brief the SNCO as to the specific duties of the mail parcel inspector. The relieving SNCO will work with the relieved inspector until the closing of the concession operations on the Saturday beginning his tour.

1. Purpose. To establish an effective program within the Force Logistic Command to ensure that valuable knowledge and unique experience gained by Marine Corps personnel currently deployed in the Republic of Vietnam is promptly recognized, evaluated, and promulgated for use in Marine Corps training improvement programs in accordance with references (a) and (b).

2. Cancellation. FLCO 3480.2C

3. Background. Valuable professional experience is being gained by Marines engaged in combat operations in Vietnam. The nature of the deployment has, on occasion, sorely taxed the logistic support capabilities of combat service support units. Frequently the imagination, resourcefulness and ingenuity of personnel involved has been a determining factor in the success or failure of a support mission. Practices and procedures thus evolved must be identified and passed along for use in training programs, supply and maintenance procedures, and materiel improvement programs.

4. Action. Commanding Officers of battalions under the command and operational control of the Force Logistic Command will establish a program which will: .''.'

a. Provide for the collection and forwarding of "Lessons Learned" to this Headquarters (G-3 Supply) by the 5th of each month for compilation and forwarding to the Commandant of the Marine Corps. Reports will be submitted in the format shown in enclosure (1), as an enclosure to a standard Naval Letter. Negative reports are required.

b. Items relative to problems or conflicts internal to FLC will not


be reported as "Lessons Learned" until they have been completely resolved.

c. Identify those personnel who possess significant information which could enhance the effectiveness of the Marine Corps training and materiel equipment improvement programs and direct such individuals to prepare a written report for forwarding to the Commandant of the Marine Corps (Code AO3H) via this Headquarters.

d. Members of the General and Special Staff will also submit "Lessons Learned."

5. Professional Articles. Commanding Officers should encourage individuals who possess specialized or particularly significant information, to submit articles to the Marine Corps Beneficial Suggestion Program and/or to a professional publication, such as the Marine Corps Gazette.

1. Purpose. To establish procedures for physical examinations to be conducted prior to personnel being transferred to CONUS for separation or transfer to the Fleet Reserve.
2. Information. References (a) and (b) direct that personnel returning to CONUS for separation or transfer to the Fleet Reserve be given a separation physical examination prior to transfer. This action is being taken to preclude the unnecessary detention of officers and enlisted personnel at overcrowded separation centers pending physical examinations.

3. Action

a. Command Surgeon

(1) Establish procedures at the Headquarters and Service Battalion Aid Station to accomplish the timely completion of separation physicals, as required by references (a) and (b) and this Order, for all organizations of this Command without medical officers attached.

(2) Accomplish X-ray and laboratory examinations for those organizations with medical officers attached but without a laboratory capability.


b. Commanding Officers

(1) Screen service records and direct personnel requiring physical examinations to report to the appropriate organizational aid station 30 days prior to their separation date for completion of the required physical examination. In the event unexpected transfers will not allow personnel to report 30 days prior to their separation date, they will be required to report at the earliest possible date for completion of the required physical examination.

(2) Ensure that completed physical examination forms are included

in the staff returns of all personnel returning for separation or transfer to the Fleet Reserve. If unforeseen difficulties prevent the conduct of a physical examination prior to transfer or the inclusion of completed physical examination forms with the staff returns, a statement to this effect will be made in the Health Record (SF 600) and the detaching endorsement to individual orders giving the reasons therefore. This statement will include, if appropriate, the estimated date of completion and forwarding of the physical examination forms. In the event that a member must depart prior to the receipt of results of a physical examination, such results shall be forwarded, immediately upon receipt, via certified mail, to the Commanding General, Marine Corps Base, Camp Pendleton, Calif. 92055 (Attn: Separation Center).
