NARRATIVE SUMMARY

1. Fleet Stock Account (FSA) operations during the month of March included twenty-seven daily updates of the files. 17,097 requisitions and 4,274 picking tickets were processed in the regular updates. The overall fill rate for the month was 68%, with a fill rate of 64% for RO items.

1 March: Value of on hand assets in the MC100 account was determined to be \$4.8 million, of which \$4.3 million was excess. A special program was run to zero the ROP and thereby suppress automated buys.

4 March: Approximately 80,000 deficiencies at 3rd FSR were matched against FLC excesses and 7,200 picking tickets were issued for items so matched.

6 March: The PURA process directed shipments of 49 issues to PURA participants valued at less than \$1 thousand and 572 issues to PDO valued at \$1 thousand. Also, an initial message provided shipping status on 1400 items valued in excess of \$200 thousand which were shipped to MMSAO2 and reported to MPB.

7 March: A concerted effort was completed to identify valid requirements to support continued operations. A tape containing 5,600 requirements thus validated was couriered to 3rd FSR with a request that items in process of shipment not on this validated list be frustrated and that cancellations be processed for other invalid requirements.

8, 11 March: Direct liaison was effected with 2nd Log Command on Okinawa to arrange for release, beginning on 1 April, of all PURA referrals held for MC100.

12 March: A reconciliation with 3/31 Medical Depot for medical items was conducted. 68 FSN's valued at \$4 thousand for material no longer required were cancelled.

13 March: A reconciliation was conducted with Philadelphia. Of 853 validation requests received, eleven valued at \$7 thousand were determined to be valid and 842 valued at \$1.0 million were cancelled. In reconciling with Camp Butler, 84 requests were received and 81 FSN's valued at \$16 thousand were cancelled.

14 March: The PURA process directed shipments to PURA participants for 160 issues valued at \$16 thousand and 351 issues to PDO valued at \$66 thousand.

15 March: No additional PURA FTE's were offered as of this date because of planned phase down of PURA participation.

16 March: Of the 7,200 FSN's directed for shipment on 4 March, 360 FSN's, which had assets on hand, were ordered shipped to Barstow.

18 March: The culmination of concentrated effort to clear T-Lot of all assets was achieved when disposition was completed on the final assets stored in T-Lot. Over 1,000 FSN's were redistributed/retrograded by this intensified effort.

19 March: The value of the MC100 account at mid-month was determined to include \$4.7 million on hand, of which \$4.4 was excess. In addition, 6500 special FTE's were offered to MCSA Philadelphia for FLC excess assets, which were NRO items not matched to the Philadelphia Want List.

20 March: The PURA process directed shipments to PURA participants for 253 items valued at \$19 thousand, and 238 items valued at \$30 thousand were directed to PDO. The allowances for the Direct Exchange Branch were reduced to 20% of the 30 January level with the objective of attriting on-hand plus dues to the 20% level by 1 May.

23 March: A total of 238 SAC 2 line items valued at \$308 thousand were identified for intensified retrograde and disposition action.

24 March: The NRO items on the locator file were matched to the Philadelphia Want List and issues were made to Barstow of 186 FSN's valued at \$44 thousand.

27 March: A special program was run to produce issue mats on all incompleated PURA referrals with no status in excess of 20 days.

28 March: All RO items were assigned a "999" requirement code and a "3W" operation code so that transactions for these RO items would produce an ESSR (Exception Stock Status Report) for manual review in an effort to inhibit replenishment requisitions.

29 March: Intensified action was directed to gas cylinders, resulting in a turn-in to the Army Depot of filled cylinders valued at \$13 thousand and empty cylinders valued at \$55 thousand. In addition, intensive cancellation action was directed to excess dues in FG 61, resulting in 109 cancellation requests valued at \$438 thousand to various supply sources.

31 March: A total of 141 cancellations valued at approximately \$16 thousand, were requested from the ICCV Long Binh. In addition, the

value of the MGL00 account at month's end was determined to include \$2.4 million on hand of which \$1.9 was excess.

2. The Medical Supply Section received 751 FSN's valued at \$17 thousand as turn-in's from supported units, and also completed shipments to West-Pac USMC accounts for a total of 1,243 FSN's valued at \$220 thousand.

3. Identification and retrograde/disposal of large cube items was titled "Project Big Cube" and resulted in confirmed shipments of 4,218 items valued at \$2.7 million. These items were shipped as follows:

4. Six line items of monsoon material valued at \$8 thousand were shipped to 3rd FSR.

5. A total of 81 line items of SAC 3 material, valued at \$481 thousand were redistributed within III MAF and to Barstow.

6. A total of 682 backorders were cancelled by requisitioning units and 5699 dues were cancelled.

In addition, cancellation requests for DX assets were submitted for 141 FSN's valued at \$794 thousand. These actions resulted from reduction of allowances in light of current operations.

8. Confirmed shipping status was provided to MSAO2 and MFB on items shipped to Barstow. The total value of assets so retrograded was \$2.0 mil.

9. The value of 62 SAC 2 items (primarily blank forms) including excess on hand was approximately \$20 thousand by the month's end.

The value of shipments to 3rd FSR during the month was \$194 thousand.

11. This Command provided the following ammunition highlights for the month of March:

a. LZ Baldy was closed 4 March 1971.

b. On 15 March ASP #2 was turned over to the U.S. Army. Total S/T turned over was 6,821 valued at \$13,783,130.43.

13. The number of new TEROS received during the month of March decreased by 489 with a total input of 5769. The input of TEROS for combat essential equipment decreased by 187 TEROS with a total input of 334 TEROS. The overall backlog decreased by 500 TEROS this month. At the end of March, 512 TEROS were on backlog, of which 74 were for combat essential items.

14. Reports for the month of March disclosed a total output of 6269 TEROS which included 334 TEROS for combat essential items. The 6269 TEROS represented a total output of 7669 items which included 426 items of combat essential equipment.

m. Safety

(1) Significant Events

STORY OF INTEREST

MARINE TOUCHED TO ACTION
BY "SILENT WAR" OF VIETNAMESE ORPHANS

DANANG, Vietnam (Delayed)--Three boxes of summer and winter garments varying in size from infant to teenager were donated recently to the Phuoc Thanh Orphanage in Hoa Khanh.

The clothes were given by Marine Sergeant Roland Girouard, Security Company, Headquarters and Service Battalion, Force Logistic Command (FLC) who was so touched at the plight and condition of the orphaned children, that he was moved to action shortly after his tour of the orphanage several weeks ago.

"During the tour of the orphanage, I noticed that many of the small children had little or no clothing and the babies wore only diapers," Sgt. Girouard said.

Upon returning to FLC's Camp Jay K. Books, Sgt. Girouard pondered the day's events. He said, "After seeing how bad off the orphans were, I decided to write a letter to the mayor of my home town, Berlin, New Hampshire. I requested that the mayor ask the people for donations of clothes and used toys."

"Three boxes arrived recently and I have received numerous letters from home town folks who said they are sending clothes and toys," remarked Girouard.

Sister M. Agnes, a Vietnamese Catholic Nun, accepted the packages gratefully from Sgt. Girouard on behalf of the orphanage.

Perhaps the "silent war" of the orphaned Vietnamese children to survive their plight will never be fully won, but Marines like Sgt. Roland Girouard certainly have offered them a warmth and a hope they might never have had before.

1. Purpose. To publish and amplify guidance provided by references (a) and (b) regarding retrograde, redistribution and disposition of materiel prior to and during increment VII redeployment phase, and to provide procedures for excess/deficiency reports required by the III MAF Redistribution Center.

2. Discussion. In view of planned redeployments, constant realistic reviews of materiel requirements and timely disposition of excesses is of paramount importance. Enclosure (1) outlines guidance to assist unit commanders in determining actions required prior to and during increment VII redeployment phase.

3. Policy. Materiel requirements will be based on need for in-country mission. Inasmuch as requirements exist to retain an LSG capability, assets will not be reduced below the LSG allowance.

4 Definitions

a. Redistribution. Transfer of materiel from one unit to another within FMFPac or to the RVNAF as result of excess screening action.

(1) Equipment to qualify for redistribution between FMFPac units must be in either Condition Code A, B, E or W.

(2) Equipment to qualify for transfer to the RVNAF must be in Condition Code A or B.

b. Retrograde. Transfer of materiel direct to out-of-country service units, MCSC Barstow, or with a redeployed unit.

(1) Equipment to qualify for retrograde must be in Condition Code Z or better.

5. Reports

a. The III MAF Redistribution Center is staffed with the responsibility for providing redistribution instructions based on excess/deficiency reports received from major FMFPac commands. The following reports are required by the III MAF Redistribution Center:

(1) Excess Report (TAM Items)

(2) Redistribution Completion Report

(3) Deficiency Report

(a) Formats and instructions regarding above reports are contained in enclosure (1).

b. Reports will be submitted to the cognizant FLC G- Staff Section as follows:

(1) Organic unit commanders will submit reports to G-4/Supply

(2) Officers in Charge of MC100, MC114, MFAG3, 91319 and 91320 will submit reports to G-3/Supply.


c. Nonrecoverable Class II and VII (Non-TAM) items in

Condition Code Z or better are not normally reported to the III MAF Redistribution Center. Current guidance states that all assets held at time of redeployment will be retained by the unit and retrograded to the redeployment destination; however, equipment for which there is doubt that retrograde is prudent will be reported to the cognizant G- Staff Section on a case by case basis for disposition instructions.

6. Action. Unit Commanders will utilize enclosures (1) and (2) and other guidance contained herein for determining actions to be taken regarding materiel assets prior to and during increment VII redeployment phase.

LOGISTIC GUIDANCE FOR ORGANIC UNITS

1. Embarkation (Increment VII Phase). The following information is furnished regarding items which will/will not be embarked upon redeployment:

a. Class I. None will be embarked. All unused Class I supplies held, less refrigerated rations, will be turned in to Supply Battalion (Ration Platoon) for subsequent transfer to the supporting Army Logistic Unit for credit.

b. Class II

(1) Special Southeast Asia (SEA) Clothing

(a) Personnel will embark with 3 sets of utilities and at least 1 pair of boots, which may include special SEA clothing.

(b) Serviceable special SEA clothing not in hands of troops will be embarked with the unit and turned in to the supporting service unit at destination.

(2) Monsoon Items. None will be embarked. Serviceable monsoon items will be turned in to MC100 prior to end of increment VI redeployment phase.

(3) Body Armor

(a) None will be embarked. All serviceable and unserviceable body armor not in hands of troops will be turned in to MC114 prior to end of increment VI redeployment phase.

(b) Special instructions will be published for disposition of body armor during increment VII phase.

/ (4) Vehicle Fragmentation Armor Kits

(a) All kits will be recovered.

(b) Kits remaining on vehicles during increment VII redeployment phase will be removed and turned in to MC114. Kits that are installed on vehicles leaving RVN shall remain on the vehicle. At the vehicles destination, kits shall be removed and invoiced to the supporting FSR/BDE service unit.

(5) Units will embark with all serviceable and unserviceable reparable (condition code Z or better) Class II held.

c. Class III

(1) Bulk and drummed fuel will not be embarked. All assets will be turned in to Supply Battalion for subsequent transfer to the supporting Army Logistic Unit for credit.

(2) Units will embark with 30 days Packaged POL includes petroleum, fuels, lubricants, hydraulic and lubrication oils, preservatives, liquid and compressed gasses, bulk chemicals, coolants, deicing compounds and additives.

d. Class IV. None will be embarked.

e. Class V(W). None will be embarked. Assets will be turned in to the supporting ASP.

f. Class VI. None will be embarked

g. Class VII

(1) Items listed in enclosure (2) will not be embarked. Disposition of these items is discussed in paragraph 3 below.

(2) All Class VII assets held, less items listed in enclosure (2), which have not been redistributed or otherwise disposed of as a result of excess screening actions will be embarked with the unit and turned in to the supporting service unit at destination.

(3) Administrative use motor vehicles will be transferred to Marine Corps Base, Camp Butler in accordance with MCO 4440.27 unless otherwise directed by higher headquarters.

h. Class VIII. All Class VIII held will be embarked with the unit and turned in to the supporting service unit at destination.

Class IX. All Class IX assets held will be embarked.

2. Materiel Condition Criteria

a. In order for equipment to be eligible for redistribution or retrograde under any of the various utilization programs, specific condition criteria has been established as follows:

(1) RVNAF Transfer (Project 805): Condition Codes A or B.

(3) Redistribution to other USMC units: Condition Codes A, B, E or W.

b. Materiel in actual condition codes H or 2 will not be returned to CONUS or redistributed. Such items will be turned in to MC114 with appropriate documentation for further transfer to the Army Property Disposal Officer (PDO). If items in this category are listed in MCO 4400.4F as reportable, disposition code "K" will be assigned by the maintenance facility and the letter of unserviceable property provided the owning unit will direct submission of a WCS Report with Adjustment Code R in accordance with instructions contained in MCO 4440.19D. RIR's will not be submitted for these items.

(1) Above procedures do not apply to collection type items, such as Shop Sets, Bulk Fuel Systems, MTDS Equipment, etc. RIR's will continue to be submitted on collection type items regardless of condition code.

3. Items not to be returned to CONUS

a. Enclosure (2) lists items which will not be returned to CONUS regardless of condition code. These items are designated by FSN, since selection of items was predicated on obsolescence of certain models and availability of replacement items. Prior to redeployment, all assets of these items will be LTI'd and transferred to the Army PDO Via MC114. These items are assigned disposition

code "K" and WCS Reports will be submitted with Adjustment Code R. RIR's will not be submitted for these items.

(1) Pending redeployment, 1st/2d echelon maintenance/repair will be accomplished as required. Upon evacuation to the 3d/4th echelon maintenance facility, these items will be assigned disposition code "K" unless the owning unit commander designates a specific item as essential to the maintenance of his unit's mission; normal maintenance procedures will be followed for items so designated.

4 Limited Technical Inspections (LTI)

a. Items which do not meet the criteria for retrograde will be LTI'd prior to transfer to the Army PDO.

b. Items turned in to MC114 for transshipment will be accompanied by a current LTI (performed within 30 days of the turn-in date).

5. Retrograde. FLCO 4032.1A establishes procedures for retrograde of materiel.


