### PART II

### NARRATIVE SUMMARY

The highlight of the month of May was for Supply Company in seeing its mission being accomplished with all of the final stand-down operations in all sections proceeding very satisfactorily towards the total retrograde of materiel and equipment slated for shipment out of country. The reduction of personnel strength phasedown in line with the reduction of the work load and the ultimate goal of complete withdrawal of all Marine Corps forces from the Republic of Vietnam is imminent.

The Commanding General, Force Logistic Command continued his close surveillance of the daily tasks and accomplishments as the month got underway and the finalization of plans to clear all Supply Company storage areas of remaining materiel became more clearly a reality than at any time since the beginning of the project. By the 15th of the month all of the movement of materiel from the Storage areas was completed by Supply Company and the CCP assumed all of the Storage area responsibilities and full control of all future transactions concerning Storage sites.

The continuing support to using units by the PECP Platoon kept their work load constant until near the end of the month when requirements for their services seemed to rapidly decline.

TMO shipments were many for the month as cargo was moved to staging areas at Deep Water Pier for loading. Approximately 400,000 cube was shipped during the month of May.

The Retrograde Facility continued to move equipment to Deep Water Pier on call forwards during the month for shipment out of country to CCNUS and other WestPac destinations. On 29 May the Retrograde Facility buildings am grounds less the Marine Corps property was signed over to the RVN Engineers as the first step in the turn over of all areas began to materialize.

### PART III

### SEQUENTIAL LISTING OF SIGNIFICANT EVENTS

- 1. On 1 May 1971 the Commanding General, Force Logistic Command visited Retail Clothing Outlet Store.
- 2. The Receipts Section received 1180 pallets from Deep Water Pier. CCP personnel informed all division units of the availability of the pallets for their use as required.
- 3. Five truck loads of dog food, the last of the Canine delicacy was delivered to Deep Water Pier by TMO and was shipped to Korea.
- 4. Thirteen truck loads of cargo (call forward) was delivered to Deep er Pier for the USS DUBUQUE.
- Retrograde delivered twenty-six pieces of equipment to Deep Water Pier (call forward) for CONUS.
- On 3 May 1971 Retrograde delivered sixty-seven pieces of equipment to Deep Water Pier on a call forward.
- 7. TMO general cargo delivered to Deep Water Pier on call forward was approximately 66,166 cube.
- 8. Storage received MRO's for excess bulk material in B-1 warehouse to be moved to PP&P with the remainder due to be moved by mid-month.
- 9. The excess lumber had been sorted and the quantities of serviceable lumber was reported to CCP for MRO's to be prepared when the receiving unit was known.
- 10. Cn 4 May 1971 the Commanding General, Fleet Marine Force Pacific, toured the Storage area with the Commanding General, Force Logistic Command.
- 11. On 5 May 1971 PR.P furnished Data Processing Platcon-16 packaging and packing facilities for twelve (12) Computers being sent to IBM Corporation, Buffalo, New York and furnished Marine Helicopter Squadron 263 with packaging and packing for 241 weapons.
- 12. Storage received MRO's for the remainder of the barbed wire for shipment to MR100 Okinawa and CONUS (Camp Pendleton).
- 13. A quantity of new receipts was received and CCP prepared documents for all the material to be shipped back to Ckinawa as should never have been received by H.C.
- 14. Authority to resume utilizing Sealand Vans for ship ents to Okinawa was received and a large quantity slated for Fleet Shipping will be loaded in Vans and shipped.

- 15. The Assistant Commandant of the Marine Corps toured the Storage area on 6 May 1971.
- 16. On 8 May 1971 PR&P furnished III MAB Garrison Property and Marine Aircraft Group-11 with 330 various size cube boxes for redeployment purposes.
- 17. On 10 May 1971 the concertina wire located in the lumber yard was earmarked for the Army.
- 18. All of the remainder of bulk stock was moved out of B-1 warehouse to PP&P with only Medical Supplies left which also were to be removed by the end of the month.
- 19. Word was received on 14 May 1971 to start loading Sealand Vans for Ckinawa with the materiel that was staged on S-lot which was slated for Fleet Shipping.
- 20. On 15 May 1971 the CCP assumed all of the Storage area responsibilities and full control of all future transactions and the personnel of the Storage Tlatoon were reassigned within Supply Company.
- 21. On 16 May 1971 ten Sealand Vans were loaded for Okinawa and 25,000 cube was dropped from the Fleet Shipping that was loaded on Vans for shipping.
- 22. Retrograde delivered eighteen pieces of equipment to Bridge Ramp on a call forward.
- 3. The Commanding General, Force Logistic Command visited the Retrograde acility on 17 May 1971.
- 24. TMO delivered seventeen truck loads of cargo to De Vater Pier on call forward for the USS IWO JIMA.
- 25. Retrograde delivered six pieces of equipment (call forward) to Tien Shar Pier and TMO started a call forward for the USS DUBUQUE and the USS CRA II on 19 May 1971.
- 26. On 20 May 1971 the Commanding General, Force Logistic Command visited the Traffic Management area and TMO completed the call forward for the USS DUBUQUE and began a call forward for the USS SUMPTER.
- 27. Retrograde delivered sixty-six pieces of equipment to Tien Shaw and Deep Water Pier on a call forward for the USS SUMPTER on 22 May 1971
- 23. On 24 May 1971 a call forward was begun for the USS OKINAWA by TMO.
- 29. On 25 May 1971 sixteen pieces of equipment was delivered to Deep Vater Pier (call forward) by Retrograde for the USS OKTHAWA going to CCNUS.
- 30. The call forward for the USS OKINAWA continued and an additional 100 pallets of barbed wire was called for to be loaded for Camp Pendleton.

- 31. PPCP furnished Purchasing and Contracting Office with packaging and packing facilities for fifty-seven (57) pieces of Motorola radio gear to be shipped out of country.
- 32. On 26 May 1971 TMO picked up two truck loads of material from the Army Depot for CCP MC100 stock.
- 33. On 27 May 1971 the Retail Clothing Cutlet closed for monthly inventory for a period of five days scheduled reopening for 1 June 1971.
- 4. All buildings and grounds less Marine Corps property located at etrograde Facility were signed over to the RVN Engineers on 29 May 1971.
