## PART II

### NARRATIVE SUMMARY

During the month of May 1971, Bulk Fuel Platoon issued 71 drums of POL products, 56,358 gallons of mogas and 65,884 gallons of diesel fuel. The fuel site located at 1st Motors was turned over to the U.S. Army in place on 1 May 1971. The Hill #34 fuel site was turned over to the ARVN in place on 26 May 1971. Bulk Fuel is now operating one fuel site which is located at Camp Books. Bulk Fuel has no more equipment for turn-in and all remaining at the Camp Books fuel site will be turned over to the new residents of the area.

During the period of 1 May 1971 to 14 May 1971 the Ammunition Platoon issued 2002 s/tons of Class V(W) ammunition and 264 s/tons of Class V(A) ammunition. On 15 May 1971 ASP #1 was turned over to the ARVN.

Issues of "A" rations during the month of May 1971 totaled 167,400 pounds of meat, fish, produce, and dairy products. Issues of "B" rations and MCI's totaled 301,620 pounds of MCI's and Canned Goods. The Ration Platoon Ice House produced and issued 40,200 pounds of ice during the month of May.

The highlight of the month of May for Supply Company was seeing its mission being accomplished with all of the final stand-down operations in all sections proceeding very satisfactorily towards the total retrograde of material and equipment slated for shipment out of country. The reduction of personnel strength for the final phasedown has kept pace with the reduction of work load and Supply Company is ready for the final steps of disbanding.

By the 15th of May all of the movement of material from the storage areas was completed by Supply Company and the CCP assumed all of the storage area responsibilities and full control of all future transactions concerning storage sites.

Using units placed heavy work loads on PP&P during the month of May. However, as the month neared its end work requirements for PP&P services rapidly declined.

TMO shipments were many for the month of May as cargo was moved to staging areas at Deep Water Pier for loading. Approximately 400,00 cubic feet were shipped during the month of May.

The Retrograde Facility continued to operate under an extremely heavy work load as equipment was being readied for shipment out of country. On 29 May the Retrograde Facility buildings and grounds were signed over to the RVN Engineers as the first step in the turn over of all areas began to materialize.

#### SEQUENTIAL LISTING OF SIGNIFICANT EVENTS

##### 1. LOGISTICS

a. Bulk Fuel dispensed 56,558 gallons of mogas and 65,884 gallons of diesel fuel. There were also 71 drums of POL products issued.

b. Ammunition Platoon issued 2002 s/tons of Class V(W) ammunition and 264 s/tons of Class V(A) ammunition.

##### c. Ration Platoon

(1) The following amounts of rations were issued during the month of May 1971

"A" Rations	167,400 pounds
"B" Rations	301,620 pounds

(2) The Ration Platoon Ice House produced and issued 40,200 pounds of ice during the month of May 1971.

##### 2. PERSONNEL

a. During the month of May 1971 there were 2 Marine Officers joined and 20 Marine Officers dropped. There were 2 Marine enlisted joined and 403 Marine enlisted dropped. There were no Navy Officers joined or dropped. There were 13 Navy enlisted dropped and 1 Navy enlisted joined.

b. During the month of May 1971 this command took pleasure in promoting 50 personnel to present rank as shown below.

##### 3. SPECIAL EVENTS

a. On 1 May 1971 the Commanding General, Force Logistic Command visited the Retail Clothing Outlet Store.

b. On 3 May 1971 Retrograde Facility delivered sixty-seven pieces of equipment to Deep Water Pier on a Call Forward.

c. On 4 May 1971 the Commanding General, Fleet Marine Force, Pacific toured the Storage Area accompanied by the Commanding General, Force Logistic Command.

d. On 10 May the concertina wire located in the lumber yard was earmarked for the Army.

e. On 15 May the CCP assumed all of the Storage Area responsibilities and full control of all future transactions and the personnel of the Storage Platoon were reassigned within Supply Company. Also on 15 May ASP #1 was officially turned over to the ARVN.

f. On 16 May ten Sealand Vans were loaded for Okinawa. As a result the total cargo awaiting Fleet Shipping was reduced by 25,000 cubic feet.

g. The Commanding General, Force Logistic Command visited the Retrograde Facility on 17 May 1971.

h. On 20 May 1971 the Commanding General, Force Logistic Command visited the Traffic Management Area and the TMO completed the call forward for the USS DUBUQUE and began the call forward for the USS SUMPTER.

i. On 24 May a call forward was begun for the USS OKINAWA by the TMO.

j. On 27 May 1971 the Retail Clothing Outlet closed for monthly inventory for a period of five days and is scheduled to reopen on 1 June 1971.

k. All buildings and grounds, less Marine Corps property, located at the Retrograde Facility were signed over to the RVN Engineers on 29 May 1971.

4. TRAINING. At the request of Company Commanders all training has been suspended. Therefore there is a negative training report for the month of May 1971.
