PART II1. Narrative Summary.

During this period this organization furnished Helicopter Support Teams (HST's) on eight (8) occasions. These HST's were provided on Operations Union I, Webster, Duval, and Union II. Also, HST Sections were provided for company sweeps on four occasions. OPCON of Company "B" (-) (Rein) remained with the 5th Marine Regiment for this period. 1st Shore Party Battalion provided material handling equipment in support of the 1st Marine Division, (Rein). Minor construction projects assigned by work orders from the Division Engineer were continued.

In this period, 1st Shore Party Battalion had two (2) Enlisted killed in action while participating in Operation Union II, and one (1) Enlisted was killed accidentally in an aircraft accident. Also, one (1) Officer and fourteen (14) Enlisted were wounded while participating in Operations Union I, and Union II.
