During this period Helicopter Support Teams (HST's) were provided for Operations Onslow and Knox.

OPCON of Company A was passed to the 3rd Marine Division for Operations in Quang Tri Province.

OPCON of Company B was reverted from the 5th Marine Regiment to 1st Shore Party Battalion.

1st Shore Party Battalion provided engineer equipment in support of the 1st Marine Division units. Eight construction projects assigned by the Division Engineer were completed.

The Med-Cap treated 186 Vietnamese during this period. The Civic Action Program is providing materials for the construction of a Buddhist Pagoda and a Maternity Hospital.

In this period Company B lifted 1,201,376 lbs. of cargo while in support of the 5th Marine Regiment.

1st Shore Party Battalion sustained two Enlisted Wounded in Action while on mine sweep operations.






