#### 1. Narrative Summary.

During this period Helicopter Support Teams (HST's) were provided for Operations Essex, Foster, Denver, Lancaster, Knox, Osceola, and Kentucky.

One Officer and 49 Enlisted were dropped to BLT 3/1 of Special Landing Force-B.

OPCON of Company A remained with the CO, 1st Marines OPCON to 3d Marine Division for operations in Quang Tri Province.

1st Shore Party Battalion provided engineer equipment in support of 1st Marine Division units. Four construction projects assigned by the Division Engineer were completed.
