

COMPANY DENTAL CLINIC LOCATIONS AND PERSONNEL ASSIGNMENTS

a. The First Dental Company (-) stood down on 16 September 1970. All officers and men were transferred: (1) to redeployment site at Camp Pendleton, (2) to the 1st Marine Aircraft Wing, or (3) embarked on the USS MANITOWAC which departed RVN on 5 October 1970. From the period 1 October - 5 October 1970 one dental officer and three enlisted marines were the only personnel attached to the First Dental Company in RVN. All Dental Clinics previously maintained by the First Dental Company within the 1st Marine Division TAOR came under the operational control of the 11th Dental Company, 1st Marine Aircraft Wing.
