COMMANDERS NARRATIVE SUMMARY OF SIGNIFICANT EVENTS

During the month of April 1966, the First Hospital Company has remained in a temporary billeting area while work progresses on the planning of a semi-permanent hospital site. The old Fourth Marines CP area has been selected as the site for a 120-bed facility to be constructed by MCB-3 as soon as the planning phase can be completed. Building and facilities requirements have been submitted and approved, material requisitions have been placed for additional equipment and supplies for outfitting the hospital, and work on layout of the site is continuing.

During this reporting period the Company received information from CMC that procurement action for certain Medical Unit-Self-Contained, Transportable (MUST) components was being initiated by the Bureau of Medicine and Surgery. These MUST components are to be delivered to the First Hospital Company for control, use and evaluation. The expected delivery date is October 1966. Reference (a) refers. These MUST elements will be considered in the planning for construction of the hospital.



COMMANDERS NARRATIVE SUMMARY OF SIGNIFICANT EVENTS

Construction of the hospital facility has continued during January. The quonset shells for the x-ray, the two debridement areas, and the operating room are nearing completion. Construction of three living huts and a waiting room for the Outpatient Clinic was completed.

During the month, 230 patients were admitted, 211 were returned to duty. A total of 33 inpatients and 58 outpatients were transferred to other medical treatment facilities for admission. During this same period, 1,010 patients were seen at the Outpatient Clinic.



COMMANDER'S NARRATIVE SUMMARY OF SIGNIFICANT EVENTSI. PERSONNEL

Commander Frank M. ROBERTS, MC, USN, returned to CONUS on 30 days leave subsequent to extending his duty in RVN for six months. Lieutenant Commander Dana N. WEEDER, MC, USNR, assumed command as Acting Commanding Officer.

A significant number of hospital corpsmen (18) were lost from the Hospital Company during the month of February due to the need for additional personnel in the 3rd Marine Division and other units of the 1st Marine Division. This loss has not been made up. Combined with the need to use corpsmen for the Hospital Company's increased security responsibilities during the month of February, it has presented a hardship.

II. OPERATIONa. Medical.

The hospital is presently operating as the sole medical installation in the Chu Lai area for the treatment of medical diseases. It also serves as the convalescent area for these patients and has a holding capacity of 30 days.

The hospital also provides an active outpatient service for the surrounding area. In this capacity it conducts the pre-employment physical examinations required for Vietnamese workers hired by the military in the Chu Lai area.

Personnel in the hospital include specialists in Internal Medicine who provide consultation service for the outlying Battalion Surgeons and medical personnel.

Laboratory and x-ray facilities are also available at the hospital.

During the month 129 patients were admitted, 124 were returned to duty. A total of 27 inpatients and 129 outpatients were transferred to other medical treatment facilities. During this same period, 1,004 patients were seen at the Outpatient Clinic.

b. Military.

Military responsibilities for the company have been increased during the month of February. Responsibility for the security of a portion of the adjoining beach has been given to the company. This has resulted in some personnel shortage in the area of patient care.

III. CONSTRUCTION

Progress in construction of the previously planned casualty complex and related structures has continued. The external structure of six out of nine quonset huts has been completed as well as some of the inside fixtures. A water tower has been erected but, unfortunately, the previously drilled well has been requisitioned for other usage and a new one must be drilled. Construction is well along on two Butler buildings to be used for medical and Marine storage.

Construction has not been as rapid as it should be and this has been due partly to bad weather and partly to low priority, and difficulty in funding and lack of supplies. Priority has recently been upgraded to "Urgent" and a speeding up of construction is anticipated.

IV. FUTURE PLANS

Recent developments call for the movement of D Detachment, 1st Medical Battalion to the physical facilities of the 1st Hospital Company. The combined personnel will function as one unit with the capability of elements of the D Detachment to mount out at any time. The combined personnel and facilities will then constitute the sole hospital facility in the Chu Lai area and will be prepared to take care of all medical and surgical problems encountered.

Plans for the additional wards and cantonment required for this amalgamation have been submitted.



NARRATIVE SUMMARY

Since last report construction of three Butler buildings has been completed and these are occupied with Medical Supply, and Organic Marine Supply.

The surgical complex (including triage, X-ray, pre-op, operating rooms, laboratory, intensive care unit, and shock and debridement) was completed and occupied 8 April 1967. Some internal construction such as partitions, shelves, and sinks remain to be completed to afford optimal hospital efficiency.

Approval is obtained for construction of a sterile supply room, three 20-bed wards, a patient shower and lavatory, and eight living huts. Construction of some of these is underway.

Water is now supplied from a nearby well, pumped into a 25,000 gallon tank on the hospital grounds and piped to the surgical complex, wards, galley, and showers.

1st Hospital Company is now OPCON - ADCON to 1st Medical Battalion. "B" Company, 1st Medical Battalion is now attached to 1st Hospital Company which provides augmented staff necessary to operate a four operating-room complex and 120 beds including the new intensive care unit. Augmentation of the T/O of 1st Hospital Company is still deemed necessary to provide adequate staffing of the three wards under construction.

The holding capacity has been established as 30 days as per III MAF letter 16/jcw 6320 dtd 21 April 1967. This hopefully will reduce in-country evacuation of patients within limitations of space and personnel to provide patient care while maintaining adequate reserve for mass casualties.

Our surgical capacity (operating room and shock and debridement) now is sufficient to handle up to 40 or 50 mass casualties provided there is not an unusual number of severe casualties. This surgical capacity is somewhat limited, however, by the triage capacity.

Since last report construction is near completion of 3 bed wards, and is partially completed on the Central Supply Quanset and the Autoclave shack. 



1. On 9 August 1967, CDR J. S. MAUGHON, MC, USN relieved CDR F. M. ROBERTS, MC, USN as Commanding Officer, 1st Hospital Company. A formal change of command ceremony was conducted, with several distinguished guests attending, including CAPT R. W. JONES, MC, USN, Division Surgeon of 1st Marine Division, LCDR A. N. KENDRICK, MSC, USN, his Administrative Assistant, CAPT DUFFNER, MC, USN, Commanding Officer of the USS SANCTUARY, and others.
  
2. Work was begun throughout the entire hospital cantonment to up-grade existing professional capabilities. The Admission and Sorting building was completely enclosed and painted, a covered walk was installed from the wards to the Messhall, and work commenced on monsoon security for the Officer's quarters. NARRATIVE SUMMARY

1. Rewiring of the X-ray complex with correct size wire was accomplished to preclude power drop. Officer's quarters monsoon security was completed and work commenced on walkways throughout the operating services complex. Fluorescent lights were installed in A&S, X-ray, S&D, ICU, and the operating rooms. Lights were also installed in the pharmacy and MUST Maintenance Office. Two sinks were installed in hutch 06 and 08. This work was accomplished by local public works forces.
2. In the area of self-help the enlisted shower was painted and three enlisted quarters and one officer's quarters was painted. A sandbag partition was erected in X-ray to stop cross irradiation. The Hospital Laundry was emplaced, plumbed, wired and became operational. A regulation windsock was mounted to aid helicopters on landing and departure from the Hospital Company Helopad. A sentry booth was built and painted at the entrance to First Hospital Company contonement.
3. Army personnel are still augmenting the hospital staff and Army casualties are still being received due to overflow of patients from the 2nd Surgical Hospital.

NARRATIVE SUMMARY

1. Construction of building to house the Hospital Laundry commenced. The Special Services Building was torn down, a new site was selected, and construction began on a new building. The new building was subsequently redesignated as an EM Club due to the necessity of tearing down the present club to make room for the new construction. New construction commenced on a two story officer's quarters, a two story enlisted quarters, a new ICU, and a medical warehouse. These buildings are part of the Army's planned expansion program preparatory to transfer of the contonement to the Army as coordinated by 1st Marine Division Surgeon, Commanding General of the 1st Marine Division, III MAF, and 30th NCR (DaNang). Shelves were installed in CSR and two doors were installed at the entrance to the Autoclave Room. Monsoon security of the operating services walkway complex was completed. This consisted of rescreening and louvering. The hospital electrical system was extended to service the laundry area. Sinks and a partition were installed in the enlisted shower to complete the structure. Installation of fluorescent lighting was completed in the professional spaces. All doors were inspected as to condition and necessary corrections were made. Two stainless steel water bath tanks were constructed outside X-ray to facilitate a continuous wash and drain system for preservation of casualty x-rays. Wiring was installed in the Library and Korean Liaison office for future installation of fluorescent lighting, when available. An 8 foot roof extension was added to Hut O-5. Drainage pipes were installed outside A&S. A shower, with hot water, was begun in A&S to cleanse and rid patients of external parasites as they are admitted direct from the

field, to avoid hospital contamination. This work was accomplished by local public works forces, MCB-40, and MCB-6.

2. In the area of self-help, several bunkers were rebuilt, work commenced on construction of ammunition and oxygen storage spaces in Marine Supply, and a half-partition was installed in the front of the Administrative office. Drainage ditches were dug or deepened about the entire hospital complex to empty any water collections, or avoid water drainage into professional spaces.

3. The army augmentation of 1st Hospital Company has been of tremendous value in increasing the professional capabilities of this hospital. Beginning in October 1967, a complete head trauma team was established with the addition of an Army Neurosurgeon, a Ophthalmologist, and a Radiologist. This team, combined with the Navy Oral Surgeon, has afforded immediate expert care to head trauma patients in the Chu Lai area, day or night. The addition of Army nurses, especially trained in Operating Room, Intensive Care, and Ward Support has elevated these areas to the professional status of the best hospitals in Vietnam. This team effort in Chu Lai has been a smooth transition, and has reached peak proficiency at this time. There have been many American, South Korean and Vietnamese lives saved by this cooperation of the U. S. Army, Navy, Marines, and South Korean Marine Corps. I especially appreciate the guidance, cooperation, and encouragement of CAPT R. W. JONES, MC, USN, (1st Mar Div Surgeon), LT. COL. Jim THOMPSON, MC, USA (CO, 74th Medical Battalion), and LT. COL. Bill AUGERSON, MC, USA (Americal Division Surgeon) during this augmentation period.



The construction on new ICU, two Wards, a unit supply building, and the extension to CSR started in December 1967 are still in progress. NARRATIVE SUMMARY

- 1. With the assistance of the Division Engineer, the entire hospital compound was inspected for upgrading. Work requests were submitted for re-wiring, installing of air conditioners and providing proper power source from central power for the 6 OR suites and Intensive Care Unit, as well as adding fluorescent lighting for these areas. Further compound electrical wiring was to be undertaken after completion of these urgent spaces. The Division Engineer provided proper ditching of major drainage routes on the compound, as well as adequately oiling roads and dust areas in the area of the new mess hall and helicopter pad.
- 2. In the area of self-help, all bunkers were upgraded or rebuilt. Direct 30 KW generator support was provided the OR's and ICU until the permanent central power source could be installed. Previous central power hook-up had been inadequate. Upgrading and painting of several administrative and professional areas was accomplished. Upgrading and painting of the Officers, Staff, and Enlisted clubs was accomplished. Identifying signs were placed about the entire hospital.







NARRATIVE SUMMARY

1. At 0001 on 25 September 1968 all remaining patients and the entire Hospital contonment was transferred to the responsibility of 1st Medical Battalion. At that time 1st Hospital Company officially closed to admissions until such time Must Unit #1 is in operation. Company "A" 1st Medical Battalion, Clearing Platoon, Company "D" 1st Medical Battalion and Preventive Medicine Section were dropped to 1st Medical Battalion effective 0001 24 September 1968 and Must Unit #1 became OPCON/ADCON to 1st Hospital Company.

2. 1st Hospital Company relocated at west side of contonment to set up Must Unit. Hospital will not be open to patient care until Must Unit is in operation. Landscaping and construction of new site is now in progress. Above construction being done by 1st and 7th Engineer Battalions. In addition, 7th Engineers Battalion constructed fifteen wooden tent decks to be utilized for working spaces and living quarters at the new location.

3. In the area of self help, all available personnel are being utilized to construct adequate working and living spaces and necessary facilities such as urinoils, showers, latrines and security bunkers. Materials such as lumber, metal sheet roofing, nails and tools have been some what limited, but considerable progress has been made. All available material is being utilized to the fullest extent. At the present time approximately 25% of the wooden tent decks have added wooden sides, "A" frames, metal roofing, doors and screening. Similar construction on the remaining wooden decks is progressing as time, availability of material, and weather conditions permit. However, the living quarters not completed have wooden side frames with screening and are sheltered with General purpose tents. Adequate electrical wiring and lighting fixtures have been installed in all new structures by 1st Hospital Company Utilities Section. Improvements and modifications for special lighting requirements are being made daily. Facilities completed other than the above are a sheltered, cement decked shower area equipped with ten shower heads, three urinoils and six two hole latrines that have been properly situated throughout the area. Construction of wooden side frames and screening on the last of the tent decks is almost completed. A Special Service building supplied with reading material, lounging furniture, television, and indoor games for the benefit of all hands has been completed. Adequate security bunkers for new Hospital site, other working spaces and living quarters are of prime importance regarding our present needs. The speedy progress made so far is a direct result of the outstanding all out effort and participation by all hands, Marines, Corpsman, and Officers alike doing their very best to get their hospital operational again in the shortest time possible. The above construction other than the initial fifteen tent decks and the landscaping of the hospital site has been completed by company personnel.

NARRATIVE SUMMARY

1. 1st Hospital Company is still officially closed to admissions until such time the MUST Unit #1 is in operation. MUST Unit #1 is expected to be in operation approximately 3 November 1968.
2. Landscaping and construction of new hospital site is still in progress. Progress has been hampered a great deal by heavy rainfalls, but has progressed almost to the point of completion. This construction is being completed by 1st and 7th Engineer Battalions.
3. In the area of self help, all available personnel are being utilized to construct adequate working and living spaces and necessary facilities, such as urinoils, showers, latrines and security bunkers. Materials such as lumber, metal sheet roofing, nails, wiring, electrical fixtures, and tools have been some what limited. In spite of this, remarkable progress

has been made. At the present time 80% of the wooden tent decks constructed by 7th Engineer Battalion, have wooden sides, "A" frames, metal roofing, doors and screening added. This includes all living spaces that were previously sheltered with General Purpose tents. Similiar construction on the remaining tent decks is progressing as time, available materials and weather conditions permit. Construction of a trash shed has been completed. Wooden walkways have been constructed and situated throughout the entire cantonment. Overall improvements throughout are being made daily. Adequate security bunkers for new hospital site, other working spaces and living quarters are of prime importance regarding our present needs. A tremendous improvement in the overall appearance of the entire cantonment has been noted.

NARRATIVE SUMMARY

1. On 03 November 1968, 1st Hospital Company became fully operational upon completion of landscaping and construction of the new hospital site, and erection of MUST #1. Complete laboratory and X-ray services, two operating suites, and four wards totaling one hundred beds are now available for the treatment of patients.
2. Landscaping and minor construction in the hospital area continues. Public Works is presently completing a patient's shower. All major construction has been completed.
3. In the area of self help progress continues in the areas of improving the working and living spaces. There has been quite a shortage of building materials, but all available personnel have been assigned to complete tasks for which there is available material. Additional walkways in the living area have been completed. Bunker walls encircling MUST #1 are under construction, and additional bunkers have been completed in the living area. A fire fighting system has been instituted throughout the area, drainage ditches completed, and an additional two urinoils constructed. Owing to these, the overall appearance of area has been improved.





NARRATIVE SUMMARY

1. Minor construction and repairs continue throughout the hospital compound. Particular attention was continued in improving the surrounding grounds.
2. During the morning of 27 April 1969 the Ammunition Supply Point opposite Hill 327 caught fire and began exploding. The hospital received severe concussion blasts and was exposed to minor fallout of debris and shrapnel. It was determined by the Cantonment Commander that to ensure the patients' and staff's safety from possible unexploded rounds falling in the compound, that all patients and non-essential company personnel would be evacuated. At approximately 1600 all patients were transferred to USA Station Hospital and company personnel were evacuated to the 58th U. S. Army Transportation Battalion. Marine security personnel were on the lines and placed in Alert Condition II. All other personnel were assigned security watches covering the wards, offices, and living quarters.
3. On the morning of 28 April 1969, following an inspection of the hospital area and assessment of damage, it was found that only minor damage from the shock waves, such as blown out screens, windows and doors were

suffered by the semi-permanent structures. The MUST unit also suffered minor damage, with one end panel and some doors being blown out. One MUST inflatable unit had a piece of shrapnel go through one section, but was easily repairable. All company personnel were returned and immediate cleanup and repair was begun. By 1000 hours on 28 April 1969, the hospital was fully operational and ready to receive patients.

PART IINARRATIVE SUMMARY

1. Construction of a command bunker was begun in the first part of the month, and by the end of the month the bunker's entire structure was completed and only remained to be sand bagged. The dimensions are such that were it necessary, twenty to thirty people could take shelter in it. When completed it will have been installed with sufficient communications equipment to be able to transmit the necessary information to coordinate the actions of 1st Hospital Company with those of 1st Medical Battalion.

2. The doorway frames to the MUST wards were damaged due to the ammunition dump explosions, and despite attempts to repair them there has continued to be a marked leakage in the air-conditioning. To counter this, special air locks have been added to each of the entrances of the wards. In addition, interlocking passageways were constructed to join the wards together. There is considerable traffic between wards; when the meals are distributed and when the patients go to the showers, and this last measure has thus reduced the exposure of patients to the elements, especially during the rainy seasons.

3. Other minor construction and repairs jobs have been effected during the month. For instance, a new urinoil was built for use by the ward patients, and other urinoils have been relocated. Also light poles to be placed outside the entrance to each ward were prepared for erection.


