1. ORGANIZATIONAL DATA

- a. 1st Marine Division (Rein)(Rear), FME, Camp Pendleton, California
- b. Period Covered: 1 January 1966-12 February 1966
- c. Commanding General: BGen W. A. STILES

2. SUMMARY OF EVENTS

a. At the start of the new year, the 1st Marine Division (Rein)(Rear) was engaged in activities incident to its deployment to WestPac. The task organizations of BLT 2-5, BLT 3-5 and the SLF Element as promulgated on 30 December 1965 became effective on 1 January.

b. Readyng the above and other Division (Rear) organizations for deployment resulted in a myriad of tasks. As deployment dates grew closer it became apparent that the major task would be the acquisition of sufficient personnel. For further discussion of this and other personnel problems see Appendix 1 (General Staff Section, G-1 Chronology).

c. The 1st Marine Division (Rein)(Rear) deployment order was published on 3 January. The mission as stated therein was to direct and coordinate where appropriate the embarkation and movement to WestPac (begining in January) of designated 1st MarDiv (Rein)(Rear) and ForTrps, FMEPAC units, and of cargo as directed from MarCorSupGen, Barstow and 3d MAW.

d. Due to the nature of the mission, the operations and embarkation sections worked hand in hand ; with the operations section having established its requirements, the embarkation section published its instructions sufficiently in advance to provide for the smooth execution of the missions assigned.

e. LtGen V. H. KRULAK, CG FMEPAC, visited this Hq on 20 January and was briefed on the status of deployments.

f. As of 4 February there were no deadlined items of combat essential equipment within this command.

2. SUMMARY OF EVENTS

a. Organization

(1) At the start of the period BLT's 2/5 and 3/5 were task organized into combat units, while other units were organized to facilitate embarkation and control for deployment to WestPac. The 1st Marine Division (Rein)(Rear) was organized into a total of six embarkation teams, which were tailored to fit personnel and equipment into available shipping.

(2) Upon departure of General STILES on 12 February 1966, the 1st Marine Division (Rein)(Rear) was redesignated 1st Marine Division Rear Echelon (Camp Pendleton) and Colonel J. E. GARNER, Commanding Officer, 1st Force Service Regiment was assigned the Commanding Officer.

b. Personnel

(1) As deployment dates grew closer it became apparent that the 1st Marine Division (Rein)(Rear) did not have sufficient personnel resources to flesh out the initial deploying units without wholesale reassignments from other units. Shortages were reported to CG, FMFPac who in turn forwarded the necessary information to HQMC. Both lateral and recruit input were re-allocated to this command, and units in Phase I deployment departed at virtually manning level. There were over 100 basics and a noticeable grade and skill shortage in BLT 2/5.

Phase II units deployed at manning level, and overall, had better balance of grade and skills with no basics remaining in units.

(2) Programs to encourage nondeployable personnel to waive overseas control dates and to reenlist/extend enlistments continued to the moment of final deployment. The Commanding General's assurance that such men could be assigned to deploying units of their choice netted the Command approximately 300 previously unscheduled deployable personnel through 12 February 1966.

(3) The relatively large number of 17 year olds in Division (Rear) units has created personnel problems of some magnitude. The deployment criteria precluded assignment to combat units those personnel who would not attain their 18th birthday prior to their arrival in WestPac, or 1 May 1966 in the case of personnel in combat support/service units deploying to Okinawa. When BLT 2/5 deployed all 17 year olds not meeting the deployment criteria were transferred to units where they could be utilized.

(4) A total of 270 17 year olds are currently assigned to Sub Unit #3 and 1st FSR. Some of these were employed as embarkation working parties and were of inestimable value in permitting the bulk of the deploying units to train and prepare for deployment until the last possible moment. Most of the 17 year olds, however, were programmed into occupational areas where they could be trained to later fill critical skill shortages as they achieved eligibility status.

(5) The Commanding General, Marine Corps Base assumed responsibility as supervisory authority for courts-martial which will not reach final processing prior to departure of the Commanding General, 1st Marine Division (Rear).

2. SUMMARY OF EVENTS

This report covers 1Jan-12Feb66. Personnel turnover, and preparations for embarkation most characterized this period. Key personnel who were transferred from the G-2 Section were LtCol FLYNN (MACRON-4), Capt HERNANDEZ (BLT 2/5), SSgt COLEMAN (BLT 2/5). Four non-deployables were left behind for further transfer or separation. Three 0241's joined.

This section turned over to Sub-Unit #3 four buildings and the property therein, which had been used by the Combat Intelligence, Photo Interpretation, Map, and Counterintelligence sections.

Terrain models of Camp Pendleton, and other training areas including off-shore islands were turned in to Base Training Aids Library. Also in this category were local maps and terrain studies.

Mounted maps, copies of past exercises orders, extra field manuals and miscellaneous supplies have been stored in building 1573, with the materials formerly used in the Division's Aerial Observers School.

Contingency plans for 5th MEB and GDF were passed to CGFMFPAC. Maps and charts were turned into ComNavAirPac for storage and maintenance in current status pending reissue as required to future command.

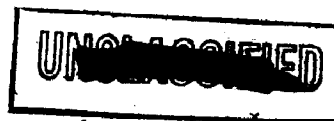

2. SUMMARY OF EVENTS

a. The activations for deployment as promulgated on 30 December 1965 became effective, with few exceptions, on 1 January 1966. Included in these activations were BLT 2-5, BLT 3-5 and the SLF Element.

b. The 1st Marine Division (Rein)(Rear) Deployment Order was published on 3 January. Its execution was the primary concern of the G-3 Section during the period covered by this report. The only significant change to the order as written involved the SLF Element, due to the element deploying in two increments vice one. By means of close coordination with FMFPAC and our own Embarkation Section, the order was executed without difficulty.

c. LtGen V. H. KRULAK, CG FMFPAC, visited the Hq on 20 January and was briefed on the status of deployments.

d. By 12 February, all units scheduled for deployment, with the exception of the 107MM MortBtry (Rein), 2d Bn 11th Mar, had departed CONUS. The 107MM MortBtry had reported to HMM-164, 3d MAW, for embarkation aboard the USS PRINCETON (to sail on 16 February).

BRIEFING FOR LTGEN KRULAK
20 JAN 1966

General Krulak, General Cushman.....this discussion pertaining to the Division Rear will center around those main topics specified by you ten days ago. After I have discussed Division Rear matters, Colonel Garner will continue with remarks concerning 1st FSR activities.

When we leave here, we will visit the nearby CP's of the 1st MP Battalion and 9th Engineers. Then, time permitting, a short visit to the 1st FSR area on the way back to the airstrip.

The agenda items I will discuss are: first, status of Division Rear personnel. Second, our supply & equipment situation and how that situation improved prior to the January mountout, and third, a recap of the Barstow gear shipments. Then, my final topic will be a recap of our plans for closing out this 1st Division Rear, 3 weeks from tomorrow.

When we discussed personnel last fall, on the occasion of your October visit here as well as the November conference at your Hqs, the picture was far from a good one.

(Enclosure One)

Here was that mid October picture, 1900 enlisted non-deployable, (40% non-deployable) and 365 men in FMF Assistance and Base Augmentation.

As a result of actions taken by your staff and by HQMC to improve that situation, the picture drastically changed, to this, at deployment time just 10 days ago.

(Enclosure Two)

Our enlisted inputs from December through mid January are shown here. Assignment of these personnel was made on a basis of priority, to build up units based on known sequence of deployment.

It still was necessary, however, to study the personnel characteristics of each major input, to ensure assignment of individuals where they could be best used, rather than just fill billets. Wholesale transfers between units were avoided because of the manifest effect on morale. As a result, 2/5 received its final personnel increment, 91 men, shortly before sailing. By careful monitoring we have been able to deploy each unit very close to M/L. And --

(Enclosure Three)

Personnel to meet any minor last minute shortages are being deployed by air, using seat vacancies in Staging Bn flights, or are accompanying subsequent units deploying by surface.

Although M/L strengths are being achieved, shortages in ranks do of course exist.

(Enclosure Four)

Enlisted personnel distribution by paygrade is shown here — both as of 10 January, and projected to 10 February. It is based on known input. Information indicates that these shortages in Sergeants and above will be reduced.

In addition to ITR graduates and lateral input of personnel, a major contribution to our deployability has been achieved through extension of enlistments and waiver of overseas control dates. As an incentive, non-deployables who so extend or waive OSCD were offered the opportunity to deploy with any Division (Rear) unit of their choice. As a result of our campaign here, 300 personnel have been gained to date. Accordingly almost 10% of our deploying strength has been re-recruited by us.... a noticeable assist to our personnel department.

Throughout the past weeks and months, 17 year olds have created another factor to consider in assignments. Those who will be 18 prior to May have been assigned, of course, in accordance with prescribed criteria. However, we now have 292 17 year olds who will become 18 after 1 May, and are thus not deployable at all with the Division Rear. They have been assigned to the 1st FSR and to Sub Unit #3 of this Command. The 57 of them now in Sub Unit #3 actually are performing many camp functions for BLT 3/5, allowing that BLT to give full attention to training. The 235 in First FSR have been used in large measure to assist in basic tasks, and were particularly useful in ship loading during last week's embarkation. For a final glimpse of our personnel picture,

(Enclosure Five)

here are today's strengths and projected strengths of the Division (Rear) units still here.

It appears at this time, that remaining units will be able to deploy at M/L.

The deployments to date have indeed gone smoothly. My assignment as coordinator for the embarkation of deploying force troops units and Barstow cargo is accomplishing its purpose — a common focal point for embarkation matters and a single point of contact with the Navy. In the case of Barstow gear, the simple, logical procedure shown here is followed.

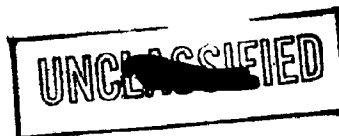
This has resulted in a good working procedure, considering the fact that Barstow is using other ports and shipping for cargo as well.

(Enclosure Seven)

Shown here is the Barstow cargo lifted to date. Cargo priority is as determined by your Hqs.

While mentioning Barstow, I might discuss logistic support from a slightly different angle - specifically equipment readiness for deployment, which in the case of our Division Rear equipment, I now consider to be nothing but first rate.

Upon deployment of the Eastpac Mab during July and August, a serious equipment problem arose wherein many items of equipment were deadlined awaiting parts at time of embarkation, even though priority 5 requisitioning had been authorized. To overcome that deficiency, in August your Headquarters (through CMC) caused Barstow to establish a pool of end item replacements at Camp Pendleton, to ensure that all units of Eastpac Mab had a full t. e. of serviceable equipment upon deployment.

The Division (Rear), however, has not experienced any such difficulty in preparing combat essential equipment for deployment. To date only one piece of equipment, (an M-51 Tank Retriever) could not be repaired in time for deployment, and it has been replaced by a like item from Barstow.

Two primary reasons, however, lie behind this improved equipment posture for our January deployment.

First, the January deployment target date, confirmed well in advance by your Headquarters, gave us valuable time to get all Division (Rear) equipment prepared for deployment.

Second, and most important, the priority two requisition authority, granted in December, quickly provided the repair parts required to remove all combat essential equipment from deadline status. With those planning preparations, little wonder that the units which have embarked and sailed so far have done it without a major hitch.

(Enclosure Eight)

BLT 2/5 did sail, combat loaded. RLT-5 Hqs was combat loaded, in-so-far as practicable, and the remaining units were administratively loaded to economically use ship spaces.

Remaining units to be embarked, their organization for embarkation, sail dates and shipping are shown here:

(Enclosure Nine)

These units will be administratively loaded, except the SLF element and BLT 3/5. They're positioned in shipping to maintain unit integrity as well as to meet dates. I might invite your particular attention to embarkation unit Echo, which must be in RVN in March and embarkation unit Foxtrot which must be in RVN in Feb. Planning for these embarkation units was done on the basis of eliminating the need for transshipment from Okinawa to RVN.

My advance party departs by air on 12 Feb with a one day stopover at your Headquarters. Close-out of the Division (Rear) will be accomplished by means of a Rear Echelon and Sub Unit #3.

Sub Unit #3 now consists of 460 Marines, all non-deployable for various reasons (EAS, OSCD, IHCA, Sick, etc.). Those men who are on full duty have been performing regular work with their former unit until that unit is deployed. Now that a majority of our units have deployed, however, this Sub Unit 3 group is performing duties with the First FSR and is carrying out certain housekeeping functions at Camp Margarita for 3/5, as I mentioned earlier. Upon my departure, the Rear Echelon left here will consist of approximately 9 officers and 25 enlisted. Their tasks are as shown here:

Upon completion of assigned Rear Echelon tasks here, personnel remaining with the Rear Echelon will be immediately flown to Okinawa. Arrangements exist with the Staging Battalion to utilize vacant spaces on special air flights for those people, by utilizing this air transportation, most of the Rear Echelon should be on Okinawa awaiting arrival of the Headquarters surface element.

Upon my departure, command of the First MarDiv Rear Echelon will devolve upon the senior FMFPac officer remaining at Camp Pendleton, who then will be Colonel Garner — 1st FSR. I anticipate that that final Rear Echelon would have a life expectancy of only two or three weeks.

I want to point out at this time the excellent cooperation and support provided us by MajGen Cushman and his Command throughout our deployment preparation. Turn over of garrison property and buildings, by deploying units, has been handled promptly and efficiently. Also, transportation support to POE's during deployment was available to all degrees desired. Further, close cooperation with the Base in personnel matters has resulted in an expeditious exchange of 130 personnel to bring BLT 2/5 to M/L. Finally, cooperation and support in legal matters eased our preparations for deployment to a great extent.

I can assure you that there will be no detail left uncovered when the final personnel of this command depart Camp Pendleton. The activation of Sub Unit #3 has been beneficial beyond our expectations in processing non-deployable personnel. Further, this will give to the Commanding General, Marine Corps Base, Camp Pendleton, in one package, all non-deployable Marines.

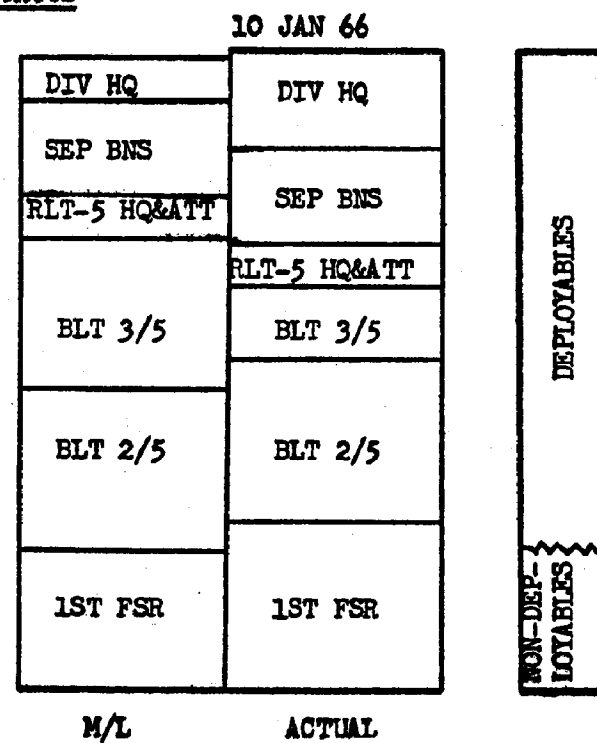
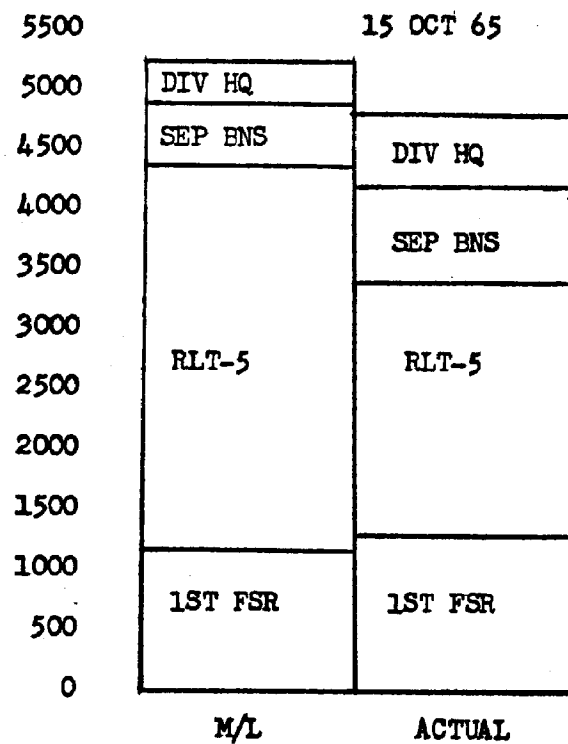
