

2. SUMMARY OF EVENTS

This temporary rear echelon was established on 12 February 1966 upon the departure for WESTPAC of the Commanding General, 1st Marine Division (Rein) (Rear).

During this period the command continued the function of the 1st Marine Division (Rein) (Rear). It assumed ADCON of all remaining 1st Marine Division (Rein) (Rear) elements remaining at Camp Pendleton to include the 1st Force Service Regiment and the 5th Interrogation-Translation Team (5th ITT).

BLT 3/5, 107mm Mortar Battery 2/11, and individual members of this command embarked for overseas. The Mortar Battery was reinforced with postal and disbursing elements.

All facilities and garrison property were inventoried and receipted for by the Property Control Officer, Marine Corps Base, Camp Pendleton. The 1st Marine Division now has zero assets at Camp Pendleton.

ADCON of 1st Force Service Regiment and 5th ITT was passed to Commanding General, Fleet Marine Force, Pacific, and OPCON of 5th ITT was passed to Commanding General, Marine Corps Base, Camp Pendleton, California.

Having completed its business, this command was reduced to zero strength and closed operations at Camp Pendleton, California, on 9 March 1966.

3. CHRONOLOGY OF EVENTS

- 12 FEB ESTABLISHMENT OF TEMPORARY REAR ECHELON
1st Marine Division Rear Echelon, FMF, Camp Pendleton, California 92055 established this date. 1/2/ Colonel J. E. GARNER assumed command. 3/4/ (See Tab A for assignment order; see Tab B for assumption of command order; see Tab C for tasks and functions; see Tab D for closing instructions.)
- 14 FEB COMMAND SECURITY INSPECTIONS
Vacated command posts of 2/11, 7thMTBn, and Sub Unit #2 were inspected. No security violations were noted.
- 14 FEB COMM/SUPPLY AUGMENTATION REASSIGNED
All personnel in Comm/Supply augmentation 1st Marine Division (Rein)(Rear) were reassigned to Marine Corps Base, Camp Pendleton for duty with 4th Marine Division Headquarters Company Cadre. 5/
- 16 FEB 107 MORTARS DEPLOY
107mm Mortar Battery 2/11 embarked and sailed aboard USS Princeton (LPH-5)
- 21 FEB REAR/ADVANCE PARTIES DEPART
Rear Echelon/Advance Parties of 7thMTBn, 2ndBn(=)11thMar, and the remainder of the rear echelon of disbursing section and seven enlisted replacements departed for WESTPAC by air.
- 28 FEB ITT ATTACHED TO FSR
Two officers and nine enlisted members of 5th ITT were attached to 1st Force Service Regiment.
- 28 FEB BLT 3/5 DEPLOYS
BLT 3/5 under the command of Lieutenant Colonel BRONARS embarked and sailed for WESTPAC aboard the USS Renville (APA-227), USS Winston (AKA-94), and USS Tortuga (LSD-26).

1. Reference (a) directs that the Commanding General, 1st Marine Division (Rein) (Rear) constitute a temporary Rear Echelon at Camp Pendleton, California until all units are deployed. Reference (b) contains the mission and tasks of the Rear Echelon. Reference (c) provides for the change of command from the Commanding General, 1st Marine Division (Rein) (Rear) to the Commanding Officer, 1st Marine Division Rear Echelon, FMF, Camp Pendleton.

2. In addition to continuing the function of the 1st Marine Division (Rein) (Rear) at Camp Pendleton the Rear Echelon has been charged with the following additional responsibilities:

a. Assume ADCON of all 1st Marine Division (Rein) (Rear) elements remaining at Camp Pendleton, California to include the 1st Force Service Regiment and the 5th ITT.

b. Embark remaining elements as directed.

c. In coordination with the Commanding General, Marine Corps Base, Camp Pendleton, and upon completion of Rear Echelon functions, to include final disposition of Camp Pendleton facilities and garrison property, pass:


(1) ADCON 1st Force Service Regiment to Commanding General, Fleet Marine Force, Pacific.

(2) ADCON 5th ITT to Commanding General, Fleet Marine Force, Pacific and OPCON to the Commanding General, Marine Corps Base, Camp Pendleton, California.

(3) MCC 168 as directed.

(4) Sub Unit #3, HqCo, HqBn, 1st Marine Division (Rein) to the Commanding General, Marine Corps Base, Camp Pendleton, California.

3. Actions required incident to carrying out the functions and activities of the 1st Marine Division Rear Echelon, FMF, Camp Pendleton are listed and expanded in detail in enclosure (1). Additional items which may arise during the execution of Rear Echelon tasks, will be accomplished as directed by the Commanding Officer, 1st Marine Division Rear Echelon, FMF, Camp Pendleton.

1.
