1. 3 November 1966. Military Police Company displaced from CHU LAI to DANANG TAOR.
2. 8 November 1966. Major R. C. RICE assigned as Headquarters Battalion Executive Officer.

Captain D. R. WEST assigned as Assistant Logistics/Embarkation Officer.

Lieutenant Colonel MOLESKY assigned duties as Officer-in-Charge of Sub-Unit #2, Headquarters Company, Headquarters Battalion.

RIC Captain B. C. HENRY assigned as Ass't Opns/NBC Def O, Civil Affairs, IRO Legal O, and Spec Serv O.

Service Platoon was transferred from Service Company to Headquarters Company with a strength of eight officers and 129 enlisted.

3. 10 November 1966. Headquarters Battalion celebrated the Marine Corps' 191st Birthday with a modified cake cutting ceremony. MGEN H. NICKERSON was the Guest of Honor.

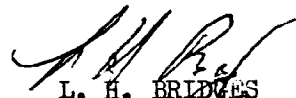
