PART II  
NARRATIVE SUMMARY

During this reporting period:

Three officers and 157 enlisted attended the Battalion Orientation and Indoctrination Presentation and seven officers and 247 enlisted fired individual and crew-served weapons for familiarization. Civic Action was emphasized; 507 patients were treated through MEDCAP by the HQBN Medical Staff. Extensive heavy equipment operations to improve fields of observation and fire and generally improve the defenses of the Division Command Post were approximately 50% completed. 117 men participated in scheduled one day R&R at China Beach.

Sub-Unit #1 released the personnel of the I Corps Security Group to 1st MP Battalion. The GACs suffered eight combat casualties.

Service Company Command Group displaced from the CHU LAI TAOR to DA NANG.

Subj: Commendation

1. On 25 November 1966, acting on intelligence provided by HOA LAC Village Chief, Combined Action Platoon B 1-5 effected the capture of a group of fifteen Viet Cong, including a Viet Cong Hamlet Chief, a Viet Cong Political Team and a Viet Cong Reconnaissance Unit.
2. At 1210 on 8 December 1966, Combined Action Platoon B 1-5 received small arms fire from a group estimated as six Viet Cong. Fire was returned and in the ensuing brisk fire fight, four Viet Cong were killed at a cost of four Vietnamese Popular Forces members and two U. S. Marines wounded in action. The action uncovered an extensive cave complex, which was destroyed and resulted in the capture of one five pound shape charge, six chicom grenades, three M-26 grenades, one 45 caliber pistol, one carbine, and one French automatic weapon.
3. The aggressive spirit and decisive professional conduct of Combined Action Platoon B 1-5 throughout these actions reflects a high degree of teamwork and sound leadership throughout your platoon and is a tribute to the effectiveness of the Combined Action Concept.
4. I commend Combined Action Platoon B 1-5 for its fine display of professional competence and determination. A hearty "Well Done" to all.
