

## PART II

NARRATIVE SUMMARY

During this reporting period enemy movement and activities were light to moderate in the areas of operation of Combined Action Companies 1-1 and 1-2. Combined Action Company 1-3 in Binh Son District experienced a pronounced VC mining campaign with moderate enemy movement. To react, patrolling was increased, along with an added emphasis on the PsyOps activities in the area. Emphasis on the Volunteer Information Program was a strong factor on the high number of VIP and ordnance turn-in incidents, which for this period were thirty-two and thirteen respectively. Most of these incidents involved mines and many of the contacts with the enemy were mine related. Of the one hundred and four contacts, eighty-one were initiated by CAP personnel and twenty-three by the enemy. Of the former, almost half of the contacts resulted in mines being captured while being placed or while being carried by the VC. As a result of all contacts, one hundred and forty one VC/NVA were KIA(C) and nineteen POW's were captured.

An added commitment for 1st CAG during November was to support the Accelerated Pacification Campaign which is aimed at up-grading twenty-two villages from contested status to secure, pro-GVN status.

The CAG S-3 enlarged its PsyOps capability by assigning a PsyOps NCO, and charged him with keeping abreast of the APC program. He also was to develop a special PsyOps program to accompany the insertion of new CAPs. during the reporting period.

The project to provide adequate living quarters for CAPs was completed by MCB-74 by construction of nine sea huts during the reporting period.

The large number of personnel leaving during the month for REED or special leave resulted in a 34% turnover in personnel. The Group received enough new personnel to offset the losses so that no great problems arose as a result of the high rate of turnover.

During the last week of the month a Gunnery Sergeant (MOS 2591) joined 1st CAG and was assigned as Communications Chief. This addition should improve the quality of the Groups communications and assist the CACOs with their communications problems.

## PART III

SEQUENTIAL LISTING OF SIGNIFICANT EVENTS

a. Mission. The mission of the 1st Combined Action Group has been tailored to respond to the Communist doctrine of Wars of National Liberation as applied by the VC/NVA in 1st CAG's areas of operation. This includes (1) destroying the VC infrastructure, (2) protecting assigned villages and friendly infrastructure, and (3) participating in civic action and conducting psychological operations as part of the local effort toward "nation building". An additional commitment during the reporting period was to support the Accelerated Pacification Campaign which began 1 November. Twenty-two villages in the three Districts had been officially listed as "contested areas" and were to be up-graded to a secure status during the ninety-day campaign. In one case support was offered by relocating the Marines of one CAP to a targeted village and having a new Popular Forces Platoon assigned to them. In most cases the CAP's assisted by extending their activities to help secure a neighboring village which was on the list. If an "APC" village was not close enough for night patrols, day patrols from the nearest CAP were directed into the area for added protection when Campaign activities needed such support.

b. Combat Operations. Combat operations showed an expected increase in relation to the Accelerated Pacification Campaign. Operations involving more than one CAP platoon increased in order to sweep areas around a village before the Campaign was initiated and publicized there. Propaganda teams accompanying VN officials necessitated extra patrols for security, and if enough information on enemy movements was gained, other joint sweeps were planned and conducted.

e. New Techniques. As a result of the emphasis on PsyOps during the reporting period a PsyOps "Insertion" plan was developed which, with improvements, will become standard for all insertions of new CAPs. Prior to CAP 1-3-2's relocation as a mobile CAP, the area was "prepped" with PsyOps activities which described the Combined Action Program. After insertion, major PsyOps themes were introduced. After a few days, when the CAP had time to observe their targets, more sensitive topics such as anti-VC propaganda could be introduced. By the end of the reporting period the "insertion" plan was organized as listed below.

f. Command Relations. 1st Combined Action Group now consists of nineteen CAPs in three CACOs and two Mobile Training Teams. During the reporting period two CAPs were relocated, leaving their PF Platoon in charge of the

old compounds and being assigned new PF units. On 2 November 1968 CAP 1-3-2 was relocated from BS609918 to be mobile in the area of BS554898. On 10 November 1968 CAP 1-2-4 moved from its compound at BT460000 to the other end of their AO as a mobile CAP in the area of BT445105.

Training and administration of the two Mobile Training Teams are now supervised by the group S-3, while logistical support and tactical employment is handled by the Company Commanders. At this time 1st CAG has a radio shack which monitors all frequencies of subordinate CACOs and keeps the S-3 briefed continuously. However, activities are coordinated only through the District and supporting Battalion Command Centers.

g. Logistics. During November nine Sea Huts were constructed at CAPs completing a project by MCB-74 to provide living quarters at all CAPs. Two vehicles were lost to enemy mines during the month and replacement vehicles have been placed on requisition. A problem area during November was the shortage of batteries, BA-386, for the PRC-25 radio.

h. Training. The training program of the group consisted of both formal and informal instruction. A schedule of formal instruction to be accomplished by the CAPs for both Marines and Popular Forces was published and monitored weekly by the group S-3. Instructions for the Marines were aimed at subjects to fill the particular needs of the group. Weekly training for the CAPs is conducted daily for both the Marines and Popular Forces, subjects reviewed are Map Reading, Mines and Booby-traps, Air support, Artillery Adjustment, Crew served Weapons and leadership. NCO leadership school is conducted bi-weekly at the group headquarters for both Marine squad leaders and their Vietnamese counterparts.

Units completing training at the Mobile Training Teams were two platoons from MTT 1-1 which began on 2 November and graduated on 14 November. The next platoon commenced training on 14 November and graduated on 28 November. MTT 1-2 graduated one platoon on 11 November.

i. Civic Action. For the month of November 1968, 1st Combined Action Group held a total of 44,155 MedCaps, 41 DentCaps and medicated 94 Vietnamese civilians. In the distribution of commodities, 1966 lbs of food, 678 lbs of clothing, and 837 lbs of soap were provided to the Vietnamese by the CAPs. One female child received hair-lip surgery. In addition, there was one Physical Education kit, twenty school kits, ten sewing kits, one farmer kit, and three resettlement kits donated to the Vietnamese. The education effort included 1198 Vietnamese attending 127 hours of English classes and 433 persons receiving vocational training.

j. Administration. The 1st Combined Action Group continued to operate on group level administration and experienced no administrative difficulties during the reporting period.

k. Personnel. During the reporting period 50 personnel were transferred and the unit joined 84 personnel, resulting in a 34% turnover. The join-ees included an increased input of sergeants. Personnel being assigned to the group continues to be of high caliber, all being volunteers, selected by a board and all possessing above average records.

Thirteen Marines extended their overseas tour for six months during the reporting period.

Meritorious promotions were presented to four members of the command, all four to Lance Corporal.

Chaplains of both the Americal Division and Marine Air Group 12 provided weekly religious services even to the most remote CAPs. In addition, Red Cross Representatives visited the CAPs on a regular basis providing playing cards and books for the Marines.

One ARVN 1stLt and four SSgts were attached as interpreters during the reporting period.

Twelve Vietnamese Hoi Chanh were serving as Kit Carson Scouts under the program set up by III MAF.

During the week ending 2 November, 20 Marines and 10 PF's of 1st CAG received decorations from the RVN.

l. Communications. During the last week of the reporting period, a Gunnery Sergeant, MOS 2591, was assigned to 1st CAG as the Communications Chief. The tasks listed below were assigned to the new Comm Chief in order to up-grade the quality of communications within 1st CAG.

1. Acting as chief advisor to the Commanding Officer in all matters pertaining to communications.
2. The promulgation of a revised Group Communication Plan.
3. Operator training.
4. Supervision of the CAG Headquarters radio central.
5. General supervision of all CAG radio networks.
6. Maintenance of all communication-electronixs logs and records in accordance with TM 4700-15/1.
7. Issuance of call signs, frequencies and various code tables.
8. Ensuring that proper communication security procedures are being adhered to.
9. Supervision of a preventive maintenance program.
10. Supervision of the supply of all communication equipment to the CAPs.

Provision for levels of maintenance are as follows:

1. 1st Echelon. The CAP is authorized to perform this level of

maintenance only. This is performed by the operators on a daily and weekly basis.

2. 2nd Echelon. This level of Maintenance support is provided by the Communication Section, Supply Company, Force Logistical Support Unit Three.

3. 3rd Echelon. This level of support is provided by 1st Force Service Regiment, Maintenance Battalion Liaison, Chu Lai, RVN, as part of the Direct exchange of equipment, particularly with the RT-505 (AN/PAC-25), is rarely accomplished in less than 30 days, and usually is in the time frame of 30-90 days. In view of this, the Direct Exchange Program is presently inadequate for the needs of 1st CAG.

Frequencies, call signs, and code tables are provided by the Americal Division Signal Office, and are given on both a monthly and as required basis.

M. Intelligence. The main sources of intelligence have been III MIF, Americal Division, and the 198th Light Infantry Brigade, and supporting units around the AO. When the intelligence is received, it is read, screened and digested by the S-2 office, and the Commanding Officer, 1st CAG. The information applicable to the CAP is then given to the Company Commander to be used in his program. The activities of the CAPs are adjusted to comply with recent trends in enemy movement, infiltration and supply. The greatest source of intelligence to the group is still, as in the past, the CAP itself. The intelligence functions are handled by designated personnel at the CACO. The company radio operators are responsible for intelligence functions, but are closely monitored by the Company Gunnery Sergeant. Some CAPs have intelligence NCOs who perform these duties as secondary duties. The squad leader is still responsible for intelligence requirements. All intelligence received by the CAP are sent to the CACO by spot report. All intelligence received by the CACO is sent to CAG and District Headquarters. All intelligence received by CAG is then screened, digested, and sent to supporting units. All intelligence received concerning troop movement in the units AO is plotted on an enemy situation map.

N. Fire Support. Each CAP has artillery support, close air support and helicopter gunships available. Artillery support includes 105MM howitzers, 155MM howitzers and 8 inch howitzers. Helicopter gunships are procured from either of two Aviation Battalions attached to the Americal Division. Close air support comes from MAGs 12 and 13. Navy Swift boats of Coastal Division 12, Chu Lai detachment are able to support CAPs along the beaches with 81MM mortars and 50 Caliber Machineguns fire.

Subj: Relocation and redesignation of Combined Action Platoon 1-2-4

Encl: (1) Proposed AO for Combined Action Platoon 1-2-4

1. It is recommended that Combined Action Platoon 1-2-4 be relocated from its present position (BT468080) to the vicinity of KHUONG PHU (BT445112).
2. Combined Action Platoon 1-2-4 is presently occupying a position adjacent to highway #1 in what is now considered a pacified area. In addition to this there are presently two to four Popular Platoons assigned to this Combined Action Platoon. It is felt because of its location and the number of PFs assigned to it that they are now capable of taking over the duties of this Combined Action Platoon.
3. The proposed relocation area is now occupied by an RD platoon that is experiencing difficulty in keeping the Viet Cong out of the area. The proposed relocation would strengthen the RD effort in this area and is concurred in by the Province RD Coordinator, the District Senior Advisor, and tentatively by the District Chief.
4. Presently it is not planned to construct a compound in this area, but rather to utilize the Mobile Combined Action Platoon concept to see if it will work successfully in this area. In addition to the Combined Action Platoon Marines, one platoon of PF's will be provided to insure the security of this area. It is further recommended that Combined Action Platoon 1-2-4 be designated a Mobile Combined Action Platoon if and when the relocation is effected.

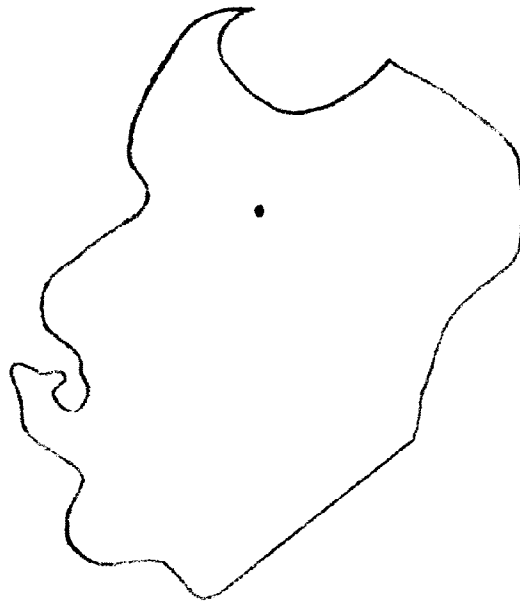
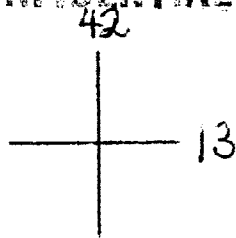

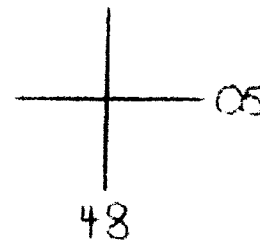

Subj: Relocation and redesignation of CAP 1-3-2

Ref: (a) Verbal request of Province Chief, Quang Ngai Province  
(b) Verbal request of District Chief, Binh Son District, Quang Ngai Province

1. In accordance with reference (a) and (b), it is recommended that CAP 1-3-2 (BT614016) be moved from its present position to the vicinity of (BS575906).
2. The area in which this CAP is presently located is adjacent to the Chu Lai Air Base and is considered pacified. The Popular Forces Platoon which is presently located with CAP 1-3-2 will remain in position and is capable of providing security for this area.
3. The proposed area of relocation is composed of five hamlets containing 6000 people and is a prime target for RD activity. The location of a CAP in this area would provide adequate security to support the RD effort.
4. The Vietnamese officials desire that this move be made as soon as possible to fit with the schedule of the Province Campaign Plan. 1 November 1968 is the proposed date of relocation. This date is close but is feasible as the CAP is ready to move at this time. If and when the move is made CAP 1-3-2 will operate as a mobile CAP and cover the five hamlet area.


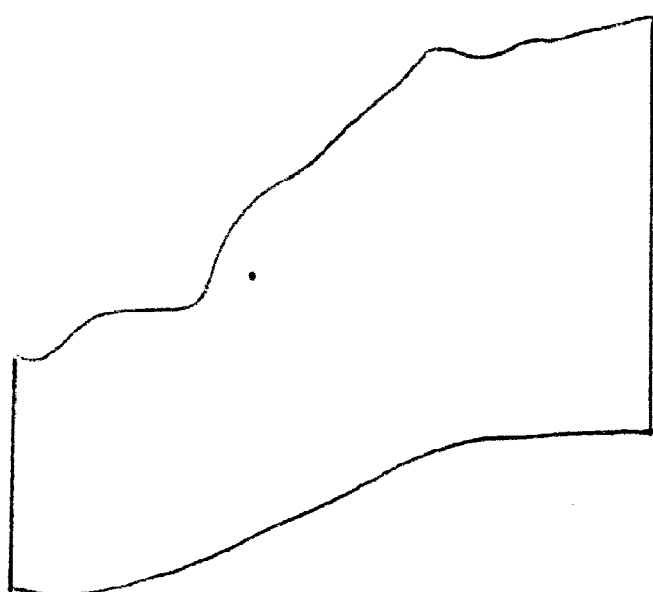





CAP 1-3-2: An Dien Village, Binh Son District

- 010200H - CAP 1-1-7. The compound southeast of 1-1-7 received approximately 45 60mm mortar rounds and an unknown number of B-40 rocket rounds. CAP 1-1-7 sent a reaction force and called in artillery. Results: 5 VC KIA (C); 1 PF KIA; 2 PF WIA.
- 010345H - CAP 1-2-2. Compound received approximately 12 60mm mortar rounds. The village defense force also made contact with thirty-five VC at the same time. CAP 1-2-2 moved a patrol to area of mortar flashes and sent a patrol to help village defense force. Checked area with negative results. Results: 1 PF WIA, 3 VDF WIA.
- 010700H - CAP 1-3-7. Patrol made contact with possible platoon of VC. Called gunships and reaction force. Both elements were pinned down by VC. Gunships worked area over and patrol swept area immediately. Results: 5 VC KIA (C), 1 VCS, 1 M1 Carbine CIA.
- 010735H - CAP 1-1-7. While sweeping through area one BL detonated a booby trap 105 round, killing one BL and wounding one BL. While waiting for Med Evac another BL detonated a mine. Results: 1 PF KIA, 2 PF WIA.
- 010930H - CAP 1-1-7. While sweeping through area patrol found VC storage area. Results: 19 Grenades CIA, 2 Carts Belts CIA.
- 012030H - CAP 1-3-3. One female VC turned herself in under the Chieu Hoi Program. Results: 1 Hoi Chanh
- 022230H - CAP 1-2-7. Element heard talking and left ambush site to check it out. Dogs barked and point man observed one VC five meters away. Point man fired on VC and went to check area. VC opened fire on patrol from both sides and point man was killed. Patrol then called in illumination and swept area. Results: 1 MC KIA.
- 030900H - CAP 1-2-7. Patrol was sent to area of previous night activity and found one AK-47 magazine and expended rounds of AK-47 in three positions also found one pool of blood five meters from grenade crater and drag marks. Also found plastic folder with papers in it and apprehended VN in house found which drag and blood marks led. Results: 13 VCS.
- 031115H - CAP 1-3-2. Patrol found one claymore mine along side of road in bush. Mine was destroyed. Results: 1 Mine destroyed.
- 032315H - CAP 1-3-2. Patrol heard movement to their south. Five minutes later received five M79 rounds and small arms fire. Patrol returned fire and called illumination. At that time patrol spotted three VC and opened fire. Results: Negative.

- 051115H - CAP 1-3-5. Patrol received sniper fire from approximately ten VC moving in a northwest direction. Patrol returned fire and called in 81mm mortar fire. Then sweeping area found two dead VC. Results: 2 VC KIA (C).
- 051410H - CAP 1-1-7. Patrol observed fifteen to twenty VC loading seven sampans. Called in artillery and observed with field glasses. Results: 3 sampans destroyed.
- 051805H - CAP 1-3-6. Patrol observed 25 VC and fired small arms. VC fled and patrol checked area. Results: 6 VC KIA(C), 200 lbs Rice CIA.

- 080915H - CAP 1-3-2. Village Chief showed patrol a house with 16 60mm rounds and a command detonated mine. Results: 16 60mm rounds and 1 mine CIA.
- 081600H - CAP 1-3-2. Villagers showed patrol 2 M26 grenades and one 60mm round. Results: 2 M26 grenades, 1 60mm round CIA.

- 111700H - CAP 1-3-2. One USMC received shrapnel wound in hand from VC mine. Results: 1 USMC WIA Med Evaced.
- 111700H - CAP 1-3-8. 1 USMC Officer was returning to Highway 1 when vehicle struck a booby trapped 155 artillery round. CAP 1-3-8 sent a reaction force to the area. Results: 1 USMC KIA; 1 PF KIA; 1 Jeep, 1 45 caliber pistol 1 Shotgun destroyed.
- 121300H - CAP 1-3-3. Patrol moved into village to check intelligence. While checking area had negative contact with VC, but apprehended four VCS, one of whom was wounded prior to this action. Results: 4 VCS.

- 151800H - CAP MTT 1-1. Patrol was informed by VN that VC were at a rally point. MTT swept area after calling artillery. While patrol was returning to compound they apprehended 5 VC with 100 lbs of rice, 10 lbs C rations, 5 lbs tobacco, and 2 gallons of whiskey. Results: 5 VC CIA, 100 lbs rice.
- 160220H - CAP 1-1-3. Patrol was enroute to ambush site when it received one M79 round. Results: 1 PF WIA.
- 160730H - CAP 1-3-7. PF detonated an M14 mine and was Med Evaced. Patrol proceeded on and a USMC detonated a mine killing 1 USMC and wounding another, both were evacuated. Patrol continued on again and received small arms fire. Patrol then called artillery and swept area under barrage. Results: 6 VC KIA(C); 1 USMC KIA, 1 USMC WIA, 1 PF WIA.

- 161100H - CAP 1-3-1. Patrol observed one VC who ran into house, patrol opened fire killing two VC. Patrol then proceeded 100 meters and received sniper fire, returned fire killing one VC. Patrol was joined by elements from 1-3-3 and 1-3-7 and swept the area. Results: 3 VC KIA(C), Medical supplies, NVA money and documents CIA.
- 161435H - CAP 1-3-5. Patrol spotted 5 VC planting mines and called in artillery and gunships. Results: 2 VC KIA(C), 1 mine CIA.
- 161600H - CAP MTT 1-1. Patrol found VC storage area containing 300 lbs of rice. 200 lbs were destroyed and 100 lbs were given to the VN. Results: 300 lbs rice CIA.
- 161900H - CAP 1-2-7. PF's apprehended one female who was carrying a letter from VC pertaining to 1-2-7. Woman was sent to district for further interrogation. Results: 1 VCS.

- 170905H - CAP 1-3-5. Patrol received heavy sniper fire, returned fire and called in artillery. Results: 9 VC KIA(C), 3 M14 mines, 1 M16 mine and propaganda leaflets CIA.

- 191950H - CAP 1-3-6. Patrol encountered 10 VC, opened fire and swept area. Results: 1 VC KIA (C).
- 201230H - CAP 1-1-7. Patrol came upon and killed three VC. Results: 3 VC KIA (C), 1 Med kit CIA.
- 210800H - CAP 1-1-7. Patrol received small arms fire, returned fire and swept area. Results: 1 VC KIA, 1 Civilian WIA.

- 251400H - CAP 1-1-7. Patrol on sweep encountered five VC who fled to bunkers and returned fire. Patrol assaulted. Results: 5 VC KIA(C); 1 USA WIA; 3 packs CIA.
- 251645H - CAP 1-3-3. One USMC went into mine field to rescue two VN children. Marine stepped on mine. RESULTS: 1 USMC WIA (DOW).
- 251900H - CAP 1-3-3. Apprehended one female identified as VC. Turned over to district. Results: 1 VC CIA.
- 252130H - CAP 1-2-4. Patrol spotted fifteen to thirty VC moving across sand dunes. Patrol opened fire on VC. VC returned fire with eight rounds M-79 from two M-79s and approximately 150 rounds small arms fire. VC fled and patrol called in illumination and swept area finding one VC corpsman killed and two blood trails. Results: 1 VC KIA(C); 1 Cart Belt and Med gear CIA.
- 261230H - CAP 1-1-1. Patrol came across two VCS in rice paddy. One did not have an ID card and the other one had a false ID card. Both taken to district for interrogation. Results: 2 VCS.
- 271230H - CAP 1-1-7. While in village made contact with possible reinforced squad of VC. Small arms fire exchanged, one PF killed. Swept area finding five VC killed and no weapons. Results: 5 VC KIA(C); 1 PF WIA.
- 281300H - CAP 1-2-7. One VN reported that two VN women were supplying VC with rice and money. Women were brought to compound and questioned by PF's. Under questioning one was found innocent and released. The other confessed and will be turned over to district. Results: 1VCS.
- 290510H - CAP 1-3-2. Approximately 60 VC assaulted two night positions with twenty-one satchel charges, twenty Chi-Com grenades, nine 60MM mortar rounds fired and two thousand small arms fired. Returned fire and called in artillery on enemy escape routes. Searched area finding three VC killed, seven Chi-Com grenades, two BAR magazines, and two M-26 grenades. Results: 3 VC KIA(C); 1USMC KIA, 1 PF KIA, 5 USMC WIA, 3 PF WIA.
- 290300H - CAP 1-1-7. While ambush was set in they heard noises, went over to check it out and found VC in bunkers in surrounding area. Results: 3 VC CIA, 1 M2 Carbine CIA.
- 290830H - 1-3 HQ. Reaction force hit a mine on its way out to 1-3-2. Results: 1 USMC KIA, 4 USMC WIA, 1 Vehicle destroyed.
- 291150H - CAP 1-1-4. While conducting sweep through village VCS spotted tunnel complex. Dropped one smoke into tunnel and one female came out while another VN stayed and died of smoke inhalation. Searched area finding one Chi\*Com grenade, clothing, rice in a bunker. VN was guerrilla squad leader. Results: 1 VC KIA(C); 1 VC CIA; 1 USMC WIA.
