PART II

NARRATIVE SUMMARY

During September the major effort of the First Field Artillery Group continued to be long range fires into the A SHAU Valley, general support for the 3d Marine Division with priority to deep reconnaissance activities and close defense, counter mortar and counter battery fires in defense of the fire support base. From 1 September to 12 September, First Field Artillery Group occupied two separate locations. The command group, consisting of the operations platoon and the communications platoon were located within the Cumberland operations area. The administration, supply and motor transport sections remained at the Phu Bai base area. On 12 September the entire First Field Artillery Group was located within the Phu Bai base area. On 28 September the First Field Artillery Group was assigned, by the Commanding General 3rd Marine Division, a special project consisting of establishing and operating a Supporting Arms Combat Operations Center in the Dong Ha Combat Base Area. The Command Group consisted of the operations platoon and communications personnel. The administration, motor transport and supply sections remained at the Phu Bai base area.

PART III

SEQUENTIAL LISTING OF SIGNIFICANT EVENTS

1. Operations

Cumberland The First Field Artillery Group, during the month of September, continued to participate in Operation Cumberland. The operation commenced prior to the reporting period and terminated 152400H September 1967.

The Commanding Officer First Field Artillery Group was designated as the area commander of the Cumberland area of operations.

The mission of the fire support base at Cumberland was to place long range fires into the A SHAU Valley, utilizing heavy artillery weapons (175mm Guns); provide deep supporting fires for long range reconnaissance patrols for units of the 3d Marine Division.

The light/medium artillery weapons (105mm/155mm) were to provide supporting fires for ground operations and defense of the fire support base.

At 101115H Battery B, 6th Bn, 27thFA (USA) was chopped OrCON from the First Field Artillery Group to the Commanding General III MAF.

At 101130H 1st Platoon of Battery "L", 4th Bn, 12th Marines was chopped OPCON from First Field Artillery Group to its parent unit within the Phu Bai base area.

On 10 September the Commanding Officer and elements of the command group returned to the base area at Phu Bai.

On 12 September the remainder of the First Field Artillery Group returned to the base area at Phu Bai.

At 152400H Operation Cumberland terminated.

Special Project 28 September, the First Field Artillery Group was assigned by the Commanding General 3rd Marine Division a special project consisting of establishing and operating a Supporting Arms Combat Operations Center in the Dong Ha Combat Base Area.

At 281900H, the Commanding Officer, First Field Artillery Group, Operations Chief and three (3) Fire Control men embarked to Dong Ha as advance detail to establish a Supporting Arms Combat Operations Center.

At 300800H the operations platoon and communications personnel (total 28 personnel) embarked to Dong Ha to man the newly established C. O. C.

b. Two office hours were conducted.

4. Enemy, Weather and Terrain

a. There was a little intelligence matter received other than periodic intelligence summaries and target listings within the A SHAU Valley.

b. The first week of the month showed a marked increase in heavy rain. Weather did not effect any movement or commitments at the fire support base. During periods of heavy rain zone 3, fuze 4, being fired by the 175mm Gun had premature bursts. This delayed firing during these periods.

5. Training

a. Due to personnel shortages and operational commitments, training other than on-the-job training was negligible during this period.

6. Civics Action There was no significant civics action.

7. Logistics

a. Normal logistics support continued for the First Field Artillery Group located at Phu Bai and also at the Fire Support Base at grid YD 602095.

- 070745 - A SHAU Valley now belongs to the Air Wing. Reported by Div FSCC.
- 071810 - From Div FSCC ASK no longer in effect.
- 091200 - B/6/27 Reported they will check fire, except for emergency, to get ready to CSMO.
- 101115 - B/6/27 in march order and ready to leave, FDC secured.
- 101130 - B/6/67 and L-X/4/12 CSMO. 1st FAG CSMO, leaving personnel behind to tear down bunkers.
- 101630 - FAG CO departed area.
- 121300 - CSMO for FAG personnel remaining in Cumberland area.
- 121700 - FAG personnel returned to Phu Bai.
- 181800 - FAG assumed 100% alert from Div.
- 190700 - Secured from alert status.
- 281900 - CO 1st FAG dispatched to Dong Ha by Asst Div Commanding General with advance party.
- 291030 - Warning order issued to augment the command at Dong Ha. All 0848 and 0844 personnel to depart this afternoon.
- 291200 - CO 1st FAG returned to Command Post.
- 291500 - CO 1st FAG and 28 men went to ~~air~~ freight for transportation to Dong Ha.
- 291600 - CO 1st FAG and 28 men returned due to lack of transportation to Dong Ha.
