5. Special Operations



1. During the period covered by this report, Communication Company has continued to provide necessary communications support to the Red Beach Complex and other units of Force Logistic Command not at Red Beach.

Telephone service has been improved by the publication of a Switchboard Operator's SOP listing performance guidelines for our operators. Two sound power loops for defense communication were installed, one at CAC-2 and CAC-3 and the other a tactical net for the Provisional Rifle Company. In addition the Wire Platoon installed a public address system for the Transient Facility plus clearing over 100 trouble reports.

The Maintenance Shop repaired a total of 132 pieces of equipment for the Company and received some substantial help in personnel when three technicians reported aboard. One man, Corporal WOJICKI returned from IBM 1013 repair school at the USSTRATCOMFAC Phu Lam, RVN and another, Corporal SPALDING left for KG-13 Crypto repair course in the Philippines.

Message Center during this period handled in excess of 18,000 messages while operating at less than one-third (1/3) of its authorized (T/O) strength. During the month, numerous circuit outages were reported between FLC and III MAF and FLSG-ALPHA and BRAVO.

Radio Platoon continues to experiment with the capabilities of the AN/MRC-109 using various antennas to determine its transmission range using the KY-8. In addition, an antenna RG-292 was mounted on FLC Headquarters for future use in x-mode operation with MRC-109/KY-8.

PART IINARRATIVE SUMMARY

The greater part of April was devoted to the conversion of MILSTRIP. On 26 April the last SLIT up-date was performed and conversion commenced. A Master Header File and a match of our files against the Master Header File from Philadelphia was completed. By 30 April, approximately 3000 documents had been received from using units and have been processed for the first MILSTRIP up-date run in early May.

A locator/item file match was completed, the match discarded 14,000 items with "zero" balances for which there was a location shown in the file and 18,000 items for which there was a recorded location but no item record.

Ammunition Company recorded another record month in the receiving and issuing departments, with 29,524 S/T of Class V material - an increase of 66% over last month's previous high.

EOD Platoon members serviced 480 calls, recovering 8,069 explosive items, and destroyed 7,605 explosive items. The Platoon supported Operations BOONE, CANYON, PERRY, CHINOOK, BIG HORN and LEJEUNE.

Average daily production of bread amounted to 13,577 pounds; donuts averaged 452 dozen per day. Ice production was up to 592,800 pounds. The ISA, An Hoa received an average of 7,500 pounds of Class I daily.

2. Administration

There were no significant administrative problems encountered during the reporting period.

3. Intelligence. Nothing significant to report.

4. Training

Regularly scheduled General Military Subjects and Technical Training continued. Indoctrination lectures are held for newly arrived personnel within twenty-four (24) hours of joining. Rifle, personnel, clothing and equipment inspections are held by Company Commanders weekly and each Company is in turn inspected by the Battalion Commander once a month. Fleet Stock Account personnel have all received twenty (20) hours of classroom instruction on MILSTRIP.

5. Special Operations

The last SLIT up-date was completed on 26 April and conversion to MILSTRIP programs commenced. DaNang, Chu Lai and Phu Bai general files, plus DaNang and Chu Lai's medical files were loaded to tape. A master

Header File and match of our files against the Master Philadelphia File was completed by 30 April 1967. Approximately 3000 documents have been received and key punched for the first MILSTRIP up-date early in May. Manual review of MILSTRIP requisitions indicates the validity of the intensive MILSTRIP training throughout the Marine Corps. All in-country requisitions will be processed at DaNang and issue mats forwarded to the remote storage activity nearest the customer.

Data Processing Platoon Ten displaced from Camp Books to FLSG Alpha (Phu Bai).

On 29 April, under the guidance of representatives from Headquarters Marine Corps and the Washington D.C., IBM Corporation Office, conversion of the Stock Account process from 1401-B6 mode to MILSTRIP mode commenced.

The beach unloading station at Cua Viet was used to refuel a ship rather than the normal procedure of the ship filling the beach unloading station. The ship, an ocean going dredge, belongs to the U.S. Army Corps of Engineers and took on approximately 9,000 gallons on two occasions.

9. Community Relations:

This Battalion Civil Affairs section has been assigned the Hamlets of Phuoc-Tan and Tiep Cu in the People-to-People Program. The Hamlet of Phuoc-Tan is presided over by a Vietnamese Catholic Priest. It seems to be well organized. It's citizens require only a minimum of rehabilitation. On the other hand, the Hamlet of Tiep Cu is a typical model of desolation and deprivation. Approximately 320 families are crowded into an area of about one-half acre. The majority of these families have no visible means of support. Sickness, dirt and disease are rampant within it's boundaries. The nine (9) wells existing therein are inadequate and contain only minimum amounts of water. A project was conceived to build decent living quarters. Drawings of the proposed project have been completed and work is under way on one hundred and fifty (150) duplex houses. Within ten (10) days the first concrete pads were laid, and to date, frames have been started on all, three (3) have been completed with temporary siding being applied on the remainder. A crew was hired to dig new wells, at present three (3) have been completed and a fourth is nearing completion.

A Marine interpreter and a LCpl with CAO have initiated a clean-up campaign and have been instrumental in giving instructions in personal hygiene. The progress has been slow. However there are signs of improvement. Several adults and children have been observed washing their bodies near the site of a new well and proposed public shower.

To date, eleven (11) swine and six (6) fowl have been donated to the people of Tiep Cu. A sty and duck pen were constructed in hopes that a small industry can become a reality.

The citizens of these Hamlets seem most appreciative of the efforts put forth by members of CAC and CAO personnel.

Manual review of the submitted MILSTRIP requisitions has confirmed the validity of the intensive MILSTRIP training throughout the Marine Corps; most RUC's have been submitting the correct format. Upon completion of the MILSTRIP system during May, all in-country requisitions will be processed at DaNang and issue mats forwarded to the storage activity nearest the customer. The computer's table (RUC) will keep track of the current location of a RUC and automatically switch to the nearest storage area when a unit is moved.

During the month of April 1967, DPP #16 completed the conversion of the FLSG-B Stock Account process from 1401-B6 mode. The conversion process was run on the System/360 computer operating in 1401-B6 mode. This method of processing was an addition and adaptation of the programs used at 3d FSR during the period Jun66-Apr67. On 29 April, under the guidance of a representative from Headquarters Marine Corps and the Washington, D.C. IBM Corporation office, conversion of the Stock Account process from the 1401-B6 mode to MILSTRIP mode commenced. It is anticipated that this conversion will be completed by 5 May 1967.

Data Processing Platoon #10 displaced from Camp BOOKS to FLSG-A (Phu Bai) for duty as an element thereof. Captain KERRIGAN conferred with Colonel S. JASKILKA, G-1, HQMC; Major G. WALL, DPO FMFPac (Fwd); and Captain J. JENKINS, DPO Camp Butler, during the period 3-6 April concerning the feasibility of establishing a centralized Personnel Accounting center for WestPac forces. At the present time accounting functions are shared by DPP #16, FLC, and DPO #27 Camp Butler. The outcome of the conference was to be a recommendation submitted to the ACofS, G-1 HQMC that accounting jurisdiction for WestPac forces be centralized at Camp Butler. Mr. C. MAXWELL IBM Coordinator, Systems Engineer, IBM Corporation arrived at FLC. He is to provide resident computer systems engineering assistance to the IBM customers in the DaNang area. He will be operating out of the DaNang area, and will be based at DPP #16. Four rooms within the DPP building were rewired for better and safer electrical service by the Seabees. It was found that the wiring as originally installed was far too inadequate to handle the many data processing machines used within the building. Commenced construction on a "Clean Room" as an annex to the DPP building. The purpose of this room is to provide control over access to the building; to provide an area where personnel who are permitted entry can store their boots, coats and rifles; to provide an adjacent area to store a clean pair of gym shoes for use only in the building; and to provide an area for the receipt and issue of work coming into and leaving the DPP building. The underlying purpose of the room is to provide control over introduction of dust, dirt, and sand into the building. A temporary barrier was erected around the outside of the DPP to provide protection against possible mortar/artillary attack. The barrier consists of 1'x1' beams banded 4 square, and staked 4 units high, giving a wall 8-9 feet high, and two feet thick. Visitors to the installation during April included LtGen BUSE, DepCofS, Policy and Programs, HQMC; LtGen WALT, CG III MAF; MajGen CUSHMAN, III MAF; BGen METZGER, CG, 9th MAB.

9. Community Relations

a. This Company's Civil Affairs section has been assigned the hamlets of Phuoc-Tan and Tiep Cu in the People to People program. The Hamlet of Phuoc-Tan is presided over by a Vietnamese Catholic Priest. It seems to be well organized and it's citizens require only a minimum of rehabilitation. On the other hand the Hamlet of Tiep Cu is a typical model of desolation and deprivation. Approximately 320 families are crowded into an area of about half an acre. The majority of these families have no visible means of support. Sickness, dirt and disease run rampant within it's boundaries. The nine existing walls are inadequate and contain only minimum amounts of water.

b. A project was conceived to build decent living quarters. Drawings of the proposed project have been completed and work is under way on 150 duplex homes. Within 10 days the first concrete pads were laid and to date frames have been started on all. Three have been completed with temporary siding being applied on the remainder. A crew was hired to dig new walls and at present three have been completed and a fourth is nearing completion.

c. A Marine interpreter and a Lance Corporal with CAO have initiated a clean up campaign and have been instrumental in giving instructions in personal hygiene. The progress has been slow however there are signs of improvement. Several adults and children have been observed washing their bodies near the site of a new well and proposed public shower.

d. To date 11 swine and six fowl have been donated to the people of Tiep-Cu. A Sty and duck pen were constructed in hopes that a small industry can become a reality.

e. The citizens of these Hamlets seem most appreciative of the efforts put forth by members of CAC and CAO personnel.
