NARRATIVE SUMMARY

1. During the period covered by this Chronology, Headquarters and Service Battalion (-), (Reinforced), 1st Force Service Regiment/Force Logistic Command, Fleet Marine Force, Pacific provided command, administration, communication, and transportation support for the Force Logistic Command/1st Force Service Regiment and other supporting services to Marine Division/Wing elements of the Third Marine Amphibious Force deployed in the I Corps Area, Republic of Vietnam as depicted in the mission, which included graves registration, fumigation, bath and laundry, air delivery, material handling, mess, utilities and construction and other logistical services as required; personnel and supporting services for the operation of the Third Marine Amphibious Force Transient Facility; operational supervision and personnel for internal and perimeter security defense of Force Logistic Command units located at Camp Books; Red Beach Complex, Danang.

- a. CAP Quebec-4 conducted thirty-one night patrols (ambush, listening posts, and reconnaissance), ten day security patrols, and seventeen MED CAP patrols.
- b. CAP Quebec-6 conducted sixty-two patrols (ambush, listening posts, and reconnaissance), twenty MED CAP patrols.
- c. The Provisional Rifle Company conducted forty-five patrols (ambush, listening posts and reconnaissance).

8. Logistics.

(5) On 4 October, 4 wells were completed in Nam-O.

(6) On 5 October, started to rebuild the Hoa Hiep Village Headquarters, which was destroyed by an explosion last April.

(7) On 7 October, the repairs to the school in Xuan Thieu were completed.

(8) On 12 October, started construction of Xuan Doung Aid Station.

(9) On 13 October, started construction of 5 wells in Xuan Doung.

(10) On 15 October, started construction of 5 wells in Da Phouc.

(11) On 19 October, started construction of dam & dike

As in the past members of the platoon assisted in over 60 security patrols in the Camp Books Area plus supplying communication support to convoys as directed. Instructors were also provided to NCO School on an as needed basis. One new circuit was established using an AN/TSC 15 to 3rd FSR on Okinawa.

3. Electronics Maintenance Section completed in excess of 100 work orders while answering 224 trouble calls during the month. Sixty-five (65) cord circuits on the switchboard AN/TCC-7 required repair. A technical training syllabus has been established and further preparation is being made to implement this program. Assistance was provided to the Radio Platoon in establishing the AN/TSC-15 circuit to 3rd FSR.

4. During the reporting period, the Wire Platoon accomplished the following: eighty (80) trunk, dial and long local troubles were reported and repaired. One hundred and eighteen (118) teletype and Autodin troubles were reported and repaired. One hundred and fifty three (153) local troubles were reported and repaired. Three trunks were installed to the TSC-15 van which now gives the switchboard direct telephone communications with Okinawa. All perimeter security lines were relocated to improve reliability. A one hundred pair cable was installed by 5th Comm Bn, replacing two twenty five pair cables and giving a added capability of forty more lines. This cable was partially destroyed by small arms fire on 28 October, but service was restored the same day. Two five pair cables were installed to the TRC/27 site which provides emergency communications to III MAF Headquarters. One serial four cable was installed from DaNang Control to 1st FSR for Autodin circuits but this cable is not operational at present.

NARRATIVE SUMMARY

On 24 October, this Command was visited by the Commanding General, FMFPac, Lt. Gen. V. H. KRULAK.

From 14 October to 16 October, 10,000 DD1348 issue mats were delivered to the Supply Company for processing. Knowing that approximately 15,000 additional issue mats were due out of FSA on about 20 October, it was apparent that organic personnel would have no capability of maintaining currency of processing. In recognition of the existing backlog of issue mats and the forecasted increase to this backlog, a decision was made to temporarily augment Supply Company with personnel. These personnel would have the objective, after training, of reducing the issue mat backlog to manageable proportions within 30 days. 121 FLC personnel of various MOS's were assigned to this effort. These personnel were organized into 11 teams, each team had a NCO leader and 10 Marines assigned. 7 teams were provided by FLC organizations and 4 teams were constituted by the assignment of incoming PCS personnel. The first 7 Backlog Issue Mat Assistant Teams (BLIMAT)

from FLC organizations were operational on 20 October with follow on incremental addition of the 4 teams constituted from incoming PCS personnel. At the beginning of the BLIMAT effort on 20 October, the issue mat backlog was 23,567; during the period 20-31 October, 32,555 issue mats were received; at the close of business on 31 October, the backlog was 20,714. The 31 October backlog of issue mats without the BLIMAT effort would have been an estimated 31,700.

On 28 October 1967, this Command received 8 rental forklifts; four 4,000 lb. forklifts and four 6,000 lb. forklifts. These were rented for both day and night shifts with Korean operators provided. A trial basis of one month was initiated for an approximate cost of \$24,000. This one month trial contract was negotiated with Seung Ki Kim, manager of Korean Express Keangeam Ltd., Danang Vietnam.

The added materials handling support provided by these rental forklifts has contributed greatly to the increased efficiency of the Receiving Unit, Storage Section and the Shipping and Receiving Section of Supply Company.

During the month of October 1967, five convoys, termed "Rough Riders", departed Supply Battalion as follows:

20 October 1967 - 88 trucks bound for Dong Ha and Phu Bai with 310,000 lbs. of cargo.

23 October 1967 - 66 trucks bound for Dong Ha and Phu Bai with 265,800 lbs. of cargo.

27 October 1967 - 23 trucks bound for Dong Ha with 187,000 lbs. of cargo.

28 October 1967 - 53 trucks bound for Dong Ha and Phu Bai with 210,000 lbs. of cargo.

30 October 1967 - 49 trucks bound for Dong Ha and Phu Bai with 349,653 lbs. of cargo.

The above totals 279 trucks with 1,322,453 lbs. of cargo.

The rewarehousing augmentation personnel provided by the Third Force Service Regiment, 9th MAB and FMFPac continued their tasks of rewarehousing and inventorying. The efforts of these personnel in locating, inventorying and placing material on inventory record, by both day and night crews, resulted in inventory gains in excess

of 6,000 line items which caused the subsequent release of an estimated 15,000 issue documents (MRO's).

The Ration Company Bakery averaged a daily production of 15,206 pounds of bread for the month of October, which is a slight reduction from the previous month. This reduction was due to the reopening of the bakery unit at Dong Ha which ended the requirement to provide support from Red Beach.

Ammunition Company moved 23,846 S/T's of ammunition during October, averaging 795 S/T's (1,590,000 lbs) daily. ASP #1 received 11,348 S/T's and issued 12,498 S/T's. In addition 308 S/T's have been moved from ASP #1 to ASP #2 to date. During the first ten months of 1967, ASP #1 handled 244,148 S/T's of Class V compared with 65,908 S/T's handled in the first ten months of 1966. The dump level at ASP #1 decreased 5,225 S/%'s from 23,040 to 17,815, a 23% decrease, however, the dump remains 78% over design capacity.

The EOD Platoon made 62 calls, recovering 642 explosive items and destroying 115 items and 11,950 lbs. of dynamite.

7th Separate Bulk Fuel Company continued to maintain normal receiving, pumping, dispensing, and storage operations within the DaNang TAOR. One officer and twenty enlisted personnel were deployed to Quang Tri to install a 240,000 gallon fuel site at the new Camp Evans LSA.


