1. Support Company continued its mission of providing services in the following areas: Laundry, Garrison Property, Traffic Management Section, Material Handling Equipment, Air Delivery and Graves Registration. Additionally this Company operates the III MAF Transient Facility and is responsible for billeting and feeding all Marines arriving and departing Vietnam.

3. INTELLIGENCE: Negative.

4. TRAINING:

In addition to the normal General Military Subjects Classes, the Material Handling Equipment Platoon trained and licensed a total of twenty nine (29) students on the 4,000 and 6,000 pound forklifts.

5. SPECIAL OPERATIONS:

a. The MHE Platoon completed a total of 185 work orders for the month with 75 remaining open.

b. 4 February to 21 February, a detail of Air Delivery parachute riggers was sent to Mobile Strike Force, to aid them in packing of parachutes in preparation for the Vietnamese Jump School.

c. On 12 February 1968, SSgt CLASS from Air Delivery Platoon began working on an extraction system for the KC-130-F aircraft when carrying POL. This system will be as follows; (2) 22 foot extraction parachutes will be connected to the pendulum system on the aircraft and then to the 6,000 pound load bearing platforms on which the bladders of POL are secured. One Air Delivery Man will be stationed at the manual release handle, located aft of the cockpit. If any emergency should arise, the platforms of POL could be extracted in a matter of seconds.

d. On 29 February 1968, SSgt CLASS made the first experimental air lift to Dong Ha with the new system of extraction of the POL aboard. The entire flight was a complete success.

7. EQUIPMENT: The Material Handling Equipment Platoon maintained an availability of 55.5% for RKF 6,000 lb. forklifts and 40% for the CFY-40.

1. During the period covered by this report, Communication Company continued to provide support for the Red Beach Complex and other FLC Units not physically located at Red Beach.

4. Radio Platoon. During the month of February, Radio Platoon continued operation of three (3) twenty-four hour nets; FLC Command, FLC Tactical and the Logistic Net to the LSA at An Hoa until it was discontinued on 28 February. Additionally, during February, Radio Platoon assumed the responsibility for operating the 24 hour Red Beach Defense net for the C. P. Bunker.

Two TSC-15 Vans under the control of Radio Platoon completed a total of 190 phone patches to Okinawa. The teletype circuit with 3rdFSR is still on a trial basis.

Radio Equipment and operators were provided on a continuing basis to CG,

FLC, Camp Books C. P. Bunker, Supply Battalion, and the Heli pad. Operators and equipment were supplied for 52 combat patrols, 58 augmentation guard call-outs, 38 Provisional Rifle Company call-outs and 22 convoys.

Instructional assistance is provided weekly to the FLC NCO Leadership School on the operation and maintenance of AN/PRC-10 and AN/PRC-25 radios.

5. Maintenance Platoon: Maintenance Platoon provided an inspection/service team TAD to FLSG-A and FLSG-B for three days and provided instructor assistance to the Red Beach NCO Leadership School. Technicians answered a total of 525 trouble calls and processed 346 work orders for repair of radios, telephones, teletype equipment, and IBM data communications equipment during February. The Maintenance Platoon installed an intercomm system in the CG's Office and assisted in the activation of an additional full duplex teletype/cryptographic circuit to Bravo.

6. Wire Platoon. Wire Platoon continued to provide wire services to Camp Books, Maintenance Battalion, and Camp Monahan. Certain wire services were provided for the Army's 15th Transportation Bn, 33d Field Artillery, and Sub-Unit one, 9th MAB. During February, Wire Platoon added 12 new telephone subscribers; installed 3 trunk lines, 5 long locals, and 6 hot lines; re-installed the Tom-20 system in H&SBn; answered 197 trouble calls; and handled an average of 8,320 telephone calls a day.

Cables located at Camp Books were repaired and extensions due to negligent damage by cargo and earth moving equipment and certain buildings.

The Frame Section made a total of 5-7 tests on wire lines and upgraded the helo pad and certain security lines.

NARRATIVE SUMMARY

Due to interdiction of Highway 1 during the month of February, no convoys departed Supply Battalion for resupply north of Danang.

Helicopter support operations from the FLC, Red Beach helipad, which is operated by Supply Battalion personnel, increased during the month of February. 197 S/T of all classes of supply were lifted to units throughout the I Corps Area during the month. In addition, 474 S/T of ammunition were lifted from the ASP#1 helipad with the assistance of helicopter support teams from 1st Shore Party Battalion.

The M-16 Barrel Exchange Program continued during the month of February. The following accumulative data reflects total program performance through the end of February:

A special inventory team consisting of 26 NCO's, assigned TAD to FLC from various FMFPac units, completed Phase III of the Commanding Generals Special Inventory Program on 24 February. Phase III of the Special Inventory Program consisted of verifying zero balances of stock items reflected as having valid RO on current CCP records.

Upon completion of the third phase of the special inventory program, this team was assigned, on 24 February, to assist in the rewarehousing of bin storage facilities in warehouse 35 of the Supply Battalion. Progress in the rewarehousing effort and the results obtained during the five day period ending 29 February far surpassed initial estimates and as a result, the teams TAD orders were extended from a termination date of 9 March 1968 to 21 March 1968. It is anticipated that this extension will permit completion of the rewarehousing of bin storage facilities in warehouse 35 by 17 April 1968, in lieu of the previous estimate of 1 June 1968.

Supply Battalion has been assigned the responsibility for the operation and control of an in-country Repair/Re-build Control Center (R/RCC). This program requires the battalion to control the physical receipt, storage, shipping and issuing of specific program repair/rebuild assets, to include monitoring the asset location while out-of-country. The R/RCC is presently in the process of being established and will be physically located across the road from Marine Air Freight, Danang Air Field. All personnel and equipment for operation of the R/RCC have not been received. Thus, full operational status not anticipated until the first part of April 1968.

The Ration Company Bakery averaged a daily production of 14,194 pounds of bread for the month of February. In addition, doughnut production was 59,050 pounds and ice production was 403,800 pounds.

On 25 February 1968, Supply Battalion was designated by Force Logistic Command as the administrator of Project 31 Funds for all Marine Corps ration issue points in ICTZ. On 27 February 1968, a Ration Company detachment was established at the Naval Support Activity Danang, to monitor all requisitions for FLC ration support. This includes control of requisitions, processing for shipment, and maintenance of records for obligation and commitment of funds to cover all ration purchases from NSA.

The month of February again saw Ammunition Company increase the amount of ammunition handled during a single

The dump level at ASP#1 increased 635 S/T from 24,092 S/T to 24,727 S/T of which 24,611 S/T are USMC assets and 116 S/T are US Army assets. The dump level at ASP#2 increased from 9,101 S/T to 17,815 S/T of which 9,713 are USMC assets and 8,102 S/T are US Army assets.

The EOD Platoon made 420 calls, recovering 589 US explosive items and 581 VC, NVA or Chi Com explosive items. The platoon destroyed 133 S/T of unserviceable ammunition from ASP#1 that was too dangerous for deep water disposal.
