9. Community Relations. During the month of March, the Civil Affairs Officer, Headquarters and Service Battalion continued its program of Med-Cap, Self-Help, and other projects assigned to assist the Vietnamese people in our TAOR.

a. On 2 March 1968, Distributed 21 garden kits, 17 carpenter kits, and 19 mason kits to Xuan Duong to aid in rebuilding homes and reoutfitting local farmers.

b. On 7 March 1968, Furnished lumber and tin to rebuild 3 homes in Xuan Thieu which were destroyed by fire from flares.

c. On 12 March 1968, Distributed playground equipment to Nam O and Phuoc Nghia primary schools.

d. On 13 March 1968, Donation of \$500.00 to the Children's Hospital Fund from the Headquarters and Service Battalion Civic Action Fund.

e. On 14 March 1968, Provided CAC Q-4 with playground equipment to establish a playground for the children of Xuan Thieu.

f. On 15 March 1968, Assisted the Preventive Medicine Unit in the spraying of Hoa Hiep village for plague.

1. Support Company continued its mission of providing services in the following areas: Laundry, Garrison Property, Traffic Management, Material Handling Equipment, Air Delivery, and Graves Registration. Additionally this Company operates the III MAF Transient Facility and is responsible for billeting and feeding all Marines arriving and departing Vietnam.

2. ADMINISTRATION

a. Savings Bonds participation within the Company at the end of March was 94%

b. Seventeen (17) men extended their tour for six (6) months.

c. One (1) man reenlisted in the Marine Corps for a period of four (4) years.

3. INTELLIGENCE: Negative.

4. TRAINING:

In addition to the normal General Military Subjects Classes, the Material Handling Equipment Platoon trained and licensed a total of sixty-two (62) students on the 4,000 and 6,000 pound forklifts, also trained were five South Koreans and were licensed.

5. SPECIAL OPERATIONS:

a. The MHE Platoon completed a total of 82 work orders for the month with 132 remaining open.

b. From 1 March to 23 March, a detail of seven (7) parachute riggers were sent to Okinawa. The detail inspected, modified, repaired, and repacked Cargo Parachutes as needed.

c. From 5 March to 9 March, a detail of parachute riggers were sent to Tan Ky for the purpose of air dropping supplies to the Special Forces. During that period of time the personnel dropped a total of 81,550 lbs, utilizing a CV-2B (Caribou) aircraft.

d. On 4 March, at 0100 hrs. incoming hostile rounds were received in the vicinity of the 1st Air Delivery Platoon. There were no injuries to the Air Delivery Personnel.

e. On 6 March, five (5) men from the Air Delivery Platoon in Okinawa arrived for temporary duty to this unit.

f. From 7 March to 24 March, a detail of parachute riggers were sent to work with the Army Air Delivery Platoon on the drops to Khe Sanh. During this time the personnel of the 1st Air Delivery Platoon greatly aided in the rigging of vast amounts of supplies that were dropped to Khe Sanh.

g. on 8, 16 and 26 March, experimental drops were conducted on High Altitude, Low Opening, Aerial Delivery System by the 1st Air delivery Platoon. The tests were conducted at Red Beach drop zone. The system provides for a way to drop a standard A-22 Container at a minimum altitude of 2,000 feet with a delayed opening of the Cargo Parachute attached to the load so as to cut down on the unnecessary drift of the load as it settles to the ground and also to insure the safety of the aircraft and it's crew members by removing it from the dangers of hostile enemy small arms fire due to low altitude required in a standard Combat Cargo Drop. The system itself proves to be ideal for the situations encountered in Vietnam.

h. One (1) Field Laundry Machine was installed at the 3rd Battalion, 27th Marines Area, one man was sent TAD from the Laundry Platoon to assist in operations of the Unit.

i. A total of seven (7) Officers and 293 Enlisted personnel, fired for familiarization, their TO Weapons during the Month.

NARRATIVE SUMMARY

1. During the period covered by this report, Communication Company continued to provide support for the Red Beach Complex and other FLC Units not physically located at Red Beach.

2. Radio Platoon. During the month of March, Radio Platoon continued operation of three (3) twenty-four hour nets; FLC Command, FLC Tactical and the Red Beach Sector Defense Net. Additionally, during March, a Supply Battalion common net was established providing high frequency communications among Supply Battalion, ASP #2, and Camp Monahan. The Okinawa Radio Net completed 210 phone patches. Radio teletype stations in CCP and G-3 are operational on the net.

Radio equipment and operators were provided on a continuing basis to CG, FLC, Camp Books C. P. Bunker, and the Helo pad. Operators and equipment were supplied for 34 combat patrols, 21 augmentation guard call-outs, and 81 convoys.

3. Maintenance Platoon. During March, the Maintenance Platoon continued to provide a repair point and give technical assistance for Communication Company. The platoon assumed control of the transportable telephone central, AN/TTC-28, and is currently making preliminary preparations for its installation in the future. During March, radio, telephone, teletype/crypto, and IBM technicians completed 410 trouble calls and processed 209 work orders. Maintenance Platoon technicians provided assistance for repair of teletype equipment couriered from Dong Ha.

4. Wire Platoon. Wire Platoon continued to provide wire services to Camp Books, Maintenance Battalion, and Camp Monahan. Certain wire services were provided for the Army's 15th Transportation Battalion, and 58th Transportation Battalion. During March, Wire Platoon added new service to 16 subscribers; installed 2 trunk lines and 6 hot lines; answered 98 trouble calls; and installed an intercomm at CCP/FSA. Wire Platoon reinstalled phones and intercomms in conjunction with the FLC Headquarters expansion. New perimeter lines were installed at Camp Books and ASP-2. Dial type telephones were installed to replace field phones in preparation for conversion to dial service.

The Frame Section made 354 tests on lines. Caution signs were attached to low cables throughout the camp to prevent unnecessary cable breakage. Two mechanical mules were received for use for local wire construction work. The FLC switchboard averaged 8,231 calls per day.

Instruction of Autodin Mode V Teletype procedure was held in preparation for the cut over to the Mode V Terminal.

Section of this command has increased its issue output capability by 378% as the daily average output prior to 25 March 1968 was 1150 issues compared to 4372 issues per day for the period 25-31 March 1968. 5. Special Operations

a. The Provisional Rifle Company conducted forty-one (41) night patrols (LP's, Combat, Recon) and seven (7) day patrols. They also participated in a search and cordon operation with elements of the 7th Marines. During this operation twelve (12) Viet Cong suspects were apprehended and released to the III MAF POW compound.

b. Contact for the month of April has been increasing steadily.

(1) On 5 April 1968, a Provisional Rifle Company patrol captured two (2) Czech assault weapons.

(2) On 5 April 1968, a patrol received small arms fire from an estimated three (3) to four (4) Viet Cong.

(3) On 6 April 1968, at 0100 Force Logistic Command received nine (9) to fifteen (15) rounds of 81/82mm mortar approximately 200 meters outside of the perimeter. No damage or casualties were sustained from this assault.

(4) At 0935 on 24 April 1968, a Marine working party stringing barbed wire was fired upon by a suspected Viet Cong with a M-79 Grenade Launcher; results were two (2) USMC Wounded In Action.

(5) Seven (7) other contacts were made during the month.

c. Camp Defensive Construction.

(1) Construction on Bunker #27 has been completed and the bunker should be manned by 3 May 1968.

(2) All sandbagging renovations on the C.P. Bunker have been completed. Approximately 1200 meters of wire (single strand-double apron fence) has been installed on the Northwest area of the perimeter.

(3) Defensive wires have been placed on the Southwest area of the perimeter.

(4) Sandbagging of Bunker 19A has been started and is expected to be completed by 4 May 1968.

(5) An interbase defense was initiated to augment the perimeter defense in the event of enemy penetration.

(6) The Ammo storage area for 81mm mortar has been completely sandbagged.

9. Community Relations. During the month of April, the Civil Affairs Office, Headquarters and Service Battalion, continued its program of Med-Cap, Self-Help, and other projects assigned to assist the Vietnamese people in our TAOR.

a. On 2 April 1968 - Delivered 350 school kits to children in the Nam O primary school.

b. On 3 April 1968 - Started toilet project for Da Phouc primary School.

c. On 4 April 1968 - Supplied Xuan Duong High School with materials to replace damage sustained during TET.

d. On 9 April 1968 - Supported "County Fair" type operation in Mieu Tach Son area just north of Camp Books. Approximately 400 people were detained, fed, and treated medically.

e. On 10 April 1968 - Provided transportation to haul 200 bags of rice to Phouc Nghia from Danang.

f. On 16 April 1968 - Started project to rebuild Nam O grade school, which was destroyed during TET.

g. On 16 April 1968 - Started project to repair the Kuan Duong Aid Station which was damaged during TET.

h. On 16 April 1968 - Started project to install well and pump for the Da Phouc hamlet primary school.

i. On 20 April 1968 - Delivered two sewing machines and 150 school kits to the Camp Chaplain for further distribution to Phouc Thanh Orphanage.

j. On 23 April 1968 - Hauled 150 bags of bulgar, 100 bags of beans and 100 cases of cooking oil to Nam O from Hoa Vang Distric Headquarters. These commodities are the initial payment from the Vietnamese Government for losses incurred during TET.

k. On 30 April 1968 - Delivered materials to rebuild a home in Xuan Thieu that was destroyed by a flare from CAG.

l. During April 1968, the Civil Affairs Office hauled three (3) truckloads of material from NSA to the Children's Hospital for construction.

m. During the month of April 1968, four (4) hours of English instructions were also given to the Vietnamese of the Trung Phouc hamlet.
