5. Special Operations

a) The Provisional Rifle Company conducted 106 night time patrols (Ambush, Recon, L.P.'s and Combat) and 18 day patrols during the month of August.

b) On 1 Aug. a day patrol found one tunnel and fresh digging in Hieu Na Islands (AT923821). Tunnel was blown on the 2nd of Aug.

c) On 16 Aug. a night patrol, while passing by the eastern edge of Trung Son, had a man charged by a water buffalo. Man was brought to Sick Bay for treatment of cuts and bruises.

d) On 16 Aug. a day patrol found one Chi Com grenade booby trap at AT931808. Grenade was blown in place.

e) On 20 Aug. a day patrol found 3 bunkers at AT923821. Bunkers blown 27 Aug.

f) On 23 Aug 0247, FLC perimeter received 5 RPG Rockets. Four rounds landed inside the compound with one landing outside. One round hit Post #11 with slight damage. One round hit the supports of the new water tower damaging some of the boards. One round hit close to building 801 with slight shrapnel damage to the building. One landed close to the stop sign on the road going to Truck Co. and damaged one M-38 slightly.

g) On 23 Aug a day patrol found a VC propaganda leaflet on trail warning the Vietnamese to stay off the roads.

h) On 24 Aug AT2012 patrol found one man in the wire at AT933803. Patrol fired at man with negative results.

i) On 28 Aug at 1944, seven (7) rounds of 122mm rockets impacted in Camp Books, resulting in 1 KIA, 4 WIA's (3 med-evacs). One hut was totally destroyed, two huts had 20% damage, two huts had 10% damage, and one vehicle had its windshield broken. One hut in Rolling Stock yard was slightly damaged.

CWO HUFF - ORDNANCE MAINTENANCE COMPANY EXECUTIVE OFFICER

Chief Warrant Officer Robert R. Huff was born in Mineola, Tex., on 25 October 1916. He was graduated from the Mineola High School in 1935 and went to work for the Magnolia Petroleum Co., as an oilfield hand.

He joined the Marine Corps in 1940 and received his recruit training at San Diego. His first duty station was aboard the Battleship Oklahoma as a seagoing Marine. His tour aboard the Oklahoma turned out to be a short one as that ill-fated ship was sunk by the Japanese at Pearl Harbor on 7 December 1941.

He then served aboard the Aircraft Carrier Hornet, also a very short tour, as the Hornet was destined for the same fate as the Oklahoma. It was sunk off the coast of Guadalcanal in October 1942. Warrant Huff received the Silver Star for his role as a machine gunner before the ship went down. He also received the Purple Heart for a shrapnel wound on his arm sustained during the

sinking. Once back in the States he joined the Fourth Marine Division in Camp Pendleton and returned to the Pacific with it. He participated in the battles for Roi-Namua, Saipan, Tinian and Iwo Jima.

After the war he served at Camp Pendleton, Pensacola and in China.

In 1950 he moved out to Korea with the First Marine Division and made the Inchon Landing. While in Korea he earned the Navy Commendation Medal.

After Korea he served in Quantico, Va., went seagoing aboard the USS Arneb (AK-56), then served at Camp Lejeune, Albany, Ga., Okinawa, and Camp Pendleton.

He arrived in country in January 1968, just in time for the Tet Offensive.

He is married to the former Miss Hazel A. Reichel of Somerset, Tex. They have four children and two grandchildren.

3. Last month our doctor and his crew treated 144 Villagers through the MEDCAP program and evacuated one child to the Childrens Hospital at Red Beach for treatment of worms.
4. The old bread truck continued to roll during August with 4800 loaves of bread delivered to the Sacred Heart and China Beach Orphanages.
5. Thanks to your generosity, over 2500 human being enjoy a better life each month. Your contributions are used to help maintain two orphanages in the DaNang area. The Sacred Heart (Catholic) and United World Mission (Protestant). Our current money situation looks like this:

The dump level at ASP #1 increased 6,290 S/T from 27,475 S/T to 33,765 S/T, of which 23,993 S/T are Class V(W) and 9,772 S/T are Class V(A). The dump level at ASP #2 decreased 2,358 S/T from 23,009 S/T to 20,651 S/T of which 13,608 S/T are USMC assets and 7,043 S/T are U.S. Army assets. The EOD Platoon made 266 calls, recovering 3,373 U.S. Explosive items and 3,074 V.C. or CHI COM explosive items. The platoon destroyed 600.75 S/T of unserviceable ammunition from ASP #1 that was too dangerous for deep water disposal.

The MAERU team reworked 167 rounds of C706 - ctg. 1.2" illumination and 739 rounds of C451 105mm cartridges. The MAERU team overhauled 4,492 rounds of D550 155mm WP smoke rounds. The MAERU team prepared for deep water preparation and shipping of 15 tons of ammunition.

During August 1968 normal receiving, pumping, dispensing and storage operations of Bulk Fuel items were carried out. The 1st platoon at Wunder Beach began closing down and is scheduled to complete operation during September. The fuel dispensing site at An Hoa continued in operation. The MEDCAP team now visits Phuoc Tan and Phuoc Xuan hamlets in the morning and Tiep Cu in the afternoons. Tiep Cu II has been informed of the MEDCAP and are now starting to come to the MEDCAP for treatment more often.

Lumber for construction and burning purposes is being delivered to each of the hamlets as available.

A childrens festival for all the hamlets is being planed to take place, during the month of October.

2. The projects progress for each of the Hamlets is as follows:

a. Phuoc Xuan Hamlet, Hoa Khanh Village, coordinates C965782

(1) The elementary school is still under construction, but classes are being held at the church, until the school is finished.

(2) A sewing school has been build at Phuoc Xuan and classes are being held everyday. Phuoc Xuan was given five sewing machines for instructional purposes and for village needs.

(3) A generator was given to Phuoc Xuan for the lighting of the official buildings of the village.
