5. SPECIAL OPERATIONS (Security Section)

a. Training. Daily classes have been held for the Security Platoon and Thirty Day Guard during the month of May. The Thirty Day Guard and Security Platoon FAM fired all weapons organic to the perimeter as part of their guard school. This month practice for the 60 MM mortar crews was included in the initial training.

b. Defense Construction

(1) Ten bunkers have been rebuilt. The bunkers built now using 4x4 timbers and unservicable connex boxes are expected to last longer than their predecessors.

(2) Our main ammo storage area as well as positions for storing mortar ammunition at the 81 MM and the four 60 MM mortar pits have been reconstructed to provide increased safety for personnel and protection for the ammunition.

(3) 81 MM mortar concentrations have been plotted along northern and western edges of the Force Logistic Command perimeter.

b. Equipment and/or operators were also provided for 210 patrols conducted by the Provisional Rifle Company, 80 convoys, Red Beach Sector Defense Net, Provisional Rifle Company Net, EOD Control Net, Northern Sector Rocket Alert Net. The Radio Platoon supported two company size operations during the month of May. There were 170 phone patches for the month of May on the FLC-Okinawa Common Net.

c. The Wire Platoon continued to provide telephone service to Camp Books, Maintenance Battalion, Camp Monahan, III MAF Transit Facility, Army units in the Red Beach Area, and Camp Haskins. New Telephone service and additional extensions were provided for 55 subscribers. The automatic dial equipment completed 582,946 calls for subscribers and 29,627 operator assisted calls. The FCC tested and checked 207 lines and circuits. The Wire Platoon installed and maintained the public address system for the III MAF brig in their temporary location in the new Maintenance Battalion area. The Wire Platoon also provided switchboard communications between Hill 34 and Camp Monahan for a period of about two weeks for Ammo. Company and Bulk Fuel Company. The Wire Platoon completed the installation of telephone service to the new CGP building. Also the Wire Platoon installed a switchboard at ASP-2 and put fire reporting phone system in effect. Wire Platoon worked with

1st Marine Division Wire crew locating and repairing three cuts on the M-9 cable caused by bullet holes. The Wire Platoon also completed a line quality and evaluation and circuit usage survey for III MAF. The Wire Platoon turned in 74 pieces of equipment for 2nd echelon or higher repair.

d. The Maintenance Platoon Radio and Telephone Technicians answered four trouble calls and processed 176 work orders. The Teletype/Crypto Technicians answered 355 trouble calls and processed 72 work orders. The IBM Technicians answered 10 trouble calls. The Maintenance Platoon's training was primarily OJT except for the scheduled GMS Training. On two separate occasions Maintenance Platoon's Teletype/Crypto Technicians assisted personnel from FLSG-Bravo in repairing and aligning their fixed plant teletype equipment. During the month 12 pieces of equipment were received from Phu Bai and Chu Lai. Maintenance Platoon also sent 22 pieces of teletype equipment to the Sea Anchor to be rebuilt.

e. During the month of May 1969 the Communication Center Platoon continued to provide Teletypewriter/Digital data communication for Headquarters, Force Logistic Command. During the month of May the Communication Center Platoon sent GySgt. VINSON to attend a CMC sponsored briefing on the MMS program for the IBM 360/20. Upon his return GySgt. VINSON installed the program without any problems. This program will enable the Communication Center to better serve our units with an increased magnetic tape reliability. On 6 May 1969 the Communication Center had a all time daily high for message traffic; this was in the amount of 1,646 messages.







c. The 30 Day Guard and Security Platoon FAM-fired all weapons organic to the perimeter as part of their initial Guard School. This month practice firing for the 60 mm Mortar crews was included in this initial training as well.

d. Defensive Construction

(1) 10 bunkers have been rebuilt this month. The new bunkers being built around otherwise unserviceable connex boxes or with 4+4's are sturdier and better weatherproofed than their predecessors.

(2) A mixture of powdered CS and water was sprayed into the sand in the areas where our tactical wire is located around the perimeter.

5. SPECIAL OPERATIONS.

a. The Provisional Rifle Company conducted 145 night patrols (Ambush, Recon, Listening Posts, and Combat) and 29 day patrols during the month of May.

The ambush, located at AT 919 818 took the enemy under fire with small arms, M-60 and M-79 fire, then swept the area with negative results. 58th TC reported 24 82mm mortar rounds had been fired at their compound with negative damage or casualties.

d. On 15 May 1969 a day patrol at AT 918 819 discovered a Spider Hole, 1 M-26 Booby-Trap, 1 pair of blood-soaked black P. J.'s, 1 AK-47, a IIA, 3 M-16 Magazines, and a ChiCom Grenade. The grenades were blown in place and the other items returned to COC.

e. On 16 May 1969 a Day Patrol discovered 1 ChiCom Grenade rigged with a trip wire at AT 928809. Booby-Trap was blown in place.

f. On 26 May 1969 a Marine on day patrol tripped a Booby-Trap, which consisted of 1 M-26 grenade rigged with a trip wire, resulting in 3 Marines WIA.

g. On the night of 26-27 May 1969, Provisional Rifle Company, 5th CTF and a platoon of ARVN rangers, conducted a cordon and search of Kom Lom Hamlet, resulting in the capture of 4 VC guerrilla suspects and the capture of 650 lbs of milled rice. The 4 VCS were taken to 5th CTF for interrogation and the rice was confiscated by the ARVNs.
