## PART II

NARRATIVE SUMMARY

1. Headquarters and Service Company continues its primary mission of providing the Battalion Commander with facilities for command and control. To provide administration, organic supply, light motor transport, maintenance and service support of the Battalion.
2. Eighty one percent of the personnel have allotments registered for the purpose of U. S. Savings Bonds. In addition, eighteen members of the Company are active participants in the Ten Percent Savings Program. The overall percentage for savings (Bonds and Savings Deposits) is Ninety-One percent.
3. One enlisted man was promoted to Gunnery Sergeant, six enlisted men to Corporal, ten enlisted men to Lance Corporal and three enlisted men to Private First Class.
4. The Company had one career reenlistment for the month.
5. There were eleven men awarded non-judicial punishment at Company Commanders Office Hours. Of the eleven, two were referred to the Battalion Commander. Battalion Commander's Office Hours resulted in the following awards, one man was reduced to Lance Corporal and one received a suspended sentence.
6. Two men were confined to the III MAF Correctional Center. One man was confined for safe keeping and the other was convicted of a Special Court-Martial. The company received orders on three members who were confined to the III MAF Correctional Center. The three men were transferred to Marine Barracks, Pearl Harbor, Hawaii for confinement.
7. The Company joined one Chief Warrant Officer, one Sergeant Major, one Master Gunnery Sergeant, two Master Sergeants and two Staff Sergeants.
8. Two men were awarded the Navy Unit Commendation Ribbon for service in Vietnam from 16 March 1967 to 31 May 1968. The company Volley Ball and Football team became first place winners in the Battalion Intramural Competition.



2. The Maintenance Battalions MedCap Team has treated a total of 521 Vietnamese this month in the Hamlets of Phuoc Nghia and Hoa My. It is felt by many that the MedCap program has done much to better the Relationship with the people of Vietnam. The medical treatments and advice that is given, has done more than give physical aide to these people, but also to advocate a bond of friendship and trust between these people and ourselves. Lets face it, a better understanding between people is all the world needs for peace. However this takes 100% participation from all of us, if it is to work effectively.

3. The personal response tours will start shortly, with luck this week. These tours are set up by the IRO Office to make the personnel more familar with the way of life that exist besides our own. So many people have forgotten that there is much more of this world than the part we live in and there are different beliefs, different ways of accepting and facing life. Everyone doesn't accept things the way that we see them. This is one of the reasons for these tours, to go there and actually see another culture besides our own. One picture is worth a million words.



## PART II

NARRATIVE SUMMARY

During the month of February, 1970, Headquarters and Service Battalion provided administrative, motor transport, communications and general support to Force Logistic Command and numerous other Marine and Allied Units.

Headquarters and Service Company provided administrative and support services for over one thousand (1000) members of the Company who functioned in some thirty (30) different sections. The Company's Engineer Platoon, under the operational control of the Battalion S-4, contributed significantly to the habitability, safety, and security of Camp Books in completing twenty-four (24) major work orders and ninety-three (93) minor work orders. In addition, the Engineer Platoon continued a program of roads and grounds improvement which involved heavy equipment loading and grading of three-hundred (300) truck loads of sand and sixty (60) truck loads of rock. The Battalion Industrial Relations Office, also under the cognizance of the Battalion S-4, supervised the personnel and medical administration of 432 Vietnamese National employees under three (3) separate fundings. A total of 3,823, 400 Vietnamese piasters were paid these employees during February, a figure equivalent to \$32,401 (U. S.). Sections under the administrative cognizance of the Company also performed invaluable Camp Books-level functions during the month. The Camp/Battalion Police Sergeant, under the operational control of the Battalion S-4, was responsible for the removal and disposal of 21,660 cubic meters of dry trash and 77,000 gallons of wet garbage from the confines of Camp Books during the month of February. The Command Fire Department fought twelve (12) wood and structural fires and four (4) fuel fires during the month.

Truck Company provided administrative and tactical motor transport support to all elements of Force Logistic Command, specified Third Marine Amphibious Force Commands and First Marine Division Units during the month of February. The Company conducted daily "Rough Rider" convoys to Landing Zone Baldy, Fire Support Base Ross, and Hill 55 in support of the First Marine Division. Vehicle task units were also assigned daily to convoys enroute to Division units at An Hoa. In support of local commitments, Truck Company transported all classes of supplies for Supply Battalion's Bulk Fuel Company, Ammunition Company, Shipping and Receiving Section and Rations Company. The Company also conducted port clearance/retrograde operations at the DaNang Bridge Ramp and Deep Draft Pier and the Red Beach Causeway. Daily motor transport support was also rendered to the III MAF Transient Facility, DaNang Marine Air Freight, DaNang Press Center, and the III MAF Correctional Facility. Truck Company's Maintenance Platoon provided second echelon support for over five-hundred (500) pieces of organic motor transport equipment, of which over three-hundred (300) were prime movers. Part IV contains the Company's operational and maintenance statistics for the month of February.

During the month of February, 1970, Communication Company provided Communication Center Services to all Marine, Army, and Naval Commands in the Red Beach Complex. The Company processed 9,256 messages for Marine Commands, 2,418 messages for Naval Commands, and 366 messages for Army Commands during the month. In an effort to enhance the physical security of the Communication Center Complex the Company spent many hours in building new defensive positions, strengthening old positions and training personnel for security duties in the event of enemy attack. Communication Company put forth a great effort during the month in expanding and renovating work spaces in preparation for the tremendously increased communication workload anticipated when III MAF Headquarters physically moves to the Red Beach Complex. During the month over 600,000 telephone calls were processed by the Company. Part IV contains Communication Company's operational and maintenance statistics for the month of February, 1970.

Support Company performed many diversified services for the Force Logistic Command and other Marine and Allied Forces during the month. In operating the III MAF Transient Facility and R&R Processing Center, members of Support Company processed and billeted 17,357 personnel, and messed 41,754 transient personnel during February. The Company's Material Handling Equipment Platoon (MHE) unloaded four (4) LST loads of ammunition during the month in support of Supply Battalion's Ammunition Company. The Platoon's RIF-060, 6000 pound forklifts moved 46,500 tons of materials during the month while operating 2,150 hours. The GYP-40, 4000 pound forklifts moved 37,250 tons of supplies during 2,778 hours of operation. The MHE Platoon trained and licensed thirty-nine (39) new forklift operators during the month. Support Company's Graves Registration Platoon, with elements at five (5) locations in I Corps, processed 111 remains during the month of February. The Laundry Platoon, in support of Marine units throughout I Corps, cleaned 95,480 pounds of laundry during the month, an average of 3,410 pounds each day. The Company's First Air Delivery Platoon made nightly flare drops in conjunction with VMGR-152 in support of the First Marine Division and the Army's Americal and 101st Airborne Divisions. A total of 3,919 flares were dropped during 302 man hours of flight time. Of particular note is the Platoon's performance during the High Velocity air delivery drop of four (4) High Velocity A7A containers in support of the First Reconnaissance Battalion on 9 February, 1970.

## PART III

SEQUENTIAL LISTING OF SIGNIFICANT EVENTS

1. SECURITY. The month of February marked many new highs in the efforts of the Command Security Forces. Tasked with the responsibility of coordinating the security efforts of all United States Forces in Sub-Sector A, Northern Sector Defense Command, the Security Forces successfully planned and implemented a coordinated security program which included Army, Navy and Marine Corps Commands located within Sub-Sector A. This security program included the delineation of a coordinated fire support plan for Sub-Sector A and implementation of mutually supporting contingency plans for the Sub-Sector.

In a successful effort to deter the threat of enemy ground and sapper attacks during the TET season, the Provisional Rifle Company conducted 553 security operations during the month. This figure marked an increase of 141 operations over the previous monthly high conducted during the month of January 1970. The First Platoon, Provisional Rifle Company captured one (1) Viet Cong on 18 February 1970, AT 935773. This prisoner proved to be an invaluable source of intelligence data concerning VC/NVA activities and infiltration routes within Sub-Sector A. Upon questioning by counter-intelligence personnel this Viet Cong prisoner revealed the location of three (3) enemy AK-47 rifles, one (1) pound of enemy propaganda leaflets, and numerous other items of enemy material. The Provisional Rifle Company apprehended thirty-four (34) Viet Cong suspects during the month and returned these suspects to counter-intelligence personnel for screening.

Throughout the month of February, 1970, the Command Security Force concerned itself with the development and implementation of a coordinated contingency plan for the defense of Camp Jay K. Books, Red Beach, DaNang, RVN. This plan tasks each of the battalions located at Camp Books with organizing and training a fully equipped reserve force and establishes an effective communications net for the implementation of all facets of the defense plan. A full-scale exercise was conducted during early February to insure the preparedness of these reserve forces.

The Chart included at the conclusion of Part II depicts in detail the Security Activities for February, 1970.

2. CIVIC ACTION. The Battalion Civil Affairs Section supported agricultural, refugee relief, educational, and self-help programs in seven (7) hamlets during the month of February, 1970. Within the spectrum of agricultural activities the section assisted three (3) hamlets with IR-8 experimental rice-growing projects and contributed significantly to the development of numerous vegetable plots throughout the section's area of responsibility. In an effort to assist the refugee families in Thuy Tu (AT 928838), an area heavily effected by the current hostilities, six-thousand (6000) pounds of captured rice were delivered to the inhabitants of that hamlet. The section assisted to a great extent in the training of thirty-four (34) Vietnamese nurses and a Vietnamese dental assistant in a continuing program of Vietnamization of the staff of the Hoa Khanh Children's Hospital. Members of the Battalion served as English language instructors for over one-hundred (100) Vietnamese Elementary School children at Hoa Khanh Village (AT 959790) in a constantly expanding program.

In the area of "self help" projects the Civil Affairs Section assisted the populace of Phu Loc (AT 975784) in the construction of a Maternity Hospital. This is of particular significance since Phu Loc is the home of the 1st Vietnamese Ranger Group and the hospital treats a great many of their dependents. Also within the purview of "self-help" the section assisted the populace of Thuy Tu (AT 928839) in the construction of a hamlet headquarters and the populace of the hamlet of Xuan Thieu (at 935825) in the construction of a dam. The Civil Affairs Section Medical Team rendered medical assistance to 5984 Vietnamese Nationals during the month.




MILES TRAVELED







NARRATIVE SUMMARY

1. 7th Separate Bulk Fuel Company continued normal Fuel Operation. During the month of February, Bulk Fuel Company issued 669,091 gallons of diesel fuel, 293,599 gallons of mo-gas and 1899 drums of POL products.
2. Ration Company maintained normal production of Class I products.
3. Ammunition Company reported routine handling of Class V(W) and Class V(A) ammunition with a daily average for receipts and issues at 1,193 short tons.
4. Industrial Relations Section reported the on board strength for Local National Civilians in Supply Battalion at 557. An ARVN Civic Action team assisted Supply Battalion for one week during this reporting period. Approximately 45 MedCaps were held with a total of 1,227 patients being treated. Due to the TET holidays only 50 English classes were held during February.
5. Several dignitaries visited Supply Battalion including Lt General BUSE, Brigadier General PADALINO, Brigadier General LEE and Major General DOLVIN.
6. Central Control Point processed fifteen updates (10 daily and 5 special), with a total of 53,677 requisitions, 9,326 receipts and 52,201 shipping documents produced. The fill rate for the month was 72% with the fill rate for RO items being 81%. In addition Automated Services Center processed 45,000 personnel changes. A total of 315,564 changes were processed during the month of February for entry into the Man Power Management System.

a. 7th Separate Bulk Fuel Company issued 669,091 gallons of diesel fuel 293,599 gallons of mo-gas and 1899 drums of POL products. A steady improvement in the status of combat essential equipment and tables of equipment occurred.

b. Ammunition Company handled 29,939 short tons of Class V(W) ammunition and 3,556 short tons of Class V(A) ammunition with a daily average for receipts and issues at 1,193 short tons.

(1) The dump level at ASP #1 increased to 13,370 short tons all of which are USMC assets, 10,063 short tons are Class V(W) and 3,307 short tons are Class V(A).

(2) The dump level at ASP #2 decreased to 9,706 short tons of which 6,225 short tons are USMC assets, 3019 short tons are US Army assets, 462 short tons are US Navy assets, 326 short tons are project 972 and 200 short tons are Grade III.

c. Central Control Point underwent a reorganization on 1 February 1970. This reorganization was required to shift the emphasis to getting excess items redistributed to other Marine Corps stock points. The new organization has a Headquarters, Stock Management Branch, Services Branch, Medical Supply Branch, and a Direct Exchange Branch.

2. CIVIC ACTION

a. At the beginning of this reporting period, the on board strength of Local National Civilians within Supply Battalion was 564. The total on board was reduced to 551 as a result of 5 resignations, 1 disqualification and 1 hired by the end of the month.

b. Psyops leaflets were distributed at all 45 MedCaps. A total of 1,227 patients were treated.

c. English classes were not held for two weeks due to the TET holidays. Approximately 50 classes were held during the remaining two weeks.

d. Approximately 25,000 \$VN was expended from military resources for Civic Action projects. The Civil Affairs section also received 10,000 \$VN in voluntary contribution from Vietnamese employees in Supply Battalion. Candy was purchased with this money and distributed to children in orphanages during TET.

3. PERSONNEL. 5 Marine officers and 148 Marine enlisted were joined. 5 Marine officers and 125 Marine enlisted were dropped. There were 13 career re-enlistments during the month of February. This command took pleasure in promoting 266 to present rank as follows:

**NARRATIVE SUMMARY**

Supply Company continued operations, in support of I Corps Marine Units. Increased operations by all sections in areas of traffic and issues were attributed to the extensive excess programs being put into effect.

Continued use of the Red Beach Causway accounted for the efficient movement of 3,000 plus short tons of ammunition to the supply points.

Several dignitaries visited Supply Company's area during February including General Buse, FMFPac; and General Lee, ROK-KMC.

The new retrograde facility became fully operational and the rear salvage area was closed for operational purposes and will only be used as an emergency staging area in the future.

Project MOMOA began on 23 February 1970 and has resulted in redistribution of over 30,000 items of excess material shipped to other Marine Corps. Movement of material was extremely satisfactory and pointed up the outstanding cooperation between sections within the Company.

Visual surveillance by storage personnel and maximum efforts from Technical Research has continued to help purge unserviceable stocks.

Numerous special projects were accomplished during the month as follows: ONTOS spare parts, BUTLER construction material, AM-2 matting, LOGISTICS Command GS requirements, and LVT/TANK project.

The efficient operations accomplished during February were shadowed by a serious incident in which two Supply Company personnel were injured when an assailant threw a hand grenade into their hut. The assailant was apprehended and is being charged with attempted murder.

## PART III

SEQUENTIAL LISTING OF SIGNIFICANT EVENTS1. Significant Operations Conducted

a. Despite numerous extracurricular projects that were handled on an exception basis, the month of February saw maximum operational effectiveness throughout Supply Company. Of course, many of our plans for stock surveillance and purification could not be fully implemented because of the additional workload.

b. The Red Beach Causeway was utilized for offloading four IVT's during the period. These ships accounted for the movement of 3,531 short tons of ammunition across the Causeway. L 27

d. Only nine vehicles remain in the Rear Salvage Area at the end of this month. For all practical purposes, Rear Salvage operations have ceased and the Retrograde Facility has assumed the total function.

e. Project MOMOA, the result of various screenings of our excesses by other Marine Corps activities to fulfill their mount-out/mount-out augmentation requirements, was initiated on the 23rd of February. The entire workload consists of 33,179 documents. Progress has been extremely satisfactory and on the 28th of February, our status was as follows:

f. Internal efforts have continued throughout the month to purge unserviceable stocks from our warehouses and open lots. This action is taken through Phase Codes L (superceded by FSN) and N (total disposal), visual surveillance by storage personnel and the efforts of Technical and Research personnel. Significant disposal actions resulting from this effort have been the removal of 21,000 green shirts (500 cu.ft.) and 14,000 lbs. of scrap metal.

g. Procedures have been established with MMFAC9 whereas their issues will be processed through the PP&P Facility. Prior to this action, all packaging and packing was performed by MMFAC9 personnel. This service is expected to eliminate several past problem areas and improve overall effectiveness of the Battalion.

h. Excess individual clothing was disposed of this month to fulfill the requirements of the 3rd Force Service Regiment and MCSC, Barstow. A total of 31 line items valued at \$6,095 was shipped to the 3rd FSR and 60 line items valued at \$68,000 was transferred to Barstow.

i. The Company was involved in numerous special projects during this period. Those of significance were:

(1) ONTOS spare parts. This was a shipment of 167 documents to M15660 (5th MEB). The project was completed on 16 Feb when the material was loaded on vehicles of the 7th Motor Transport Battalion.

(2) BUTLER CONSTRUCTION MATERIAL. This was a special purge of material used to construct butler-type buildings. Seventy-nine individual pieces were turned over for shipment on 4 Feb 1970.

(3) AM-2 MATTING. This project consisted of pulling all AM-2 Matting from MC100 stocks and positioning them at the Bridge Ramp. This task was complicated by the washing requirements and a short time period imposed by known Motor Transport commitments. Despite these handicaps, all matting had been removed from T-Lot by the 22nd of February - a total of 3,221 bundles within a 9-day period.

(4) LOGISTICS COMMAND GS REQUIREMENTS. This was the result of offering excess General Supply items to the 1st Army Logistics Command, Da Nang. The total project consisted of 353 documents.

(5) LVT/TANK PROJECT. This was another drawdown of LVT/TANK stock. It consisted of approximately 500 documents, 11 separate items from MMFAC9 and 30 items from Shop Stores.

Both Gunnery Sergeants involved were slightly wounded under non-hostile conditions when an assailant threw a fragmentation grenade into their hut. The Article 32 investigation was held and the suspect was charged with attempted murder and referred to a General Court Martial.



WORDS FROM THE XO

The past month has seen a number of unpleasant events take place in Supply Battalion. Hopefully we will never have another month such as this. To a large extent it will be up to you to prevent a recurrence. I think it may be well to emphasize a few Command policies so there will be no misunderstandings on certain points:

1. Marijuana, barbituates and other narcotics will not be tolerated except as prescribed by a physician. A number of young Marines have come in and can't understand why they are being processed for an Undesirable Discharge for possession of just one "joint" or "roach". I want to make it absolutely clear, in plain language, so there will be no doubt --

POSSESSION HAS AND WILL CONTINUE TO BE CAUSE FOR AN UNDESIRABLE DISCHARGE, AS A MINIMUM. IT MAY BE CAUSE FOR A COURT MARTIAL AS WELL.

If you want out, this is a sure way. However, bear in mind that an Undesirable Discharge sticks with you FOREVER, both in the military and in civilian life. There are very few employers who do not ask the nature of your service discharge.

2. Unauthorized weapons and ordnance will very likely get you to court. The only reason a man could have for wanting these items is to either sell them or he intends to cause trouble with them in the future. This month, five men have been injured, from unauthorized ordnance. If you know of the existence of these items either report their location or put them in the "amnesty boxes" located in the Company areas. The reason should be pretty obvious - the next man injured or killed could be you. A "head" has no sense of reason or consequences when under the influence. If you happen to be there, you get it. These policies are not whims of the CO, CG, or CMC. They are necessary for the well being of the group as a whole. If a man wants to injure himself it is pretty much his own business; however, when his actions results in harm or misery to others it is no longer his business, IT IS OURS!

(EDITORS NOTE: Benefits lost by a U.D. were in last issue of the SCOUTLEBOT)

All you have to do is bring the unserviceable item to your "Friendly Organic Supply" storeroom and effect exchange, better known as survey, without charge. The amount of clothing varies, depending whether you arrived in country before or after 15 Jan 1970. The Battalion Supply Officer has indicated that there will be no handouts. To get replacements, promptly report to your 1st Sgt or Company Gunnery and tell him your sad story. He has a form (Report of lost, missing or stolen property) which you can fill out. Should your Company Commander buy your story he'll sign the form and you will be issued the items at Battalion Supply. If the Company Commander determines that the items were lost or damaged through negligence, the items will be replaced by you through Cash Sale conducted at the Clothing Outlet Store. The Supply Officer keeps records, so don't try to survey or replace a quantity exceeding what you're authorized.





OFFICERS/NCO'S

What's happened to the pride which Marines displayed not long ago? Pride in our Corps, uniform, installations and most importantly, OURSELVES.

This question has been muled over by Officers, Staff NCO's and many other individuals interested in the Marine Corps. More than discussion is needed. Have we forgotten ACTION?

The leaders of our Corps have on numerous occasions stated that today's Marine is the finest ever. Granted, that in RVN present-day Marines of all ranks are doing an extremely difficult task in an exemplary manner. But a different picture is seen in garrison.

Many of the "problems" which exist today are due to flaws in leadership. How often do we see Marines improperly wearing the uniform, walking with their hands in their pockets, not saluting, needing a haircut. Yet, I've seen many instances of officers and NCO's passing Marines who should be stopped and corrected, but not doing so.

How many times have we heard "You've got the Marine Corps and then you've got 'this' outfit?" All Marines go through the same basic training. Why, then, should it appear that standards differ? The only reason Marines don't wear their uniforms properly and fail to obey the regulations is that they are not immediately corrected, fairly but firmly, when they violate the regulations.

The officers and NCO's of the Corps MUST SET THE EXAMPLE AND INSIST THAT ALL MARINES COMPLY WITH ALL REGULATIONS!

We must follow-up the patterns set by the drill instructors, who put forth untold hours of instruction and years of experience to insure that basic Marines and newly commissioned officers could and would serve the Corps with pride.

Each of us must examine ourself and ask if we're providing the leadership which the younger Marines need and really want. Remember, if we don't provide that leadership, the Marine Corps of the future will suffer by being something less than the best fighting force in the world. Then how proud will we be to say, "I'm a Marine".

IT MUST DON'T PAY

16 Dec 1969, PFC Gary COOPER, H&HCo, 3d Brigade, was convicted by a General Court Martial convened by the CG, 101st Airborne Div (Airmobile), of wrongful possession of opium and marijuana. He was sentenced to a dishonorable discharge, confinement at hard labor for 18 months, forfeitures of all pay and allowances and reduction to pay grade E-1.

9 Dec 1969, Pvt Reginald F. SMITH, K Co. 3d Bn 9th Marines, was convicted by a General Court Martial convened by the CG, 3d MarDiv, of conspiracy to commit murder and the premeditated murder of 1st Lt Robert T. ROHWELLER by throwing a fragmentation grenade into the building in which the LT was sleeping. SMITH was sentenced to a dishonorable discharge, life imprisonment and total forfeitures.

Many benefits a veteran of the Armed Forces is entitled to are lost upon receipt of a Dishonorable, Bad Conduct of Undesirable Discharge. Some of these are as follows:

BENEFITS BY THE VA

- Educational Assistance
- Medical and Dental Care
- Burial benefits (flag and expense)
- Home and farm loans

BENEFITS FROM MILITARY DEPARTMENTS

- Burial in national Cemetery
- Retain and wear uniform home
- Notice to employer of discharge
- Award of medals, crosses and bars
- Use of wartime title and wearing of uniform

BENEFITS FROM OTHER FEDERAL AGENCIES

- Civil Service employment preference
- Reemployment benefits
- Naturalization
- D.C. Police, fireman, and teacher retirement credit
- Preference in purchasing defense housing
- Unemployment benefits

FORKLIFT

The larger number of accidents with forklifts in RVN indicate that many forklift operators fail to appreciate some of the very obvious driving precautions which these vehicles require. Large loads, and the lack of forward vision thus created, require an extra degree of caution and a special driving technique. The following list of DO's and DON'TS addresses these matters, and should be studied in detail by Marines who drive forklifts or are required to supervise cargo handling operations.

DO

- \* Sound horn at all blind intersections, inside or outside warehouses.
- \* Drive slowly over rough surfaces.
- \* Watch overhead clearances.
- \* Make sure brakes are holding before leaving your forklift.
- \* Check bridge plates between ramps and decks to ensure that they are secure.

Check wooden decks and ramps to see that they are strong enough to support the forklift and its load.

DON'T

- \* Permit unauthorized personnel to operate forklifts.
- \* Overload your vehicle - lighten loads instead of counterweighting.
- \* Descend ramps with load in front. Drive down backwards at slow speed.
- \* Cut corners --- watch your turns and prevent accidents.
- \* Jam your brakes and risk dropping your load.
- \* Elevate people or allow them to ride 11th forks, the vehicle, or the load.

SHIPPING CONTAINERS

When your unit receives supplies in a good reuseable container, see to it that the box isn't scrapped or knocked apart for the lumber it contains. That box may be just what your section needs to achieve a satisfactory embarkation posture. Mount-out boxes are always needed, but they are not always easy to find. An excellent source for good reuseable containers is the field bakery. Bulk flour is packed in a good solid box which is acceptable for most embarkation needs. As is often the case, a little prior planning will make a big difference when the work is passed to mount out. Take advantage of reuseable containers, and leave the last minute scrambling around to the other guy.

CONTRABAND BOXES

There have been recent incidents of contraband equipment, supplies and ordnance being found in trash collection points. This means of disposal is not only dangerous to persons handling the trash but may be a source of supply for the enemy.

To contribute to efforts being made to prevent these occurrences, collection boxes within the area for receiving contraband equipment, supplies and ordnance "found" by personnel, will be established.


