PART IINARRATIVE SUMMARY

During the month of August 1970, Headquarters and Service Battalion provided administrative, communication, motor transport and general support to the Force Logistic Command and numerous other Marine and allied units.

Headquarters and Service Company provided administrative and support services to over 800 members of the company who functioned in 30 different operational sections. The company's personnel strength increased from the previous month by 24, for a total strength of 835 during the month of August. Continuing to contribute to the habitability, safety and security of the Camp Books complex, the company's Engineer Platoon completed 161 work orders. In preparing for the monsoon season, the platoon prepared and installed 1,200 feet of drainage culvert, fabricated and laid 1,548 feet of wooden boardwalk, distributed 3,500 Cubic Yards of sand, 1,050 Cubic Yards of rock, and 1,750 Cubic Yards of dirt. They also leveled and graded the main storage lot in the Supply Battalion area. The carpenter section constructed an addition to the Non-Commissioned Officers Club and partitioned the Support Company supply warehouses. They also constructed 31 mount-out boxes and 17 new doors. The Engineer Platoon's electrical shop continued to supply maintenance for the Headquarters and Service Battalion.

The Battalion's Industrial Relations Office under the cognizance of the Battalion S-4, supervised the personnel and administration of 480 Vietnamese National employees under three separate fundings. The Vietnamese National workforce decreased by one person during August through normal attrition. Promotion for 41 appropriated workers were processed during the month of August. The Vietnamese National employees received remuneration in the amount of 3,090,457 piasters (\$26,188.00 U. S.), an increase of 174,502 piasters (\$1,478.83 U. S.) from the previous month. The increase in payroll is due primarily to the rise in pay rates afforded under new promotion. In the realm of sanitation, the Battalion/Camp Police Sergeant, also under the cognizance of the Battalion S-4, was responsible for the removal and disposal of 8,920 cubic meters of dry trash and 23,456 gallons of wet garbage from the confines of Camp Books. The Battalion Organic Supply section, an integral unit of Headquarters and Service Company, processed 1,270 requisitions, an increase of 80 over the preceding month. This amounted to a total monetary obligation of \$152,290.00 including \$41,000.00 in foul weather gear in preparation for the coming monsoon season. During the period, the command Fire Department fought ten fires. Of those fires, seven were class A (Brush Fires), two were class B (Electrical Fires), and one was a class C (Pol Fire).

Communication Company provided communication support to all Marine Corps, Army and Navy units located in the Camp Books - Red Beach area. The company's Communication Center Platoon noted a net reduction of 1,097 messages processed for August. This is the third consecutive month that

the total traffic has decreased. Over the last three months, the total volume has decreased by 7,902 messages. Current thought is that the down grading of the III MAF Command sphere of responsibility is the significant cause of the message decrease. During the month of August, communication guard was furnished for the Commanding General, Fleet Marine Force, Atlantic, and Commander in Chief, Pacific. No messages were received for the Commanding General Fleet Marine Force, Atlantic, however, seven were processed for Commander in Chief, Pacific. Part IV TAB-A contains the Communications Center workload statistics for the period July through August 1970. The Maintenance Platoon provided communication electronic support to all platoons of the company on a 24 hour basis, responding to a total of 268 trouble calls. The Radio Platoon manned an average of nine radio nets during August 1970. Utilizing the AN/TSC-15 Radio Set, the Radio Platoon made 48 phone patches to Okinawa in August. The Wire Platoon continued to provide dial telephone services to Camp Books, Camp Haskins, Camp Viking and Camp Love. Field telephone service was provided for Camp Monahan, ASP-1, ASP-2, and Camp Books Combat Operations Center, and to the perimeter defensive positions.

On 13 August 1970, the M-8 Cable, a 100-pr cable that connects the Force Logistic frame to the 31 Test Station at Danang Air Base and carries 65 circuits which are tied to the Force Logistic Command Telephone Exchange was shot by small arms fire at 984773. The cable was repaired within four hours, on August 1970 a pole was down at 984773, this incident was repaired within four hours also. The Wire Platoon was called upon four times during the month of August 1970 to provide a public address system, twice for Change of Command ceremonies, once for an Awards Ceremony held by the 58th Transportation Corps, U. S. Army, and once in support of the 3rd Military Police Battalion embarkation at Deep Water Pier. The automated dial system handled 709,415 calls. Also, a total of 56,859 operator assisted calls were handled, and there were 14 new installations of Class-C telephones, with 27 extensions added. The Wire Platoon completed 47 telephone work orders and cleared 134 trouble calls. The Truck Company Change of Command at 0900, 15 August 1970, saw Major L. R. ELWELL relieved as the old Company Commander and Major C. R. NOYES assigned as the new Company Commander. Truck Company continued to provide administrative and tactical motor transport support to all elements of Force Logistic Command, specified III Marine Amphibious Force units, and conducted "Rough Rider" convoys in support of the 1st Marine Division. "Rough Rider" convoys rolled in continuous support of Landing Zone Baldy 132453 and conducted "shuttle runs" with aviation fuel to support operation "Pickens Forest". The addition of shuttled fuel was necessitated due to fuel bladder damage at Landing Zone Baldy. Daily fuel runs were made to An Hoa under the operational control of 11th Motor Transport Battalion. Weekly convoys to Chu Lai were picked up from Truck Company FLSG 3. Small vehicle serials were also sent to the 2nd Combined Action Group near Hoi An and north to Phu Bai and Quang Tri. Local commitments included transporting all classes of supplies for battalions and attached units within the Force Logistic Command and 1st Marine Division Headquarters area. Extensive daily support was also rendered to 5th Aerial Delivery Platoon, Marine Air Freight, Purchasing and Contracting office in Danang and

the XXIV Corps Rest and Recuperation Center/Transient Facility. Part IV TAB-B contains the significant operational statistics for the month of August 1970. Truck Company's Maintenance Platoon continued to provide second echelon support for over 500 pieces of equipment, over 300 which are powered prime movers, and also provided second echelon support for specified III Marine Amphibious Force units.

Support Company performed many diversified services for the Force Logistic Command and other Marine and allied forces during the month of August 1970. In operating the III Marine Amphibious Force Transient Facility and Rest and Recuperation Processing Center, members of Support Company processed and billeted 10,909 personnel and messed 43,410 transient personnel during August. The company's Material Handling Equipment Platoon's RKF-060, 6,000 pound rough terrain forklifts, and CYF 4,000 pound commercial forklifts operating during the month of August moved 72,164 tons of supplies and equipment. Operators licensed during the month of August numbered 46. Of this total, 31 operators were licensed to operate the RKF-060, 6,000 pound rough terrain forklift, 6 for the CYF 4,000 pound forklift, 7 for the warehouse tractor and 2 for the H150G 15,000 pound forklift. To date, the platoon's equipment repair shop has completed 95 work orders. During the month of August the company's Air Delivery Platoon made a total of 4 parachute operations in order to maintain their proficiency. The Air Delivery Platoon also performed two heavy cargo air drops. Support Company's Graves Registration Platoon processed 95 remains, the Danang Team processed 95 and 9 were processed by other teams. The combined total being 104 for the month of August 1970 and a total of 1924 for the year. Part IV TAB-C contains the supporting statistics.

PART III

Sequential Listing of Significant Events

1. Security. Tasked by the Commanding General, First Marine Division with the mission of coordinating all security activities with Sub-Sector "A" Northern Sector Defense Command, the Battalion continued the planning and implementation of tactical operations and programs which would enhance security within the Sub-Sector. On 10 August 1970, the Northern Sector Defense Command was dissolved with all responsibilities being passed to the 1st Marine Regiment, 1st Marine Division. All Sub-Sectors remain the same, and the Battalion is continuing it's present program. During the month of August 1970 the Battalion's Provisional Rifle Company conducted a total of 736 security operations.

On 1 August 1970, a squad from the 2nd platoon, occupying a night ambush site to the North of Camp Books in the vicinity of Mieu Thach Son, (928815) sighted one VC/NVA moving south along the rice paddy dikes toward the ambush site. The squad took him under fire and illuminated the area. The enemy was observed fleeing to the north. An immediate sweep of the area resulted in the capture of one AK-47 rifle, a further search at dawn failed to produce any other equipment.

On the 2nd of August 1970, the 3rd and 4th platoons, in support of India Company, 3rd Battalion, 1st Marine Regiment, and Combined Unification Pacification Platoon 42, participated in a joint cordon and search of AN QUAN NAM (1). Prior to first light the 3rd and 4th platoons moved into their cordoning positions south of the village at (910818), linking up with units of India Company who cordoned off the remaining area around the village. At first light members of CUPP 42 swept the village discovering 7 Chinese Communist grenades and 11 M-16 magazines. There were no detainees.

On 8 August 1970, a similar cordon and search operation was conducted on the village AP Da Phuoc which occupies grid squares (9478) and (9578) south of Camp J. K. Books. On this operation the Provisional Rifle Company's 3rd platoon operated in support of the Vietnamese National Forces Police, Hoa Vang District Officials and Popular Forces. Again the Provisional Rifle Company Marines provided a portion of the cordon force at the north east side of the village (953788). The results of the operation were negative in all respects. Ap Da Phuoc is considered to be a very pacified village.

To enhance the effectiveness of the Provisional Rifle Company's operations within the Battalion's assigned Area of operations which encompasses approximately 14 square miles (from north south grid lines 92 to 94, in the northern portion, and east west grid line 77 in the south to east west grid line 83 in the north) the company utilizes several specialized assets.

One of which are two "Kit Carson" scouts that are assigned to the 5th Counter Intelligence Team. These scouts are from the local area and have been a great help in identifying members of the local Viet Cong Cadre and pointing out routes of infiltrations, and methods of operations used by the enemy within the Battalion's Area of Operations. Scout and Sentry dogs from the 3rd Military Police Battalion War Dog Platoon provide an additional asset to the company. These dogs and their handlers are assigned to the company on a rotational basis and are used both in night ambush sites and in daylight patrolling. Part IV, TAB-E depicts the vertical security activities for August 1970.

2. Civic Action. The Battalion Civil Affairs Section supported agricultural refugee relief, education, medical and self-help programs in eight hamlets during the month of August 1970. In continuing to assist and improve agricultural production, the section provided six bundles of agricultural tools to the hamlets. Ap Da Phuoc (948787), Thuy Tu (906836), Ap Xuan Duong (936836), Phu Loc (973796), Ap Xuan Thieu (933812), and Ap Trung Son (919805). Each bundle consisted of six shovels, five handles, one pick head, one iron digging pole and one rake. Also in continuing to support the two experimental hog farms in Ap Troung Son and Mieu Thanch Son (933816) eight, 100 pound bags of corn were donated to further stimulate the animal growth.

In the realm of self-help programs the section, in a joint operation with the International Relief Commission, is continuing it's efforts in the program to relocate 70 refugee families from the hamlet of Ap Da Phuoc (at 948787) to a less densely populated area within the perimeter of that hamlet. The International Relief Commission, with assistance from this section is providing the building materials for the homes. This section is providing well rings and cement to construct five planned water wells for the new settlement. To date, four have been completed, and five more are planned for. Families are scheduled to move into the new homes as they are completed. This program will provide much needed relief to the over populated refugee hamlet of Ap Da Phuoc (948787).

The section also coordinated with the 10th PSYOPS Battalion for a psychological broadcast and leaflet drop in the village of Hoh Hiep (922860). The approximate number of people that heard the broadcast is undetermined.

Anti Viet Cong slogans were also painted by residents Ap Nam-O (934824) and were mounted above the entrances of their homes. Materials for the fabrication of those signs were provided by this section at the request of the hamlet chief.

Total cost of materials expended to support the hamlets in this Battalion's area was 129,400 piasters (\$1,096.61 U. S.)

3. Medical. During the month of August 1970, response to the manual cordon system of immunization improved 5% over July 1970.

The Headquarters Battalion Aid Station rendered medical services to 1,263 personnel at normal sick call, performed 262 physical examinations and 467 physicals for personnel going on R&R and being assigned to mess duty. In addition, 1,646 prescriptions were filled, 1,206 laboratory tests were performed, 526 X-RAY's were taken, 157 personnel were seen by the Medical Officer for consults, 206 Vietnamese were treated and 57 pair of eyeglasses were ordered.

In addition to providing four Hospital Corpsmen to the Provisional Rifle Company on a full time basis, Corpsmen participated in 55 additional field operations, and held eight formal classes of instruction for the Provisional Rifle Company Marines.

4. Commanding General Fleet Marine Force Atlantic Visit.

Lieutenant General F. E. LEEK, Commanding General Fleet Marine Force, Atlantic, visited the Force Logistic Command on 16 August 1970. Security required for his visit was provided by the Force Logistic Command Security Section of Headquarters and Service Battalion. Included in his visit was a motor tour of the Battalions. During this tour, Lieutenant General LEEK was walked through the Communications Electronics facility in the Maintenance Battalion area, the Reclamation building in the Supply Battalion area, and the Retrograde Facility.

5. Administration. The battalion's performance in the Manpower Management System for the month of August continued to be below Marine Corps standards. The total items reported were 2435. The error rate was .5%. The following table outlines unit performance by Company:

6. Headquarters and Service Battalion Material Handling Equipment Platoon Story.

The Material Handling Equipment Platoon (MHE Platoon) of Support Company is assigned the mission of providing forklift support to the Force Logistic Command. The platoon is organized into three sections; headquarters, operations and maintenance. These three sections comprise a total of one officer (First Lieutenant) and 161 enlisted Marines. Within the operations section are found the heavy equipment sub-section and the light equipment sub-section. The heavy equipment section operates, controls and maintains 71 RFP-060, 6,000 pound rough terrain forklifts. These forklifts are used primarily in ship loading and unloading operations. They are also used at both ASP-#1 and ASP-#2, where they are invaluable in handling large quantities of ammunition. The light equipment section operates, controls and maintains thirty-six 4,000 pound commercial forklifts and is responsible for supporting warehouse operations with the Force Logistic Command. These commercial forklifts are operated on a "U-Drive" basis, with operators being supplied by the using units. All maintenance performed on MHE platoon equipment is accomplished by the maintenance section. During the month of August 1970, the maintenance section has completed 125 work orders and has been responsible for maintaining an availability percentage of above 90%. This excellent availability has resulted in the MHE Platoon equipment being responsible for movement of 1,169,700 tons of supplies within the Force Logistic Command area.

The MHE Platoon is tasked with the secondary mission of administering a forklift school. This school is attended by Marines from Force Logistic Command, and Marines from 1st Marine Division. It is especially interesting to note that the MHE Platoon instructors also teach the Local National Civilians both men and women to properly operate the different types of forklifts, and how to correctly maintain them. This is accomplished through the use of interpreters and lesson plans written in the native language. The work supplied to the Vietnamese people through this system is considered to be extremely beneficial to the Force Logistic Command people to people program. Through this program both people have come to know and understand each other, and it is especially gratifying to observe a United States Marine working side by side with a Vietnamese civilian toward a common goal. That goal being to provide the best material handling service available to the Force Logistic Command. TAB-F contains a Pictorial account of the Material Handling Equipment Platoon's activities.

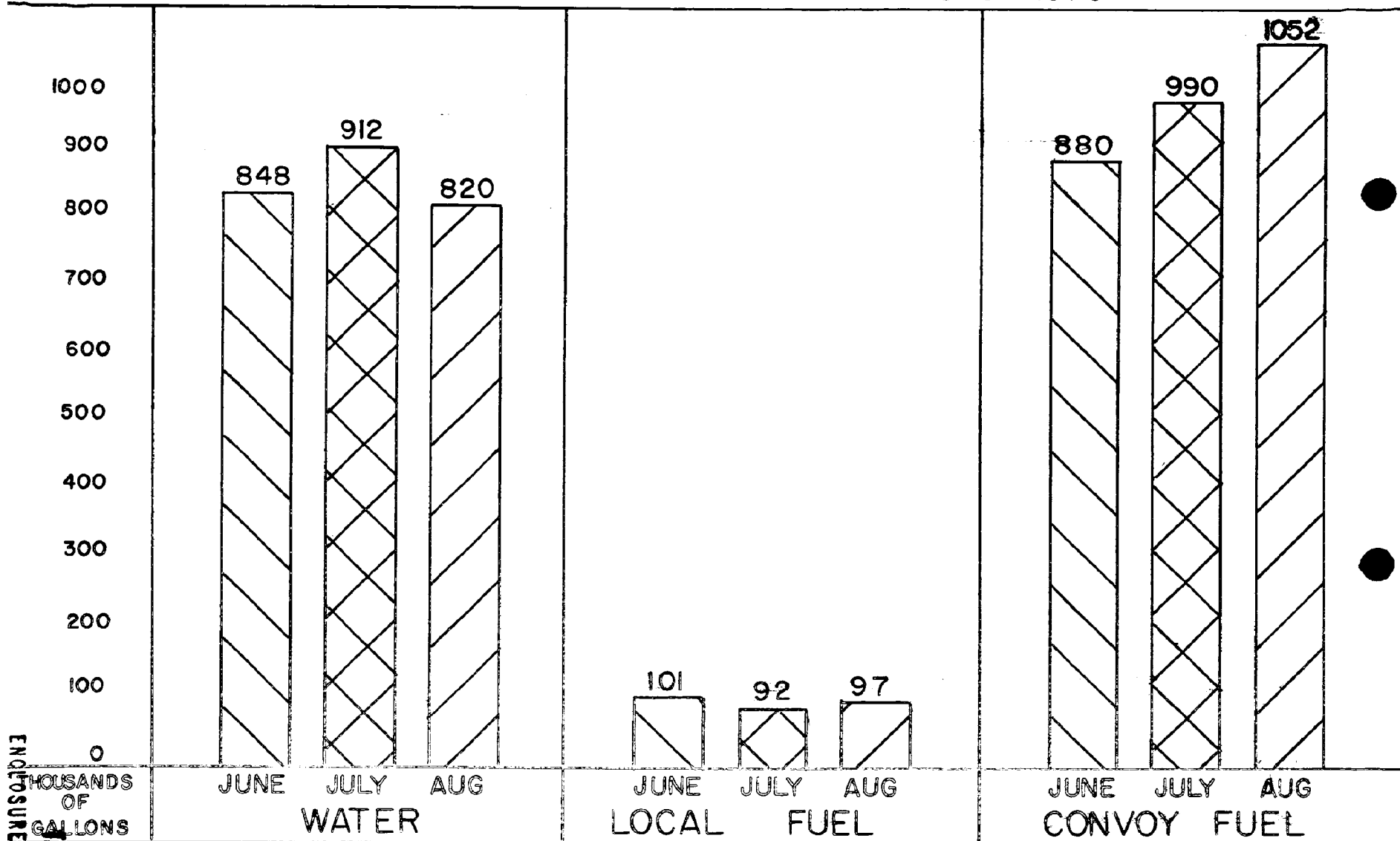

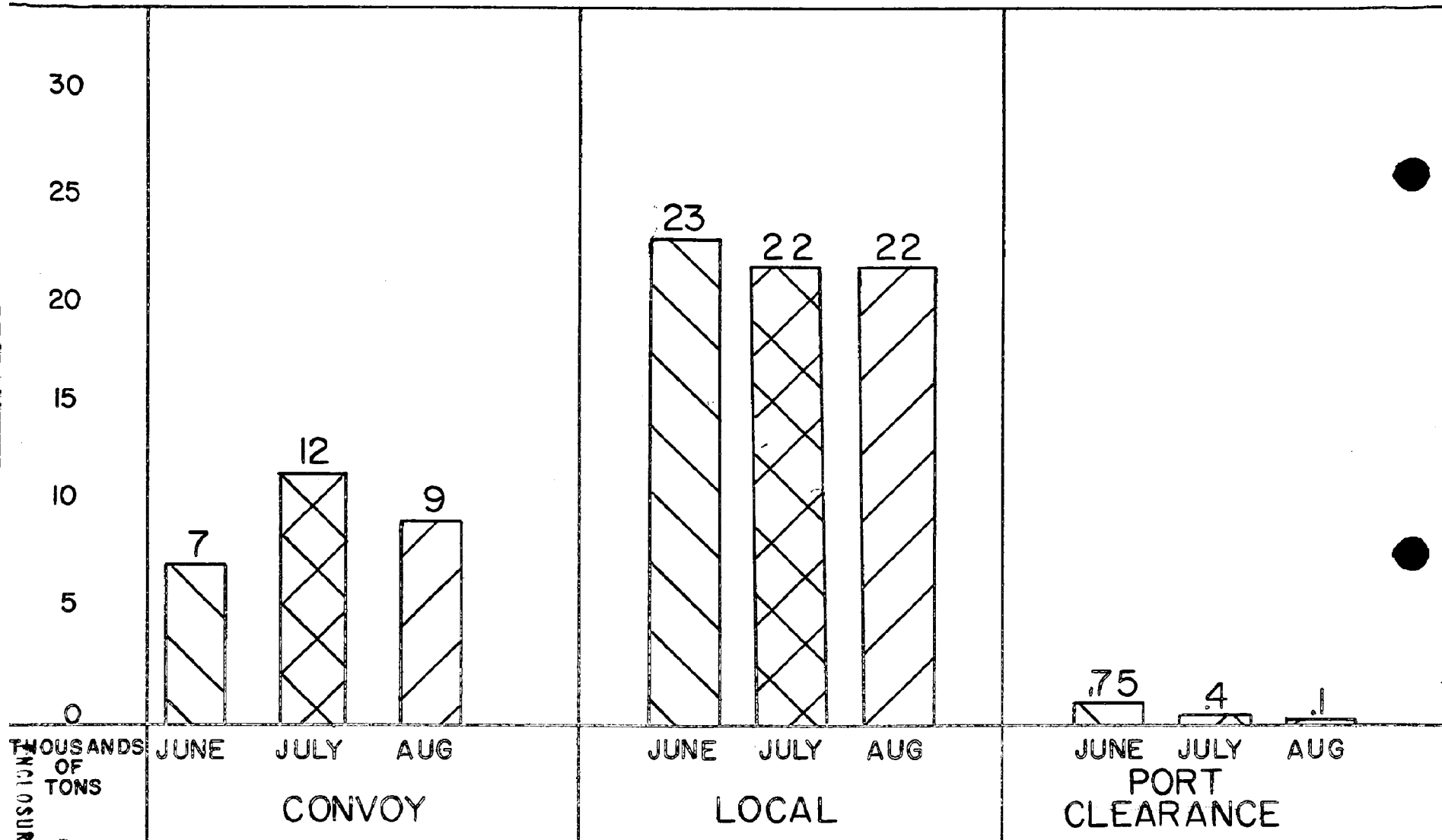

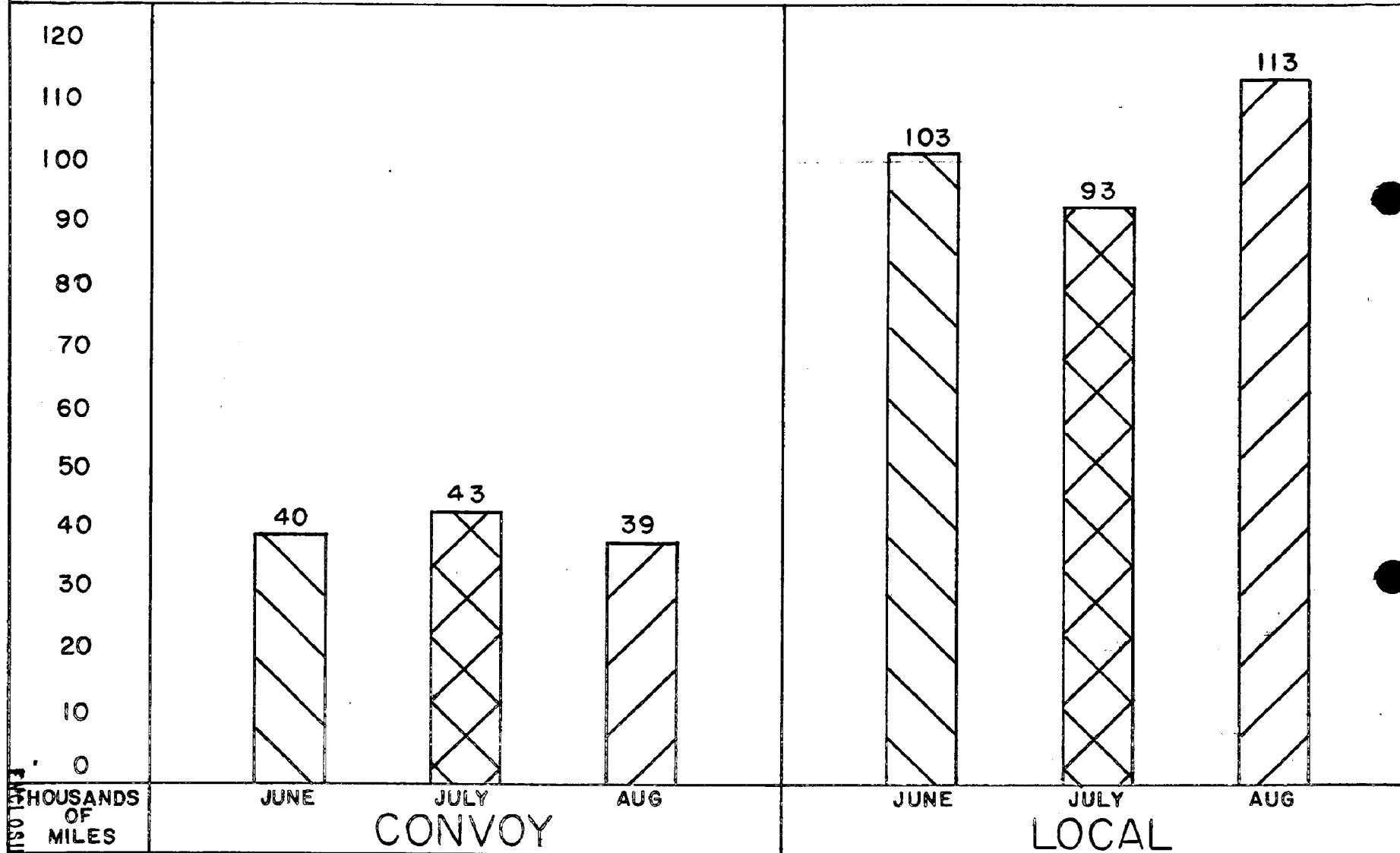

NARRATIVE SUMMARY

During the month of August, Bulk Fuel Company continued to support U.S. and Korean units in I-Corps with Bulk and packaged fuels and lubricants. During this period the company issued 439,385 gallons of Diesel and 249,840 gallons of Mogas at the eleven fuel dispensing points. In addition, drums of packaged fuels and oils were issued. The fuel site at An Hoa is currently being closed down, and no fuel will be issued after 5 September 1970. Renovation projects were carried out throughout the month at Camp Books, 1st Motors, and Hoi An fuel sites. All serviceable excess gear is being readied for embarkation. In addition to its normal mission the company washed all of 7th and 9th Engineer Battalion gear prior to deployment and provided engineer equipment support for 3rd MP Battalion, 1st MP Battalion, Ammunition Company and Supply Battalion S-4.

During the month of August, Ammunition Company handled 28,299 s/tons of Class V(W) ammunition and 7881 s/tons of Class V(A) ammunition. The daily average for receipts and issues was 844 s/tons. EOD Platoon made 103 calls recovering 1438 US explosive items and 56 VC or ChiCom explosive items. The platoon destroyed 3 tons of unserviceable ammunition from ASP #1.

During this period, approximately 30,000\$VN was expended from military resources for Civic Action Projects. During this period the following Civic Action Projects were completed; 25 Heads constructed in Phuoc Xuan, a Hamlet Office was constructed in Phuoc Xuan hamlet; 10 wells and a Hamlet Gate were constructed in the hamlet of Chieu Hoi #3; 150 homes were constructed in the hamlet of Trung Phuoc; and 1 well was constructed at the Hoa Khanh Village Headquarters. During this period approximately 57 MedCaps were held. A total of 5,243 patients were treated. Psyops leaflets were distributed at all MedCaps held by Supply Battalion. Approximately 5,000 leaflets were distributed in this manner.

Supply Company continued support for Marine Corps units in Military Region I. Support centered on units primarily within the Danang area but did extend South to Chu Lai, An Hoa and LZ Baldy and to Combined Action Group units in the Phu Bai area. Support was also provided to the 2nd ROK Marine Brigade units in the Hoi An area. Receipts for August 1970 were 44,635.

In view of the lack of significant events, there is no Narrative Summary for the month of August for Ration Company.

PP&P completed the Federal Group 84 Project early in the month which was a complete physical inspection of all assets, drying where required, repacking and reboxing the materiel for storage and for export shipment. Federal Group 83 Project, similar to the 84 Project, was initiated immediately upon completion of Federal Group 84 and is presently in progress.

e. Medical receipts and issues remained at the normal level. Medical Supply has provided logistical support to the hospital ship USS Sanctuary several times during the month and prepared a total of 10 shipments (CONEX boxes) of unserviceable obsolete items for transfer to the Army PDO facility. The Medical Section has completed their rewarehousing project designed to place all materiel in covered storage.

f. Shop Stores observed a month of relative calm with only routine work accomplished. There were a total of 4605 transactions conducted with an over all fill rate of 69% for all items and a 79.9% fill rate for R/O items.

g. Storage Platoon continued the extensive rewarehousing efforts. Additional warehouse space was obtained from FLSG-Bravo. During this period the Storage Platoon received large quantities of Class IV turn-in from using units.

h. Clothing receipts and issues remained at a normal level.

NARRATIVE SUMMARY

During the month of August 1970, the Supply Company continued support for Marine Corps units in Military Region 1. Support centered on units primarily within the DaNang area but did extend South to Chu Lai, An Hoa and LZ Baldy and to Combined Action Group units in the Phu Bai area. Support was also provided to the 2d ROK Marine Brigade units in the Hoi An area.

Incoming receipts has leveled off with 7,835 receipts being processed to MC100 during the month. The majority of the Materiel Release Orders (1348-1), a total of 44,635 processed by Document Control Unit, was received during the last 10 days of the month and included PURA, MO/MOA, 3rd FSR/EASTPac Cp Stock and regular customer support NRO's.

The Storage Platoon continued the extensive rewarehousing efforts. Additional warehousing space was obtained from FLSG Bravo as a result of their stand down which included 4 Butler Buildings with a total storage area of 16,000 square feet. An aggressive program was instituted where the Storage Platoon used this additional storage space to remove Federal Group 84 (clothing) and 83 (textiles) from outside area's to covered Storage. During this period the Storage Platoon received large quantities of Class IV turn-in from using units.

Federal Groups 58 and 59 were removed from outside storage, consolidated, and placed into covered storage during this period. A decision was made to move the location of the lumber yard from its present site to a more favorable location and simultaneously to conduct an inspection for serviceability of lumber for embarkation purposes. A course of instruction was given by a representative of the Preventive Medicine Unit, Department of Agriculture on the causes of lumber rejection during the agriculture inspections for embarkation purposes and how to classify the lumber for various end application. A complete check was conducted by the 1st Marine Division Combat Intelligence Team and the unofficial reports indicate that security was satisfactory. The Shop Stores Platoon observed a month of relative calm with only routine work accomplished. There were a total of 4605 transactions conducted with an over all fill rate of 69.9% for all items and a 79.9% fill rate for R/O items. A location verification and an inventory was conducted on all issue points with satisfactory results.

The Clothing and Medical Sections issues and receipts remained at the normal level. The Clothing Section continued shipping items in excess of the established R/O to CONUS. An effort is being made by Clothing to compute an R/O based on the current reduced strength of Marines in country and to ensure, by establishing liaison with departing units, that sufficient assets are available to meet immediate requirements. Medical has provided logistical support to the hospital ship, USS Sanctuary, several times during the month and has prepared a total of 10 shipments (CONEX boxes) of unserviceable obsolete items for transfer to the Army PDO facility. The Medical Section has completed their rewarehousing project designed to place all materiel in covered storage.

The Retrograde Platoon was deluged with sundry items as a result of units turning in excess items for redistribution, deactivation of the CAG Units

and the additional operational function, assignment of the jungle utility rehabilitation program. A total of 288 pieces of communication equipment, 340 pieces of rolling stock and 500 weapons were LTI's of which most were NCM-RIR items. There was a total of 144 RIR's submitted during the month with many items from the Keystone Robin Alpha movement being processed. A newly installed traffic pattern at the Retrograde Facility is providing for more efficient utilization of existing parking space and has reduced greatly the possibility of accidents.

As a direct result of the Storage Platoons Care-in-Storage program, the retrograde work load and the excess redistribution programs there was a tremendous increase in the PP&P Platoons work load. Units external to the Force Logistic Command who had no PP&P capabilities added to this work load with requests for shipping containers and preservation requirements. PP&P completed the Federal Group 84 project early in the month, which was a complete physical inspection of all assets, drying where required, repacking and reboxing the materiel for storage and for export shipment. Federal Group 83 project, similar to the 84 project, was initiated immediately upon completion of Federal Group 84 and is presently in progress.

During this period the TMO has been the recipient of all the retrograde excess and MC100 generated cargo. Most of the cargo has been staged and held pending Fleet Shipping vice commercial shipping. As a result of holding this large quantity of cargo the TMO has experienced a problem in finding adequate storage areas to stage pending shipments.

All platoons within the company functioned with adequate officer supervision. This, however, was not the case with Staff Non-Commissioned Officers as there was a noticeable decline in this area being most critical in the Storage Platoon.

Increased emphasis has been placed on training in an effort to instill in our junior NCO's a sense of responsibility and confidence so that they can fill the void left by departing Staff NCO's.

1. The PP&P packed and prepared for shipment to Okinawa 40 boxes containing Butler Building components. These boxes had to be specially fabricated as they were an estimated 20 feet long by 5 foot wide. Construction of these 40 boxes consumed 575 manhours.
2. The Commanding General, Force Logistic Command visited PP&P Shops 3&4 for a briefing and tour on 3 August 1970.
3. The Supply Battalion Commanding Officer, Col, MORIN marked the 23rd anniversary of the Medical Service Corps, USN by presenting the Medical Supply Section with a cake and congratulatory message on 4 August 1970.
4. Storage Platoon received a shipment of 60,000 sandbags, a critical items, at 1600 5 August and issued them at 1630 the same day.
5. The project Federal Group 84 was completed on 6 August and project Federal Group 83 (Textiles) was immediately started.
6. The Vietnamese vendor who has the contract for rehabilitation of used jungle utilities made his first pickup from the Retrograde Platoon 8 August. The contract administrator prior to this time was General Services Maintenance Platoon. With the deactivation of that platoon this company became the contract administrator.
7. The Retrograde Platoon experienced a very heavy turn in of M100, M107, M107A1, M107A2, M170 and M38A1 trailers from the 1st Marine Division as a result of a III MAF message (III MAF 090904 Aug 70) directing turn in prior to redeployment.
8. Retrograde Platoon received disposition instructions on 1200 weapons on 11 Aug. All were to be redistributed to out of country units and the weapons were turned over to PP&P for preparation for shipment.
9. The Traffic Management Office began pulling and staging 14,000 cube of cargo for fleet shipping, LST-1073 on 11 Aug.
10. The 1st Marine Division Combat Intelligence Team began inspecting security procedures within the Storage and Retrograde Platoon on 13 Aug.
11. The Preventative Medicine Unit inspected MC100 lumber assets for infected (insects, dry rot and fungi) stock. All infected lumber found was pulled from stock and disposed of in the best interest of the government.
12. A class was held for Supply Company Storage Personnel by the Army Preventative Medicine Unit on the procedure to be used in the inspection of wood to determine infestation and identification of same. This class on 15 August was held to insure no infected lumber would be issued for use in fabricating embarkation containers.
13. The Traffic Management Office personnel moved 43,000 cube of materiel to the Red Beach Causeway for embarking on LST 1150, 16 August. Loading of 13,648 cube aboard LST 1073 was completed.

14. The Commanding General, Force Logistic Command, visited the Issue Pad Control Platoon on 18 August and was briefed by the Officer in Charge on the operation. The Commanding General also toured the new medical warehouse and was given a briefing by the Medical Supply Officer.

15. The PP&P Platoon relocated the Parcel Post Section from warehouse B-1 to the PP&P Shop #1 area. This was accomplished on 19 August and is expected to give positive control and afford closer supervision.

16. Two Butler Buildings, 8000 square feet, were turned over to Supply Company by FLSG-Bravo for use as covered Storage areas on 19 August.

17. The Commanding General, Force Logistic Command visited the Retrograde Facility on 21 August.

18. The Traffic Management Office moved a total of 46,363 cube to Deep Water Pier, DaNang for LST 1182 on 23 August.

19. The Commanding General, Force Logistic Command visited the Retrograde Facility, 26 August to inspect communication vans which were turned in as excess by FLSG Bravo.

20. A series of vener^{ed} disease lectures has been scheduled for the period 31 August to 11 September. This lecture will be given by qualified corpsmen.

21. On 30 August the Storage Platoon assumed operational control over two more Butler Building, 8,000 square feet, as FLSG Bravo continued its stand down.

22. The Supply Company received 14,181 issue mats (1348-1) from MC100 on 30 August.

23. During the last few days of the month Supply Company directed its efforts to preparing all cargo for fleet shipping. A ship will be due at DaNang about 6 September and present requirements for cargo is 400,000 cube.

24. TRAINING

CIVIC ACTION MEMORANDUM 8-70

1. Our Civic Action Team has been working in the hamlets of Phuoc Nghia and Phuoc Ha on two additional housing projects of 15 units each. Our trucks hauled 72,000 pounds of rice from Dakang to the hamlets of Phuoc Nghia and Phuoc Ha.
2. The Civic Action Team distributed approximately 6,000 PsyOps leaflets, posters and literature. About 300 bars of soap were hand delivered to the hamlets, wrapped in leaflets concerning sanitation. Approximately 200 school kits were hand distributed and wrapped in "Banb-Khin", a pro-CVN, Polwar newspaper.
3. During the month of August, our MedCap Team treated 639 people. Two small children with burns were treated by Civic Action Team members on a daily basis.
4. Scrap wood was taken to Phuoc Nghia for use in the vocational school for training the students. The product of their labors will be a bench and desk for each home in the hamlet.
5. Popular Force units in Hoa My received instruction in the use of their newly acquired M-16 rifles, while Popular Force units in Phuoc Nghia and Phuoc Ha received instruction in the use of flares (illumination) and the 60mm mortar. Hamlet security in Phuoc Ha is 95% complete with the laying of 92,000 meters of barbed wire and concertina.
6. Working relations with local officials are extremely well, due to Civic Action Team participation in hamlet activities as requested by the local chiefs. All officials are striving to see their hamlets on solid footing for the eventual pull-out of U.S. forces. All Civic Action Team members have been instructed to work through hamlet officials, rather than with hamlet residents so as to strengthen the local government. Popular Force and Civilian Irregular Defense Groups especially are showing more spirit and are giving the local people more confidence in their own power.

7. Present projects include full-scale sanitation facilities for the people of Phuoc Nghia and Phuoc Ha. The people expressed their desires to the chiefs, who requested the aid of the Civic Action Team. In Hoa My hamlet, a modern market place is being constructed, utilizing GVN and civic action aid. Target date for completion is 15 October 1970.

8. A special word of thanks, again, to the BAS corpsman, who aids the RedCap effort. This project is of continual benefit to the people affected.
