PART II

NARRATIVE SUMMARY

During the month of November 1970, Headquarters and Service Battalion provided administrative, motor transport, communications, and general support to Force Logistic Command and numerous other Marine and Allied Units. The Battalion Commander and his staff continued to function in a dual capacity as Camp Books Commander and staff and as such were responsible for the many common usage facilities and functions of Camp Books, i. e. sanitation, police, maintenance, fire protection, utilities, etc.

PART III

Sequential Listing of Significant Events

1. Administration. The battalion's performance in Manpower Management System for the month of November indicated an increase in items reported and an increase in error rate from 0.0% for October to 1.0% for November. The trend was noted prior to the later part of the month and a quality control monitor system was initiated as a correction measure. The following table outlines unit performance by company.

The Combat Action Ribbon was awarded to one enlisted man during the month of November.

2. Civil Affairs. The Battalion Civil Affairs Section supported agriculture refugee relief, medical, and self-help programs in ten hamlets during the month of November.

a. In the realm of self-help programs, the section in a joint operation with International Relief Commission, has embarked on a program to relocate seventy refugee families from the hamlet of Da Phuoc (at 948787) to a less densely populated area within the perimeter of that hamlet. International Relief Commission, with some measure of assistance from this section also provided the building materials for the homes. Approximately fifty families have already moved into their new homes and more will follow as the homes are completed. This section alone has provided well rings and cement to construct five wells for the new relocation area. One of five additional wells has been completed. The other four should be completed in the near future.

b. The total cost of materials expended to support the hamlets in the battalion area was 187,460\$VN.

3. MEDICAL. The Headquarters and Service Battalion Aid Station for the month of November, rendered routine medical and emergency services to Marines from Headquarters and Service Battalion, Supply Battalion, and to Vietnamese LNC's employed by the camp. This totals well over 3,000 personnel supported. The total visits for the month were 3,126 Marines, 52 Navy personnel and 472 LNC's. Further broken down, these figures reveal 505 Marines from Headquarters and Service Battalion at sick call, 774 from Supply Battalion, and 200 LNC's for a total of 1,483 sick call visits. This was an increase of 165 sick call visits over October. In addition to sick call, 145 complete physical examinations were conducted, 471 screening physicals for personnel assigned mess duty, going on R&R, and returning to CONUS. Laboratory examinations were conducted on 813 personnel, X-Rays were taken and developed on 471, and 1,960 prescriptions were filled. Specialized consultation was sought and obtained for 128 persons and a total of 54 Marines and 1 Navy man were hospitalized. In conjunction with FLC Orders and MCO 6100.3, a weight control program was started and reports were forwarded routinely to both Headquarters and Service Battalion and Supply Battalion Commands. A total of 50 Marines and Navy personnel were assigned to weight control, 36 from Headquarters and Service Battalion and 14 from Supply Battalion. Hospital Corpamen were assigned 102 additional functions, such as, but not limited to, field operations with NCO School, convoy duty, routine exercises by companies and to S-5 for MED CAPS in local villages. Instructions in first aid, sanitation, and drug abuse was given to 217 Marines from Headquarters and Service Battalion by medical personnel and technical training provided to corpamen totaled 122 persons.

4. LOGISTICS. The Force Logistic Command Fire Department, operating the Camp Books Fire Department Complex, the Freedom Hill Fire Department Complex, and substations at both ASP #1 and ASP#2 is under the direction of Captain G. W. SMITH, the OIC, and Staff Sergeant A. L. LAWLESS, the NJOIC. During the month of November a total of 17 fire calls were responded to. Fires in heads accounted for five fires. There were four grass fires. Three incidents involving vehicles required the attentions of the fire department. Two calls having to do with electrical fires were answered. In addition there was one wall locker fire, one trash fire, and one controlled burning of batteries. Also, seven fire drills were conducted during the month. The Battalion Organic Supply Section, an integral unit of Headquarters and Service Company, processed 1062 requisitions, amounting to a total monetary obligation of \$137,739.52. In addition, 125 line items were processed for excess turn-in, a total monetary value of \$39,570.40. The Battalion/Camp Police Shed was responsible for correction of Camp discrepancies in the BAS Weekly Sanitation Inspections for the month of November. Due to a typhoon alert, preparations were made in advance of emergency storm conditions. During the month various small construction projects and carpentry repairs were carried out by the Bn Police. In regard to the base sanitation/trash removal, there was removed from Camp Books during the month of November, 224.5 barrels of wet garbage and 3377.41 meters of dry trash. Engineer Platoon made 26 separate issues of materials for various self-help projects. The electricians at Engineer Platoon made 77 electrical repairs during the month as well as performing miscellaneous minor installations. Engineers hauled a total of 81 loads of sand and gravel in November and completed six grading jobs. The platoon fabricated 699 feet of boardwalk in November. Three jobs installing drainage culvert were completed. Carpenters completed 28 jobs requiring construction and 26 carpentry repair jobs. Ten boxes were built. Plumbers made 26 plumbing repairs and adjustments and they furthermore repaired three hot water heaters.

NARRATIVE SUMMARY

Truck Company continued to provide administrative and tactical motor transport support to all elements of Force Logistic Command, specified III Marine Amphibious Force units, continued operational control of MTCC and conducted "Rough Rider" convoys in support of 1st Marine Division units.

IV-B-2

On 9 November and 10 November 1970 two FLTP's from Transport Section hauled 341 personnel from Force Logistic Command and 1st Marine Division to the Marine Corps Birthday pageant.

Local commitments included transporting all classes of supplies for battalions and attached units within the Force Logistic Command and 1st Marine Division Headquarters area. Extensive daily support was rendered to the Marine Air Freight, Purchasing and Contracting office in Danang and the XXIV Corps R and R Center/Transit Facility.

Under the OpCon of 11th Motor Transport Battalion daily fuel runs were continued to Landing Zone Baldy as were fuel runs to Fire Support Base Ross and Hill 37. During the month of November Truck Company conducted six double fuel runs from Landing Zone Baldy.

Added documents contain significant operational statistics for the month of November 1970.

The number of enlisted personnel increased greatly over the month of November. Starting out with 255 enlisted at the beginning of the month, a low point was reached on 8 November with 243, and a high point of 311 enlisted at the end of the month.

Truck Company's Maintenance Platoon continued to provide second echelon support for over 500 pieces of equipment, over 300 of which are prime movers, and also provided second echelon support for specified III MAF units. Maintenance is continuing its program of supplying one (1) sergeant and two (2) mechanics for the first echelon inspection station. Wreckers have been resumed for convoys. Maintenance discontinued providing a wrecker driver nightly to the retrograde facility, but has instituted a duty wrecker driver operating out of the maintenance office. Truck Company has sent 30 vehicles to Motor Transport Maintenance Company, Maintenance Battalion for 3rd echelon repair, with 25 of these for repairs, 3 for accident investigation LTI's and 2 for condition code LTI's. Maintenance had 247 TERO's opened during the month of November and has completed 180.

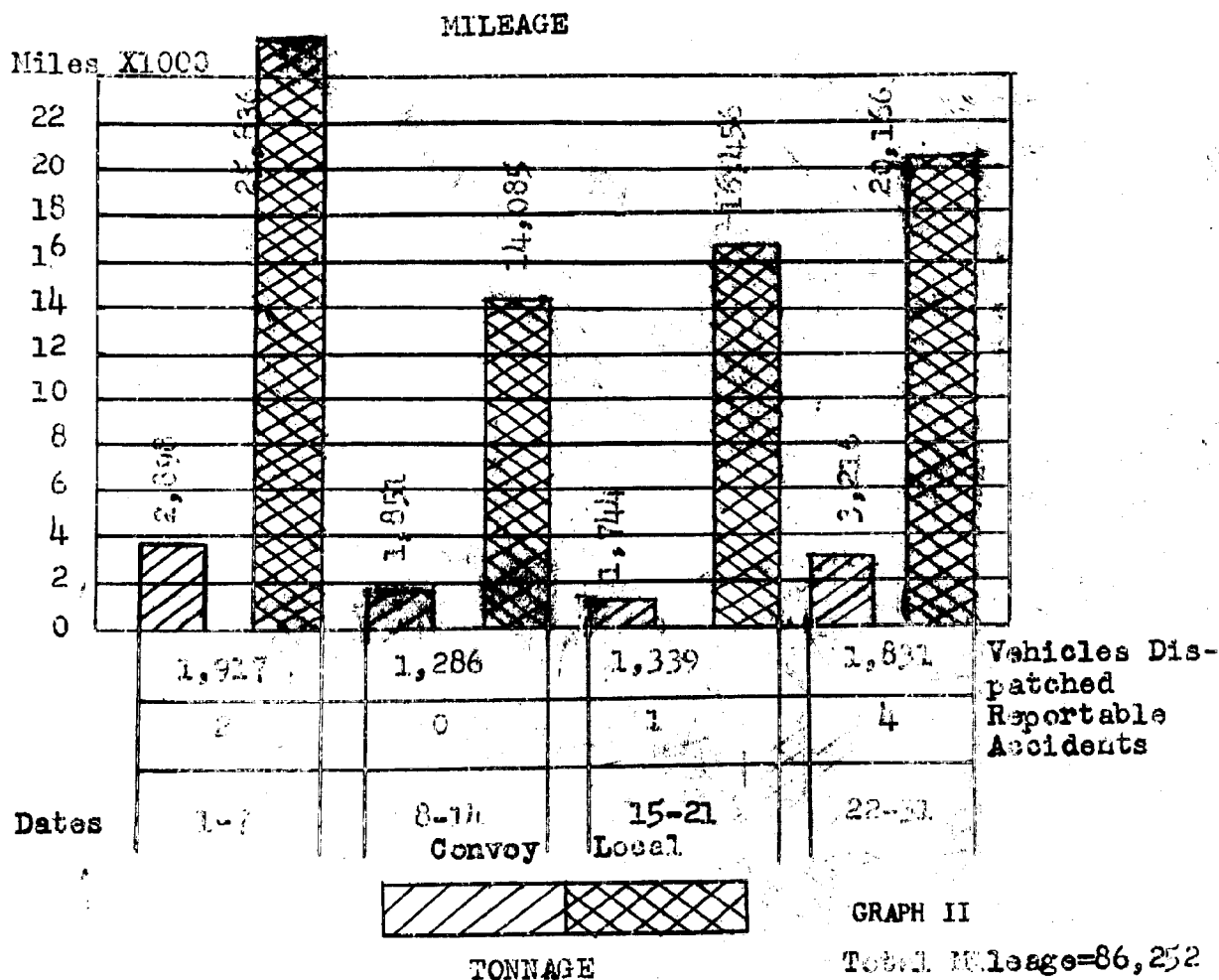

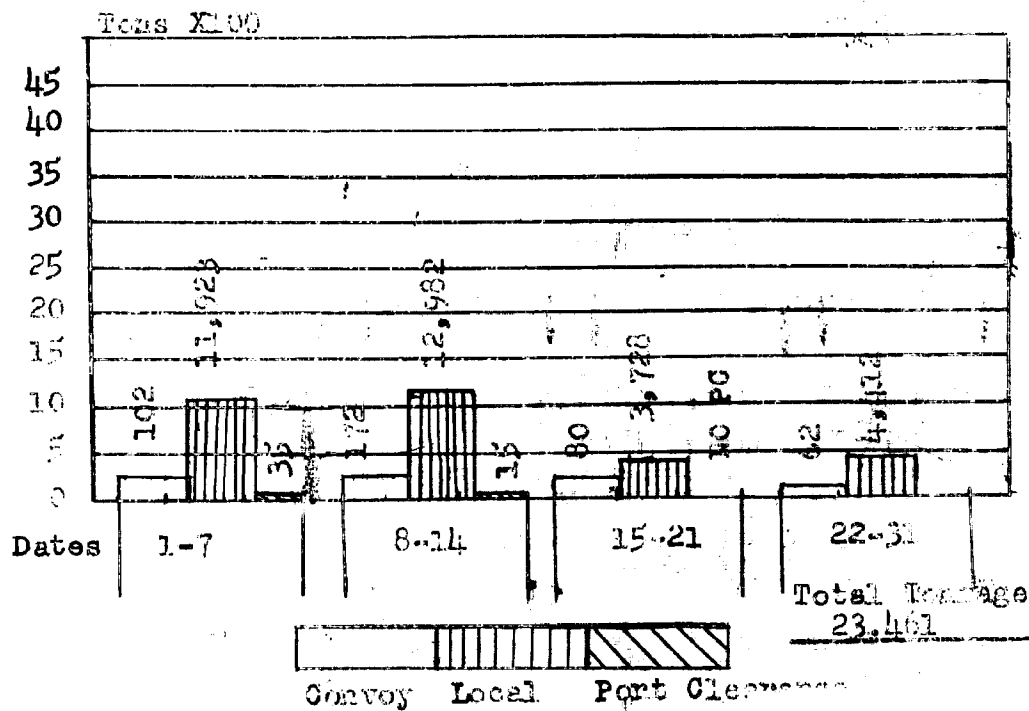

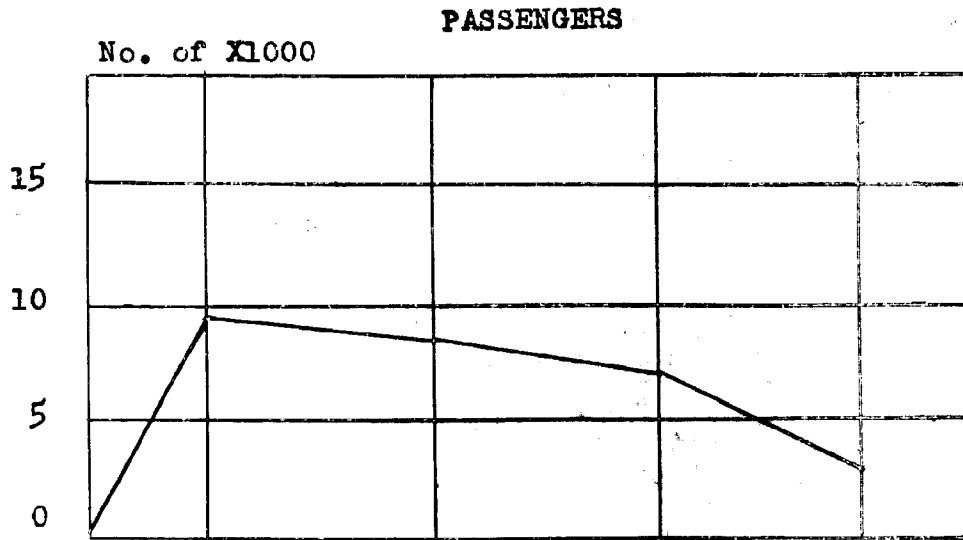

Total Mileage=86,252

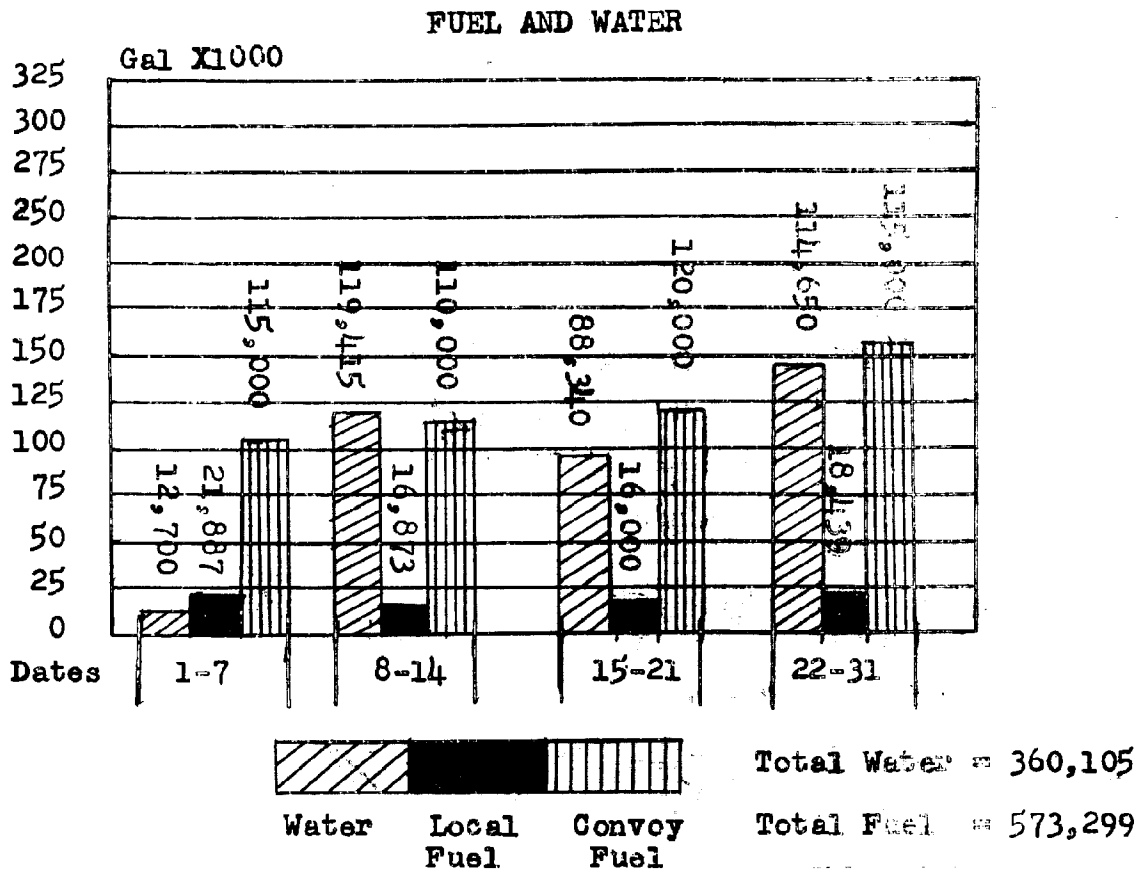

Total Passengers = 36,676

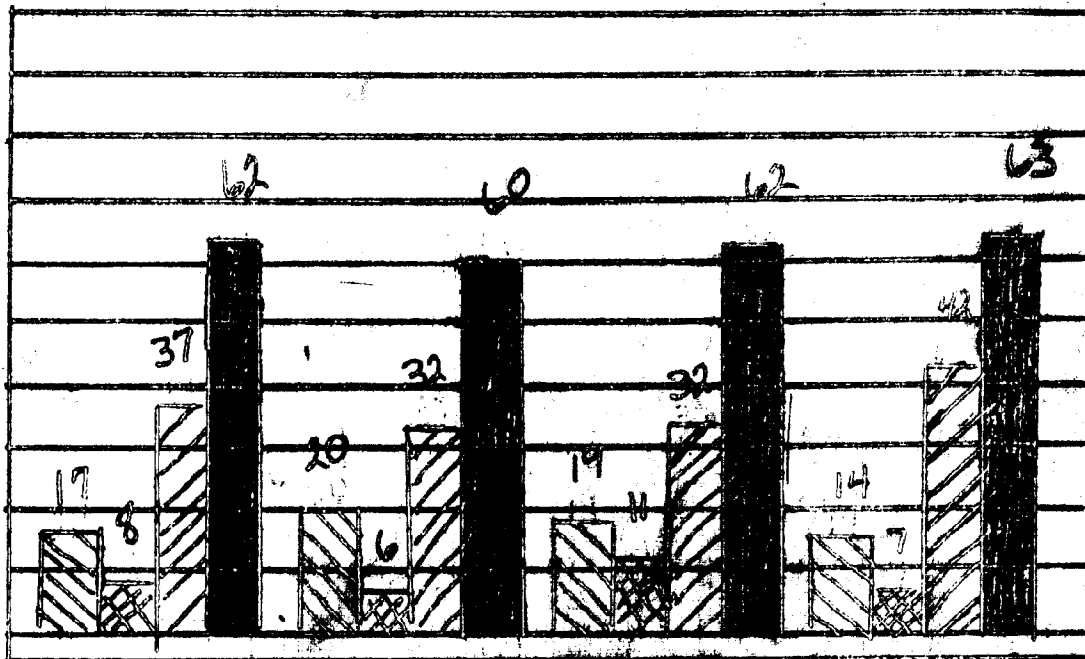

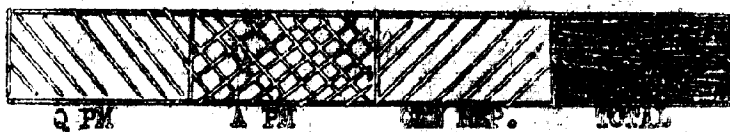
HERO'S PROGRESS 247

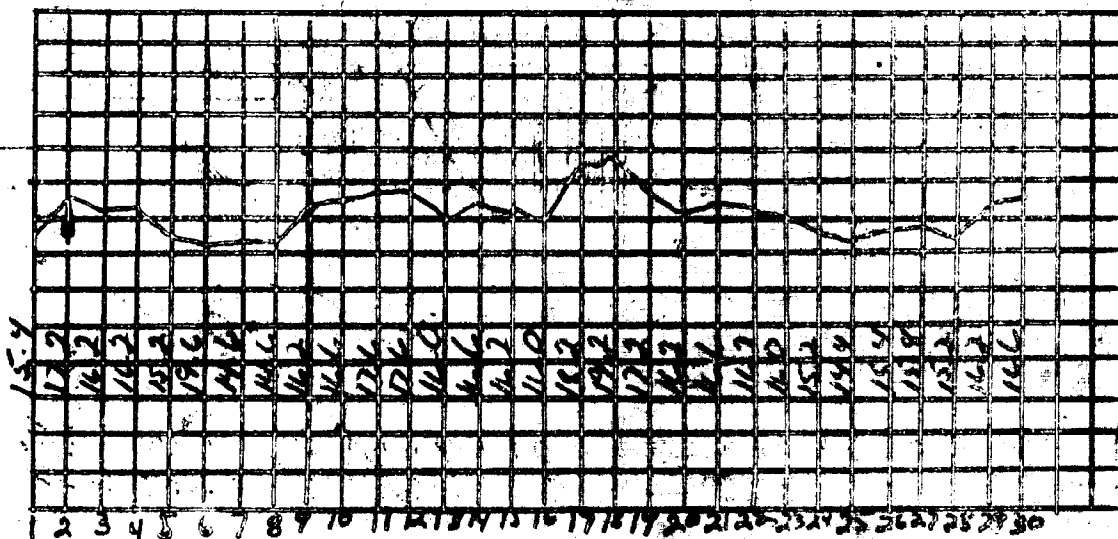

PART II

NARRATIVE SUMMARY

During the month of November 1970, Support Company performed many diversified services for the Force Logistic Command, FVMAF, and other Marine Units. The Laundry Section of Service Platoon in support of Marine units throughout the Danang area, processed 69,420 pounds of laundry, an average of 2,314 pounds per day. The 1st Medical Battalion and the Hoa Khanh Children's Hospital were the principle users of the Service Platoon's service.

The Company's Material Handling Equipment Platoon licensed 35 equipment operators during the month. Of this total 20 operators received licenses for the RKF 6000 pound forklift, 13 for the CYF 4000 pound forklift, and 2 for the Warehouse Tractor. The Platoon's equipment repair shop completed 63 work orders during the month of November. To date, 68,074 tons of supplies have been moved utilizing Material Handling Equipment.

During the month of November Communication Platoon provided communication support to all Marine Corps, Army and Navy units in the Danang North - Red Beach area. The Communication Center processed a total of 25,198 messages during November. This represents an increase of 5,497 messages and is the first month in six that an increase has occurred in message traffic. Within the Wire Section, the Dial Central Exchange (AN/TTC-28) processed 829,833 calls and in addition, a total of 31,679 operator assisted calls were handled. The Wire Section further completed 18 new installations, 146 telephone work orders, and cleared 203 trouble calls. The Maintenance Section completed 149 work orders and 227 trouble calls. The Radio Section provided and maintained required radio communication.



NARRATIVE SUMMARY

1. This month there were 92 items scrounged (the majority of these items were assemblies/subassemblies) enabling this unit to keep the deadline rate to a minimum. There were 245 demands with 63 fills for a 25.71% fill rate. For the period 31 October to 27 November there was 566 TERO's opened, and 542 TERO's completed. Open TERO's at the beginning of the period totaled 113 and at the end of the period 137.
2. Thirty maintenance contact teams were dispatched during the month, providing 294 man hours of service to supported units. The utilization of these contact teams continues to keep the unnecessary equipment out of the shops.
3. During the month this unit transferred five enlisted and joined nine.
4. One Marine received a meritorious combat promotion to sergeant; nine corporals and one lance corporal were promoted to their present ranks.
5. This unit stood a Commanding General's inspection on 16-19 November with the official results pending.
6. The change in responsible officers for this unit has been completed. Items considered excess to needs have been reported to higher headquarters, and are being staged pending receipt of disposition instructions.
7. A total of ten Marines from this unit participated in the weekly cultural tours of Danang conducted by the Battalion. These tours have been the subject of many favorable comments from the troops attending.
8. Excess scrap lumber is being turned over to the Battalion S-5 for distribution to the hamlets.



NARRATIVE SUMMARY

Bulk Fuel Platoon, Support Company, manned and operated seven (7) fuel sites (LZ Baldy, LZ Ross, Hoi An, Hill 37, Hill 34, 1st Motors, and Red Beach) dispensing 195,066 gallons of bulk motor gasoline and 277,357 gallons of bulk diesel fuel to Marine, Army, and ROK forces.

The POL Section dispensed 887 drums of packaged fuels and 3192 gallons of assorted greases, oils, and lubricants to Marine and ROK forces.

During the month of November, Ammunition Company handled 16,459 short tons of Class V (W) ammunition and 4,746 short tons of Class V (A) ammunition. The daily average for receipts and issues was 6,277 short tons.

All forces, USMC and Korean, are now drawing dairy products from Formost Dairy. Formost Dairy is now delivering milk and other dairy products to seven USMC Messhalls and one LSU.

LSU #3 is located at LZ Baldy. The LSU provides Class I and V supply support, 3rd echelon maintenance in Engineer, Motor Transport, Ordnance and Electronic commodity areas. Forklift, Laundry, RUC line and ice machine services are also provided the supported units.

LSU #5 is located at Hill 37. The LSU provides Class I and V supply support as well as forklift and laundry service to the 1st Marine Regiment.

During the month of November, Supply Battalion Civil Affairs expended approximately 20,000\$VN from military resources for Civic Action projects. During this period approximately 48 MedCaps were held. A total of 2600 patients were treated. Psyops leaflets were distributed at all MedCaps held in Supply Battalion. Approximately 2600 leaflets were distributed in this manner.

Plans for a concerted effort by all hands within the Supply Company to prepare all facets of our operation for an inventory of all R/O assets were made early in the month of November. During the month there was a flurry of activity within the Storage Platoon while materiel was moved to the Technical Research Section for identification, to PP&P for preparation for storage and back to location. As soon as all materiel was returned to location and the storage section returned to normal operations a wall to wall location verification was conducted to ensure valid location of materiel prior to the inventory of R/O items scheduled for 1 December 1970. Due to the activity in the Storage area an additional work load was placed on all supporting functions. PP&P worked against time to induct large quantities of materiel into the preservation cycle and complete them prior to the location verification. Document Control was deluged with keypunch work as a result of the verification and this unit maintained control of all backlogged Materiel Release Orders until the verification was completed and the storage system was able to process

them. The Receipts Section maintained a large backlog and were continually processing hot items into stock as received so that the materiel would be available and not frozen by the verification process. Although almost all of our efforts were directed towards preparing for the impending inventory, support of all Marine and ROK combat elements within Military Region 1 continued. Supply support remained at a relative low level and the input of new receipt also was at a low level. The major activity within the receiving area was the large volume of excess roll back materiel received from all units. The roll back started slowly at the beginning of the month and increased until now it consumes most of receiving activity.

As a result of this policy there has been large quantities of cargo being offered and shipped via commercial transportation. In an effort to maintain segregated cargo, e.g. air, surface, commercial shipping or fleet shipping, the TMO has established a staging lot where all materiel is located, the locations recorded and the cargo is readily accessible at all times. This method of staging also allows for easy control of all cargo and provides accurate inventories of cube, shipping quantities on hand, etc.

(3) PP&P in addition to the work done during the location verification completed the packing of all class IV materiel being shipped to 3rd FSR for MC/MOA and was required to pack engines, ordnance and other items being retrograded out of country by units external to Supply Company.

PART II
NARRATIVE SUMMARY

Plans for a concerted effort by all hands within the Supply Company to prepare all facets of our operation for an inventory of all R/O assets were made early in the month of November. During the month there was a flurry of activity within the Storage Platoon while materiel was moved to the Technical Research Section for identification, to PP&P for preparation for storage and back to location. As soon as all materiel was returned to location and the storage section returned to normal operations a wall to wall location verification was conducted to ensure valid location of materiel prior to the inventory of R/O items scheduled for 1 December 1970. Due to the activity in the Storage area an additional work load was placed on all supporting functions. PP&P worked against time to induct large quantities of materiel into the preservation cycle and complete them prior to the location verification. Document Control was deluged with keypunch work as a result of the verification and this unit maintained control of all backlogged Materiel Release Orders until the verification was completed and the storage system was able to process them. The Receipts Section maintained a large backlog and were continually processing hot items into stock as received so that the materiel would be available and not frozen by the verification process. Although almost all of our efforts were directed towards preparing for the impending inventory, support of all Marine and ROK combat elements within Military Region 1 continued. Supply support remained at a relative low level and the input of new receipt also was at a low level. The major activity within the receiving area was the large volume of excess roll back materiel received from all units. The roll back started slowly at the beginning of the month and increased until now it consumes most of receiving activity.

The Medical Section has been receiving numerous amounts of new items into their supply area as a result of the recently assigned duty for supply support of all medical items vice the Naval Supply Activity, DaNang. Medical Supply is also preparing for an inventory but their inventory will be a wall to wall rather than just that of R/O items.

TMO received the policy guidance which was requested on what materiel was to be shipped and what cargo was to be held for fleet shipping. As a result of this policy there has been large quantities of cargo being offered and shipped via commercial transportation. In an effort to maintain segregated cargo, e. g. air, surface, commercial shipping or fleet shipping, the TMO has established a staging lot where all materiel is located, the locations recorded and the cargo is readily accessible at all times. This method of staging also allows for easy control of all cargo and provides accurate inventories of cube, shipping quantities on hand, etc.

PP&P in addition to the work done during the location verification completed the packing of all class IV materiel being shipped to 3d FSR for MO/MOA and was required to pack engines, ordnance and other items being retrograded out of country by units external to Supply Company.

The Retail Clothing Outlet conducted business as usual during the month and was visited by the Field Supply Analysis Team during the latter part of the month. The Clothing Section is now in the process of correcting all discrepancies noted during the FSAO visit.

With the inventory being conducted on 1 Dec 1970 the company ended the month maintaining strict control on all activities within the storage complex to ensure a valid inventory is obtained.

A project was started, dubbed Project Yellow Tag, during the month which will ensure that all materiel of a mechanical nature that is not in a sealed container is in a ready for issue condition. Simply stated all materiel will be visually inspected by warehouse personnel and items found not in a sealed container will be reported to a special team who will tag the materiel thus freeing it from issue and obtain the services of maintenance personnel to perform a serviceability check. If found to be A or B condition codes it is sent to PR&P for proper protection. If other than condition code A or B it will be reported to the Central Control Point requesting disposition instructions.

The Retrograde Facility was relatively quiet during the month with most activities confined to preparing retrograde materiel for anticipated shipping during the forthcoming month. A pilot project of loading bomb pallets and associated materiel was initiated within the Retrograde Facility. Previously this had been done at the MAG-11 Bomb Dump by personnel from Retrograde and proved to be totally inadequate due to the limited loading facilities available. The pilot project worked extremely well and a request was made to higher headquarters to have the entire procedure changed so that all loading is done within the Retrograde Compound.

7. The Marine Corps Birthday was celebrated by all hands as ceremonies began at 1100 at the enlisted mess and 2030 in the officers mess. All activities were forced inside as a result of extremely heavy rains received throughout the day.
8. The Commanding General, Force Logistic Command visited PR&P Shop #4, Warehouse B-4 and B-5 on 11 Nov 1970. In the afternoon the Commanding General visited Deep Water Pier, DaNang.
9. On 12 Nov Lieutenant General SOUTHERLAND USA, Commanding General XXIV Corps and the Commanding General, Force Logistic Command visited the Supply Company Area.
10. On 20 Nov Project Yellow Tag was initiated within Supply Company.
11. Typhoon PATSY caused work to cease while Supply Company prepared for anticipated high winds and heavy rains.
12. On 25 Nov the Field Supply Analysis Team arrived and began a review of the Retail Clothing Outlet procedures.
13. An abandoned M151A1, USMC Number 358435, was found on a storage lot on 26 Nov and turned over to the Supply Battalion Motor Pool.
14. A GAO representative visited the TMO office on 29 Nov to discuss retrograde shipping.



FLC Marines Aid ARVN Vet After House Fire

DA NANG — Fire destroyed the home of one of Phuoc Tan hamlet's most respected residents recently.

But Nguyen Khanh, 40, a 16-year ARVN veteran who was discharged after he stepped on a land mine and lost the lower half of his left leg, didn't go for long without a home.

"He lived in a lean-to for a couple of weeks until we could get him enough lumber to build a new house," said Maj. Wayne V. Bjork, Civil Affairs Officer of Supply Bn, FLC.

After civic action personnel secured enough lumber, it took Khanh and the 75-year-old man who lives with him only a week to build a new house, much sturdier than the one destroyed by fire.

In the same hamlet, one of 10 in Hoa Khanh village of which Supply Bn.'s civil affairs personnel are charged with the Vietnamization program, construction on a new meeting hall and office building has been recently completed.

Hamlet people, supervised by the hamlet chief, built the meeting hall with lumber and concrete supplied by the civic action Marines.

Texas-Sized Donations Big Boost To MEDCAP

DA NANG — Hundreds of bars of soap and numerous non-prescription medicines are being distributed by a Navy hospital corpsman to inhabitants throughout the 10 hamlets of Hoa Khanh village, eight miles northwest of here.

The goods are a gift from the people of Sweetwater, Tex., hometown of HM-3 Joe D. Jeffrey.

HM-3 Jeffrey is assigned to

the civil affairs office of Supply Bn., FLC.

Recently Jeffrey sent a letter to his mother requesting that she ask people to save used bars of soap they would normally discard and send them to him.

He also asked his mother to let people know non-prescription medicines such as cough drops, cough syrup and antiseptic ointments were needed.

The response was astounding. Soap and medicines began to pour into Mrs. Jeffrey's home. From there they were packaged and sent to Jeffrey to distribute to the people of Hoa Khanh village when he conducts MEDCAPs.

Jeffrey's first shipment included 450 new bars of soap and four boxes of non-prescription medicines.

"And more are on the way," he said.

The project, fittingly for Joe Jeffrey, has been named J. O. E. (Join Our Efforts).
