2. Sequential listing of significant events, as they relate to:

a. Personnel. 1 officer and 1 enlisted were on emergency leave during this reporting period. 21 Marines from the Company made use of R&R quotas to Hong Kong, Bangkok, Saigon, Manila, Okinawa and Tokyo. One problem area which arose during the month concerned individuals sleeping on post. Three Special Court-Martials resulted from these offenses. To prevent such incidents from recurring, the guard was supplied coffee throughout their watch period. In addition posts were physically visited more often and TA-1's were installed in bunkers to facilitate reporting and enable more frequent checking of posts. Regimental Bulletin 5510 was also published setting forth more specific requirements for the guard. Finally, strong emphasis was placed on small unit leadership, a special services program, and availability of varied duties and liberty.

b. Combat Operations and Training. During the month of February the two provisional platoons formed within Headquarters Company were extensively utilized in the combat role of occupying defensive positions within the 1st Marines TAOR. Training emphasis was placed on combat intelligence, command post defense, land mine warfare, individual protective measures, and character guidance.

c. Logistics. In the logistics field the following were noted relative to motor transport and supply:

1. During the month of February 1966 Headquarters Company vehicles drove a total of 9717 accident free miles. There were no major maintenance problems encountered during this period. The present preventive maintenance system for vehicles, adopted upon arrival in Chu Lai last month has worked satisfactorily and has kept the wear on high usage parts i.e., brakeshoes, brakedrums, wheel cylinders etc, down to a minimum. Strong emphasis has been placed on driver maintenance, which has resulted in minimum breakdowns. At present no Headquarters Company vehicles are on deadline for motor transportation maintenance.

2. During the month of February, Headquarters Company submitted 482 requisitions. All but one of these requisitions was priority twelve or seventeen. Particularly noteworthy were the 55 in-kind clothing requisitions, of which more than 50% were filled within two days. The Quarterly Obligation listing was completed on 25 February along with FSA-C1. Headquarters Company requirements for tentage were met when fourteen General Purpose tents from 3rd FSR were received. At present there is adequate tentage for Headquarters Company. FSA-A2 began operations for the Chu Lai enclave, and it is expected that Headquarters Company will soon see a vast improvement in the lead time of all requisitions.

1. As directed by reference (a) the 2d Provisional Platoon moved to BT 529105 18 February and assumed defensive positions as directed by 2d Platoon, Company M, 3d Battalion, 7th Marines.
2. The first night passed without incident. However at 2130 19 February movement was seen at coordinates 529105. After throwing two hand illumination grenades approximately 25 rounds from M-14's and 30 rounds from M-60's were expended at sighted movement.
3. At 2245 19 February movement at the protective wire was again seen. Person was challenged and one illuminating grenade was thrown. One M-14 round was then fired at the movement. At that point 5 rounds of small arms fire was received from BT 523108. The platoon returned the fire with 30 rounds and called for 81 illumination. Patrol then went forward to check wire, and nothing was found.
4. At 0100 20 February movement was again observed at BT 522106 from which the platoon received 5 to 7 rounds of small arms fire, and 8 to 10 rounds were returned. At first light a patrol searched the area and observed blood splashes leading away from the wire.
5. The platoon returned to the 1st Marines CP at 1700 20 February without further incident.

1. Purpose. To set forth liberty regulations governing the personnel of Headquarters Company, 1st Marines.
2. Background. Because of the geographical location and tactical situation within the 1st Marines TAOR liberty, by necessity, is very limited. When liberty is granted it will be the responsibility of each Marine to conduct himself in an exemplary manner as directed in references (a), (b), (c), and this directive.
3. Authorized Areas. When liberty is authorized runs will be made to other unit clubs and the hamlet of An Tan.
4. Liberty Hours. Liberty hours will go at the following times:
  - a. An Tan - 1300 - 1600 Saturday and Sunday
  - b. Unit Clubs - 1830 - 2100 Wednesday
5. Procedure. A Marine desiring to go on liberty at one of the above listed times will first obtain approval from his section. Section chiefs will then submit to the company 1stSgt the number and the date of those going on liberty from their section. This information will be forwarded two days prior to the actual liberty run in order to facilitate transportation arrangements.
6. Supervision. One Staff NCO will be in charge of each liberty run. It will be his responsibility to ensure his liberty party is thoroughly briefed on the regulations set forth in references (a) and (b). He will further ensure that all members of the party are returned to the 1st Marines CP no later than the times indicated in paragraph 4 above.







1. Purpose. To establish a procedure whereby the subject platoons can be quickly deployed within the 1st Marines TAOR.

2. Background. Because of the fluid tactical situation within the 1st Marines TAOR it may become necessary at various times to supplement front line units with additional Marines. In view of the above, two provisional platoons have been established within Headquarters Company, 1st Marines to provide subordinate units support on a 30 minute call basis.

3. Organization. The subject platoons will be organized as cited on enclosures (1) and (2). The 4th Squad will contain one machinegun and one rocket launcher. In addition to those Marines listed on the above cited enclosures it will be the responsibility of the Communications Officer and the Medical Officer to provide one radio operator and one corpsman respectively for each platoon upon their deployment.

4. Action. Upon receipt of word to deploy a provisional platoon, the Headquarters Commandant will alert the platoon on standby to be prepared within 30 minutes to be transported either by truck or helicopter to the objective area. Exact instruction as to their deployment and mission will be given in the form of a frag order prior to departure from the 1st Marines CP. Should the need arise for both platoons to be deployed, the second platoon must be prepared for departure within one hour after notification.


5. Duty Assignment. To prevent Marines in the duty provisional platoon from leaving the area on liberty or varied assignments, enclosure (3) is established to ensure their ready availability for 30 minute deployment. When on duty status those Marines in the provisional platoon noted on the dates of enclosure (3) will remain in the CP on the day indicated.
