Part II

Narrative Summary

1. Personnel. One officer and four enlisted personnel completed overseas tours and rotated to COMUS. Fourteen members of this company made use of R&R quotas to Manila, Bangkok, Taipei, Tokyo, and Hawaii. Eleven Lance Corporals were promoted to Corporal. Five members of this company extended overseas tours and took special 30 day leave.

2. Combat Operations and Training. The C.P. was harrassed on seven separate occasions by small arms sniper and one hand grenade, resulting in no Marine casualties. No Viet Cong casualties reported. Improvements continue to be made on the C.P. perimeter in the form of additional wire and lights. The Combined Action Team continues to live and operate in Duong Son (2). Listening Posts, patrols, and ambushes continue to be run. Indoctrination was conducted for all personnel joined during reporting period.

3. Logistics.a. Supply

(1) During the month of January, this organization submitted 564 requisitions, of which, 5 were a priority 02, 45 a priority 05, 288 a priority 12, and the remaining 226 a priority 17.

(2) Quantities of material on hand was sufficient to satisfy 70 per of the recurring demands received. Shortages are on valid priority requisitions. Tracer action has been initiated where the circumstances were
