



SYNOPSIS

26 Sept - At 0655H G/3 at BT 000642 sew a VC with rifle run into hamlet (BICH NAM(2)) of BT 000639; he was taken under fire with small arms and wounded. During the period 0700H to 1200H homlet was swept with dogs, PF's, and a psychological werfere unit while Echo and Golf Compenies surrounded it. At 1040H 1 of the CHIEU HOI's was overcome by gas and med-evoced. Later he returned and pointed out 2 VCC and 1 VCS from the group of 6 women detained during the sweep. Results of the action were 1 VC WIM, 2 VCC, 1 VCS; 1 tunnel and a mine destroyed; essorted clothing, a punji stake, and 2-3.5" rockets were found and returned to Bn CP. At 0915H F/3 at BT 043599 spotted 2 VC at BT 041598; they were fired on and the patrol swept the area with negative results. At 0945H G/3 st AT 989642 received 1 round of sniper fire from AT 993633; it was returned by 7 rounds of 60mm mortars. The sniper fire ceased. At 0950H H/2/A patrol at BT 028586 received 3-5 rounds of small arms fire which was answered by 50 caliber, 3 M-79 rounds, and small arms fire. The patrol continued its mission while roceiving sporedic fire. Ares was checked with negetive results. At 1245H F/2 at BT 027634 surprised 2 VN meles on a trail end they ren from them; the patrol pursued but was

emable to apprehend. Later 1 VN male returned on e bicyclo and was questioned and released after he was identified as an ARVN. At 1305H F/1 at AT 997633 was moving from blocking position when they were fired on by 3 sutemetic wespons from AT 999 628, AT 994628, and AT 996626. Fire was returned. with a heavy volume of small arms, machineguns, 106RR, and artillory; VC broke contact and fled in unknown direction. Platoon continued mission. At 1530H H/3 CP observed a body floating in the SONG DIEN BINH river with a badly burned torse and 1 leg missing. It opposed to have been dead for several days. In attempt to retrieve the body feiled and the matter was reported to DIEN BAN District Headquertors. At 2115H H&S reported 15 rounds of small gras fire were taken at the POW tent from BT 011622. The prisoners were moved to a more secure position. The 81mm morters were leid on the sniper's position should firing resumo. However, they were not fired. There were I plateon search and destroy patrol; 5 platoon and 2 security potrols; 2 pletoon and 2 squed embushes; 4 listening posts; and 4 observation posts during this period.

27 Sept - At 0500H Foxtrot Co with 2 scout dog teams, engineers, and an interpretor accompanied a Woman from the Bn CP (BT 015627) to her hemlet (BT 011607) to search out any VC end to find the women's children. At 0710H l lone sniper round struck a Marine resulting in 1 WIA: F/l-plotoon with dog teem, interpreter, VCS, Company Command group, and ebgineers conducted s sweep of the village. Women identified her house st BT 011607, but the children were not there. Search was continued and the secut dogs slerted the petrol to a house at BT 012606 where the 2 children were found slong with 4 VN women and 10 other children. The other women were questioned, but no further information about weapons, personnel, mines, or supply osches could be sttsined. At 0918H s tunnel was discovered searched, and destroyed at BT 011606. A bemboo bridge located at BT 010606 was discovered. A search of the village continued until 0958H with negetive results. At 1050H E/2 petrol at BT 032624 observed a man running into & treeline approximatly 100 meters to the south. The men was wearing green clothesend a pack; no helmet or weapon. The patrol fired small arms and an M-79; a squad swapt the area with negetive results. At 1420H G/1 at BT 012647 had 1 grenade thrown at the rear of the column which resulted in 1 minor WIA. The petrol returned smell erms and M-79; eres was checked with negetive results. At 2030H the Bn CP (BT 015627) received several small orms rounds from BT 002622. 10 rounds of 81mm morters were returned. The small arms fire coased. At 2125H E/3/B in embush position at BT 013618 captured 2 VCC without weepons weering white PJ's. They were traveling east slong the trail with a 2 minute interval between them. They were taken to the RF compound at the THANH QUIT Bridge for the night. The embush was rolocated. At 2130H the Bn CP (BT 015627) received several rounds of smell erms fire from BT 002622. The fire was appearently provoked by the Psychological Warfare loudspeaker broadcast from the Bn CP. Fire was roturned by 81mm morters and 2 106RR's silencing the sniper fire. At 2240H H/1/A as it moved clong & rice peddy dike et BT 041582 was attacked by an unknown number of VC using smell orms and hand granades. The petrol returned fire while calling in an 81mm mortar mission which had good target coverage. The VC broke contect and fled in an unknown direction; the patrol returned to the Hotel CP with 1 WIA and prepared to move out over different route to embush position.

There were 2 Platoon search and destroy patrols; 5 platoon and 1 squad security patrols; 3 platoon ambushes; 4 listening posts; and 4 observation posts during this period.

At 0830H Echo 3 had a patrol member trip a M-26 granada rigged as a mine with a trip wire attached to a bush at BT 032634. The patrol hit the dack and no casualties resulted; the patrol continued on its assigned mission. At 1130H E/3 patrol at BT 021628 was attacked by an unknown number of VC from the vicinity of BT 024623 and BT 026619.

About 10 rounds of sutometic end semi-sutometic wespons Tire were received wounding 3 lerines. E/1 and E/2 with the Echo command group deployed from the Bn CP to exploit the contect with the enemy. in 81mm and artillory mission was called in on enemy a position. In the face of superior numbers the VC broke contect and fled in unknown direction. One VCS was captured and returned to the En CP. At 1243H E/1 ot BT 020622 received 2 rounds of sniper fire from BT 020611 and returned it with small arms and 60mm morters. Area was swopt with negative results. At 1515H Echo Co while in process of conducting a sweep at BT 024616 received small arms fire from across the SONG THANH QUIT river at BT 028615 wounding I Marine. Artillory, 81mm morters, and organia weapons were fired and the enemy's fire ceased. 29 Sept - At 0700H ANDERSON TRAIL road completed with negative contect. At 0935H F/l PPB security patrol found an unoccupied grass but at BT 051,606 containing wire, lights, and 29 new BA-279 batteries. The material was picked up and area was searched with negative results. At 1020H F/l patrol at BT 028621 moving on a trail through


SYNOPSIS

30 Sept - At 0945H F/2/B in embush position at BT 008 617 had 1 VC move into killing zone carrying a M-72 which detonated when hit. - 1. In accordance with reference (a) Enclosure (1) is submitted.
- 2. This operation demonstrated the 2d Battalion's capability of shifting from a defensive posture to the offensive swiftly and efficiently. Initially the 2d Battalion was to provide blocking forces for an ARVN search and clear operation but after contacts were made on 2 September the operation evolved into a three (3) company reinforced search and destroy operation. This rapid reaction had a marked effect on VC units operating in that portion of our TAOR.
- 3. Significantly, the A/O and Marine Air Support contributed greatly to the success of this operation. During the operation Marine Air is credited with 36 VC KTA's. The ever present A/O took away the VC's capability of undetected movement. Additionally, the A/O was able to control fixed wing and artillery missions which materially increased the VC casualties is 36 KBMA, 33 KBGF.

- The secretary Sold . . . The major support in this operation was provided by 1st Bn, 11th Marines and elements of the 3rd MAW,
- b. Artillery support played a major role in assisting the conduct of the ground operations and in exploiting targets of opportunity. The use of an eirborne artillery FO in exploiting VC sightings in the vicinity of GS's AT 9959, AT 9958 and BT 0060 was particularly effective and accounted for a good percentage of the probable VC casualties. Throughout the operation, artillery was generally responsive and effective.

- c. Helicopter support played a vital role in the resupply and movement of the ground troops. On 2 September the troop lift of Company G from the vio AT 998611 to the LZ in vicinity BT 005596 was late in execution. This delay fortunately was not vitel and was caused by the initial lete arrival of the helicopters and initial inability to communicate. Once the fixed wing siroreft, the TACA, and the helicopters were in communication the lift was executed. The insbility of 3rd MAW to provide for the troop lift of Foxtrot Company on the morning of 3 September caused this portion of the operation to be deleyed 24 hours.
- d. Close air support throughout the operation was both effective and responsive. In all cases, it was controlled by a TACA.

7. Intelligence

- e. Enemy. The estimated VC strength in the area of operations is 200 to 300.
- (1) The mojority of contact consisted of sniper fire from 4 to 5 VC with automatic weapons.

(e) 020911H. Elements of Golf Company waiting in LZ, vicinity AT 998611, received automatic weapons fire from vicinity AT 996608. Fire was returned with small orms and 81mm morter mission was called. Enemy fire was suppressed.

- (b) AT 020915H. Golf Company while at their helicopter pick up point (vic AT 998611), received heavy automatic weapons fire from vicinity AT 992609. Fire was returned with small arms, M-79 rounds and artillery. Contact was broken by the VC.
- (c) 020920H. Golf Company landed vicinity ET 005596 via helicopter and upon landing received .30 Cal MG and small arms fire from vicinity BT 003597. An air strike was called and enemy fire was suppressed.
- (d) 021000H. Golf Company swept hamlet vicinity BT 003597 and found a great deal of blood in the huts. As Golf Company moved into the hamlet, the AO on station observed a group of VC fleeing in a westerly direction. An air strike was called and there was excellent coverage of the target resulting in 5 KBA (probable).
- (e) 021210H. A0 observed approximately 15 VC in vicinity AT 992600 and an artillery mission was called. A0 observed a direct hit on fleeing VC resulting in 9 KBA (probable).
- (f) 021300H. At observed a VC unit (vic AT 991585) fleeing in a southerly direction. An air strike was called, resulting in 10 KBA (probable).
- (g) 021350H. A0 observed a VC unit in the vicinity AT 993609. An air strike was called with A0 observing good effect on the target, resulting in 6 KBA (probable).
- (h) 021700H. Echo Company (BT 01860h) observed 3 VC in vicinity BT 015609 and called 81mm morter mission. Coverage of the target was excellent and the VC disappeared.
- (i) 031030H. Golf Company (BT 005595) received 2 sniper rounds from vicinity BT 012595. Fire was returned with small arms and M-79 rounds. VC broke contact.
- (j) 031910H. Golf Company located vicinity BT 004603 observed 5 VC vicinity BT 003600. The AO on station controlled an air strike on target with good coverage. Results were unknown due to darkness.
- (k) 032030H. Golf Company (BT 003598) called an artillery mission in on 4 snipers vicinity BT 003602, and on 3 snipers vicinity BT 003604. There was excellent coverage of both targets and the sniping dessed.
- (2) The VC withdrew on each occassion leaving small units with sniping and heressing missions. The VC are capable of massing company size units and defending an area of their own choice. These units can be reinforced by the Q-15 Company (operating in the vicinity of GS 0061) and one unidentified battalion (operating in GS 9859). Estimated VC losses during the operation were 57 KIA (probable).

- b. Terrain. The area of operations is characterized by flat delta land with numerous rice paddies.
- 8. Mission. To provide blocking forces for the 1st Bn, 51st ARVN Regt (-) and 39th ARVN Renger Battelion and to conduct comp. y size search and clear operations either unilaterally or in coordination with ARVN forces.
- 9. Concept of Operations. Initially 3 companies provide the blocking forces with one company in reserve. Company H provides block along north bank of SONG CAM LAN River from vicinity GS 0156 to GS 0455; Company G provides block on the west vicinity GS 0160; and Company E blockson north bank SONG THANH QUIT River vicinity GS 0160 and GS 0261.

10. Execution

Programme Company

- a. 2 September At 1600H Operation H-149 changed to Operation TROY. At 1700H Echo Company at BT 015609 reported enemy movement at BT 018604; Simm morter mission was called resulting in 3 probable VC KBA's. At 1930H F/1 with EOD support team was held lifted into vicinity AT 991588 to search for dud 500 lb bombs. Received heavy automatic fire from south, west, and east and called extensive artillary prep fire prior to attempting insertion. One held was shot down and burned; troops, EOD personnel and crew was extracted while aircraft on station provided air support. Burning held was destroyed by satchel charge.
- b. 3 September At 1030H Golf Company received 2 sniper rounds from BT 012595 and returned fire with small arms and M-79 rounds; results were I U.S. WIA who was med-evaced. At 1340H AO observed 3 VC in village containing extensive fighting holes throughout. As artillery mission was called; VC took evasive action and move into tree line at AT 981589; they were weering green and block clothes and carried web gear. Rounds hed good coverage of target, but body count was impossible due to dense foliage. At 1500E Foxtrot Company at BT 024634, while conducting reconsissance for Operation TROY, observed 3 VC with weapons approximately 300 meters from their position. village was swept and 3 freshly dug transhes were discovered and distroyed; there was no further contact. At 1745H Golf Company at BT 003597 received sniper fire from BT 010598 and countered with small arms. No casualties resulted. At 1910H Golf Company located at BT 003600 observed 5 VC at BT 004603. AO on station controlled air atrike consisting of 20mm cannon fire and 5" ZUNI rockets, no body count was possible due to darkness. H/1/A patrol at 1945H received sniper fire from northwest of their position (vio AT 998553) and returned fire with small arms and 4-60mm mortar rounds; sniper fire ceased. Golf CP at BT 003598 received 15 rounds of sniper fire into their perimeter at 2030H; a fire mission was called on sniper positions at BT 002602 and BT 003604. There was excellent

coverage of target and sniping cassed. At 2145H Echo Company received 60-75 rounds automatic fire from vicinity BT 020613 and returned fire with 19 rounds of 60mm morter and 5 M-79 rounds were fired. Results were unknown.

d. 4 September - At 0930H Golf Company received sniper fire from AT 993593 and eir strikes were called using 20mm cannon, napelm, and bombs against enemy positions. Although good coverage of target was noted, results were not known. Smoke was seen, however, coming from opposite side of the bank on which bombs were dropped indicating a tunnel network; Golf Company socrohed area with negative results. There was one marine injured slightly. At 1600H H/1 patrol at AT 995580 received sniper fire from AT 995580; it was returned with M-79 and small erms; troops were unable to sweep area due to H/1 remaining in position as ordered. At 1700H H/I at AT 992577 took sniper fire from VC in but at AT 998582 and ONTOS returned 106RR fire at aniper's location; sweep of position was out short by Golf Company's 81mm morter mission on same target controlled by AO. Results were 3 probable VC KIA's. At 1800H Golf Company CP, while ewaiting helo lift, received sniper fire from AT 985582; gunships mede runs along with fire support from ground troops. Fixed wing made 20mm cannon runs and dropped napalm. Upon complotion of sir strikes, artillery mission called; results were 3 U.S. WIA's; 2 minor and I serious with stomach wound: I heat cesualty was also evacuated. At 1830H Operation TROY terminated,

a. Friendly Personnel and Equipment

- e. Logistics. There were no logistical problems encountered during the operation. Resupply was accomplished by both helicopter and vehicular means. Med-evecs were removed and sent to either Battalian Aid Station or "C" Company, 3rd Med Bn by helicopter.

- (1) Battle casualties 0 KIA & 18 WTA.
- (2) Non Battle casualties 2.
- (3) Special problems. None.
- c. Communications. No problems encountered.
- 13. Special Equipment and Techniques. None employed.
- 14. Commander's Analysis. This operation confirmed heavy VC infiltration in the general areas GS's 9958, 9959, 9960, 0059, 0060, 0260, 0361 and 0261. While both of these general areas are populated to one degree or another, the populace is definately VC orientated. Military age males are not in evidence; one old man and a few women and children occupy the hamlets during the day. Their apparent mission is to provide early warning of the approach of government troops and to deter further destruction of the hamlets. The military age men are hiding in well-concealed caves and tunnels.

15. Recommendations

The state of the s

The enemy forces moving through or harboring in these areas have not shown any willingness to stand and fight marine units. When marine patrols approach the area, the enemy harasses by long range sniper fire and deters vigorous pursuit by emplacing mines and in this manner he is able to evade solid contact. The experience of 2 Sep 66 when G Company executed the helicopter landing and assault of the hamlet flushing the VC into a hasty retreat was a fine example of how to kill VC in this environment. Although the VC again showed no inclination to really stand and fight and again commenced his usual "fade into the distant tree line", the combination of the sudden entry of marine forces and the all important OE on station made the difference. The VC no longer enjoyed the relative immunity normally afforded him when pursued by ground forces alone. Air was able to keep the VC under surveillance and by proper use of artillery and fixed wing kept the enemy in retreat inflicting heavy casualties along the way.

b. An occasional, well-planned operation of this type with all of the necessary assets and based on timely intelligence will do far more to damage the VO in this environment than regular patrolling and is a better atilization of Marine forces.



1. In accordance with reference (a) Englosure (1) and the following comments are submitted:

s. The Commander's commants and recommendations are concurred in by this command.

b. The success attained in Operation CANKON can be attributed to the close cooperation between Marine ground and air elements. This cooperation was amply demonstrated on 9 September when the ground units flushed a large YC force and the serial observed directed a fixed wing strike on the fleeing WC. This strike resulted in 10 KIA (confirmed and 19 KIA (probable). It is strongly recommended that the Marine AO capability be expended, so AO support can be made more readily available to infantry units.

c. If employed properly, the stay behind ambush can produce notworthy results. In addition to an ambush force, artillary concentrations sust be plotted in and around the vacated CP, and the embush force must have the capability to direct these fires. Although no contacts were made during this operation, it is falt this tentic should be employed on future operations.

a. The major support in this operation was provided by 1st Bn, 1lth Marines, 12th Marines and elements of the 1st MAW.


b. Artillery Support

- (1) During the operation, "C" Battery, 1st Bn, 11th Marines displaced 2 platoons to DIEN BAN to provide direct support, and the 11th and 12th Marines were in general support. During the entire operation "C" Battery demonstrated a high level of proficiency and professionalism by placing rounds on the target quickly and accurately.
- (2) Direct support batteries fired 507 rounds on 33 observed mission, 588 rounds on prep fires and 276 rounds on 43 H&I targets.
- (3) Other supporting batteries placed 110 rounds on observed targets and H&I's.
- (4) An organic section of 81mm mortars fixed 56 rounds on 4 observed missions, 200 rounds for prep fires, and 563 rounds on H&I targets.

c. <u>Air Support</u>

- (1) Helicopter support was effectively used for resumply each day and no problems were encountered during resumply. Helicopters were also used extensively for medical and VCS evacuations. No helicopters were damaged by enemy fire during the operation. On 12 Sept M/G-16 provided 8 UN-34's for a total extraction of 2nd Battalion, 1st Marines elements. This extraction was held up 45 minutes by the late errival of escort aircraft from CNU LAI.
- (2) Air observation was used extensively each day with a UH-IE strike 10 Sept resulting in 1 KBA. A USAF OE controlled several airstrikes on 9 Sept resulting in 11 KBA (confirmed) and 10 KBA (probable), and the scattering of approximately 50 VC. These VC were moving west after breaking contact with our ground forces and only could be spotted by an AO.
- (3) Fixed wing support by 1st MAN was late in arriving on 9 Sept for a river crossing prep. When it did arrive, the fixed wing was used for preps of VC strongholds in our line of sweep. One prep was controlled by an FAC with Fortrot Company, all other fixed wing support was controlled by a TACA.





- a. Enemy. The estimated VC strength in the area of operations varies from 200 to 500.
- (1) The majority of the contact in the area of operations consisted of sniper fire from small groups of VC armed with carbines.
- (a) 071513H. Battalion CP received approximately 3 rounds of sniper fire from coordinates 3T 053512. No fire returned, 1 friendly KIA.
- (b) 071830H. CP group received 1 round of sniper fire from BT 053513. Returned fire with 3 rounds 60mm mortars. Enemy broke contact.
- (c) 081135H. F Company at coordinates BT 032523 received 3 sniper rounds from unknown coordinates. 5 VCS were captured after they were seen helping 2 men into a tunnel. Smoke thrown into tunnel with negative results. VCS forwarded to district with PF forces.
- (d) 081400%. Echo Company point at coordinates BT 029522 received approximately 4 rounds of sniper fire from west of position. Fire was returned in the snipers general direction with negative results. I friendly MA, and one man suffered a sprained ankle.
- (e) 081645H. Echo Company received heavy volume of sniper fire and automatice meapons fire from coordinates BT 030532. Returned fire with small arms automatic weapons, 60mm mortars, 3.5" rockets, H-79 and artillery. I enemy KIA.
- (f) 082300H. Echo Company observed movement in the vicinity of coordinates BT 028526 and shortly thereafter received I incoming grenade. Fire was returned with 60mm mortars and movement ceased.
- (g) 090825H. Echo Company observed 4 VC vicinity BT 020533. VC taken under fire, broke contact and fled. Negative results.
- (h) 091100H. Echo Company and Foxtrot Company received heavy small arms and automatic weapons fire from coordinates BT 018549 and RT 028544. Returned fire with small arms, F-79's, automatic weapons 81mm nortars, 60mm mortars, 3.5" rockets, and intensive artillery missions and air strikes with rockets, bombs, and napalm. VC units broke contact and fled to the west and north. Friendly casualties: 1 DOV, 6 VIA, 3 heat and 1 with injured knee. VC casualties unknown at that time.

(i) 0912221. VC flushed from vicinity BT 007547: Air strikes of napalm and rockets were guided by 03 on station. 11 VC WIA (confirmed) and 10 VC WIA (probable).

- (j) 0914 0XI. Echo company found 1 70 body vicinity BT 019548 and an extensive trench line network with company trench line was spotted with much fresh blood.
- (k) 091460H. Foxtrot company found 1 VC body vicinity BT 025549.
- (1) 0916001. 14 VCS, micked up in sween after fire fights, were forwarded to District Headquarters.
- (m) 100935H. Echo corpany spotted 7 VC dressed in khaki uniforms fleeing from BT 021543. Taken under fire, results were: 1 VC KIA, 1 VC wounded and 7 VCS med-evaced. I friendly MA.
- (n) 101307%. Echo comeny captured 2 VC3 in sweep of village 37 029543. VC5 were forwarded to District Readquaters.
- (o) 1017/5%. Echo company patrol spotted 1 VC-fleeing area vicinity LT 060550. VC taken under fire with K-79. Results: 1 VC KIA. Sweep of area turned up 2 VCS who were forwarded to pistrict Headquarters.
- (p) 111015%. Echo corpany received automatica weapons, and small arms fire from estimated VC squad vicinity BT 068542. Returned fire with small arms and 60rm mortars with negative results. Sweep of area yielded 2 VC3 who were sent to District Headquarters.
- .(c) 111500%. Echo-1 patrol spotted 1 VC fleeing area vicinity ET 067547. Search of area revealed 2 female VCB who were sent to Bistrict Headquarters.
 - (2) Intelligence Information Received by Interrogation.
- (a) Information received from the VCS interrogated, tends to verify earlier information as to strict control of the area by VC. VC propaganda teams had told the young men and women to leave the villages when the Marines were in the area and the old people were to stay to guard their houses and property.
- (b) The VC withdrew on each oncasion of contact and left small groups of snipers behind to harass and delay us. The main group then pulled out in a circular movement to their rear and then west.
- (c) The VC are able to mass at least a company size unit and are able to defend any area of their choice. These units can be reinforce by the Q-15 Company (BT 0058) and the V-26 (BT 0053) The hamlets were all extensively fortified with trenches and bunkers as well as booby traps and possible phone communication.

- (d) The area is characterized by flat delta land of numerous rice paddies with thick bamboo strands around the hamlets. There are also fields of sugar cane and tall grass which added to the difficult task of finding snipers.
 - (e) Estimated losses to VC are as follows:

(1) 5 KIA (confirmed)
(2) IJ KBA (confirmed)
(3) 10 KBA (probable)
(4) 1 WIA
(5) 30 VCS were sent to District for inter-

regation.

- 8. Mission. To conduct a search and destroy operation in order to provide a screen in the assigned area thereby decreasing Viet Cong pressure on local populace during the national election period.
 - 9. Concept of Operations. A command group and two reinforced rifle companies will conduct a search and destroy operation in the area bounded by BT 010558, BT 093517, and BT 010500 and BT 082548.

10. Execution

No. of the Superior of the Sup

a. General

The second secon (1) At 071200H a command group with two reinforced rifle companies traveled via motor convoy on Route #1 south of the SONG DIEN BINH and moved west off of Route #1 on a road approximately 3000 meters south of the SONG DIEN BINH. The convoy moved about 4000 meters west along the road and then dismounted and moved into Objective "A" near the hamlet of CHIEM SON DONG (4). after making liaison with local officials. The next morning the unit moved towards Objective "B", about 2500 meters to the northwest, meeting sporadic sniping along the way. Upon reaching Objective "B" a great deal of fire was received from across the SONG CHIEM SON during a helicopter resupply mission. The next morning after extensive artillery and air preparation all units crossed the SONG CHIEM SON and moved north towards Objective "C". About 1500 meters north of the crossing point, the lead units met with heavy automatic fire from the north and west. Air, artillery, 60mm, 81mm and automatic fire was used to suppress the enemy fire. Area was swept and a night time position was established about 1000 meters east of the contact area. Movement east to Objective "D" commenced the next morning and trailing elements of Echo Company brought fire on an enemy unit to the rear of the column. Objective "D", 2500 meters to the east, was secured in the afternoon and movement south to Objective "E" commenced the next morning. Lead elements of Echo Company tripped and neutralized a VC ambush about 1500 meters south of Objective "D". Objective "E" on the north bank of the SONG CHIEM SON was reached at approximately 111100H. The next morning at 1000H all units were extracted by helicopter back to the Battalion CP.

b. 7 September - At 1200H Operation CANNON commenced. A light command group and Echo Company (Rein) and Foxtrot Company (Rein) departed the Bn CP by motorized convoy, enroute to Objective "A" in the vicinity of BT 057515. At 1325H, near the bridge located at BT 063512, on the advice of army advisors in that area 2/1 (-) elements dismounted and proceeded to Objective "A" on foot with Echo Company as lead element, the Command Group following, and Foxtrot Company providing rear security. After arriving at Objective "A", and after talking with local officials and "F forces the CP was established at BT 057514. At 1513H 3 shiper rounds were fired from unknown location dausing 1 friendly FIA. At 1845H 2 sniper rounds were fired from the vicinity of BT 053515. 3-60mm mortar rounds were fired in return and sniping ceased. At 2225H-a squad size patrol working with PF's in hamlet at "T.054511 ristook a PF for a VC when he sumped from bushes along a trail, and the PF was mortally wounded. Body was given to PF officials with an explanation of deep regret for incident.

c. 8 September - At 0730H units commenced movement to Objective "B" with 7 PF's with each rifle company. At 1135" Foxtrot Company's lead unit in the vicinity of BT 032523 received 3 sniper rounds from unknown position. At 1140H Foxtrot lead unit apprehended 5 VCS who had just helped 2 men into a cave at RT032522. Smoke grenades were thrown into the cave with negative results and the 5 VCS were returned to District Headquarters for interrogation. At 1400H Echo Company's lead unit in the vicinity of BT 029522 received 45 rounds of small arms fire from an unknown location to the west, causing I friendly WIA and one man suffered a strained ankle. Both were evacuated. Small arms were returned in sniber's general direction and area was searched with negative results. At 1445H Echo Company in the vicinity of BT 029596 received beavy small arms fire from the vicinity of BT 029532. Fire was returned with artillery, 60mm mortars, machineguns and small arms. Enemy fire ceased. At 1645H during helicopter resupply at Objective "B", in the vicinity of BT 028526, heavy automatic and small arms fire was directed at the CP and helicopters from across the SONG CHTEM SON at BT 030532. Artillery, small arms, automatic weapons, 1-79's, and 60mm mortars were fired in return resulting in one confirmed VC KIA. At 2300H Echo Company perimeter in the vicinity of "T 028526 received one granade and observed movement in front of the lines. 4-60mm mortar rounds were fired and movement ceased. Area was checked at first light with negative results.

- 9 September At 0730H after an intensive 10 minute artillery prep, Foxtrot Company commenced movement across the SONG DIEN BINH, conducting a reconnaissance by fire as they approached the northern shore. The Command Group and Echo Company followed after the river bank was secure. The movement was made with no enemy contact and no major problems. At 0825% Echo Company's lead unit observed 4 VC at BT 020534. VC were taken under fire and fled. At 1100H the lead element of Echo Company at BT 019545 and the lead element of Fortrot Company BT 026545 received heavy automatic fire from the vicinity of BT 018549 and BT 028544. Artillery, automatice fire, 60mm and 81mm nortar fire, and air strikes were used to return the enemy fire. OE on station observed approximately 50 VC fleeing to the west after the artillery mission. Air and artillery missions were called on fleeing VC in the vicinity BT 010546. OE observed 11 VC XIA confirmed and 10 VC VIA probable after artillery and air strikes in that area. Echo Company sweeping hamlet at BT 019549 discovered 1 VC YIA and apprehended 12 VCS. Also a great deal of blood was found in the trenchlines. Two huts used as fortified position in enemy's position were destroyed. Foxtrot Company upon sweening enemy position discovered 2 VCS, 1 VC KIA, fresh blood trails, and 1 CNI CHO! grenade. 2 packs with many documents were returned to Battalion Rear. The grenade was destroyed and all VCS were evacuated to Battalion rears. From this 4-hour contact there resulted 13 VC confirmed KIA, 10 VC probable KIA, 14 VCS apprehended, 1 friendly DOW, 6 friendly VIA, 1-injured, 3 heat casualties. All were evacuated.
- 10 September At 0945H Echo Company in the vicinity of BT 035548 observed approximately 7 VC at BT 030546 and took them willow fire with small arms, 60mm morters, artillery, and UH-LE gunships controlled by OE ran strafing missions. Echo Company swept area and discovered 1 VC WIA. 5 VCS and a great many blood trails. OE on station observed 1 VC KIA in same area and also observed a group of VC fleeing westerly in the vicinity of BT 025545. VC were taken under fire with artillery and UK-1E gunships, With excellent target coverage as the VC moved into houses at that location. At 17450 1st Platoon, Echo Company in the vicinity of BT 062550 observed 1 VC fleeing in the vicinity of BT 060550. He was taken under fire and killed. Two VCS were also apprehended in that area and evacuated the next morning. These actions resulted in 2 VC KIA, 1 VC MA, 7 VCS apprehended, 1 Friendly WIA with broken leg.
- f. 11 September At 1015H Echo Company in the vicinity of BT 065545 received automatic and small arms fire from an estimated VC squad in the vicinity of BT 068542. Fire was returned with 60mm mortars, small arms and artillery. Echo Company swept enomy area and apprehended 2 VCS who were evacuated to District Headquarters. One house burning due to artillery mission produced a small ascendary explosion. At 1500H lst Platoon, Echo Company on patrol in the vicinity of BT 067547 observed a suspicious male fleeing from patrol. Patrol chased male, but could not annrehend him. However, 2 female VCS in house man emerged from were appre-CARL STREET

hended and evacuated to District Headquarters. At 2045H Echo Company on CP perimeter at BT 068533 observed one VC 150 meters from perimeter and fired 3-60mm mortar rounds. I short round caused one minor friendly VIA.

g. 12 September - Echo Company, Command Group, and Foxtret Company were extracted by helo from ST 068533 in that order. Extraction commenced at 1000H and ended at 1215H. Operation CAMMON also terminated at 1215H.

11. Results

a. Friendly Personnel and Ecuipment

12. Administrative Matters

a. Logistics - No logistical problems were encountered during the operation. Troops were embarked by vehicular convov. All resupply and medical evacuations were conducted by helicopter.

b. Medical

(1) Battle Casualties - 1 KIA (Evacuated)

1 DOM (Evacuated)

11 WIA (Evacuated)

6 WIA (Non-evacynted)

- (2) Non-Battle casualties 15 (Svacuated)
- (3) Special problems There were no special problems encountered during the operation. There were only 4 heat casualties despite the heat, the distance traveled and the fact that flak jackets were worn by all hands.

c. Communications

- (1) Radio. Three nets were maintained by the command group. These were Battalion Tactical, Helicopter Direction #4 and Tactical Air Direction. HD # 4, an FM net, was used for tactical air request. A relay site was located one half the distance from the Battalion CP to the center of the search circle. While on the move the command group found it impossible to maintain communications with the Battalion CP without using the relay station. The terrain in the search area was roughly level and marshy. The weather during the operation was hot and humid with considerable cloud coverage at times. While in a static situation at night, the command group erected an RC-292 antenna. With this anntenna up, the command group had no difficulty in reaching the Battalian CP. Communications within the command group and companies were normal.
- (2) <u>Wire.</u> No wire communications were used on this operation.
- 13. Special Equipment and Techniques. Mone employed.
- 14. Commanders Analysis. This operation disclosed that in the area between the SONG CHIEM SON and the SONG DIEM BIMM, bounded by Grid Lines OI and O7, every hamlet is a fortified position consisting of trenchline networks, fighting holes, communication wire in trenches in one instance, barbed wire and punji sticks. The hamlets were inhabited by a few old men, old women, and children. From intelligence obtained, and from analizing contacts, all indications disclose main force VC units operating in this area, and the contact on 10 Sertember was believed to be a 70 man VC main force company believed to be moving west in that vicinity at that time.

15. Recommendations.

a. In the vast majority of contacts on this operation the VC used their standard tactic of sniping and then breaking contact as unit neared their location. However when the VC stayed and fought for any amount of time, with the use of proper equipment they could be found and hert. As a unit moves towards enemy positions in troolings or hamlots, it is imperative to have an OE on station to observe the VC when they break contact and flee. At this time with responsive air and artillery the OE can fix and direct devastating fire on the enemy flushed by the ground troops.

eanra

b. In a completely VC controlled and occupied area, such as the area between the SONG CHIEM SON and the SONG DIEN BINH extensive prep fires and reconnaissance by fire on anticipated trouble spots or routes of advance can facilitate the move, and reduce casualties.

c. Another recommended tactic that was discovered on this operation is the placing of troops in holes to remain behind, when the rest of unit leaves it's nightime position. In almost all cases, the VC will move into a vacated CP area. With this unit remaining and hidden, it creates a very good embush.



a. Major support in this operation was provided by lst Bn, 11th Marines and elements of the 1st MAW.

b. Artillery Support

- (2) As a result of well executed coordination and close liaison between the company commander, FAC Team, and artillery FO Team, maximum and efficient use of air as a supporting arm was accomplished with no loss of aircraft.

7. Intelligence.

a. Enemy. The estimated VC strength in the area of

- (1) The majority of the contacts consisted of sniper fire from approximately 2 to 5 VC with small arms and automatic weapons.
- (a) 200945H. Foxtrot Company moving at BT 047595 apprehended 1 VCS. Results of action 1 VCS.
- (b) 241215H, Foxtrot Company moving at BT 035593 received 4 rounds of small arms fire from BT 031593. Area was swept with negative results.
- (c) 241230H. Foxtrot Company moving at BT 033592 received 10 rounds of small arms fire from BT 033600. An artillery mission was called on the enemy position. The area was not swept due to river barrier.
 - (d) 241345H. Foxtrot Company moving at BT 025593 found a bloody shirt and blood trails. Area was searched with negative results. 1 VC WIA.
 - (e) 241430H. Foxtrot Company moving at BT 025591 received small arms fire from BT 021591. An air strike was called with unknown results.
 - (f) 241635H. Echo Company moving at 022573 received small arms fire from BT 019583. Fire was returned with small arms, 10 rounds of 60mm mortar and an artillery mission was called. VC broke contact and Company continued mission.
- (g) 241745; Echo Company moving at BT 038578 received heavy automatic weapons fire from BT 038580, from an estimated 5 VC. Fire was returned by Echo Company with small arms, and 60mm mortar. Hotel Company (vicinity BT 042579) fired with 81mm mortars and 106 RR's. Artillery fire was called on the enemy fire. Enomy firing equand and Company continued mission.

 Results of the actions 5 VC KIA (probable).
- (2) The VC have withdrawn on each occasion leaving small units with sniping and harassing missions. The VC are capable of massing company sized units and Mefending an area of their choice. These units can be reinforced by the Q-15 Company (operating in the vicinity of BT 065625). VC losses during the operation were: 5 VC KIA (probable) 1 VC VIA, 1 VCS.



a. Terrain. The area of operation is characterized by flat delta land with numerous rice paddies. Obstacles in the area are as follows: The SONG TAM GIAP, a slow moving river with a soft silty bottom; at RT 025593, there are a series of draws approximately 8 feet deep running north toward river; at RT 028590, a wall of wire and bamboo runs north to south along the trail; at RT 019577 there is a marshy area of waist-high water and grass shaped in an "S"; at BT 019574 there is a triple strand of wire running east to west.

8. <u>Mission</u>. To conduct a search and destroy operation in southern section of the TAOR.

9. Concept of Operation. Two companies abreast sweep west in zone from vicinity Highway #1 to SONG CO CA to search the area and kill or capture VC. One company follows in trace to provide screen to the rear, kill or capture VC who may have evaded the seault companies, and is prepared to move rapidly to exploit any major contact.

10. Execution

a. General

Echo and Fox (Reinforced) traveled via motor convoy on Route #1 south of the hamlet of QUANG LOC TAY(2). Commany "H" moving in from the south joined with company F; the two company ies abreest then swept toward SONG CO CA. The sweep was conducted with an intensive air and artillery preparation. Company "E" followed in trace accompanied by a U.S. Army Psychological Warfare unit and two scout dog teams to exploit the success of the assault companies. Sporadic rifle fire was received throughout the area of operations. Upon reaching SONG CO CA, the assault companies turned south toward Route #14, then east along Route #14 toward the entrucking point on Highway #1 near Hotel Company Cf. On the return route the heaviest small arms fire of the day was encountered. Fire was returned with small arms, 60 and 81mm mortars and artillery. One VC was seen to be hit and five probable kills are suspected.

b. 24 September - At 0800H Operation COFFEE commenced. A light command group, companies Echo and Foxtrot, and 2





sections of 81mm mortars departed the Bn CP by motorized convoy, enroute to If on Highway #1 south of QUANG LOC TAY (2). Company H (-) moved from Co CF (BT 042579) and established contact with Company F on Highway #1, near BT 054595. The two companies, with Company E, Command Group, Psychological Warfare Unit, and scout dog teems following in trace, commenced movement westward. Aerial Observer on station swept the area of operations. After artillery had fired on suspected key targets, an air strike was called on BT 022578 resulting in a fire and a large secondary explanation. At 0945H (vic BT 047595) Fortret Company apprehended one male VCS. Continuing west they received sporadic sniper fire as they swept. At 1345H vicinity BT 025593 blood trails and a blood soaked shirt were found. At this time a psychological warfare team member become a heat casualty due to excess load being carried; he was med-evaced by helicopter. Turning southward toward Route # 14, upon reaching the grid square BT 0158, Echo Company received sniper fire from BT 019583 at 1635H. Fire was returned by small arms, 60 and 81mm mortars, and artillery. Spiper fire ceased. At 1745H a heavy volume of automatic weapons fire was received by Echo Company from an estimated 5 VC in vicinity of PT 035584: fire was returned by Echo and Motel Companies with small arms, 106's, 60 and 81mm mortars. An artillery mission was highly accurate, resulting in 5 possible VC KIA's. Both companies continued their mission. Operation COFFEE concluded at 1900H. 11.7

- (3) Special problems There were no special problems encountered. One heat casualty was attributed to an exceptionally heavy load of psychological warfare equipment.
 - C. Communications Normal.

13. SPECIAL EQUIPMENT AND TECHNIQUES

- (1) A psychological warfare team, employed with Company E following in trace of the assault companies, was used to exploit their discoveries and contacts.
- (2) Two scout dog teams were utilized behind the assault companies to locate hidden VC arms caches and personnel.
- 14. COMMANDER'S ANALYSIS. It is apparent from prior contacts that there are hard-core VC units in the operating area. However, they will fight only on their own terms. Due to the size of the friendly force, they did not chance contact and fled the area.
- 15. RECOMPENDATIONS. Although this particular operation did not develop any major contact, it did serve to distrupt enemy plans and drive him from harboring areas. It also demonstrated to the friendly local civilian population as well as the VC the strong Parine forces that can move into the area at anytime.

CAUDE.

It is considered appropriate to conduct similar operations on a random basis in this and other areas throughout the TAOR.
