

Part Two. Significant Highlights

1. During the month of December a HAWK Missile Training Shoot was conducted at Battery A position on Ky Hoa Island. All firing batteries of both The 1st Light Anti-Aircraft Missile Battalion and the 2d Light Anti-Aircraft Missile Battalion participated in the shoot which ended 19 December, 1965. A total of 42 missiles were fired at two targets, jet drones, and propeller driven drones.

Battery C, 2d Light Anti-Aircraft Missile Battalion, accomplished a "first" when it fired a HAWK Missile at a target towed by a manned aircraft. Battery A, 2d Light Anti-Aircraft Missile Battalion, duplicated the shot.

Many visitors, including those listed in paragraph 4 of Part One, were on hand to observe the shoot. Also on hand were many members of the press.

Part Three. Significant Events

1. Personnel

a. During the month of December this battalion lost 88 enlisted due to rotation to CONUS.

b. Present total strength breakdown is as follows:

2. Administration

a. During December eight second lieutenants were promoted to first lieutenant and seven warrant officers received temporary commissions as second lieutenants.

b. Lt D. B. CHRISTENSEN was granted emergency leave to return to CONUS due to the death of his father.

3. Casualties

a. No casualties for the month of December.

4. Civic Action

a. On 31 December a partial shipment of requested MEDCAP supplies arrived. Supplies recieved will be sufficient to operate the battalion's program on Ky Hoa Island without serious shortages in the near future..

b. On 31 December the Battalion Civil Affairs Officer, Battalion Doctor, and two Corpsmen toured Ky Hoa Island in preparation for the eventual assumption of responsibility for Civil Affairs from "B" Company, 1st Battalion, 4th Marines. At this time plans were made to operate a clinic five days a week, beginning on 3 January, on the north end of the Island.

c. During the month of December members of this battalion have been engaged in building a playground for the school in the village of An Tan. The playground, consisting of a swing set, two slides, and a see-saw, will be presented to school officials in January.

5. Ground Defense

a. On 7 December this battalion received 20 seismic intrusion detectors.
