

2. General Information.

a. On 17 January, a MAG-12 Disbursing on-site audit was conducted to update information and correct errors noted on pay records of H&S Battery.

b. Buildings being constructed at Battery A site were completed by the SeaBees on 1 January 1967.

c. The Battalion Commanding Officer held a Buildings and Grounds inspection of all Battalion facilities.

d. On 24 January 1967 the Regimental Commander 5th Marines visited Battery A site.

e. Access road repair was begun by the SeaBees at Battery A site on 31 January 1967.

3. Casualties. None

4. Civil Affairs.

a. During the month of January, 1040 people on the island of Ky Hoa were treated by the Battalion Medcap personnel.

b. An extensive effort was made during the month to aid the schools on Ky Hoa, including blackboards, school kits, and paint.

c. Native fishermen with the help of the Civil Affairs NCO, SSgt. D. M. LEMOS, have set up a rock lobster market which supplies various clubs and individual groups. This program was started to help increase the income of the people on the island.

5. Motor Transport. During the month of January this Battalion provided two vehicles traveling a total of 120 miles in support of the Chu Lai Combat Base.

6. Communications.

a. During the month of January a new Communications Operations Center was opened for this command.

b. Construction of a new Electronics Maintenance Facility was begun during the month of January. This project is expected to be completed during the month of February.
