1. "A" Company. The Company was engaged in Operations Cimarron and Rockett throughout the month. The Company Command Post, 2d and 3d platoons operated out of the Khe Sanh Combat Base in direct support of the 26th Marines (XD 843418); the 1st platoon (rein) operated out of Camp J. J. Carroll (YD 060541) in direct support of 3d Battalion 4th Marines with a light section deployed at D-5 (YD 096518) in support of "M" Company 4th Marines. During the month, a total of 250 rounds of 106mm were expended as registration and counter mortar fire. During the enemy rocket/mortar attack of 27 June on Khe Sanh Combat Base, Ontos counter mortar fire resulted in one secondary explosion. The Company sustained one USN WIA, (non med-evac) during the attack of 27 June 1967. A new concept of Ontos employment was effected when Ontos, Tanks and Army Dusters, M422, were used to insert a Reconnaissance Team. On 17 June two Ontos on patrol with "L" Company 26th Marines ascended Hill 861 west of Khe Sanh demonstrating the cross country mobility and trafficability of the Ontos. The light section of the 2d platoon displaced from the Company CP to (XD 913403) to provide bridge security. During the month "A" Company received one R&E Ontos USMC Number 226756.

2. "B" Company. During the month the Company Headquarters, 2d and 3d platoons were in direct support of the 4th Marines on Operation Chocotaw (YD 532319). The first platoon remained in direct support of the 3d Battalion, 3d Army of the Republic of Vietnam Regiment at (YD 691214) throughout the month. The platoon was visited by delegations of high-ranking American and Vietnamese Officials twice during the month and was involved in the filming of a joint USMC-ARVN operation to be utilized on television. The members of the 1st platoon assisted in repairing the access road to National Route 1. The 1st platoon sustained one NBC from an accidental discharge of a .50 caliber spotting rifle. The 2d and 3d platoons supporting the 1st Battalion 3d Marines and 1st Battalion 4th Marines, OPCON 4th Marines, participated in perimeter security and sweep operations with no enemy contact. The 3d platoon sustained 1 KIA and 2 WIA when an Ontos traveling from Phu Bai to the Chocotaw Operation Area was hit by shrapnel from a 500 pound bomb detonated by a truck directly behind in column at (YD 598308). On 27 June one Ontos was reassigned from "C" Company 3d Antitank Battalion to "B" Company bringing the Company strength to 12 Ontos. During the month two R&R vehicles USMC Numbers 226827 and 226823 were received by the Company.

3. "C" Company. During the month of June "C" Company (Rein) was in direct support of 9th and 12th Marines. The Company CP was located at Dong Ha, (YD 231583). The company was in direct support of Operation Cimarron and Operation High Rise. The 4th platoon was in direct support of land clearing operations at Con Thien, and sustained 3 WIA's at Con Thien who were treated in the field and returned to duty. The 3d platoon was in direct support of the 12th Marines at Gio Linh. All other platoons supporting 9th Marines in their operational commitments. Damage was sustained to the left bank of guns on one M50A1, USMC 22690, by shrapnel and also one M50A1, USMC 226953, had one support arm on the left side of the vehicle damaged by mortar fire; guns have been replaced and support arm repaired.

4. H&S Company. The company remained with the Battalion CP at (YD 825153) during the month. The reaction platoon conducted 33 night patrol/ambushes and six daylight squad patrols in the Battalion AOR. A Command Bunker is being constructed and water proofed in preparation for the Monsoon Season. The emplacement is 50% complete. A Communications Bunker has been completed, with a minimum of six feet of sand bags installed to provide 360 degrees protection. The Battalion participated in a practice 100% alert conducted by the Installation Coordinator on 30 June 1967. Primary and alternate landlines were tested and worked satisfactorily. A composite platoon of 38 men was committed by the Company to rough rider security and security for a Naval Survey Team at Colco Beach (YD 765346).

a. On 26 and 27 June the Battalion furnished 37 men 1 Officer for a rough rider security detail to Khe Sanh. On completion of this mission this detail was assigned the mission of providing security for an engineer survey team located at Colco Beach. This security detail was still on this mission as of the end of the month.

b. Motorized patrols made up of MedCap and resupply convoys made a total of 14 trips within Division TAOR for a total of 712 miles.
