



The double General Purpose tent will be used on the next operation instead of the two Fly tents previously used for the treatment area. The double General Purpose tent appears to be more practicable as it gives a larger area for patient treatment.

c. Medical Support:

(1) On 1 March 1966 at 1740 hours the "D" Company Shock & Resuscitation Platoon returned to the 3d Medical Battalion via truck convoy upon the completion of Phase II of Operation Double Eagle.

(2) On 2 March 1966 at 1800 hours the "D" Company Shock & Resuscitation Platoon was placed on a twelve (12) hour alert.
