

WING LASS OF SIGNIFICANT EVENTS

During the month of October "D" Company provided Special Escorts for General CUSHMAN and General NICKERSON. A three vehicle, sixteen (16) man Special Detail was also provided for the Change of Command Ceremony at Force Logistic Command. Prisoner strength at III MAF Brig was 206, a decrease of 6 from the previous month. The average number of detainees at III MAF POW Compound was 67. A total of 487 people were treated by the MEDCAP Program. Five (5) mid-wife kits were distributed to the hamlets. One concrete well was completed in the Hamlet of Thach Nham, coordinates 948706. A water pump was also obtained through Force Logistic Command, G-5, and given to Thach Wham, Hoa Khuong and Phuoc Thuon. LtCol GAMBARDELLA and SgtMaj FLOWERS went to Saigon to attend a conference on currency control. Brigadier General OLSON, Commanding General, Force Logistic Command, inspected the III MAF Detention Facility. Major General R. L. MURRY, Deputy Commander, III Marine Amphibious Force, also inspected the III MAF Detention Facility. 1stSgt STUCKEY relieved SgtMaj FLOWERS as Battalion Sergeant Major. On 21 October this unit was on 100% alert due to increased enemy activity in the area. Lt. W. A. LAPPEMAN joined the Battalion as the new Battalion Surgeon. No enemy action has been initiated in the 3d Military Police Battalion's TAOR. Cpl GUERRO and Cpl WOZNIAK were wounded in action at Con Thien, and Cpl WATERMAN was wounded in action while a member of a scout patrol.


