CONFIDENTIALPART IINARRATIVE SUMMARY

1. OPERATIONS: The month of July brought many changes to Third Motor Transport Battalion. On 9 July 1969, a change of command ceremony at the battalion cantonment was held as Major J. F. LAVIN transferred the Battalion Colors to Major R. S. DAVIS, JR. On 21 July 1969, Major J. E. QUILL, Battalion Executive Officer, was reassigned as Executive Officer, Ninth Motor Transport Battalion.

The loss of Company "A" (Rein) and Company "C" (Rein) to RLT-9 left the Battalion with Company "B" and essential personnel of Headquarters and Service Company. Company "B" remained at Vandegrift Combat Base in support of the units stationed there. Headquarters and Service Company remained at Quang Tri Combat Base until 18 July 1969 when it relocated and joined Company "B" at Vandegrift combat base and established Battalion Headquarters. Although the mission of Third Motor Transport Battalion still is the support of the Third Marine Division, it is mostly confined to support of Vandegrift Combat Base which is controlled by the Fourth Marine Regiment.

Operations Virginia Ridge, Cameron Falls, Herkemer Mountain and Apache Snow which were previously supported by Third Motor Transport Battalion have been terminated. During the month of July, 3d Motor Transport Battalion was additionally assigned to support Operations Idaho Canyon, Williams Glade, Arlington Canyon and Georgia Tar in the I Corps Tactical Zone.

In addition to the loss of two T/O Companies, the detachment of Carrier Amphibious M-76 Otters assigned to Headquarters and Service Company was reassigned on 8 July 1969 to Ninth Motor Transport Battalion.

During July, daily availability of task vehicles was 88% and daily commitments averaged 95%. In addition, the average monthly deadline was 12%. Total miles traveled was 37,870, a total of 1,843 tons of cargo and 20,852 personnel were transported.

2. CIVIL AFFAIRS. During the month of July, all civil affairs action was suspended because of Battalion reassignments and relocation.
