3. Significant Events

a. Logistics

- (1) Received April CRITAPAK.
- (2) A reinspection of Battalion Supply was conducted by the Division Supply Management Team on 15 April 1966 with satisfactory results.
- (3) An FSAO assistance team visited the battalion on 25 April 1966.

4. Operations

- a. The 3d Reconnaissance Battalion (-)(Rein), in general support of the 3d Marine Division, maintained its elements deployed around the periphery of the Division's TAOR in Da Nang. Significant operational events which occurred within the battalion during the reporting period were:

- (1) At 011800H April 1966 the OPCON of the 1st Force Reconnaissance Company was shifted from this command to Commanding General, III MAF. No significant events occurred during the 18 hours of this reporting period that 1st Force Reconnaissance Company was OPCON this battalion. 1st Force Reconnaissance Company has prepared its own Command Chronology, which is being forwarded separately, for the month of April 1966.
- (2) On 20 April 1966, one platoon and one squad from Company D, 3d Reconnaissance Battalion was detached and placed under OPCON of 3d Battalion, 9th Marines for Operation GEORGIA. At the end of the reporting period they had not been returned to OPCON of this



command. Significant events pertaining to these personnel which occurred during Operation GEORGIA will be reported in the Command Chronology submitted by 3d Battalion, 9th Marines.

- (3) On 27 April 1966, Company A (-), consisting of two platoons and a company headquarters section, was detached and placed under OPCON of the 4th Marine Regiment for operations in the HUE-PHU-BAI TAOR. Significant events pertaining to Company A for the period 1-27 April 1966 are contained herein.
- b. Co A. During the reporting period the company operated in the field for a total of 49 patrol days. Eleven huts and four punji stake pits were discovered. Drum beats were heard on three occasions. New trails, water points, HLZ's and possible VC OP sites were located and reported. Patrols had 24 enemy sightings totalling 80 VC. Four contacts with the enemy resulted in 2 VC KIA (BC), 1 VC WIA (Confirmed), 4 VC KIA (Possible) and 1 VC WIA (Possible). One USMC was WIA when one round of small arms fire was received through the bottom of a helicopter during extraction of a patrol from an HLZ.
- c. Co C. Company C operated in the field for a total of 46 patrol days. Four huts, and numerous harbor sites, possible VC OP sites and HLZ's were discovered and reported. Two grenade booby traps and two punji stake pits were located. A flashing mirror, which possibly was being used as a signal, was observed. Artillery fire called on the position where the mirror was observed produced unknown results, but the mirror was not seen again. Five U.S. M-26 grenades, two and one half bandoliers of U.S. 7.62mm ammunition and one roll of communication wire were found and returned with the patrols. Four elephants were sighted. There were eight enemy sightings totalling 30 VC. One minor contact occurred which caused no friendly casualties. VC casualties, if any, could not be determined. Two artillery fire missions were called on suspected VC OP sites, both resulting in small secondary explosions.
- d. Co D. The company operated in the field for a total of 26 patrol days during the reporting period. Numerous new trails, huts and possible VC harbor sites and OP sites were discovered and reported. Fresh elephant tracks were observed. An unoccupied boat, 15 feet long was found by a river.
- e. Company B (Rein) was not under the operational control of this battalion during any part of the reporting period. Significant events pertaining to Company B will be included in the 4th Marine Regiment's Command Chronology for April 1966.

8. CONCLUSIONS AND RECOMMENDATIONS:
 - a. Recommendations: Patrol leader recommends not taking the SID.
 - b. Conclusions: 1. Area doesn't appear to have been used in the past 6 months.
2. Due to terrain situation in the area of operation (ZC 185862-187845-161843) it does not appear that the high ground in this area is used by the enemy. Lack of water sources in the high ground and poor observation of avenues of approach into the area render this area of little tactical value to the enemy.

9. DEBRIEFER COMMENTS: There is no evidence of recent enemy activity in the area of question. The SECRET ZONE previously reported in the (ZC 1886) grid square is not in the area reported. It is possible that the zone exist to the North and West of this area but there have been no enemy sightings in this area in the past two months.



3. Significant Events

a. Personnel and Administration. Officer personnel shortages have resulted in several officers having to assume duties normally requiring two officers. For example, the Executive Officer is also filling the billet of Operations Officer. This shortage of officers has also necessitated utilizing sergeants as platoon leaders of many reconnaissance platoons.

b. Training

- (1) During the month the battalion conducted weekly classes for patrol leaders, stressing tactics and new techniques of reconnaissance operations learned in Viet Nam.
- (2) Forward Observer schooling was continued, with the eventual goal that every reconnaissance Marine have the capability of calling and adjusting artillery fire missions quickly and accurately.
- (3) Block training, stressing reconnaissance and patrolling techniques, was conducted for newly joined personnel during the month.
- (4) Reconnaissance companies received classes at the platoon level, in weapons, tactics, and general information.
- (5) Nine personnel were given a pre-SCUBA indoctrination course and will attend SCUBA training in Subic Bay, P.I. during June 1966.

(1) Major Thomas R. STUART assumed command of the 3d Reconnaissance Battalion on 6 May 1966, relieving LtCol. Roy R. VAN CLEVE who was rotated to CONUS.

(2) The OPCON of 1st Force Reconnaissance Company was shifted to 3d Reconnaissance Battalion from 1st Marine Division at 101400H May 1966. At 130816H May 1966 OPCON of 1st Force Reconnaissance Company shifted to 4th Marine Regiment.

(3) At 141400H May 1966 the OPCON of Company A (-), consisting of two platoons and a company headquarters section, shifted from the 4th Marine Regiment to 3d Reconnaissance Battalion. Co A (-) returned at that time to DA NANG after completing operations in HUE-PHU BAI TAOR.

(4) During the period 11-19 May 1966 one platoon of Company A was placed OPCON of 1st Battalion, 3d Marine Regiment for Operation CORMORANT in the DA NANG, TAOR.

(5) One platoon and one squad from Company D, 3d Reconnaissance Battalion, remained under the OPCON of 3d Battalion, 9th Marine Regiment during the period of this report. Significant events concerning these personnel will be reported in the May 1966 Command Chronology of 3/9.

(6) The 1st Force Reconnaissance Company and Company B (Rein), 3d Reconnaissance Battalion are reporting significant events for this reporting period in separate Command Chronologies submitted to the CG, 3d Marine Division via 4th Marine Regiment exercising operational control of these units.

d. Logistics. During the month of May 1966, reconciliation of out-standing obligation listings for FLSG and 3d FSR was completed.

e. Civil Affairs

(1) 1st Battalion, 3d Marine Regiment has assumed cognizance over civil affairs projects for the PHU THOUNG Orphanage and the PHU THOUNG XA refugee center vice 3d Reconnaissance Battalion.

(2) During this reporting period a new civil affairs assignment was begun at the village of PHUOC LY. The Battalion Civil Affairs Officer, with a corpsman and an interpreter, visited the village, met the village chief, administered first aid as required and passed out soap and Kool Aid. The villagers seemed extremely responsive.

4. Operations

a. The 3d Reconnaissance Battalion (-) in ~~general support of the~~ 3d Marine Division maintained its elements deployed on the periphery of

the DA NANG TAOR. Significant operational events which occurred within the battalion during the reporting period were:

- (1) Co A. During the reporting period the company operated in the field for a total of 19 patrol days. Three huts and one trail marker were discovered. One new trail was located. An HLZ that would accommodate two H-34 helicopters was found. One VC sighting totalling three VC was made. An artillery fire mission called on these VC resulted in three VC KIA (Possible). The company sustained no casualties.
- (2) Co C. Company C operated in the field for a total of 54 patrol days. Eight huts and five lean-to shelters were discovered and destroyed. Three new trails were found. Three VC explosive booby traps were located and disarmed. Numerous punji stake pits were observed and reported. Patrols from Company C had 18 enemy sightings totalling 140 VC. Ten artillery missions were called on these sightings which resulted in ten VC KIA (VC) and five VC KIA (Possible). Nine contacts were made with the enemy totalling 40 VC. Small arms fire accounted for seven VC KIA (Possible) and four VC WIA (Possible). There were no friendly casualties.
- (3) Co D. The company operated in the field for a total of 15 patrol days. Four VC OP sites were discovered. Five HLZ's each of which would accommodate 1-4 H-34 helicopters were located. Three small bridges were discovered. There were no enemy sightings or contacts and no USMC casualties.

(2) 112323H and 120005H, (ZC 177834) patrol received shrapnel from H & I fires into there OP.

(3) 151655H at (ZC 159846), patrol found elephant dung which appeared to be 6 to 8 weeks old, two hitching posts, numerous small fire sites, and two stick markers pointing northwest. Patrol checked area with negative results.





(2) (AT821732) Patrol leader stated that he had communication difficulty from this area. He also stated that when patrol established OP sites that the whip antenna was the only means of communicating back to stake out.

(3) (AT836724) Patrol located 2 structures constructed of concrete and steel frames. Structures were 44' long, 18' wide, and 10' high. Structures are in excellent condition.



