Present officer strength is 25. The shortage of 16 officers below manning level seriously impairs the combat capability of the battalion. Enlisted strength continued to decline resulting in an end of month strength of 594 marine enlisted and marking the third consecutive month in which losses have exceeded gains. The battalion remains in personnel readiness category C-1, however, should present trends continue it is anticipated that the battalion will fall to C-2 by the end of June.

Nine requests for extension of overseas tour were forwarded during May. The special 30-day leave program continues to be the major factor influencing the favorable rate of extensions in the battalion.

The battalion sustained 63 casualties during the month. Forty-eight men were wounded in action and 10 were killed in action. Serious illness and non-hostile injuries accounted for the remaining casualties.

In compliance with a CMC directive, battalion level personnel accounting was instituted on 1 May. The changeover from company level reporting was completed smoothly and problems have been minimal.

Eleven men of the battalion were recommended for awards during May. The award recommendations included one Navy Cross, one Silver Star, six Bronze Stars, one Legion of Merit and six Navy Commendation Medals.

Weather. Rainfall and temperatures during the month of May were average as defined by Climatological Data for Selected Locations within I Corps, promulgated by Captain P. V. KOSMO, Staff Meteorologist, 1st MAW, G-3.

Intelligence. During the month of May, 3d Tank Battalion supported Operations Prairie IV (Companies "A" and "B"), Hickory (Companies "A", "B", and "C" (-)), Shawnee (Company "C"), and Choctaw (Company "C").

During those operations and deployments at Gio Linh, Camp J. J. Carroll, and the Rock Pile, 3d Tank Battalion units fired 66 H&I missions and were engaged in 95 incidents.

Fifty-nine incidents were VC initiated. Of the VC initiated incidents, 44 were due to mortar, rocket, or artillery fire, seven were anti-tank attacks, four were anti-tank mine attacks, and four were small arms incidents. Enemy casualties totalled 54 KIA (confirmed) and 54 KTA (probable).

Third Tank Battalion command group and H&S Company in the Gia Le Combat Base were involved in six incidents. One was VC initiated. There were no known enemy KIA. (See 3d TkbN INTSUMS 97, 98, 99, 100, 101, and 102.)

CONFIDENTIALOPERATIONS AND TRAINING

During the month of May the battalion was very active in its role of supporting infantry units. Due to the requirements for increased tank support in the Dong Ha area, a number of platoons were shifted to this area to reinforce Company "A" which was in direct support of the 9th Marine Regiment. After receiving his briefing, the Battalion Commander moved a command group forward. This command group consisted of the Commanding Officer, Operations Officer, Intelligence Officer, Maintenance Officer, and elements of Battalion Tank Maintenance and Communication Sections. Liaison was immediately set up between the 9th Marine Regiment and Division COC. During Operation Hickory tanks were used to the maximum. Although mining incidents and anti-tank hits were sustained, the death rate remained low. No problems were encountered in resupply. A total of 16 anti-tank hits were sustained, the majority inflicted by the RPG-2.

The total number of tanks used in this operation were as follows:

Company "A" was reinforced by two platoons of Company "C" and three float platoons and had 45 tanks in use. In addition, three flame tanks were used.

Flame tanks fired a total of 202 seconds or 3 1/3 complete loads.

The battalion CP is at the Gio Lin Combat Base and is responsible for Sector III of the defense perimeter. This battalion relinquished communication guard of the combat base to 3d Engineer Battalion on 28 May 1967.

Training during May was emphasized in three areas: (1) troop orientation for newly joined personnel, including combat skills necessary for small-unit operations, (2) technical training within each MOS,

including a tank gunnery training program conducted on ranges in the Gia Le area, (3) a mine warfare school conducted from 15 to 17 May with 26 men in attendance. In addition, on 18 May 10 men received instruction on the M-16 rifle.

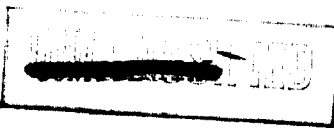
Formal school training consisted of one marine completing the Vietnamese Language School, and one marine attending the personal response course conducted by Division.

Operations and intelligence briefings were conducted for officers and staff non-commissioned officers within the battalion CP three times weekly. Special staff briefings were held nightly.

LOGISTICS

During the month of May, this battalion had a shortage of two major end items. One is a truck, wrecker, M62, five-ton, on which information has been received that MCSG, Albany shipped a truck, wrecker M543A2, five-ton from CONUS on 20 April 1967, as a replacement. The other end item shortage is a tractor, TD-15, requisitioned on document number 74645, priority 05, dated 8 November 1966.

The situation remained normal for Class II, Type two repair parts. There were two problem areas, one being the unavailability of oxygen and acetylene, the other is the delay in receiving track shoes for M48A3 tanks.

Normal supply operations were carried on. Status conversion cards were received from various supply sources and the supply section is now involved in converting all outstanding requisitions to milstrip document numbers. The last quarterly reconciliation listing was received from 1st and 3d FSR and are being run against the stock records. Repair parts for the M-3 compressor became critical items, and were ordered on 02 priority. One M-3 compressor was turned into FLSG-A for 3d echelon maintenance. Supply is conducting a review of the entire battalion matching IMR cards against the weapon actually held by the individual.

The overall maintenance situation is excellent. Seventeen major end items are deadlined, seven are the result of enemy action (mine damage and anti-tank weapon, the RPG-2). The primary reasons for equipment being deadlined are:

- a. Continuous support of infantry units, on extended operations.
- b. Extreme geographical factors.
- c. Increasing maintenance as equipment grows older, especially motor transport equipment.

The services situation has no significant problems. Electrical power is being supplied by unit generators. Potable water is provided by 3d Engineer Battalion waterpoint. A unit from 3d Marine Division Post Office is set up in the Gia Le Combat Base. An annex from the 3d Marine Division PX is set up in the Gia Le Combat Base. Unit has own showers operating. Eread and recombined milk is available for unit daily from 3d Marine Division Food Services, Phu Bai.

More than two-thirds of camp is still under canvas.

During the month of May there were 29 medical evacuations. The Motor Transport Section logged a total of 27,876 miles; 2558 miles were for 3d Marine Division commitments.

COMMUNICATIONS - ELECTRONICS

With greatly increased tank operations during Operation Hickory, the communication platoon had to shift some of the radio equipment operators into the area of the operation in order to meet the requirements laid on the platoon. A total of four extra operators, one AN/MRC-109, and two AN/PRC-25s were sent to the Dong Ha area. Two operators and one AN/PRC-25 were assigned to the tank liaison officer with the 9th Marine Regiment. The other two operators and AN/MRC-109 remained at Dong Ha to function as radio operators for the battalion commander. By the end of the month, three operators and the AN/PRC-25s had been brought back to the battalion CP.

The battalion used an AN/PRC-25 at the battalion CP to communicate with the patrols and this was not entirely satisfactory because of the frequency drifting of the AN/PRC-10. Radio communications with the companies continued to be handled with the AN/MRC-110s.

One RT-524 was bench-mounted in the COC bunker at the battalion CP and was used for all radio shots to the companies. We continued using the KY-8 nightly for sending operational status reports to Division.

The wire section was kept busy by helping division wire section to trouble shoot the lines between Gia Le Combat Base and Division when trouble developed on any line, the wire section would check Division lines back to them at their terminal board on this end. This slightly unorthodox arrangement saved much time and enabled us to give better service.

The communication center used a covered teletype circuit with Division until the 15th when Division had to put their equipment on circuits of higher priority. On the 29th responsibilities for Comm Guard for the base were shifted to 3d Engineer Battalion. Units being guarded for at that time were 3d Tank Battalion, 3d Engineer Battalion, 3d Anti-Tank Battalion, 3d Shore Party Battalion, and Navy Mobile Construction Battalion 3. On the 27th the communications center began moving into a tropical hut which they shared with the tech shop.

The tech shop was improved by moving into the tropical hut. It provided more room, and light to work by, and kept the dust to a minimum. The tech shop at Company "A" did most of the repair work during the month because of Operation Hickory, and they were augmented during the operation by three technicians from H&S, including the shop chief.

The AN/PRC-12 series is due to be installed in the tanks shortly, and most of the future planning concerns employment, installation, and training on the new radios.

CIVIL AFFAIRS

During the month of May work continued on the rice warehouse and Xuan Hoi school.

The rice warehouse will cost approximately 200,000 piastres. This figure will include the cost of 20 cubic meters of sand, 25 cubic meters of crushed stone, and wages for 15 people for 30 to 40 days. Cement will be provided by the G-5 office. It is planned that the rice warehouse will be capable of storing in excess of 100 tons of rice.

The school in the hamlet of Xuan Hoi has the necessary timbers, cement, and sheet tin for completion. Work should be completed by the middle of June.

In the planning stage is a project to rebuild a seven-mile dike system in order that 600 to 700 acres of land may be reclaimed from tidal water.

One hundred school kits, six masonry kits, six carpentry kits, and 400 burlap bags for rice storage were delivered to Loc Son during May.

Four male teenage youths are attending the World Relief Foundation School in Hue learning carpentry, tinsmithing, and automotive mechanics. Their course of instruction will terminate during the second week in June.

The MEDCAP program was conducted by HM-3 FINNLEY of CAG H-2. A total of 2347 civilians were treated for various maladies. MEDCAP resupply was handled through the normal G-5 supply channels.

During May there were a total of 226 people reporting to military sick call throughout the entire battalion. The majority of the ailments were minor in nature, consisting mostly of rashes, aches, and pains. Since the start of dental services at 3d Engineer Battalion, the turnout of 3d Tank Battalion personnel has been very good. During May, 25 people turned out for dental work from this battalion.

Immunizations administered during May totalled 110. No serious tropical diseases or ailments were reported or seen this month.

There was a total of two VD cases, with both of them being gonorrhea. This figure represents a drop in cases of VD reported. Credit for this may partly be due to the indoctrination lecture given to newly joined personnel. The lecture gives the men an idea of the chances they take and the seriousness of the disease and also methods of avoiding VD.

INEDCAP activities have not been resumed as of the end of the month.

1 May 1967: At 011745H an H&S Company, 3d Tank Battalion jeep travelling on highway at (YD 872151) received three small arms rounds, two through the windshield and one through the dashboard. The rounds resulted from a fire fight between two ARVN units at (YD 872151). Result of action was one USMC WIA (non-med-evac).

Today the Civil Affairs Officer and Major Sylvester met with Ong Le Khue in Loc Son to discuss the possibility of repairing a dike system to the east of Loc Son. Upon preliminary scrutinization of the area the project would ultimately reclaim approximately 700 acres of rice producing land. This would potentially enable the higher ground currently under rice cultivation to be used for vegetable crops, thereby, not only providing a more substantial diet for the people but might also allow the vegetable excess to serve as a cash crop.

Consultations are now underway with 3d Engineer Battalion to establish what equipment and material will be necessary for the job.

NARRATIVE REPORT

Today in Loc Son more sand was acquired for the construction of the rice warehouse. Approximately 20 cubic meters of sand will be needed. Five cubic meters are already in Loc Son. The sand will cost 400 piastres per cubic meter. Approximately eight to 12 cubic meters of crushed stone will also be needed. Six cubic meters of crushed stone acquired from the Seabees are presently in Loc Son. The remaining crushed stone will cost 700 piastres per cubic meter. On hand in Loc Son are 6000 piastres worth of cooking oil and dried milk. The cost of labor will come to approximately 90,000 piastres. The project will take 15 people 30 days at 200 piastres per person per day. Total cost will come to about 99,400 piastres above the 6000 piastres currently in Loc Son.

Completion of the school house roof and cement floor in Xuan Hoi only awaits the end of the harvest which is about five days hence. At that time the labor will be free for employment on that project. A labor cost estimate is forthcoming.

One hundred school kits were delivered to the Hamlet of Ha Chau for use in their new school.

Four hundred burlap bags suitable for rice storage are needed so that the rice can be stored within the GAC compound.
