INT ELLIGENCE

MINING During February there were five mining incidents. On 7 February, A33 was operating off existing trails at coordinates YD 140694 when it detonated an estimated 50-60 pound mine. The left side of the tank suspension was moderally damaged. On 12 February, B33 hit a 20 pound mine with the left track at YD 095625. C33 hit a mine on 25 February at coordinates YD 935588, damaging a road wheel, support roller, roadwheel housing and three track blocks. On 28 February, B34 hit a 30-40 pound mine in a ravine at YD 095625. The suspension system on the right side was damaged. On 28 February, APC 16 hit a 30-40 pound mine at YD 090598. Two sets of road wheels and sprocket drives were damaged on the left side.

MPG There were no MPG incidents involving the 3d Tank Battalion.

ENEMY ACTIVITY During the month of February, several significant action took place involving units of the 3d Tank Battalion. While providing security for land clearing operations of the 59th Engineer Company, U. S. Army, the APC platoon and B Company, 3d Tank Battalion discovered several enemy bunker complexes in the Leatherneck Square area in vicinity of coordinates YD 1567 and YD 1666.

on 22 February, the APC platoon suffered two friendly KIA's from an enemy ambush in the Leatherneck Square area. The APC platoon and a platoon from B Company, 3d Tank Buttalion inflicted 4 enemy KIA's (confirmed) and captured one NVA/POW. On 22 February at 2345, elements of C Company, 3d Tank Battalion, in support of B Company, 1st AmTrac Battalion at Oceanview, engaged an enemy force of unknown size. This action was terminated at 0730 on 23 February and resulted in one enemy KIA (confirmed). On 28 February, the APC platoon, elements of B Company, 3d Tank Battalion, H/2/3 and elements from the 3rd of the 5th Cav., U. S. Army engaged the enemy at coordinates YD 1063. The engagement resulted in 60 enemy KIA's (confirmed). Enemy activity has increased substantially in magnitude and frequency. Units of 3d Tank Battalion have experienced an increase in both mining incidents and direct combat engagements with enemy forces.

WEATHER February was a normal winter worth for Northern I Corps with a total of 1.74 inches of percipitation.

On 22 February, a record temperature of 102 degrees was set for the month of February. This covers 35 years of reported weather. Average maximum temperature was 73 degrees, average minimum temperature was 60 degrees, average mean temperature was 72 degrees.

Humidity remained at a normal average of 90%.



1. OF ERATIONS

From 1-17 February, 3d Tank Battalion (-) continued operating in the Kentucky AO while OPOON to Task Force Bravo. One platoon of M4843 tanks and two platoons of M50Al Ontos were in direct support of Task Force Hotel, operating in the Scotland II AO. During this period, contact with the enemy was light, consisting of small engagements, with no significant enemy force encountered.

On 18 February, Task F ree Bravo was dissolved upon return of the 3d Marine Regiment to the 3d Mar Div, and the 3d Tank Battalion was placed in general support of the 3d Marine Division. During the latter part of the month enemy activity increased and the Battalion, in support of the infantry, participated in three engagements which resulted in sixty-five NVA killed and one captured.

2. TRAINING

During the latter part of the month of February, plans were made to begin a Tonk Commander's Refresher Course. The syllabus has been completed and lesson plans are being prepared. Current plans are to commence the school on 13 March.

All c mpanies in the Battalion continued military subjects training at the company level.

During the month, there were four In-C untry Indoctrination lectures conducted with forty-two personnel attending.

The Commanding Officer's weekly breifing with the Battalion Staff continued.

3. Company A (Rein)

Company A continued operations in direct support of 2nd and 3d Battalion, 3d Marines and operated from Con Thien, C2 Bridge, and C2. In addition to providing security for Route 56l between Con Thien and Cam Lo and for mine sweep teams, Company A conducted numerous effensive operations and sweeps within the Kentucky AO. The company also provided elements for a reaction force after a unit was ambushed in the Leathernock Square area. The reaction force consisted of seven MABA3 tanks, two M67A2 flame tanks, four APC's and two M42A2 win 40mm mtd., accompaniby infantry. While on this operation, the reaction force confirmed four NVA/KLA's, and captured one FOW.

As the month closed, Company A was effecting preparations to move it! CP from C n Tion to Vandegrift Combat Rase.

4. Company B (Rein)

Company B continued operations in direct support of the 2nd and 3d Battalion, 3d Marines. The company, operating from Vinh Dai, provided a platoon of tanks and the APC platoon for security of the land clearing operation in Leatherneck Square. In addition, the company operated with the infantry, in coordination and cooperation with Regional Forces and Popular Forces, in the Mai Loc TAOR. During the latter part of the month Company B, in support of elements of H/2/3, served as a blocking force North of Cam Lo for elements of the 3d Bn, 5th Cav, U. S. Army. During the operation, Company B fired in excess of two hundred rounds of 90mm ammunition at NVA in the open. The result of the action was 60 NVA/KIA's (confirmed).

As the month closed, Company B continued in direct support of 3d M rines and prepared one platoon for movement to A2 in support of the 2nd ARWN Regiment.

5. Company C (Rein)

Company C (-) continued it's general support role operating from Quang Tri Combat Base. One platoon continued in direct support of Task Force Hotel at Vandegrift Combat Base, and a section operated ENCLOSURE (1)

from Oceanview in direct support of the 1st AmTrac Bettalion. This section was instrumental in repelling an enemy force that attempted to overrun the friendly outpost at Oceanview. In addition, the company operated with the 3d Reconnaissance Battalion conducting reconnaissance team insertions and extractions in the Quang Tri Combat Base AO. Other tank operations included convoy security escort on Route 9 and security at night for Route 1 between Dong Ha Combat Base and Quang Tri Combat Base.

As the month closed, Company C continued it's general support mission; and prepared one platoon for operations in the Moi Loc TAOR.

6. Company A, 3d AT Battalian

The Company CP remained at Quang Tri Combat Base, while two platoons were in direct support of Task Force Hotel; and one platoon was in general support of Task Force Bravo and 3d Morine Division. The platoon in direct support of Task Force Hotel provided security for road sweep teams on Route 9, and provided fire support for infantry units operating from fire support bases in the 4th Marines AO.

7. Swaary

As the month closed the 3d Tank Battalion continued in it's general support role, with tanks in direct support of the 3d Marine Regiment and Task Firce Hotel.

8. Maintenance


