NARRATIVE SUMMARY

1. During the reporting period 1-31 March 1969, the 3rd 155mm Gun Battery (SP) (minus) fired 1,804 rounds on 610 missions. There were no enemy casualties or enemy structures reported destroyed this period. This unit did receive one (1) secondary explosion on Grid AT 73478435, Concentration No. GZ1032 at 1640 hours on 24 March 1969.

During this reporting period, the 3rd 155mm Gun Battery (SP) (minus) was OPCON and ADCON to the 11th Marine Regiment, 1st Marine Division, Da Nang, RVN. "A" Plt., 3rd 155mm Gun Battery (SP) was OPCON to 1st FAG, 1st Marine Division, An Hoa, RVN, from 1-7 March 1969. From 8-31 March 1969, "A" Plt. was OPCON to 2nd Battalion, 11th Marines, 1st Marine Division, at An Hoa, RVN. (Refer to OPCON unit's Command Chronology for data)

On 25 March 1969, the 3rd 155mm Gun Battery (SP) received two (2) Gun Field Artillery, Self-Propelled: 175mm, M107, for familiarization and service practice. The battery fired 3 missions and expended 25 rounds in practice. (Paragraph #2 below)
