ORGANIZATIONAL DATA

1. DESIGNATION STAFF DENTAL OFFICER/COMMANDER

COMPANY DENTAL CLINIC LOCATIONS

a. 3d Dental Company, Headquarters. The 3d Dental Company CP is temporarily located in the Headquarters Battalion Cantonment 4 Clinic in Phu Bai. The Commanding Officer Administrative Officer, Administrative Chief, Clerical and Training Chief, two office clerks, and one staff driver staff the CP.

b. 3d Medical Bn., Phu Bai Site. Four Dental Officers nine Dental Technicians staff this clinic. Operative, prosthetic, periodontic, oral surgery, and preventive dentistry services are provided. Three technicians man the prosthetic laboratory and one technician is assigned to full-time preventive dentistry. The oral surgeon treats the maxillofacial casualty injuries in the 3d Medical Battalion hospital facility.

c. Headquarters Cantonment 4, Phu Bai Site. Five Dental Officers and six Dental Technicians staff this clinic. One technician is assigned to full time preventive dentistry.

d. Supply/Mount Out/Dental Repair Sections, Phu Bai Site. The Dental Supply, Repair and Mount Out Sections are located in Cantonment 4, 3d Marine Division Headquarters, Phu Bai. The Repair Shop will move to Dong Ha.

e. "D" Med. Clinic, Dong Ha Site. This clinic is staffed by three Dental Officers and four Dental Technicians. Two Technicians man the prosthetic laboratory.

f. Division CP, Dong Ha Site. Five Dental Officers and six Dental Technicians staff this clinic. One technician is assigned to full-time preventive dentistry.

g. 1st AMTRACK Bn., Gua Viet Site. A Dental/Surgical Van is in this area and is staffed by one Dental Officer and two Dental Technicians. One technician is assigned to full-time preventive dentistry.

h. 11th Engineer Bn., Dong Ha Site. A Dental/Surgical Van is in this area and is staffed by one Dental Officer and one Dental Technician.

i. Camp Carroll, Dong Ha Site. This clinic is staffed by two Dental Officers and three Dental Technicians. One technician is assigned to full-time preventive dentistry.

j. Cam Lo Site. A Dental/Surgical Van is in this area and is staffed by one Dental Officer and one Dental Technician.

k. Khe Sanh Site. Two Dental Officers and two Dental Technicians are assigned to this clinic. This clinic was destroyed by enemy fire, clinic will be rebuilt. Dental personnel located in Air Force BAS.

l. III MAF Headquarters Site. One Dental Technician is assigned to this site to assist the Force Dental Officer.

PART II

NARRATIVE SUMMARY

The 3d Dental Company furnishes dental support to Marine Corps personnel in the Hue-Phu Bai, Dong Ha, Khe Sanh and Cam Lo areas of RVN.

The 3d Dental Company personnel assist Medical in Mass Casualty Care and are active in the Civic Action Program. The oral surgeons treat maxillofacial wound cases.

The 3d Dental Company CP is temporarily located in the Headquarters Battalion, Cantonment 4 Clinic in Phu Bai. It is anticipated that the Company CP will move to the Division CP area in Dong Ha in the near future.

The Dental Clinic at Khe Sanh was destroyed by enemy fire. The Dental personnel are located in the Air Force BAS, until new clinic or trailer can be provided.

The Dental Clinics at Camp Evans and 3d Engineers were dis-established due to relocation of units. Clinics in new locations will be established in the near future.

2. Administration. The Administrative Officer and Administrative Chief meet daily with the supervisory personnel to discuss problems and disseminate information. They have made trips to III MAF, Dong Ha, Khe Sanh, Camp Carroll, Cua Viet, and Camp Evans to confer with the supervisory personnel in those areas.

3. Command and Control. The Commanding Officer maintains liaison with the Clinic Directors by periodic visits and telephone calls. The Commanding Officer, Executive Officer, and the Administrative Officer confer daily concerning Company operations. The Commanding Officer visited clinics in the Phu Bai, Dong Ha, Cua Viet, Cam Lo, Quang Tri, and Khe Sanh areas.

4. Training. The weekly training program for enlisted personnel (E-3 through E-6) is comprised of a weekly study assignment of subjects in military and professional fields followed by a test covering each assignment.

## 5. Civil Affairs/Military Goverment/Community Relations.

The Commanding Officer of the 3d Dental Company is the Civil Affairs Coordinating Officer. The 3d Dental Company has two dental officers who have received Vietnamese Language Training. The Company's Dental Civil Affairs Program holds DENCAP's at Phu Bai, Quang Tri and Cam Lo areas. The Company's Dental Civil Affairs Program included the rendering of emergency dental treatment to the following villages in RVN, during January 1968.
