

COMPANY DENTAL FACILITIES LOCATIONS

a. 3d Dental Company Headquarters, 1-30 November 1968
 The 3d Dental Company Headquarters, including Mount-Out, Motor Transport, Repair, and Supply Sections, are located in the Headquarters Battalion CP area, Quang Tri Combat Base. Facilities include two tropical huts and three floored strong-back tents.

Company Headquarters	- Commanding Officer, Administrative Officer, Administrative Chief, Training Chief, Clerical Petty Officers (2) and (1) driver.
Supply Section	- Supply Chief, and (1) dental technician
Motor Transport Section	- (2) USMC drivers, (1) USMC Mechanic and supervisory petty officer
Mount-Out Section	- (6) Dental Technicians
Repair Section	- (2) Dental Technicians

b. CP Facility - Quang Tri Combat Base, 1-30 November 1968
 Two tropical huts manned by (6) dental officers and (10) dental technicians. One of the two prosthetic facilities with the company is here.

c. 3d Medical Battalion Facility - Quang Tri Combat Base, 1-30 November 1968
 Tropical hut manned by (2) oral surgeons and (1) dental Officer with (3) dental technicians.

d. Battalion Rears Facilities - Quang Tri Combat Base, 1-30 November 1968
 (1) Tropical hut manned by (1) dental officer and (2) dental technicians.
 (2) Tropical hut manned by (4) dental officers and (6) dental technicians.

e. Division CP - Dong Ha Combat Base, 1-30 November 1968
 Two tropical huts manned by (3) dental officers and (6) dental technicians. Second of company's prosthetic facilities located here.

f. "D" Medical Company - Dong Ha Combat Base,
 1-30 November 1968

Tropical hut manned by (1) dental officer and (2) dental technicians.

g. Battalion Areas - Dong Ha Combat Base, 1-30 November 1968
 Two tropical huts in separate battalion areas, each manned by (1) dental officer and (1) dental technician.

h. Cua Viet, 1-30 November 1968

Tropical hut manned by one dental officer and (2) dental technicians.

i. Vandegrift Combat Base, 1-30 November 1968

Reinforced bunker manned by (1) dental officer and (2) dental technicians.

PART II

NARRATIVE SUMMARY

The 3d Dental Company provides dental support throughout the TAOR of the 3d Marine Division to personnel of the Division. In addition it provides dental prosthetic treatment to Navy personnel of NSA and MCB units in the TAOR. Assistance to Graves Registration is provided in identification of the dead. Company personnel provide support to the Marine Memorial Children's Hospital facility at "D" Medical facility at Dong Ha. Remodeling of the dental facility at "D" Medical, damaged by hostile artillery fire in October 1968, was completed and the facility again became operational on 18 November. The relocated prosthetics facility at Dong Ha CP clinic was completed and became operational on 16 November. Construction of a tropical hut at Quang Tri CP to house the repair section was commenced on

25 November and will be operational the first week in December. Dental civic action support was provided to a 3d Marine Division-2nd ARVN Regiment "County Fair" cordon-and-search operation near Gio Linh on 23, 24, 25 November. The dental facility at Camp Carroll was disestablished due to troop movement on 27 November.

- The dental facility at Camp Carroll was disestablished on 27 November due to a relocation of troops.
- A new tropical hut at Quang Tri CP is currently being built to house the relocated Repair Section.
