1. This plan provides for the logistical support of the 3d Marine Division as the ground component of the III MEF in support of counterinsurgency operations in the Republic of Vietnam (RVN). This plan supports reference (a).

2. The Commanding General, III MEF has reviewed and approved this plan in draft form. It is effective for planning on receipt and for execution when directed.

3. Distribution of this plan will be limited until such time as execution appears probable. Final distribution will be made when units are activated for planning.

4. Reproduction of this document in whole or in part without permission of the issuing officer or higher authority is prohibited, except that authority is granted to make extracts from this plan as necessary for the preparation of supporting plans, if required. Extracts shall be classified by content, but the classification of this plan as a whole is TOP SECRET, NOT RELEASABLE TO FOREIGN NATIONALS. The officer directing that copies or extracts be made shall be responsible for the security control thereof. This plan will not be carried aboard aircraft for use therein.

1. CONCEPT OF LOGISTICAL SUPPORT.

- a. This plan details logistics and personnel instructions in support of reference (a) for the 3d Marine Division in counter insurgency operations (Phase II) in the Republic of Vietnam and assigns specific responsibilities to 3d Marine Division subordinate commands.
- b. The basic concept upon which logistical and personnel support planning is based, is the 3d Marine Division operating as a subordinate unit of the NCC/III MEF in accordance with reference (b). For the first 180 days following commitment, except when support is provided for by interservice agreements or by common or cross service agreements, NCC/III MEF will provide support for the 3d Marine Division. Support for division units will be provided by 3d Marine Division. After 180 days, certain logistical support will be provided by the U. S. Army Logistics Command.
- c. The concept of logistics support is based on rapid deployment of the 3d Marine Division by sea and air. See Annex I (Sealift and Airlift Movement Plan). Logistics responsibilities, supply procedures and Mount-Out instructions will be in accordance with reference (c) unless otherwise modified herein.

- (1) Airlifted units will arrive in objective area (DANANG and QUANG NGAI) with organizational equipment and mount-out supplies sufficient to sustain operations for 5 days. An initial replenishment of ten days of supply for these units will be airlifted into the objective area commencing B-1. Remaining initially not required organizational equipment and required operating stocks will be shipped with seatail of each airlifted unit.
- (2) Surface lifted units will arrive in the objective area with all organizational equipment, available operating stocks, and mount-out supplies sufficient to sustain operations for at least 15 days.
- (3) Remaining Mount-out stocks and 15 days of mount-out Augmentation Supplies will be transported to the objective area by first available shipping.
- (4) The two 30 day resupply blocks of STORM stocks (less Class II repair parts) will be shipped from CONUS sources direct to the objective area (reference (b) refers). Class II (repair parts) will be shipped to 3d Marine Division (Rear) on Okinawa. Subsequent resupply may be on a selective item basis determined by actual requirements if the situation ashore permits such action.
- (5) During the initial phases of deployment, maintenance support will be provided as follows:
 - (a) In objective area (DANANG).
 1. 1st and 2d echelon maintenance - individual units.
 2. 3d and limited 4th echelon maintenance - DIV/LSG, to include maintenance requirements of III MEF, 3d MarDiv and FMAW (ground common items).
 - (b) In rear area (Okinawa).
 1. 4th echelon maintenance - 3d MarDiv (Rear), to include maintenance requirements of III MEF, 3d MarDiv and FMAW (ground common items).

- (6) The CG, 3d MarDiv is responsible for and will approve, all requests for the procurement of material and labor until relieved on order by the CG, III MEF. CMCB, Force ISG, responsible for local procurement, on order, after establishment of FLSG ashore. See Reference (d).
- (7) III MEF logistics responsibilities will include coordination of port operations (including POL), development of logistics bases and ports (air/water), maintenance of interior lines of communications, control of military land transportation and provision of medical services.
- (8) 3d MarDiv logistics responsibilities will include normal supply/logistics functions for division units. In addition, the maintenance on Okinawa with 3d MarDiv (Rear) of a repair capability for performing both echelon maintenance on all III MEF equipment, less aviation peculiar items, and Class II (repair parts) stocks. 3d MarDiv (Rear) will also receive incoming repair parts from CONUS and issue upon request to Division and FLSG.
- (9) Definition. B-day. The day on which execution of COMUSMACV 32-64 Phase II (RVN) Plan is directed.

2. ASSUMPTIONS. It is assumed that:

- a. DANANG and QUANG NGAI will be under friendly control.
- b. An air-landing in the DANANG area will be unopposed.
- c. Sufficient aircraft and shipping will be available to implement the airlift-sealift plan shown in Annex India.
- d. Following the arrival of the first A/C at DANANG there will be sufficient facilities available to sustain an unloading rate of one A/C each 13 minutes for 36-38 hours.
- e. 100% availability of the sea and port facilities and assigned beach areas during deployment in accordance with landing schedules.
- f. Daily Logistics support flights between DANANG, Okinawa and Iwakuni will be commencing B+4 to transport:

- (1) High priority repair parts and cargo to the objective area.
 - (2) Evacuate personnel from objective area, deliver replacements and returned-to-duty personnel to the objective area.
 - (3) Evacuate vehicles and equipment for maintenance at Okinawa and return.
- g. III MEF will assume force Logistics Support Functions from 3d Mar-Div as outlined in paragraphs 7.a.(3)(a) through (k), of reference (c), (except dental) by B+20.
 - h. III MEF will establish and operate medical facilities for III MEF Forces.
 - i. III MEF will establish and maintain interior LOC's in the MEF area until relieved by Commander, U.S. Army Logistics Forces.
 - j. The U. S. Army Logistics Command will be operational by approximately B+60 to control common-user land transportation. Operate and further develop the POL distribution system, provide POL lab facilities, initiate resupply action on common-item support, provide some medical services, provide purchasing and contracting services, coordinate and allocate available local resources, coordinate establishment of land lines of communication, and develop logistics bases in DANANG area.
 - k. III MEF will furnish to Commander, U. S. Army Logistics Forces by B+60 common-item supply requirements for resupply after B+180.

3. LOGISTICS MISSION OF THE 3D MARINE DIVISION.

- a. Normal internal Logistics support to division units.
- b. Establish and operate Beach Support Area's (BSA's).
- c. Provide initial supply support (less Avn Supplies) to all elements of III MEF. Forward Avn Supplies to FMAW.
- d. Provide third echelon and limited fourth echelon maintenance support to all elements of III MEF except FMAW units.

- e. Operate the Port of DANANG and other ports in III MEF area as necessary to unload MEF Forces, supplies and equipment, until relieved by FLSJ.
- f. Establish and maintain interior LOC's in tentative assigned area shown on Annex A (Administrative Overlay).
- g. Provide graves registration functions in accordance with Annex B (Personnel).
- h. Establish and operate medical evacuation stations in BSA.
- i. Be prepared to establish and operate in DANANG area, the following AAFS at the tentative locations shown on Annex A (Administrative Overlay).
 - (1) 400,000 Gal. - JP-4/JP-5
 - (2) 300,000 Gal. - MOGAS
 - (3) 100,000 Gal. - 115/145 AVGAS
- j. Be prepared to establish and operate one AAFS, 400,000 gal capacity, JP-4/JP-5, in vicinity of QUANG NGAI Airfield shown on Annex A (Administrative Overlay).
- k. Be prepared to provide supply and maintenance support, and emergency medical and emergency dental service to U. S. in-country units, RVN Forces and Allied Forces, on order.
- l. Be prepared to provide, on order, medical support to III MEF units not organic to the Division.
- m. Be prepared to provide, on order, dental support to III MEF units not organic to the Division.
- n. Provide on Okinawa 4th echelon maintenance on equipment evacuated by Division/MEF ISG.
- o. Provide on Okinawa supply support facilities for Class II supplies (repair parts, especially).
 - (1) Receive and stock Class II (Repair Parts) resupply shipments from CONUS.

- (2) Receive from, process and ship to area of operation (utilizing airlift where available and feasible) requests for Class II supplies from Division (or Force) LSG.

4. SUPPLY.

a. General.

- (1) Airlifted units, if landed on or about B-day in the DANANG, TAM KY and QUANG NGAI areas must be self sufficient until arrival of sealifted elements of the Division, on or about B+8.
- (2) 3d MarDiv will provide supply support for III MEF from B+2 until relieved by III MEF approximately B-20, after establishment of Force LSG ashore.

(3) Prescribed loads.

(a) Airlifted Units.

Class I - 5 days

Class II - Essential TA/TE items for 10 days operations ashore plus required spare parts.

Class III - 5 days packaged.

Class V - Basic Allowance plus 5 days.

(b) Sealifted Units

Class I - 2 days

Class II - TA/TE allowance and repair parts.

Class III - 2 days

Class V - Basic Allowance plus 2 days.

If adequate shipping is available, units will embark with 30 days supply.

c. Control and Distribution.

(1) Control

(a) Airlifted units

1. Units designated to be prepared for early redeployment will retain custody over their embarked supplies (5 days prescribed load).
2. Units remaining at DANANG will retain 2 days supplies. Excess supplies, approximately 3 days of Classes I, III and V will be delivered to dumps on the airfield (Annex A - Logistics Overlay) under the control of Cmdr, Air Echelon, Div LSG. All subsequent airlifted replenishment supplies I, III and V will be placed in Air Echelon Div LSG dumps established within the airfield complex.

(b) Sealifted Units

1. Upon arrival of sealifted forces (less SLF), Cmdr, Div LSG established custody and control of the following landing force supplies:
 - a. All replenishment supplies except Classes II(A) and IV(A).

(a) Supply point distribution initially until establishment
of Div LSG dumps ashore, approximately B+9.

(b) During surface lift unloading, Class I, III and V supplies
embarked with units and delivered to marked dumps in the
Beach Support Area will be held until Prescribed Loads of
units can be moved forward to unit dumps.

(c) For units prepared to redeploy to TAM KY and QUANG NGAI:

1. Redeploy with 5 days I, III and V. Subsequently,
unit distribution will be by airlift from DANANG
to maintain an initial minimum 3 day supply level.
Upon arrival of the first airlift replenishment at
DANANG, dump levels at TAM KY and QUANG NGAI will be
increased to 5 and then 10 days at the earliest.
2. After landing of Div LSG, dump level at TAM KY and
QUANG NGAI will be increased to from 15 to 30 days
by air or surface resupply.
3. Supply point distribution for units in the TAM KY
and QUANG NGAI area from local dumps until further
notice.

(d) After establishment of Force LSG, unit or supply point
distribution to be prescribed.

d. Replenishment and Resupply.

- (1) During the period B-day to B+10, airlifted ground units will

supplies in not less than 5-day increments to maintain prescribed loads, para. 4.a.(3)(a) above. Beginning B+8 surface lifted ground units will start arriving with 15 days mount-out supplies.

- (2) Approximately 30 days replenishment (15 days mount-out plus 15 days mount-out augmentation) not shipped with deployed units will be embarked in first available shipping to arrive not later than B+23 in accordance Annex I, Reference (b).
- (3) Two 30-day STORM resupply blocks will start phasing into the objective area by B+35.
- (4) Replenishment Class II repair parts for ground units will be from 3d MarDiv (Rear), Okinawa.
- (5) Standard requisitioning procedures will be substituted for automatic procedures as early as practicable.
- (6) Cmdr, Div LSG responsible for local procurement for III MEF units until relieved, on order. See MCO 4230.3A (Procedures for Procurement in Friendly Foreign Countries).
- (7) See Annex I (Sealift and Airlift Movement Plan) for supply movement schedules.

e. Captured Material

- (1) Material of intelligence value will be reported and evacuated through intelligence channels. See Annex D (Intelligence) to reference (a).
- (2) All other materials:
 - (a) Report location to CG, III MEF via this Headquarters.
 - (b) Use of material by our troops prohibited, except in emergency, until re-issued.
- (3) Whenever possible, items released by CG, III MEF will be turned over to in-country forces and/or civil affairs agencies.

f. Salvage and Critical Scrap

- (1) In accordance with Chapter 14 of reference (d).
- (2) Initially units deliver salvage material to collection point ISA. Upon establishment of Div LSG ashore collection of salvage material will be made from units to which it makes distribution where possible.
- (3) All units salvage all fuel and diesel drums and bungs. Return to Class III supply points for refilling and re-issue.
- (4) Div collection points - Annex A (Admin Overlay).

g. Aerial Delivery.

- (1) Request for aerial delivery will be made to this Headquarters in accordance with Chapter 15, reference (d). All requests will receive priority handling and be forwarded, with coordinating instructions, to CG, FMAW in accordance with Wing Order 4631.5.
- (2) After establishment of Force LSG ashore, requests will be passed to Cmdr, FLSG via normal request channels for action.

5. EVACUATION AND HOSPITALIZATION

- a. See Annex C (Medical)

6. TRANSPORTATION

a. To the objective areas.

- (1) Planned allocation of A/C and Shipping is tentatively based on airlift requirements listed in Appendix 2 (Airlift Movements) and 3 (Sealift Movements) to Annex I (Sealift and Airlift Movement Plan) of reference (b).

- (c) The Division Motor Transport Officer is responsible for establishing coordination and control measures essential to insure maximum economical use of vehicles in the objective area.
- (d) The Division Provost Marshall is responsible for establishing and enforcing related traffic control measures in the objective area.
- (e) After establishment of III MEF Headquarters in the DANANG area, CG III MEF will assume control on order.

- (1) Prisoners of War will be handled in accordance with references (k) and (l).
- (2) Commanding Officer, Division Military Police Company will assume control of Prisoner of War collecting points on order.
- (3) Capturing organizations are responsible for safeguarding and evacuating POW's to collection points.
- (4) The Force Logistic Support Group Commander will provide and operate a temporary POW stockade in the III MEF operating area for the initial internment of prisoners.

- (2) Religious services in objective areas to be scheduled and conducted in accordance with reference (m) as the situation permits.

g. Decorations and Awards

- (1) In accordance with reference (c), (n) and (o).
- (2) Organizations submit award recommendation cards (NAVMC 539-PD) to CG, 3d MarDiv for further transmittal to CG, III MEF.

8. Civil Affairs - Military Government. See Appendix 2 (Civil Affairs - Military Government) to this Annex.

9. Personnel Procedures

- a. Personnel accounting and administration in accordance with references (a), (b), (c), (d) and (p) and this Annex.



1. General

- a. III MEF will activate a Casualty Reporting Control Center (CRCC) at its headquarters. Upon activation, all organizations/units of the 3d MarDiv down to and including company level and battalion aid stations are designated as having casualty reporting responsibilities. Elements below company level, who are attached, shall be reported upon by the operational superior except when the operational superior is a regimental commander. Regimental commanders shall designate an activity to assume responsibility for unit casualty reporting for such attachments.
- b. Organization/Unit Commanders and other elements having casualty reporting responsibility will comply with reference (a) in submitting casualty information to III MEF CRCC. Electronic Accounting Machine procedures will be utilized to produce reports necessary to the system.
- c. Combat casualty reporting as used in reference (a) means the reporting of changes in the status of those Marines and attached personnel from other services who are lost to the parent combat unit because of death, capture, wounded, missing, ill or injured. "Wounded-in-Action-Not-Evacuated" will be reported for administrative purposes.
- d. The success of the reporting system requires that all personnel who may be responsible for carrying out specific procedures of the system be familiar with their particular responsibilities. Of prime importance are the tasks performed at the "Reporting Unit" level, involving the completion of casualty and burial cards, and the forwarding of these cards to the CRCC by the most expeditious means.
- e. Commanders having casualty reporting responsibilities will

insure that personnel concerned understand the current procedures specified in references (a), (b) and this Appendix.

2. Casualty and Burial Cards

- a. Casualty Card, USMC, NAVMC 10453-PD (Rev 12-60) will be the standard form used as the primary casualty means and source document.
- b. Burial Card, USMC, NAVMC 10454-PD (Rev 12-60) will be used by Graves Registration Teams.
- c. A casualty card will be prepared by reporting units on all casualties passing through the medical and/or evacuation chain of command:
 - (1) When initially admitted for treatment.
 - (2) When treated and simultaneously returned to duty.
 - (3) When treated (processed) and evacuated.
 - (4) When returned to duty after treatment or hospitalization.
 - (5) When evacuated.
 - (6) When death occurs after admission.
 - (7) Upon KIA's.
 - (8) Whenever the status of the casualty changes other than noted above (injury, wound or death occurring subsequent to the initial report).
- d. In addition to those listed above, all organizational/unit commanders and elements having casualty reporting responsibilities will submit casualty cards on the following occasions:
 - (1) When personnel are known to be missing in action.
 - (2) When personnel are known to be captured.
 - (3) When personnel are known to be KIA and their bodies not recovered.

- (4) When personnel are known to have received superficial wounds in action which do not result in their loss to the unit.
- (5) When personnel are known to have been buried in temporary or isolated graves.
- (6) When personnel are a loss to the unit as a result of being injured or ill in a non-battle status.
- (7) Whenever the status of a casualty is known to change, i.e., MIA to KIA.

3. Preparation

- a. The first level of medical services that services the casualty will prepare casualty cards for those occurrences set forth in sub-paragraph 2.c. above.
- b. The lowest echelon with an administrative capability will prepare casualty cards for those occurrences set forth in paragraph 2.d. above.

4. Processing of Casualty Reports

- a. Casualty cards shall be packaged and forwarded as completed to the nearest unit CP for consolidation and transmitted by the most expeditious methods to the CRCC. Reports will be made as of 2000 to reach CRCC by 2400. (When no casualties occur, negative telephone or message reports will be made after 2000).
- b. Casualty and burial cards will not be forwarded by reporting units until the III MEF CRCC has been established.
 - (1) All casualty reporting activities will be notified by message when CRCC is in operation.

5. Casualty Reporting Control Center

- a. The CRCC will be established at III MEF CP on activation for operations.
- b. The CRCC shall maintain sufficient casualty and burial cards as described in paragraph 2.a. and 2.b. above for distribution to subordinate units upon request. In addition, it is essential

that the CRCC have available for use thereat, an adequate supply of printed standard machine tabulating casualty card (NAVMC 10453A-PD) and burial card (NAVMC 10454A-PD).

6. Casualty and Burial Bulletins

a. III MEF CRCC will promulgate the following reports:

- (1) Daily Casualty Bulletin.
- (2) Casualty Diagnostic Listings.
- (3) Command Losses by MOS and Rank.
- (4) Daily Patient Listing.
- (5) Patient Admissions and Dispositions.
- (6) Unit Casualty Losses by MOS and Rank.
- (7) Daily Burial Bulletin.

b. Copies of the Daily Casualty Bulletin will be sent to tactical units through company level. Any discrepancies or omissions noted in the bulletin shall be reported to the CRCC as soon as possible.

7. Coordinating Instructions. Subordinate units will mount out with sufficient copies of the following (based on ten percent of actual strength of units):

- a. Casualty Card, USMC, NAVMC 10453-PD (Rev 12-60)
- b. DD Form 1380 and/or blank "baggage type" tags.

Appendix 2 (Civil Affairs and Military Government) to Annex B (Personnel)
 to 3d MarDiv Administrative Plan 32-65 II (RVN)

1. Mission. The civil affairs mission of all commands within the III MEF is to support tactical operations, and in accordance with existing agreements, assist in maintaining law and order, support friendly local and other government echelons. Further, to assist in separating the insurgent forces from the people by aiding in the rehabilitation of local population, government and economy as permitted by local resources, military supplies and supplies or technical assistance provided by member agencies.
2. General
 - a. The primary responsibility for the exercise of CA control and authority over the local population, institutions, facilities and resources remains a function of the sovereign government concerned.
 - b. Because of the nature of Communist operations, there will be a strong insurgency threat to local government and MEF. Therefore, the authority exercised, responsibilities assumed and action taken by the military commanders with respect to the lands, properties and inhabitants thereof may, to a large degree, affect military operations.
 - c. Civil affairs operations will be conducted in such a manner as to compliment military operations by gaining support of the people and contributing to the isolation and defeat of the guerrilla or insurgent forces.
 - d. Emphasis will be placed upon development of local resources, both personnel and material to provide support in depth to III MEF objectives, and to strengthening and rehabilitating of government machinery in the area.
 - e. Military resources will not be diverted to civilian use except where failure to do so would endanger the security of friendly forces or seriously interfere with attaining military objectives.
 - f. Civil affairs operations and activities will be conducted in

accordance with international laws as well as treaties and agreements in effect or which may be subsequently negotiated between COMUSMACV and the recognized governments concerned.

3. Governmental Functions

- a. Whenever possible, civil affairs operations will be conducted through existing governmental channels, making maximum utilization of existing personnel, facilities and installations.
- b. Replacement or reorganization of local governmental structure will be in accordance with agreements negotiated with the appropriate national government, or by policies established by COMUSMACV.
- c. In liberated territory, Communist or politically compromised local governments, officials or agencies will be suspended or removed. Commanders will be prepared to initiate military government in liberated areas, pending the establishment of control by the appropriate civil government.
- d. Communist doctrine, policies and practices will be discontinued in all occupied areas immediately.
- e. In areas where military government is established, commanders will seize and secure all public records until screening or disposition can be made.

4. Legal

- a. The legal status of III MEF military forces will be as set forth in directives from COMUSMACV when relevant agreements have been made. Tab A is a guide for a Status of Forces Agreement.
- b. This Headquarters will establish civil affairs courts as necessary in areas where military government is imposed. Commanders will not interfere with the operations of local civil courts; they will cooperate with these courts in all matters that do not interfere with military operations.
- c. 3d MarDiv personnel will not be used in the enforcement or administration of indigenous criminal or civil law.

5. Public Order

- a. Enforcement of local criminal and civil law will be accomplished by the authorities of the government concerned. When local

authorities are incapable or unwilling to maintain law and order, commanders will establish the control required to provide for the security of their forces and the accomplishment of their mission.

- b. Local nationals apprehended by 3d MarDiv personnel in the commission of crimes against military forces or installations will be turned over to local civil authorities unless otherwise directed by this or higher headquarters.
- c. All incidents involving Division personnel and local civilians will be reported immediately to this Headquarters (Attention: Division Civil Affairs Officer).
- d. Commanders will plan jointly with local officials to integrate warning system and to effect joint cooperation in civil defense, rear area security and damage control activities.

6. Public Health

- a. Medical assistance is a significant factor in gaining the support of the civil population. Medical aid to the local civil population will be furnished to the maximum extent practicable, consistent with military needs and available facilities.
- b. Native customs or taboos will be observed where practicable, in the provision of medical aid and assistance.
- c. 3d MarDiv Surgeon will coordinate with and support medical activities conducted by local government or welfare agencies in the area of operations. Restoration and establishment of sanitary and public health facilities will be accomplished to the extent required to safeguard the health of Division personnel.

7. Public Welfare

- a. Public welfare activities are a responsibility and function of the local governments concerned. Welfare institutions and facilities will not be used for military purposes except in cases of acute tactical necessity.
- b. Commanders' activities in support of local welfare organizations will be within the availability of resources approved by COMUSMACV and will respect native customs and usage.

8. Public Education

- a. Public education is the responsibility of the local government. Unit commanders will insure that school buildings and facilities are not used for military purposes, except in cases of tactical necessity.

9. Economics

- a. In order to gain support of the local population, 3d MarDiv commanders will take all practicable measures to improve the economic condition in the occupied area.
- b. Technical assistance, advice and encouragement will be provided local governments and businessmen in the production of consumer items that contribute to economic stability and prevent disease and unrest.

10. Food

- a. Commanders will take necessary measures to insure that troops do not destroy growing crops or food stocks except in cases of tactical necessity. Essential local requirements will have first priority for use of local food stocks, production and processing facilities.

11. Price Control and Rationing

- a. Price control and rationing are responsibilities of the local government.
- b. CG III MEF will regulate the purchase of local commodities and the disposition and resale of III MEF military supplies or commodities to prevent creation of inflationary prices.

12. Property Control

- a. Commanders' use of public and private property will be in accordance with the Status of Forces Agreements negotiated with the host national government.

13. Public Finance

- a. Commanders will recommend to CG III MEF any necessary action to protect banks in the combat area from looting and unlawful disposition of wealth.

- b. Although banking and currency matters are the responsibility of the host national governments; commanders will insure the value of currency by:
- (1) Paying their personnel in a currency to be determined by the national authorities concerned.
 - (2) By preventing unauthorized currency practices by III MEF personnel in the area of operations.
- c. The commander in an occupied or liberated territory (unless authorized by COMUSMACV) will prohibit any foreign exchange transactions, including the importation of any foreign exchange assets or the exportation of any property from occupied territory.

14. Civilian Supply

- a. The host national government has the responsibility for civilian supply and relief. When local authorities are unable to protect stocks of civilian supplies from looting or destruction, commanders will provide all available assistance to these agencies.
- b. Commanders will make supplies available to prevent disease and hunger among the local population. Captured enemy subsistence and material may be used in accordance with COMUSMACV established policy. Civilian agencies and channels will be used for the distribution of relief supplies. When national or military stocks are used the distribution will be supervised by military personnel and appropriate end use checks established.

15. Public Works and Utilities

- a. Local national authorities are responsible for the operation and maintenance of public works and utilities. These may be used by the military to the extent that military use does not jeopardize the health and welfare of the civilian population.
- b. Supplies furnished to support public works and utilities will be in accordance with the established policy of the nation concerned.

16. Public Transportation

- a. Supervision of public transportation is the responsibility of the host national government. Military use of public transportation is authorized in accordance with agreements with the

responsible national agency. Private transportation will not be appropriated except in cases of urgent military necessity. Private transportation may be rented or contracted on a mutually agreeable basis.

17. Displaced Persons and Refugees

- a. In Thailand and Republic of Vietnam, the civil authorities are responsible for the control of civilian refugees.
- b. Where military government is established, commanders are authorized to prohibit refugee use of MSR's. Return refugees that cross international boundaries to their native country. Establish civilian collection points as required to control civilian movement.
- c. Commanders will utilize local resources to the fullest in the operation and supply of civilian collection points or camps.

18. Civil Information

- a. The host national government is responsible for the control of civil information media and the coordination of these media in public information and psychological warfare activities.
- b. Commanders will exercise the control necessary over local information media to accomplish III MEF objectives and control civil populace in areas where military government is established.

19. Civil Affairs Support

- a. The following personnel and units are available to the commanders to coordinate and support the civil affairs effort in III MEF area:
 - (1) The Law/Civil Affairs Officer on the staff of the III MEF will be the coordinating and control officer for III MEF in all matters dealing with civil affairs.
 - (2) The Army of the Republic of Vietnam has three civil affairs companies (137 men each) in the field. One of these units is located in the DANANG area. In addition, the government has civil affairs cadres within the Ministries of Civil Action, Public Health, Education and Social Welfare. These units are accustomed to working in conjunction with military operations and can be made available to assist in civil affairs duties.

- (3) The U. S. Army will have a civil affairs company available to support U. S. operations in the Republic of Vietnam. Platoon C of this company (58 men) will provide the support for III MEF. If possible, platoon C will accompany III MEF into the area of operations.
- b. Proclamations for implementation of civil affairs operations will be issued by COMUSMACV. In cases where adequate policy guidance is not available or additional information is required concerning civil affairs - military government operating principles in the 3d MarDiv area, commanders will request information from this Headquarters (Attention: Civil Affairs Officer).
20. For conduct of troops in civil affairs and personal conduct in host country matters, see Appendix 3 (Instructions to Troops) this Annex.

DRAFT OF ANY EMERGENCY STATUS OF FORCES (SOF) AGREEMENT. (It is assumed that such an emergency SOF Agreement will be concluded in the form of an exchange of notes between the Foreign Ministry or other appropriate authority of Republic of Vietnam and the U. S. Ambassador, or Commander of the U. S. Forces in the Republic of Vietnam.)

PREAMBLE

1. The Embassy of the United States of America (the Commander U. S. Forces in Republic of Vietnam) presents its (his) compliments to the Ministry of Foreign Affairs and has the honor to state that the discussions that have taken place between us concerning the status of U. S. Forces deployed, or to be deployed, in the Republic of Vietnam at the request of the Republic of Vietnam Government, has let to agreement as follows:

SUBSTANTIVE PROVISIONS

2. a. The designated U. S. Commander or, in his absence, the senior U. S. Military Commander present shall have exclusive control of the U. S. Forces and the direction thereof.
- b. The U. S. Forces shall have the right to occupy any area or facility considered necessary for the accomplishment of their mission or for their safety and continued security, as determined by U. S. Military Commanders, and to install such equipment therein as they shall deem necessary for these purposes.
- c. Military Commanders of the U. S. Forces may take such measures as they deem necessary to provide adequate security for their installations, personnel and equipment, and for the movement of personnel and supplies in Republic of Vietnam. Within installations utilized by the U. S. Military forces, military commanders shall have absolute and full authority to maintain discipline and order among members of the U. S. Forces. Outside such installations, Military Police of the U. S. Forces shall have full authority, subject to such further arrangements as may be made with local police authorities, to maintain

discipline and order among members of the U. S. Armed Forces. In the event of acts of violence against U. S. installations, equipment, or personnel by persons other than members of the U. S. Forces, such persons may be apprehended by the U. S. Forces and turned over to the Government of Republic of Vietnam for appropriate disposition in accordance with laws of the country.

- d. In the event of internal disorders which may materially affect the mission or security of the U. S. Forces, such as armed violence or widespread rioting, the Government of Republic of Vietnam will endeavor to quell such disorders with its own resources. However, should these measures prove ineffective, or should the Government of Republic of Vietnam request assistance, or should the U. S. military commander consider that the Government of Republic of Vietnam does not possess the capability of quelling such disorders effectively or in time, the U. S. Forces may take such action as the U. S. military commander deems necessary, either unilaterally or in cooperation with the Government of Republic of Vietnam.
- e. The Government of Republic of Vietnam shall make available to the U. S. Forces such information and intelligence reports as will assist them in achieving their missions or as the U. S. military commander requests.
- f. The authorities of the U. S. shall have the exclusive right to exercise criminal jurisdiction over any member of the U. S. Forces, except those who are nationals of or ordinarily residents in Republic of Vietnam. The authorities of the U. S. undertake to maintain discipline over such persons and to insure full respect by them for the laws of Republic of Vietnam.
- g. No civil action shall be brought in the courts of Republic of Vietnam against any member of the U. S. Forces.
- h. Claims arising out of the acts or omissions of the military members of the U. S. Forces; of civilian employees of the U. S. Forces who are not Vietnamese nationals and out of acts or omissions of employees of the U. S. Forces who are nationals of the Republic of Vietnam which occur while they are acting within the scope of their employment, may be referred to a U. S. foreign claims commission for settlement under claims legislation of the U. S.
- i. Property of the U. S. Forces, its instrumentalities, and of its members shall be permitted to enter and exit Republic of

Vietnam free of customs, duties, taxes, other fees and inspection.

- j. The U. S. Forces and its members may receive and send mail or packages, both personal and official, through U. S. postal facilities or any other channels free of any duties, taxes, other fees or inspection.
- k. The U. S. Forces may undertake such military movements as are required.
- l. The U. S. Forces, its instrumentalities, and the members thereof; shall be exempt from any and all fees, charges and taxes whether direct or indirect of Republic of Vietnam or its political sub-divisions.
- m. The Government of Republic of Vietnam will furnish to units of the U. S. Forces, free of charge of any kind and without present or future U. S. liability for claims arising out of the U. S. use thereof, installations and facilities which are determined to be necessary to support U. S. Forces in their mission. The U. S. Forces may develop areas and facilities made available to them by the Government of Republic of Vietnam.. Expenses involved therein shall be borne by the U. S. Government, except where such development is for the combined use of the United States and Republic of Vietnam in which case the cost shall be borne by the two Governments on the basis of proportionate usage. The U. S. Government will be under no obligation to restore there areas to their original use or to repair roads and bridges utilized by the U. S. Armed Forces, and will be held harmless by the Government of Republic of Vietnam for any and all claims for the restoration or repair thereof. The United States shall retain title to all U. S. owned removable property placed within agreed areas and facilities, and may remove such property from Republic of Vietnam or may upon the departure of its forces from Republic of Vietnam otherwise dispose of such property to the Government of Republic of Vietnam free from all local taxes, duties, or fees.
- n. Official vehicles of the U. S. Forces shall be distinctly marked and shall be exempt by Republic of Vietnam from registration, licensing, or any tax payable in respect to the use of vehicles. Authorized operators of vehicles of the U. S. Forces shall be exempt from compliance with the local laws and regulations pertaining to the operation and use of vehicles.
- o. The U. S. Forces will conform to the traffic rules and regulations of Republic of Vietnam to the extent that exigencies of the military situation permit.

- p. The Government of Republic of Vietnam shall provide, within the limits of its capability, under mutually satisfactory financial arrangements, all services and supplies necessary to support the U. S. Forces. The items to be provided will be determined through mutual agreement of the authorities of Republic of Vietnam and the U. S. military authorities. The U. S. Forces may purchase or procure from the local economy, either directly or through the Government of Republic of Vietnam any items needed in the performance of the military mission.
- q. The Government of Republic of Vietnam shall procure local labor required for support of the U. S. Forces as requested by the latter, both as to number needed and the types of skill required. This labor shall be provided to the U. S. Forces at the expense of the Government of Republic of Vietnam, which among other matters will assume responsibility for, and save the U. S. Government harmless from, all claims arising from acts or the omissions of such employees done other than in the performance of duties assigned by the U. S. Forces.
- r. The Government of Republic of Vietnam authorizes aircraft of the U. S. Forces to land in and overfly areas subject to Republic of Vietnam jurisdiction as may be required, without any charges, taxes or fees whatsoever. The Government of Republic of Vietnam authorizes U. S. Naval vessels and vessels transporting cargoes for the U. S. Forces to enter the territorial waters and harbors without inspection and free of all taxes, customs, duties, charges and fees.
- s. The Government of Republic of Vietnam authorizes U. S. Forces to bring nuclear weapons into Republic of Vietnam, to station them at such locations as may be deemed necessary.
- t. This agreement shall come into force immediately upon being signed by both parties, and shall remain in force until ninety days after the departure of the U. S. Forces from Republic of Vietnam unless previously terminated by mutual agreement. Both the English and Vietnamese texts of this agreement are equally authentic.
- u. Members of the U. S. Forces include military members of the U. S. Armed Forces, civilian personnel accompanying, serving with, or employed by the U. S. Forces who are not ordinarily resident in the Republic of Vietnam and the dependents of such persons.

Appendix 3 (Instructions for troops) to Annex B (Personnel) to 3d MarDiv

Time Zone: Hotel (in objective area)

1. All personnel of this command must be aware of the importance of good civil - military relations and their direct effect upon the 3d MarDiv mission.
2. Division operations in the objective area will be conducted in an area that is occupied by civil population residing in towns, villages and farms. The personal and property rights of these people must be respected.
3. Insurgent bands will provide a strong threat to the civil population, for without the people's support the guerrillas lose their main source of supplies, intelligence and recruits. Therefore, it is necessary for friendly forces to exert every effort to win the friendship and support of the population in the objective area. To accomplish this important mission, the following rules will be strictly adhered to (except in cases of acute tactical necessity).
 - a. All personnel will respect and refrain from disturbing or trespassing upon or near sites of religious significance such as churches, temples, tombs or graveyards.
 - b. Afford maximum protection to the arts, monuments, and buildings of religious or historic significance. Military use or temporary occupation of such buildings is strictly prohibited. Destruction of such objects will be accomplished only on order of higher authority.
 - c. All personnel will respect the customs and traditions of the civil populace. All local nationals will be treated with respect, particularly elderly people.
 - d. Troops will not enter orchards and pick fruit or otherwise disturb growing crops and local food stocks. Straw mats, rice bags and other similar personal items will not be tampered with or taken from local inhabitants. The exportation or removal of any civil property is prohibited.

- e. Private transportation will not be appropriated except in cases of urgent military necessity. Troops will obey all local laws, regulations and taboos of the civil population in their area, that do not conflict with their individual fundamental rights as citizens of the United States.
 - f. Troops will not attempt to deal with the civil population in any but local currency; the local laws forbid the use and possession of foreign currency. Monthly acquisition of U. S. currency for all Division personnel will be strictly controlled and limited to \$100.00 per month for each man.
 - g. There will be no tampering with reservoirs, lakes, ponds, wells or any part of the local water supply system. U. S. forces will not use local sources of drinking water.
 - h. In the event of interference by civilians with military operations, 3d MarDiv forces will remove the local inhabitants from the problem area and immediately turn them over to the local government's civil affairs liaison unit. In all cases where time and the tactical situation permit, the local civil affairs liaison unit will be called upon to handle civil populace and minimize mutual interference.
 - i. 3d MarDiv forces will provide medical assistance to the civil populace whenever possible provided this service does not affect the immediate military needs of Division personnel and supplies.
 - j. Troop adherence to the basic qualities of honesty and sincerity will make each Marine an Ambassador of good will and will be an outstanding step toward the accomplishment of the Division mission.



1. General.

- a. The DANANG area and vicinity are tropical areas characterized by four seasons: - dry and relative cool (February - April); hot and dry (May - July); rainy and hot (August - October); and rainy and cool (November - January). The average annual rainfall is 84.2 inches and the relative humidity averages 82.8 percent. Typhoons appear seasonally, usually October-November.
- b. The general health of the people is poor. Public health problems are aggravated by the adverse climate, poor sanitation, economic problems created by war, refugees, poor nutritional status of the people, and compounded by overcrowding in the narrow coastal strip on the South China Sea.
- c. There is a narrow coastal plain which is seldom over 20 miles in width. This area is densely populated. The land itself is level along the coast but becomes gently rolling inland toward the mountains. Behind the coastal plain lies an area of mountains and hilly plateaus. The plateaus lie between 1000 and 3000 feet above sea level. The mountains are mostly under 5000 feet above sea level, but some reach as high as 6000 to 8000 feet.

2. Water

- a. Questionably potable water for DANANG is presently supplied from two wells with capability of providing 15-20 cubic meters of water per hour. Two more are under construction which should provide an additional 65 cubic meters per hour. Water is also drawn from private shallow wells that are generally 3-4 meters deep, the water table generally being only a few feet below the surface. A few of these wells sometimes dry up during the dry season.

- b. The compound occupied by Task Element 79.3.3.6 obtains its water from its own well, 408 feet deep, with a capacity of 60 gallons per minute. This water is of good quality and is chlorinated to provide a chlorine concentration of approximately one part per million at end source.
- c. Water is of insufficient quantity and unsatisfactory quality in the rural areas.

3. Food

- a. Supply, Rice is the most important crop. Other crops include corn, sugar cane, sweet potatoes, beans, cabbages, tomatoes and other vegetables.
- b. Food sanitation. There is little food sanitation and inspection. Human excrement is used in some areas as fertilizer. In the market flies are numerous, especially during the rainy season. The local fresh milk supply is generally poor and inadequate, and there are substantial losses of foodstuffs through rot and insect infestation. DANANG has 500 cubic meters of cold storage space and an ice capacity of 15 tons per day. Two cases of infectious hepatitis have been traced to this ice recently. The Municipal Slaughterhouse in DANANG butchers from 50 to 65 pigs and 1 to 12 cattle per day. Methods of handling and slaughtering are primitive and there is no cold storage at the slaughterhouse. Pork is usually sold the day it is killed, but beef may be held until the next day.

4. Waste Disposal.

- a. In DANANG the lack of piped water system precludes the presence of a water-borne sewerage system. It is probable some of the government buildings and better homes are equipped with individual septic tanks, but the overall system of waste disposal is undoubtedly unsatisfactory.
- b. In rural areas human wastes and refuse are disposed of in open fields, canals, and rivers, although there has recently been legislation prohibiting this. Night soil is used for fertilizer.
- c. In the larger towns garbage is placed in open containers, collected in open carts, and transported to dumps.

5. Insects and Animals of Importance to Man.

a. Vectors and disease.

(1) Mosquitoes

- (a) Anopheles. Twenty-two species have been identified of which 13 are vectors of malaria. The major malaria vectors are Anopheles minimus and A. jeyporiensis. Both of these species are strongly attracted to man and breed principally after the rainy season when swift upland streams become sluggish and form pools of stagnant water. Malaria is most prevalent in the foothills, mountains, and high plateaus.
- (b) Aedes. A. aegypti and A. albopictus are the chief vectors of dengue fever and filariasis.
- (c) Culex. C. quinquefasciatus (C. fatigans) a C. tritaeniorhynchus is a possible carrier of Japanese "B" encephalitis.

- (2) Lice. Pediculus corporis (body louse) is capable of transmitting relapsing fever and epidemic typhus fever.

(3) Flies.

- (a) Common housefly prevalent throughout the country. Plays a major role in spreading dysentery. Also implicated in trachoma.
- (b) Biting flies. The horse fly or deer fly is found throughout SOUTH VIETNAM. Especially troublesome in the jungle area from May to October.
- (c) Common blow fly (Lucilia sericata). The mechanical transmitters of yaws, myiasis, and certain eye diseases.
- (d) Sand fly (Phlebotomus). P. argentipes is a vector of both visceral and cutaneous leishmaniasis and is prevalent in SOUTH VIETNAM.
- (4) Fleas. The rat flea (Xenopsylla cheopis) is the chief vector of plague and murine typhus in area.

- (5) Rodents. Rats (black, brown, and bamboo), mice, voles squirrels and other rodents are abundant throughout SOUTH VIETNAM. Rodents carry lice, fleas, and mites, which are the vectors of plague, muine typhus, and other disease. The excreta of rodents may contain organisms of the Salmonella groups, Leptospira ictero-hemorrhagiae, and a variety of parasitic ova. Spirillum minus, which causes rat-bite fever, is transmitted by the bite of the rat.

b. Snakes

- (1) Cobras. Three varieties. All poisonous. Neurotoxic venom.
- (2) Pit Vipers. Variety of pit vipers, all moderately poisonous. Russell's viper is very poisonous and able to inject double the lethal dose for man in a single bite. Hemotoxic venom.
- (3) Kraits. The common krait and the banded krait. Neurotoxic venoms, more toxic than that of the cobras.
- (4) Water snakes. At least 10 species of poisonous water snakes, usually near the shore in coastal waters.

c. Other animals

- (1) Leeches. Found on the grasses and weeds along paths and near water holes in low-lying areas during the rainy season. Their bites produce profuse bleeding, itching, and secondary infection.
- (2) Fish. Sharks and other species of fish whose flesh is poisonous to man are found in the coastal waters. Many fish contain parasites which infect man when the flesh is eaten raw.
- (3) Although dangerous animals, such as tigers, leopards, and bears are occasionally seen, they usually avoid human beings. Wild boars are very dangerous when molested.

d. Poisonous Plants.

- (1) The sack tree or deadly "upas" tree (Antiaris toxicaria) grows to a height of 100 feet, and has leaves like an elm tree. It produces a poisonous, milk-like sap.

- (2) Certain types of taro root are eaten by the natives. Some types are completely poisonous when ingested, while portions of others are edible if they are carefully prepared.
- (3) Manioc root is also eaten by the natives. It is poisonous unless properly prepared.
- (4) Various species of the genus Urtica are found. Local names "mang ong voi", "ribbon" and "nan tia to". Plants grow to 9-16 feet in height and have pointed heart-shaped toothed or serrated leaves, along the edges of which are poisonous hairs. A painful eruption follows contact with these hairs.

6. Diseases of Special Military Importance.

- a. Malaria. The principal cause of sickness and death in SOUTH VIETNAM. Foothills and highlands are intensely malarious. Plasmodium falciparum infections predominate in July, August and September when the rainfall is greatest. P. vivax infections predominate in November, December and January when the rainfall is less. These two types account for about 85% of all cases of malaria and for an even higher percentage of malaria deaths. P. malariae is present throughout the year, and accounts for remaining 15% of the cases.
- b. Gastro-Intestinal infections.
 - (1) Amoebic and Bacillary Dysenteries. Both diseases prevalent. Bacillary dysentery (usually due to the Flexner and Shigella groups) is the more serious and widespread. Known to occur in epidemics in many villages during the rainy season.
 - (2) Typhoid and Paratyphoid Fevers. Both diseases widespread among the people. Human carriers probably play an important part in the transmission of these diseases.
 - (3) Flagellate Diarrhea. Caused by Giardia lamblia, Chilomastix mesnili, Trichomonas hominis frequently.
 - (4) Cholera. Endemic in SOUTH VIETNAM. Breaks out frequently in large epidemics. Most often in southern part of the country.

- c. Venereal Disease. All known types occur. Gonorrhea most prevalent. Most common in ports and principal cities.
- d. Injuries Caused by the Heat. Heat stroke, heat exhaustion, heat cramp and prickly heat common among the inhabitants of SOUTH VIETNAM. Expected to be very troublesome to unacclimated persons.

7. Diseases of Potential Military Importance.

- a. Plague. Endemic in SOUTH VIETNAM, but no recent epidemic.
- b. Typhus Fever.
 - (1) Epidemic or louse-borne typhus (transmitted from man to man by the body louse) endemic in SOUTH VIETNAM. Crowded living conditions and migration of natives during a war in the area could easily produce an epidemic.
 - (2) Murine or rat-flea borne typhus occurs sporadically throughout the year, especially in COCHINCHINA and ANNAM.
 - (3) Scrub or mite-borne typhus (tsutsugamushi disease) is endemic and occurs throughout the year.
- c. Dengue Fever. Endemic in SOUTH VIETNAM. Disease recurs at intervals of years in pandemic waves. An epidemic may last one season or several years. Can be disabling to large numbers of people for short periods of time.
- d. Pappataci Fever. (Sandfly Fever) Although the disease has not been reported in SOUTH VIETNAM, the vector (Phlebotomus pappatasi) is present and the disease has been reported from neighboring countries. Large numbers of non-immune troops may acquire the disease at the same time and the period of convalescence is prolonged.
- e. Skin Diseases.
 - (1) Scabies. Found throughout the country.
 - (2) Ringworm. Infections due to Trichophyton and Epidermophyton are found commonly.
 - (3) Secondarily infected insect bites and chronic ulcers.

8. Diseases Likely to Affect Small Numbers of Troops

- a. Viral Infections. Infectious hepatitis is common in the country. Poliomyelitis occurs sporadically throughout the year.
- b. Filariasis. A potential threat as foci of filariasis occur around DONG HOI, just above the 17th parallel.
- c. Leishmaniasis.
 - (1) Visceral Leishmaniasis occurs throughout SOUTH VIETNAM. Transmitted by the bite of an infected sandfly. Human beings, dogs, and cats serve as reservoirs of infection.
 - (2) Cutaneous leishmaniasis transmitted by direct person to person contact as well as by insect vectors.
- d. Leptospirosis. Several forms found, principally in rural and primitive areas. Causative spirochetes disseminated in food and water contaminated by the urine of infected rats. Contracted by eating or drinking infected water or food, or by swimming, wading, or washing in water contaminated by infectious rat urine.
- e. Relapsing Fever. Can be associated with the mass movement of troops and refugees.
- f. Respiratory Diseases. Influenza occurs periodically in mild epidemic form.
- g. Rabies. Disease occurs frequently in dogs throughout the country. Vaccination of dogs is neglected. A religious tabu prohibits the destruction of dogs.

9. Diseases Causing High Mortality or Morbidity Rates in the Native Population.

- a. Tuberculosis. Widespread among all age and occupational groups. In some areas as much as 22% of the population is infected. Intestinal tuberculosis is transmitted by drinking milk from infected cows.
- b. Intestinal Parasites. Very common among the people of SOUTH

VIETNAM. Hookworm disease affects the entire country. Common parasites include: hookworm (both Necator americanus and Ancylostoma duodenale), roundworm, Strongyloides stercoralis, whipworm, tapeworms (Dipylidium canium, Taenia saginata) and the flagellates Giardia lamblia, Chilomastix mesnili and Trichomonas hominis.

- c. Trachoma. Affects a significant proportion of the population. Spread through poor personal hygiene and flies.
- d. Dietary Deficiency Diseases. Vitamin deficiency diseases a very important public health problem. Beriberi and hypoproteinoses are important.
- e. Smallpox. Endemic areas throughout the country. Epidemic outbreaks remain a possibility.

10. Miscellaneous Diseases.

a. Trematode (Fluke) Infections.

- (1) Schistosomiasis. (*S. japonicum*) Endemic, but infrequent in occurrence. Produced by the entrance of the causative parasite into the body by drinking contaminated water, or by swimming or wading in polluted waters. Transmitting hosts are small fresh water snails.
- (2) Liver Fluke (*Clonorchis sinensis*). Endemic but infrequent in occurrence. Caused by ingestion of raw or partly cooked fish.
- (3) Fasciolopsiasis (*Fasciolopsis Buski*). Occurs in COCHINCHINA. Contracted by eating infected raw water plants such as water chestnuts.

- b. Tetanus. Present. A serious potential threat to any wound.
- c. Animal diseases transmissible to man. Rabies, leptospirosis, rat-bite fever, tularemia, bovine tuberculosis, trichinosis, brucellosis, anthrax, and melioidosis.

3d MarDiv (-) (Rein) deploys initially to DANANG by sea and air, occupies and secures the DANANG, QUANG NGAI and TAM KY objectives and is prepared to assume control of the LSF or the BLT of the SLF and to conduct ground operations to destroy the Viet Cong in the III MEF zone.

3. EXECUTION.

- a. Concept of operation. An engineer platoon reinforced with an angledozer tractor, water purification equipment, bath unit and dump truck, is initially attached to each airlift and sea-lift BLT. In addition, the company headquarters of an engineer company is attached to each RLT headquarters and augmented with an angledozer tractor, dump truck, loader (scoop-type), motor grader and air compressor. An advance echelon of the 3d Engineer Battalion (-) arrives at DANANG by air on B+2.

Initial engineer operations ashore will be conducted on an area responsibility basis with attached engineer companies performing engineer tasks in the RLT zones of action as directed by the RLT commander. Upon landing on B+8 the 3d Engineer Battalion (-) will reinforce the attached engineer companies as directed and execute priority engineer tasks in the Division zone. Attached engineer companies will revert to parent control on order.

The 3d Marine Division (-) (Rein) is responsible for engineer support, to include hasty airfield repair, of the III MEF until establishment of the FEG (-) ashore on B+12.

b. 3d Engineer Battalion (-)

(7) Water Supply

- (a) Engineer units attached to each RLT will embark sufficient water supply equipment to initially provide potable water for all units in their respective areas. The Force Engineer Group and the Force Logistics Group will have sufficient water supply equipment to provide water for their organic use.
- (b) Existing water supply facilities such as wells, pumps, etc. will be rehabilitated and expanded as soon as possible.

(8) Electric Power


- (a) U. S. leased electric power is available in distribution system in and around the DANANG airfield complex. Use of this electric power service for general illumination purposes will be exploited where practicable in order to conserve use of T/E engine generators. Use of and connections to leased power facilities will be subject to approval of the Base Engineer at DANANG.
- (b) Use of non-U.S.-leased civilian electric power facilities will be subject to approval of Division Headquarters. Emergency use is authorized provided connections are effected by a trained electrician. Such emergency power utilization will be reported to Division Headquarters as soon as practicable.
- (c) Use of T/E engine generators will be restricted to the minimum at all times. Operation hours will be curtailed by establishing specific and minimum hours for illumination of essential staff, medical and logistic facilities.

(9) Construction

- (a) Airfield repairs and development will initially be the minimum required to meet operational requirements. Design and location will be planned to facilitate future development.
- (b) Building construction for troop use will be of a temporary nature.

- (e) Priority of tasks in accordance with Appendix I.

(10) Bulk Fuel

Bulk fuel will be under control of the Division Logistic Support Group initially. Engineer support in positioning bulk fuel facilities will be provided by Division as required and requested.

(11) Reports

Reports will be submitted in accordance with Annex H (Reports).

4. ADMINISTRATION AND LOGISTICS

a. Class IV Engineer items.

- (1) Prescribed initial and mount-out allowances of fortification and construction materials will be deployed to DANANG.
- (2) Engineer construction materials will be held in readiness by the Commander FLSG for issuance or embarkation for the FEG. This includes significant quantities of nestable culvert, timber bridge and railroad track materials. Equipment for constructing deep water wells is included. Sufficient SATS material will be embarked by the FEG for the construction of a 4000' X 72' runway at QUANG NGAI, plus 288,000 square feet of taxiway and parking area.

5. There is also an estimated 100 MT of Steel Rebar at SUO LO O (About 15 Km from Saigon) and owned by the RVN as a gift from USOM. Although unverified, it is reported that large quantities of material are stockpiled in USOM warehouses. These reports indicate the possible existence of some steel shapes and plates among other construction items. Most of these warehouses are located in the Saigon area.
6. Cement is available from three sources, Thailand, Japan and the U.S. The cement from Thailand is not of good quality and it is not believed that the price saving is worth the quality loss. The Japanese cement is equal in quality to that produced in the U. S. A cement mill is presently being constructed near Saigon by the RVN Government.
7. Most timber resources are in the inland portion of the country and often in the area controlled by the Viet Cong. Although this area abounds in hardwood there is one excellent construction timber available. This is called Dou and is equivalent to Douglas Fir.
8. Two known sawmills are located near Danang. One at the north end of town about $\frac{1}{2}$ mile from the river. The second is about 20 Km south of the city along the coastal road. Both mills are makeshift affairs of questionable lineage and vintage. Quality control of lumber size and grade is very poor. It is possible that other mills exist in this area.
9. All asphalt is imported from the United States, Japan, Indonesia, or Europe. There are no local petroleum resources. ESSO and SHELL provide the bulk of the petroleum services and distribution.
10. Aggregate for concrete and asphalt is developed locally. Quality and quantity are acceptable but not outstanding. A number of quarries are required to provide the aggregate needed for the current Danang airfield project. Two quarries provide the major portion of this aggregate and the rock used for the base course. These quarries are Namu Quarry, 10 miles NW of Danang along the South China Sea and Marble Mountain Quarry about two miles SE of Danang, also near the ocean. Approximately 10,000 yards of rock are stockpiled at the Danang project sites.
11. Numerous brick factories are located south of Danang. Quality of the brick is poor. Output is not known.
