NARRATIVE SUMMARY

1. Headquarters Battalion elements were stationed throughout the 3d Marine Division area of operation in RVN during the period 1 October 1969 to 23 November 1969 in the following major locations:

Quang Tri	Military Police Company (-)
Quang Tri	Service Company (-)
Dong Ha	Headquarters Company (-)
Dong Ha	Communications Company (-)

The remainder of the period from 23 November 1969 to 31 December 1969 Headquarters Battalion elements were located at Camp Courtney, Okinawa with the exception of Military Police Company which was located at Camp Hansen, Okinawa during the period 25 October 1969 to 31 December 1969.

2. Unit Activities and Events

a. Headquarters Battalion. The activities of this unit during the period October - December 1969 were concentrated in three major areas. First, to continue to provide communications, logistic and administrative support to 3d Marine Division Headquarters at 2 locations, QTCB and DHCB, RVN. Second, the planning and execution of total stand-down and redeployment from RVN to Okinawa. Third, reestablishment of support functions for 3d Marine Division Headquarters on Okinawa and assumption of additional logistic/administrative responsibilities as Headquarters, Camp Courtney and as the supporting unit for Headquarters, I MEF, 3d Marine Division Ranges and 3d Marine Division Schools. Concurrently with this third major area of activity maximum effort was devoted to post deployment recovery and rehabilitation of equipment.

b. Headquarters Company. During the second quarter FY-70 this unit was commanded by Major G. G. Bosworth. On 24 October, 1stLt J. S. Lassiter was relieved by 1stLt A. T. Augulis as Executive Officer. On 10 December, 1stSgt B. Castro was relieved by 1stSgt S. L. Hinkle as Company First Sergeant. The average quarterly strength was 177 officers and 689 enlisted. There were 79 officers joined and 136 officers dropped. There were 369 enlisted joined and 511 dropped.

c. Service Company. During the second quarter FY-70 this unit was commanded by 1stLt J. J. Foyle until 21 November 1969. On 22 November 1969 he was relieved by Captain G. G. Smallwood. 2ndLt. E. Pennington was assigned as Executive Officer on 1 December 1969. On 11 December 1969, 1stSgt S. L. Hinkle was relieved by 1stSgt D. D. Fisher. The average quarterly strength was 24 officers and 360 enlisted. There were 13 officers joined and four officers transferred. The administration of 380 personnel to include 385 joins and transfers was accomplished with five (5) effective office personnel during the quarter.

d. Communications Company. During the second quarter FY-70 this company continued to provide the Commanding General and his Staff with reliable, speedy and flexible communications link. This included intra-staff and intra-division communications. In accomplishing this task, detachments of Communications Company were at the following locations during the months of October and November: Quang Tri Combat Base, (Division Rear); Elliot Combat Base, (3d Marines); Dong Ha Mountain, (3d Marines); Vandergrift Combat Base, (4th Marines); Con Thien, (3d Marines), (1st Radio Battalion); Headquarters 2nd ARVN Regiment; DHCB Provisional Rifle Platoon and Mai Loc, (Project Delta). During October and November Communications Company redeployed in three increments from the Republic of Vietnam to Okinawa while at the same time maintaining essential communication links until the redeployment of the 3d Marine Division was completed. The mission assigned was to install, operate and maintain communication facilities for Division Headquarters, including radio, multi-channel radio relay, wire and communications center facilities. One hundred seventy-eight pieces of electronic equipment were processed by the maintenance facility during this period, and 61 of which were evacuated to higher echelon maintenance facilities. Communications support provided included handling and processing of 92,243 messages during the period.

e. Military Police Company. During the period covered by this report, this unit conducted the following types of operations.

- (1) Traffic control, criminal investigation and apprehension, POW detention and base security at QTCB and DHCB, RVN.
- (2) Escort of confined prisoners (3dMarDiv) from III MAF Brig, Danang, RVN to Camp Smedley D. Butler Brig, Okinawa.
- (3) Traffic control (government vehicles only), tours and village patrol, criminal investigation and apprehension, VIP security while at Camp Hansen, Okinawa.

- (4) Traffic violations totaled 40 for the period. A total of 8 traffic accidents were investigated, none of which resulted in human fatality.
- (5) A total 74 Class I and 146 Class II offenses were reported for investigation during the period. Military offenses reported by Military Police patrolmen totaled 407 for the period.
- (6) This unit augmented the respective units responsible for defense of Sectors A and C of the Quang Tri Combat Base perimeter, and manned gate posts at both QTCB and DECB.
- (7) On 1 December 1969 this unit assumed responsibility under the general cognizance of the Provost Marshal, USARYIS, for off-post law enforcement over a geographical area of Okinawa generally defined as that north of Highway 16, bounded on the west by longitudinal axis of the island and on the east by the Pacific Ocean. Included are the villages and towns frequently visited by USMC personnel in a liberty/leave status to include Teragawa, Agena, Iha, Ishikawa, Kin, Henoko and Nag. In addition this unit retained responsibility for Military Police and Investigative (CID) support to the 3d Marine Division.

- 20 Oct - Advance party consisting of 26 officers and 205 enlisted personnel of Increment I departed for Okinawa by air.
- 21 Oct - Communications Center Van AN/TGC-37 operational and displacement of Comm Center from DHCB to QTCB commenced.
- 22 Oct - Responsibility for operation of COC at QTCB assumed by 1st Bde, 5th Infantry Division (Mech). All cargo and personnel of the main body, Increment I, embarked aboard USS Union, USS Dubuque (LPD-2) and USS Vancouver (LPD-2) from Cua Viet, RVN. Relieved of responsibility for Reaction Force, QTCB by 2d Battalion, 4th Marines. Commenced preparation of cargo and vehicles for Increment II.
- 23 Oct - All communications support for 3d Marine Division FSCC deactivated.
- 25 Oct - Increment I disembarked at Red Beach, Okinawa.
- 26 Oct - 2d ARVN Regiment liaison communications personnel assignments terminated.

- 1 Nov - Honor Guard/Color Detail for 3d Marine Division departure ceremony departed for DaNang.
- 4 Nov - All cargo and personnel of the main body Increment II embarked aboard USS Dubuque (LPD-8) and USS Cleveland (LPD-7) from Cua Viet, RVN.
