

NARRATIVE SUMMARY

During the month of January, new construction or modification of in-progress construction continued to be dominant projects. Also significant, was the continuing refinement of mechanized accounting capabilities, with the installation of new equipment and the concentrated training of technical personnel.

Staff sections and subordinate units are maintaining effective performance under an extremely heavy, and ever-increasing workload. The 3d Force Service Regiment is fulfilling its mission to provide sustained logistical support to all FMF WestPac Forces from Okinawa, while conducting comprehensive internal training programs.

1-31 Jan 1967	The following training was conducted within the Data Processing Platoon: Three Programmers from FLC attended training and are writing conversion programs for FLC; five men aboard from FLC for operator training; on-the-job machine operator training for 16 Marines; on-the-job Programmers training for 7 Marines.
1-31 Jan 1967	Regimental Chaplain conducted weekly meetings with confinees at the Correctional Custody Facility. In addition, the Chaplain conducted a Character Guidance lecture for 500 Marines of this Command and provided six individual marriage counselling sessions.
1-31 Jan 1967	Medical personnel of the Regimental Dispensary had training consisting of five lectures on First Aid, Leadership, Health and Service Records, and UCMJ. Daily on-the-job training has been suspended due to the large influx of new Hospital Corpsman on board.
1-31 Jan 1967	On-the-job training was provided to two Republic of Korea Marine Corps Officers with Force Logistic Support Section and WestPac Fiscal Office.
7 Jan 1967	There were 22 personnel who completed the Regimental Commercial Forklift School.
10-12 Jan 1967	Representatives of 3d FSR attended FMFPac Air-Ground Training Conference.
13 Jan 1967	There were 9 personnel from III MAF who completed the Basic Ammunition Technician Course. There were 128 personnel who qualified on the Rifle Range.
15-28 Jan 1967	On-the-job training was provided to one (1) Chinese Nationalist Marine Corps Officer and one (1) Enlisted under the immediate cognizance of Maintenance Battalion in connection with the MAP Program.
19 Jan 1967	Limited Technical Inspection of Supply Battalion motor transport conducted with satisfactory results.

NARRATIVE SUMMARY

1. An Engineer Support Platoon was formed by combining the Engineer Utilities Platoon of Headquarters and Service Company with the Materiel Handling Equipment Platoon of Support Company. This Engineer Support Platoon is subordinate to Support Company and all personnel and equipment have been reassigned as required.
2. Total incoming and outgoing Message Center traffic was 24,561 messages, 61,869 AUTODIN cards and 906 AUTODIN messages.
3. Headquarters and Service Battalion served as host for Colonel KYUNG and Lieutenant Colonel CHUNG, Republic of Korea Marine Corps, for on the job training in Logistics Management for a period of 14 days.
4. Headquarters and Service Battalion vehicles traveled 141,225 miles, hauled 26,682 short tons of cargo, and moved 14,574 personnel.
5. The Baggage Facility received 10,839 pieces of personal baggage for storage while shipping out 4,667. There remains a total of 71,849 pieces of personal baggage for storage. NARRATIVE SUMMARY

The battalion performed functions during the period relative to stock control, cross-servicing, commercial contracting and supplying classes I, II, III, IV, V and VA to FMFWestPac Forces. These functions further included:

a. Receiving, storing, assembling, inspecting and issuing missiles, ~~nuclear ordnance~~ and other specific ordnance to ground and aviation elements.





NARRATIVE SUMMARY

On 17 January 1967 Electronics Maintenance Company received a letter of appreciation from the Commander, 1962nd Communications Group, Department of the Air Force. Two members of the Republic of China, Chinese Marine Corps were attached to this Command. Organic Motor Transport logged 67,253 miles. There were two motor vehicle accidents within this command. Five M-36's, three M-37's and two M-43's have been completed for this reporting period. There were five man hours spent on Contact and Technical Inspections.

In the past six months the workload within this Battalion has trebled. The Battalion is currently working nights and utilizing a six-day work week. The companies are actively engaged in refurbishing rotating BLT's on a high priority basis, at the approximate rate of one per month.

This Command's General Military Subjects Training is in balance with our workload. A shortage of personnel in six MOS's has placed an additional burden in certain areas of the Battalion. As a measure to improve our capabilities we have submitted a recommended revision to our T/O; considered in the recommendations are additional Ryukyuan civilians, earlier requested.

PART IINARRATIVE SUMMARY

1. The primary mission of Headquarters and Service Company is to provide the Battalion Commander with facilities for command and control. To provide administration, organic supply, light motor transport and maintenance and service support of the Battalion. The Headquarters and Service Company (less staff sections) is primarily occupied with the administrative functions in support of all staff sections to include the scheduling and supervision of all training.
2. In order to ensure effective accomplishment of this mission, the training goal of this company is to maintain all personnel in a high state of readiness through technical training, General Military Subjects training and off duty education, including MCI, USAFI, University of Maryland, and Group Study classes.
3. Close order drill is scheduled at least once a week for all personnel of the rank of Sergeant and below, these drill periods are conducted under the supervision of a commissioned officer.
4. Personnel inspections are held once a week. This is also supervised by a commissioned officer.
5. Rifle range quotas established by Battalion S-3 personnel are strictly adhered to.
6. All personnel are required to complete the Physical Readiness Test each quarter.
7. General Military Subjects classes are presented by qualified instructors. Marines reporting in are tested by personnel of the Battalion S-3 section and the results forwarded to the Company Training NCO. Personnel who score below the minimum on the General Military Subjects Test attend evening classes and are retested quarterly.
8. The Company Gunnery Sergeant supervises the training program for this company and also counsels all personnel on the availability of educational opportunities.
9. Due to the high rate of personnel turnover in this command, the administrative work load is increased immensely and requires constant attention and supervision.

NARRATIVE SUMMARY

1. During the month of January 1967, Second Lieutenant B. E. GARDNER and seven enlisted Marines went TAD to RVN for the period 13-21 January 1967 in connection with LTI's. 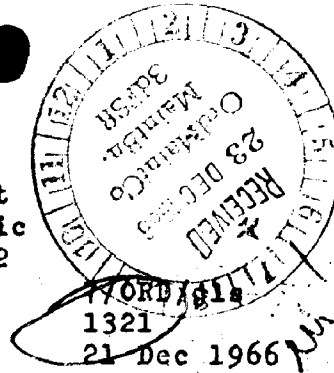
