

NARRATIVE SUMMARY

1. During the month of February the 3d Force Service Regiment fulfilled its mission to provide sustained Logistical support to FMF WestPac Forces:

a. The Baggage Facility received 5,285 pieces, and released 7,347 pieces. A total of 73,035 pieces of personal baggage remains in storage.

b. Shipping and Receiving receipted for 9,804 measurements tons and 141 short tons of incoming cargo: 5,143 measurement tons and 1,133 short tons were shipped.

c. Total incoming and out going Message Center Traffic was 13,499 messages and 278,858 Autodin Cards.

d. 3d FSR vehicles traveled 227,448 miles, hauled 14,637 short tons of cargo and transported 18,560 personnel. Commercial transportation cost was \$5,481.

e. Maintenance operations for the month of February commenced with 2,903 work requests on hand. There were 1,906 work requests received during the month and 1,816 work requests completed.

f. The Fleet Stock Account processed 25,170 demands and made 23,728 Issue/Obligation releases. There were 10,144 receipts processed during this month.

g. Supply Operations for the month of February commenced with 4,028 issue mats on hand. There were 20,675 issue mats received during the month and 19,073 issue mats were processed, leaving a balance of 5,630 issue mats on hand at the end of the month.







1. During the period 1-28 February 1969, Headquarters and Service Battalion continued its daily activities in support of the regimental logistic mission.

a. Headquarters and Service Battalion vehicles traveled 92,891 miles, hauled 14,637 short tons of cargo, and transported 18,560 personnel. During the previous month of January, Headquarters and Service Battalion vehicles traveled 105,465 miles, and hauled 19,368 short tons of cargo, and transported 17,651 personnel. Commercial transportation hire cost was \$4,441.03.

b. The baggage facility received 5,285 pieces of personal baggage for storage while shipping out 7,347 pieces. There remains a total of 73,035 pieces of personal baggage in storage.

c. The Shipping and Receiving Platoon receipted for 9,804 measurement tons and 141 short tons of incoming cargo, and aggregate decrease of approximately 5.1% under previous month's totals. 



Topic: Personnel Inspection

Discussion: Overall appearance of personnel inspected was excellent. The appearance of most individuals was indicative of their time and effort in preparing for inspection. However, discrepancies were noted in fitting of clothing, mostly trousers either being too long, or too short. One Marine had no properly fitting tropical trousers. All three pairs of his tropicals were extremely tight. It was noted that individuals were not completely familiar with chain of command. This in most cases was noted in recently arrived personnel.

Recommendations: It is recommended that action be initiated to:

1. Insure that closer supervision by Platoon Sergeants and Company Staff NCO's is maintained in future inspections.
2. That upon arrival each new Marine receive a list of the chain of command and be required to study and know the incumbent in each link of the chain.
3. Those personnel cited as having ill fitting clothing be required to replace or have altered those items of apparel that do not fit properly.

Topic: Clothing and Equipment Displays

Discussion: Neatness of wall lockers and rack layouts showed evidence of the effort taken to prepare for this inspection. The clothing displayed in the wall lockers was neat and uniform in most instances. A few individuals displayed soiled belts and other apparel, but overall effort was very good.

Recommendations: As in the case of personnel inspection, this phase could have been improved by more attention to details and better supervision prior to inspection.

Discussion: Conduct of Drill was excellent, NCO's assigned to drill the platoon showed a good knowledge and were well above average in Drill Proficiency. Platoon movements were executed with a minimum of discrepancies.

Recommendations: That continued emphasis is placed on the need for the young inexperienced NCO to acquire proficiency in conduct of drill.

Topic: Personnel Accompanying Inspecting Officer.

Discussion: This officer was accompanied by the platoon commander, platoon sergeant, and H&S Company Quarters Sergeant. Their attitude on the whole was one of inattentiveness, with many discrepancies noted by the inspecting officer going unnoticed. During the clothing inspection it was necessary to call attention of troop conduct (talking during inspection) to the platoon sergeant and direct him to take necessary action on two occasions. In some cases the accompanying personnel seem to forget who was to conduct the inspection and appeared to be conducting their own inspection simultaneously.

Recommendations: That personnel assigned as platoon leaders, platoon sergeants, etc. are made aware of their duties during inspections and of the importance of their attitude and conduct to the success of any inspection.

No records are held that indicate the above P.M.'s have been completed.

Recommendation: That MTCO be assigned the responsibility for maintaining vehicle records on equipment under their control.


