NARRATIVE SUMMARY

1. During the month of November the 3d Force Service Regiment fulfilled its mission to provide sustained Logistical support to FMF WestPac Forces:

a. The Baggage Facility received 4,324 pieces, and released 7,722 pieces. A total of 72,003 pieces of personal baggage remains in storage.

b. Shipping and Receiving receipted for 6,242 measurement tons and 176 short tons of incoming cargo; 7,534 measurement tons and 643 short tons were shipped.

c. Total incoming and outgoing Message Center Traffic was 10,204 Narrative Messages and 3,509 Card Messages.

d. 3d FSR vehicles traveled 207,582 miles, and hauled 10,427 short tons of cargo and transported 8,348 personnel. This includes Commercial vehicles and vehicles moved for SGR.

e. Maintenance Operations for the month of November commenced with 4,877 work requests on hand. There were 2,094 work requests received during the month and 2,006 work requests were completed. The month ended with 4,465 work requests on hand.

f. The Fleet Stock Account processed 16,122 demands and made 19,753 Issue/Obligation releases. There were 16,087 receipts processed during November.

g. Supply Operation Issues for November commenced with 4,770 documents on hand. There were 22,995 documents received during the month and 19,213 documents were processed, leaving a balance of 9,195 on hand at the end of the month.

h. Supply Operation Receipts for November commenced with 1,713 documents on hand. There were 17,759 documents received during the month and 17,563 documents were processed, leaving a balance of 1,797 on hand at the end of the month.

i. Marines from this command transported equipment to the Northern end of Okinawa to build a playground for the children of TAKAE-SHO-GAKKO School. This command also continued to support Community Relations projects at Hama-Naga Island and the Conversational English teaching project at Chubu High School.



NARRATIVE SUMMARY

1. During the month of November, Headquarters and Service Battalion continued its daily activities in support of the Regimental logistic mission.

a. During the period 1-30 November 1969, Truck Company continued its daily supporting activities by providing an average of 24 M-36 Trucks, 17 M-35 Trucks, 34 M-54 Trucks, 1 M-55 Truck, 24 M-52 Semi-Tractor Trailers, 40 M151A1 Jeeps, 7 M-38A1 Jeeps, 8 M-37 Personnel Carriers, 3 Buses and 1 Miller Bus.

b. During the period 1-30 November 1969, Truck Company continued to maintain operational control of 3 Buses and 1 Miller Bus. The buses provide a daily transportation service for 3d FSR personnel to and from places of duty on and off post.

c. The Baggage Facility received 4,324 pieces of personnel baggage for storage and released 7,722 pieces. A total of 72,003 pieces of personnel baggage remained in storage.

d. Shipping and Receiving receipted for 6,242 measurement tons and 176 short tons of incoming cargo. There was 7,534 measurement tons and 643 short tons of cargo shipped.

e. Headquarters and Service Battalion Vehicles traveled 149,348 miles, hauling 10,427 short tons of cargo and transported 8,348 personnel.

f. During the period 1-30 November 1969, M.H.E. Platoon continued its daily supporting activities by providing an average of 64 rental forklifts, 34 plant account forklifts, 12 tactical forklifts, 5 rental warehouse tractors, 50 rental warehouse tractor trailers, 1 Bay City Crane, 2 M-60 Cranes, 1 550 Grader, and 1 MRS-100. Two 5 KW generators were also provided.

g. During the period 27-30 November 1969, M.H.E. Platoon transported equipment to the Northern Training Area to begin a People-To-People project at the Takae-Sho-Gakko School, employing one 550 grader and one MRS-100.

h. In addition to daily standing commitments, M.H.E. Platoon supported the 3d Marine Division at White Beach, Kin Red Beach, Tengan Pier, and Camp Hauge. Also this platoon supported air units of the 1st MAF at Futema, MCAF.

f. The S-4 section has continued to provide coordination for truck and forklift commitments in support of the 3d Marine Division's debarkation on Okinawa. It is anticipated that the last contingents of the Division will be ashore and in respective camps during the first week of December.

During the reporting period, 1stLt T. W. GRIFFIN relieved 1stLt TERRELL as Headquarters and Service Battalion S-4 Officer on 26 November 1969.
