OPERATION SUMMARY

The Battalion continued S/D operations in the Kentucky 'O. On 4-2315Z December, Co I executed an ambush north of C-2 Bridge resulting in 2 NVG KIA's. A moderate amount of old ordnance was discovered and destroyed. The Battalion was OPCON to Task Force Delta on Task Force Bravo during the first part of the month. On 11 December, the Battalion moved to An Hoa and was OPCON to Task Force Yankee for Operation Taylor Common. The Battalion made a helicopter assault 18 December on Hill 375 at ZC167365 and set up Combat Base Mace. Company patrol bases were established in the area and S/D operations were conducted. Large amounts of medical equipment, weapons, uniforms, and ammunition were uncovered. These supplies were found in numerous bunker and hut complexes which were searched and destroyed upon discovery. Most of the complexes were used for R&R centers and were not set up for combat defense. Although many trails and complexes have been found in the Battalion AO, actual enemy contact has been limited to occasional fire fights with small units of 3-5 people. Indications are that the NVG main force has left the area while operations are being conducted and only small unit harassment forces have been left to contend with.

(2) Class V

During the month of December, there were no problems in obtaining Class V. Until the 14th of the month Class V was drawn from the AV at Quang Tri. After moving to An Hoa on the 14th, the source of supply became the LSU Class V dump at An Hoa.

(3) Resupply

From the 1st to the 14th of December, the Battalion was resupplied exclusively by ground transportation. After moving to An Hoa on the 14th and commencing participation in Operation Taylor Common, the Battalion was resupplied in the field by helicopter. There were no problems in the resupply of Classes I and V. However, due to the limitations imposed by the 3d Marines on the amount of equipment that could be moved from Quang Tri to An Hoa and the non-availability of Class II at An Hoa, Class II resupply was a problem area. This problem was gradually alleviated as Battalion Supply built up its stocks at An Hoa.

(4) Evacuation and Hospitalization

- (a) During the month of December, operating areas were of 2 types of terrain. In the Kentucky Area terrain was flat with little cover. In the Taylor Common Area terrain was very mountainous with double canopy.
- (b) All medevacs were made by helicopter and no problems were encountered.

(5) Transportation

- (a) Total mileage on organic vehicles during the period was 9557 miles.
- (b) Truck support in the Kentucky AO was constantly inadequate.
- (c) Truck support at An Hoa was extremely limited.

(6) Service

- (a) A platoon of C, 3d Engineer Battalion rendered assistance in all engineering tasks, but heavy equipment was unobtainable.
- (b) During the reporting period, the Battalion was supported by 4 PST Teams of the 3d Shore Party Battalion.

12. INTELLIGENCE

For the first half of the month of December, the Battalion was operating out of Con Thien and contacts were small unit incidents. The second half of the month, the Battalion moved from Con Thien to An Hoa, southwest of Da Nang. On 20 December 68, the Battalion commenced Operation Taylor Common. Many bunker and hut complexes were found ranging from platoon to possibly battalion size. M, 3/3 on 211500Z found a hut and bunker complex at ZC153379. The area had a small messhall and 1 hut was an aid station. The complex was approximately 1 month old and had been used by approximately 20 people. On 221350Z, K, 3/3 found a hut and bunker complex at ZC162385. This area was extensive with messhall facilities, medical huts, and a grain mill. Also found were medical supplies, printing material, and asserted documents. The messhall huts were 75'x25'. Upon finding this complex K, 3/3 had contact with 2 enemy vicinity ZC162385. One was killed and his weapon, a new AK-47 with 3 magazines, captured. On 291500Z, L, 3/3 coordinates ZC138353, while crossing a stream, 1st elements ran into a house. A search of the house produced 1 basket of clothes, 3 SKS, and 1 carbine. There were also 4 other huts containing medical gear, documents, and new womens clothes. One hut had 2 built-in stoves. 1 AK-47 and 3 carbines were found behind a false wall in a hut. Two bunkers were reconned by fire and heavy return fire was received. 1 POW WIA was taken. On 301100Z, L, 3/3 discovered 4 huts, vicinity ZC150366. 47 AK-47 rifles, 6 Chicom

burst guns, 6 US M-1 carbines, 2000 K-44 rounds, 300 9mm rounds, 12 machetes, 1 $\frac{1}{2}$ pound block of TNT were found. 3015051, M, 3/3 in the vicinity 201433Z2 sighted 2 NVA, wearing black pajamas, who went into dugout type positions. They were taken under fire and 1 NVA was killed. Extensive rest and storage areas were the most common finds and enemy contact was light in the Taylor Common area.

The communications at C. Chien remained excellent. The Battalion moved to An Hoa on 14 December. Communications section at 'n Hoa set up a PRC47 for communications with Quang Tri. Communication with Quang Tri was sporadic, but relay through Task Force Bravo at Dong Ha provided minimum service. Communication with the Battalion in the field remained satisfactory. The Battalion used the VY38 and PRC77 extensively.

JOURNAL SUMMARY

- 1 Dec 68 0730I to 1500I In the area of YD094657 elements of Co I discovered 7 mortar pits, 1 3x4x12 feet and a trench running north to south approximately 10 months old. Also in the area of YD115656 discovered 3 mortar pits facing in the direction of the MRR and a trench 3x4x10 feet approximately 10 months old.
- 2315I In the area of YD132677 elements of Co K observed 2 persons believed to be getting water from the river. Their movement indicated knowledge of the area. Their type of clothing or arms could not be determined. They were taken under fire with small arms and 14 60mm mortar rounds. The area was probed by artillery. The area was checked out and blood stains were found.
- 2 Dec 68 0915I In the area of YD110707 elements of Co H discovered 3 positions 2 $\frac{1}{2}$ x4x1 $\frac{1}{2}$ feet. A tunnel was also discovered with an opening of 2 $\frac{1}{2}$ feet in diameter, 3 feet deep, and 10 feet long. The tunnel appeared to be approximately 4 months old and not recently used. The position was destroyed.
- 0945I In the area of YD143733 elements of C/1/61 (USA) discovered 10 bunkers over a year old containing 50 cases 12.7 rounds, 50 boxes 60mm mortar fuses (300 per box), 350 60mm mortar rounds, 4 82mm mortar rounds, 1 Chicom claymore mine, 1 booby trap, 6000 7.62 link ammunition, 1 R-62 launcher (unservicable), 2 T-62 boosters, 3000 AK-47 rounds, 1 RPG7 round, 13 boxes blasting caps (10 per box) 5 Chicom grenades, 1 ton of rice, and 1 snake eye bomb. Ordnance was destroyed.
- 1330I In the area of YD155724 elements of Co L discovered 6 bunkers 6x5x8 feet about 10 months old and in good condition. The bunkers contained 14 60mm mortar rounds and 1 Chicom claymore mine. The ordnance and bunkers were destroyed.
- 1535I In the area of YD115718 elements of Co L triggered a booby trap believed to be an 82mm mortar round.
- 3 Dec 68 No significant events.
- 4 Dec 68 0730I In the area of YD115675 elements of Co M discovered 2 bunkers about 2 months old and showed signs of recent use. The area was searched and 1 NVA poncho, one water bowl, and 50ft of communications wire was found.
- 1700I In the area of YD110633 elements of Co K discovered 2 mortar pits, 9 living bunkers, 17 82mm mortar rounds, and 1 canister of primers with increments. All ordnance was destroyed. The bunkers were old and unservicable.

- 2315H In the area of YD126667 elements of Co I observed 2 persons moving from north to south. They were engaged with small arms and M-79 fire. An artillery mission was also called. Search at first light produced 2 bodies dressed in green pajamas and armed with 1 9mm pistol with 2 magazines, 1 AK-47 with 2 magazines. They also had papers. All items were turned over to S-2.
- 5 Dec 68 1200H In the area of YD106621 elements of Co K made contact with 4-5 enemy wearing camouflaged clothing. They were engaged with small arms and 60 60mm mortar rounds. The area was search results.
- 6 Dec 68 1115H In the area of YD115632 elements of Co K found 1 Chicom grenade laying in the trail. It was turned over to S-2.
- 1200H YD107634 started receiving 4 60 or 82mm mortar rounds. Counter-mortar and artillery was fired with unknown results.
- 1230H In the area of YD115724 elements of Co L discovered 1 bunker approximately 10 months old and 5x5x4 feet. The bunker contained 3 ponchos, 1 pair of khaki trousers, 50 rounds of AK-47 ammunition, 2 Chicom grenades, and 1 gas mask. All were destroyed.
- 1245H In the area of YD107631 elements of Co I observed mortar fire of approximately 5-6 rounds of 82mm mortar. All rounds fell short of the perimeter. Counter battery mortar and artillery fire was returned with unknown results.
- 1245H In the area of YD128722 elements of Co I while on patrol triggered a booby trap of unknown ordnance.
- 1400H In the area of YD103647 elements of Co I observed 2 persons, one believed carrying a radio. Fired 60mm mortar and artillery mission with unknown results.
- 1430H In the area of YD093723 elements of Co M discovered 2 bunkers reinforced with logs and dirt approximately 6 months old. The bunkers had not been used recently. They were destroyed.
- 1520H In the area of YD062592 Co K reported 140mm rocket fire being fired from 2 positions. 25-30 rounds were fired. Artillery was fired with unknown results.
- 7 Dec 68 2340H In the area of YD126666 elements of Co K received 3 rounds believed to be RPG. Returned fire with 90mm tank and machine gun fire with unknown results.
- 8 Dec 68 0230H In the area of YD140660 elements of Company observed 3 enemy believed to be carrying a T-54 moving across position west to east. Small arms, M-79, and 60mm mortar were fired in the area. A patrol checked out the area with negative results.

10 Dec 68 1045H In the area of YD140731 an observer plane reported taking sniper fire from a bunker complex previously discovered and destroyed. Two tanks fired 6 rounds of 90mm 'U' and 6 of 'P' in support of the plane. Results unknown.

2030H In the area of YD152615 elements of Co K observed 2 moving lights among bunkers at south end of the perimeter. Fired M-79's with negative results.

11 Dec 68 1515H In the area of YD115704 elements of Co G, 2d Bn, 3d Marines observed 1 person moving across an open field. Sent out a patrol which brought back 1 person who was turned over to Regimental MP.

12 Dec 68 No significant events.

20 Dec 68 1300H In the area of ZC161370 elements of Co I discovered an old rest area consisting of 4 bunkers, 6 huts, cooking racks, estimated area was capable of housing a platoon. The area was badly decomposed and hadn't been used for 5 months. The bunkers and huts were destroyed.

1350H In the area of ZC160367 elements of Co I observed unknown number of persons wearing dark uniforms and silver gray covers getting water from the south side of the river. Sniper fired 1 round with unknown results.

1500H In the area of ZC177358 elements of Co L discovered a grave with numerous bones.

1505H In the area of ZC1611300 elements of Co K observed 1 person and took under fire with small arms. The man jumped behind a ledge. 1 frag grenade was thrown and another person was observed. While searching the area the following items were found: 3 wheat sacks containing rice, eating utensils, 1 can full of chicken feed, 1

live chicken, 3 boxes of flashlight batteries, 2 cartons of HNV cigarettes, 2 cans of cream, 2 flashlight bulbs, 1 AK-47, 1 bag of seasoning, 1 can of mackerel, 1 sweater, 11 sheets of tracing paper, 2 bags of needles, 2 bags of rice, 1 bag of blank receipts, 4 books, 1 bar of soap, 1 can of powdered cream, 3 text books, 2 poncho liners (parachute type), 2 cooking pots, 1 bag of salt, rations, 1 bag of bandages, 2 bottles of pills, 1 basket, 5 items of female clothing, 1 razor blade, 1 pair of black pajamas, 1 shirt, 1 pair of blue trousers, 2 bags of curry powder, sugar, and 1 can of cooked rice. The personnel observed wore dark green shirts, black pajamas and had on no hats or shoes. All items were turned over to Regimental S-2.

2100H In the area of ZC159376 elements of Co K observed movement. Small arms was delivered with negative results.

2120H In the area of ZC159368 elements of Co M initiated an ambush on 10-30 enemy with 2 claymores and a heavy volume of small arms fire. The area was searched with negative results.

21 Dec 68 0915H In the area of ZC158382 elements of Co K while on patrol discovered an ambush by the enemy who prematurely fired 2 carbine rounds. Fire returned with negative results.

1100H In the area of ZC1811355, ZC184357 elements of Co L discovered an area estimated to be a platoon size rest area. The area consisted of hammocks, poncho huts, and fireplaces and no fighting holes. It was estimated to be about 2 months old. Further down the trail they discovered 2 more rest areas and a CP area with a water point. It contained 4 hammocks, 12 inch piece of blue-gray communications wire, and a MIA belt. The pieces were put together with vines. There was evidence of snails having been eaten. There were fresh tracks running north to south crossing a man-made bridge and were estimated to be of 3 persons.

1200H In the area of ZC162382 elements of Co K discovered a foot bridge across a stream. The bridge was in good condition and old logs had been replaced.

1140H In the area of ZC149379 elements of Co K came upon a natural trench line caused by soil erosion. The trench line was along a trail and fresh NW tracks were found. The area was further checked out with negative results.

1230H In the area of ZC162351 Co L found living huts and 10-50 places where hammocks could be strung. The area had been used within the past 2 months. A stream running north to south was interlaced with trails that were well used, and an OP on the southeastern side with clear observation of LZ Moc. Area was searched out and all useable items were destroyed. All the trails were searched for approximately 100 meters.

1500I In the area of 70153679 elements of Co M found a large bunker complex consisting of 9 huts 20ft long, 10ft wide, and 15ft high. One hut was determined to be a messhall, one an aid station, and the rest living huts with bunkers underneath. The area had approximately 30 fighting holes 3x4x2 foot. The complex was found by a stream bed approximately 12ft wide and 6ft deep. The stream bed did not appear on the map. The complex had been used within the last 48 hours by an estimated 20 people. The complex was capable of accomodating 3 companies and is believed to be a staging area for platoon size units. The following items were found: Document that list'd the names of enemy that are going to join units, parts of a gas mask, 1 canteen, rifle cleaning gear, open civilian canned goods, 1pr of black pajamas, flashlight batteries, 2 tubes of Ben Gay, and old newspapers.

22 Dec 68 0900I In the area of 70160380 elements of Co K observed 1 person walking east to west. He was taken under fire by small arms. Area was searched with negative results.

0900I In the area of 70185343 elements of Co L while on patrol had one man step on a booby trap consisting of a blasting cap.

0900I In the area of 70157383 elements of Co K discovered a campsite approximately 1 week old. The site could accomodate a reinforced squad. It was destroyed. Newspapers were found and sent to S-2.

0900I In the area of 70163382 elements of Co K observed 3-5 persons. They were taken under fire and fire was returned. Negative results.

1200I In the area of 70165381 elements of Co K found a letter used as toilet paper. The letter was hard to interpret but was thought to be a father to son letter and was sent to S-2.

1235I In the area of 70165384 elements of Co K discovered 5 huts constructed over bunkers. The construction was very new. They were destroyed. Two enemy were observed leaving the area but too far away to take under fire.

1320I In the area of 70150390 elements of Co I heard 25-30 Vietnamese voices and saw 1 person running from the area. Checked out the area with negative results.

1350I In the area of 70162385 elements of Co K discovered an extensive enemy bunker and hut complex. An undetermined number of bunkers and huts size 8x10 foot and larger with a 2-3 foot overhead. Huts were made of saplings and thatching with hard packed floors size 10x15 feet and larger. A cooking type hut and adjacent hall 75x25 feet. A medical hut containing test tubes, morphine, narcotics, heroin bottles, a vase with artificial flowers, female panties and a slip. The Battalion Surgeon determined fresh parts of a lung. A grain mill and 1 dye marker bunker freshly sealed within the last 24hr, and a 2 hole latrine with a roof. The platoon commander estimated it to be a

battalion or larger size R&R center and aid station. There were no fighting holes or security positions. There were indications of extensive tunnel networks, and the general appearance was neat and well used. Two enemy were observed in the central part of the complex. The enemy came from the west into Co K security. They were taken under fire resulting in 1 being killed and the other wounded. The wounded enemy escaped. The NVA had on new green uniform, brown belt and no shoes. His captured AK-47 was in very good condition. Also found were documents, Communist indoctrination pamphlets, instruction manual for nurses, and a homemade intravenous stand.

1430H In the area of ZC153379 elements of Co M discovered an 8 bunker complex containing a NVA belt, 1 empty soy bean oil can, a NVA first aid packet, 2 cans of powdered milk, tooth paste, empty fish cans, a chicken coop, a clothes line, and a well 5x5 feet. Fighting holes were dug in the bottom of the bunkers and in the side of the stream bed.

1600H In the area of ZC154368 elements of Co M discovered a rest area with no bunkers or fighting holes. It contained 8 huts approximately 1 week old with 12 women and gear racks, and 3 fire pits. The rest area was located about 25m off of a heavily used trail going east to west. A NVA helmet and black shorts were found.

2100H In the area of ZC157375 a listening post of Co K was fired upon. Fire was returned with negative results.

2200H In the area of ZC158372 Co M executed 2 ambushes. Checked area at first light with negative results.

23 Dec 68 No significant events.

24 Dec 68 1000H In the area of ZC167311 elements of Co K discovered 100 pounds of rice; saved 50 pounds for possible consumption and destroyed the balance.

1200H In the area of ZC1677382 elements of Co K searched a bunker and hut complex. The complex consisted of approximately 7 living quarters 12x20 feet, 9 bunkers 8x10 feet, a medical hut 8x10 feet, 2 huts 12x20 feet, 5 storage bunkers 5x5 feet, a storage barn 10x15 feet, 1 messhall 8x15 feet, 3 tons of rice, 25 pounds of tea, 1 buck saw, 2 machetes, 2 ammunition pouches with 23 AK-47 rounds, 5 eating utensils, 75 bowls, 150 spoons, school books, medical equipment for intravenous feeding, vitamin bottles, clothing and documents, 1 with figures 403 inside, a chinese cover, and 2 5 gallon cans of soy bean oil, (1 marked C-81). The area was destroyed.

1800H Cease Fire until 251800H.

25 Dec 68 Cease Fire ended at 251800H. No significant events.

26 Dec 68 0930¹ In the area of TC161381 elements of Co K discovered a medical bunker with surgical and laboratory equipment, an American surgical kit, drugs from USSR and Czechoslovakia, American eye glass, pictures, medical text books, pharmaceutical hand books, political organization parade banner, family records and pictures, Vietnamese class notes (medical), 1 NVA pack, and 50 pounds of rice. The rice was destroyed and the documents were sent to 3-2.

1030¹ In the area of TC150374 elements of Co L observed 1 person. The lead elements opened fire and the individual jumped into the bushes. The lead elements heard some talking and the interpreter talked the individual out of his hiding place. The "PO" stated that he was an E5 corpsman from the 338 Division, 75th Co. He claimed he was going west with 2 other companions to a village then to Route 40. He also stated that there was 27 more NVA on the objective and they had 6 AK-47's and 16 M-14's. The PO was taken to ITT. One pack containing medical supplies and rice was captured.

1530¹ In the area of TC160353 elements of Co I observed 2-3 armed enemy going north along a trail. They were taken under fire with small arms and mortar. Writing material, rice, salt, marijuana, and documents similar to a log book was captured.

1530¹ In the area of TC143374 elements of Co I observed 1 male and 1 female walking down a trail. They were fired at and the area searched with negative results.

1545¹ In the area of TC142368 elements of Co L made contact with 2 persons. They were taken under fire. Items captured were: 101 pounds of needles, 2 cooking stoves, prepacked shrimp, rice, civilian clothes, medical gear, pieces of poncho and wallet documents, 10 papers, 11 books about chemistry.

27 Dec 68 0915¹ In the area of TC136360 elements of Co L found fresh footprints about 1hr old. One was barefooted and the other wore sandals.

0930¹ In the area of TC138766 elements of Co I discovered 3 freshly dug fighting holes approximately 2 $\frac{1}{2}$ x4 $\frac{1}{2}$ x3 $\frac{1}{2}$ feet with small logs and leaves overhead. The bunkers were destroyed.

1000¹ In the area of TC155386 elements of Co M discovered 3 thatched huts 20x15 feet approximately 3-4 months old. The area had been used in the last 1 yr. Also discovered 3 caves approximately 10x10 feet used in the last 5-7 days. This area was apparently a rest area. The bunkers were destroyed. The complex contained 2 SKS rifles with 10 rounds, 4 NVA packs, 2 mosquito nets, 2 canteens, 3 monsoon sweatshirts, 22 cooking pans, 2 h-tools, 1 poncho, and documents. The documents were sent to 3-2.

1130¹ In the area of TC136113 elements of Co L while proceeding off the trail detonated a booby trap consisting of a blasting cap.

1415H In the area of TC156355 elements of Co I discovered a grave containing human bones estimated to be 30-60 years old.

22 Dec 68 1030H In the area of TC150371 elements of Co J found footprints of personnel with and without sandals. The footprints were approximately 24 hours old. The cap of a Chicom grenade was found. Approximately 10 meters from the trail a grave was discovered with a small 3 rail fence around it and a circle with a star in the center made out of bamboo about 18 inches in diameter. A stretcher made out of bamboo was laying beside the grave. The body was 5 feet deep with a towel over his face. He had on 2 pair of trousers, 3 shirts, and a pair of USA green utilities. The body was wrapped in a poncho and liner which looked like a parachute from an illumination round. The age was estimated to be 25-30 years old. About 40 meters from the trail were 3 huts and several camp sites. The size of the compound was large enough for a company and the fire sites were large enough for a squad. The huts were destroyed.

1730H In the area of TC159393 elements of Co K discovered the following items in a hut and bunker complex: 4000 malaria tablets, 50 doses of atropine, 1 cork bottle of crystalline unknown substance, 2 blood pressure cuffs, 1 otoscope, 1 orthoscope, 1 instrument tray, 3 cans of unknown substance, 20 vials of vitamin C, 10 vials of calcium carbonate, 1 pharmacist notebook, 16 bottles of substance, 6 small bottles, 1 first aid case, 15 pounds of unknown powder, 10 needle sterilizers, 3 surgical pans, 1 tin cup, 200 battle dressings, 1 spinal tap set, 11 ft of rubber 6x14 feet, 200 feet rubber tubing, 300 vials of unknown substances, 2 10 pound cans of unknown powder, 0.25kg magnesium chloride, 600 vials of unknown substances, 2 boxes of amyl nitrate, 1 jar vaseline, 5 5 pound bags of unknown crystalline substance, 5 pounds cotton, 2 rubber stamps, 3 boxes unknown substance, 10 pounds battle dressing, 1 pharmacist spoon, 8 jars of unknown substance, 1 enema set, 2 packages, 3 bags of unknown powder, 1 burner, 4 packages of cotton, 1 box unknown crystalline, 9000 unknown tablets, 1 package of 40 packets of liquid, 1 wire bracket, 1 15" crescent wrench, 1 bag of M-47 rounds, 20 bottles of unknown acid, 1 box of surgical equipment, 4 pounds of sulfur, 2500ml unknown liquid, 2

pounds of cheese cloth, 2 small heaters, 200 tubes for drawing blood, 1 hemostat, 1 syringe, 4 bags of unknown powder, 1 box of battle dressing and cotton, 12 vials of unknown vaccine, 2 packages of sterile cat gut, 2 bottles of cough syrup, 35 packets of 10 unknown vials each, 1 surgical wrap, 1 T shirt, 1 bottle of plasma, 1 box of pens and pens and surgical pens, 1 test tube sterilizer, 1 can of unknown powder, 100 pounds of rice, 40 gallons of kerosene, and 30 gallons of soy bean oil. The huts 25x15 feet and 2 bunkers 20x10 feet were destroyed. All other items were turned over to S-2.

29 Dec 68 1130H In the area of ZC138375 elements of Co L made contact with an unknown number of enemy. Small arms were used while assaulting the position. While searching the area, a wounded POW was captured as were 2 new SKS rifles, 1 US carbine, medical supplies, literature, women's clothes, and 20 pair of trousers.

1400H In the area of ZC147386 elements of Co M discovered half built huts and fighting holes approximately 1 month old with a tunnel 15-20 feet long. The area had many trails. The trails that lead to the southeast were the most heavily traveled. The huts and tunnel were destroyed.

1500H In the area of ZC138355 elements of Co L found a house and inside a basket of clothes. 3 NVA appeared and were taken under fire; 1 was wounded and they disappeared. A search of the area produced 3 SKS and 1 carbine. Another hut and 2 bunkers were discovered. At this time another platoon of Co L was sent to assist in the search. While advancing, the area was reconnoitered by fire and a heavy volume of fire was received. The area was searched and behind a false wall was discovered 1 AK-47, 3 US carbines, 4 SKS, medical gear, tennis shoes, 100pr of utilities, 20 NVA packs, 100 sweatshirts, 80 black pajamas, 2pr of women's panties, 200 pounds of rice, 2 rice bins, 1 clay stove, 35 carbine rounds, 200 AK-47 rounds, 24 AK-47 magazines, and 12 Chicom grenades.

30 Dec 68 1100H In the area of ZC145365 elements of Co L discovered 4 huts. The first was 20x40x15 feet and located under the floor was 17 K-14 rifles, 6 French submachineguns, 6 US carbines M-1, 2000 AK-47 rounds, 300 9mm rounds, 12 Vietnamese machetes, and a 2# block of TNT. The second hut was 10x16x10 with a bunker underneath 8x10x16 feet. The hut didn't have any sides and may have been used as a classroom. The third hut was 10x16x10 feet and contained construction materials. A bunker for night security was 20m away. The fourth hut was 80x20x15 feet and judged to be living quarters. A bunker 14x6x2 feet was built on the side. There were spider holes 20m from the hut. The huts were destroyed and the weapons turned into the S-2.

31 Dec 68 1100H In the area of ZC140382 elements of Co M made contact with approximately 2-4 persons. They were taken under fire with small arms and artillery. Results unknown.

1. SITUATION

a. Enemy Forces Communist activity in the objective area consists of movement along trail networks between base complexes to the west and populated areas to the east. The base complexes support large Main Force Viet Cong units and NVA infiltrators. Capabilities include rocket and mortar attacks as well as infantry units massing up to battalion size. Well-prepared defenses, ambushes, and BOOBY TRAPS will be encountered in this area. Enemy troops can be expected to be using the trails, and to stand and fight. Friendly forces have not penetrated this base complex area since 1965. Current enemy activity indicates some reaction to the build up at An Hoa Combat Base. Recent activity has been reported in GS1741, GS0634, and GS7835.

b. Friendly Forces

- (1) 3d Marines(-) and 5th Marines(-), as elements of Task Force Yankee, conduct S/D opns in the area west and south of An Hoa Combat Base (GS8747) by helilifting to key terrain features and establishing artillery fire support bases and infantry combat operating bases.
- (2) 1/3 operates to the north, establishing FSB Spear (GS1840). Recon elements will periodically be inserted to the east, south, and far west. 1st Mar Div operates to the far south.
- (3) Artillery: D/S fires will be from F/2/11 located at FSB Lance (GS7941). Upon establishment of FSB Spear, D/S fires will be provided from there by C/1/12. G/S fires initially from T/2/11 at FSB Lance. All other G/S batteries in range are available for support of 3/3.
- (4) Air: Helicopter assault, gunship, and medevac support, fixed wing close air support and A-10's will be provided by 1st MAW aircraft.

2. MISSION

At H-hour on D-day, 3/3 helilift to vic GS1735, secure the LZ, and

establish Combat Operations Base Mace. Conduct S/D ops in objective area. Be prepared to establish a FSB on Hill 551 (GS1335).

3. EXECUTION

- a. Concept of Operation: At H-hour on D-day, 3/3 helilifts from An Hoa to vic GS1335, in sequence I-KCP-81's-L-M seizes designated objectives, improves the LZ, and commencing D+1 conducts extensive S/D patrols from company patrol bases. Fire support will be provided by fixed wing and gunship aircraft, direct and general support artillery, and 2 sections of 81mm mortars.

- e. Co M: Conduct fourth lift and seize assigned objective. Establish a company patrol base. Be prepared to conduct S/D ops commencing D+1.
- f. 81mm Mortars: Conduct lift with battalion CP group. Be prepared to establish positions to provide supporting fires for all units.
- g. Coordinating Instructions:
 - (1) Objectives to be assigned by frag order.
 - (2) D-day and H-hour to be announced.
 - (3) Companies construct LZ's with at least external load capability at patrol bases.
 - (4) Minimum 2 night ambushes and 3 listening posts at each base.
 - (5) Search for and carefully examine graves and caches.
 - (6) Current thrust points and brevity codes must be used.
 - (7) Do not delay initial spot reports of incidents. Submit final reports ASAP.
 - (8) Code name: Operation 'Tayler Common'.

4. ADMINISTRATION & LOGISTICS

- a. Supply: Units carry normal combat equipment.

- (1) Assualt loads - Class I - 4 LRP's, 2 DOS MCI (LRP's consumed only on order).
Class V, B/A plus 2 DOA.
- (2) Resupply loads will be staged for helilifts at An Hoa LSA.
- (3) Units submit resupply requirements daily by 1000.
