NARRATIVE SUMMARY

The New Years' truce period was observed and the Battalion conducted extensive reconnaissance patrols and established numerous observation posts. No enemy sightings were recorded and there were no violations of the truce in the Area of Operation. On 1 January, Company G was placed under the operational control of the 3d Battalion, 4th Marines and conducted a one day search and clear operation north of CAM LO. Company E continued to consolidate the CUA Valley Company Patrol Base and observation post established 31 December 1966. The 122d Regional Force Company was also moved to the CUA Valley to conduct combined operations with U. S. Marine Corps forces. On 7 January, Company E in conjunction with the 122d Regional Force Company and CAM LO District personnel conducted a COUNTY FAIR type operation for two days in the CUA Valley Refugee Centers. The names of nine suspected VC were added to the Black List and a complete search of the area was made with negative results. A medical team comprised of members of the Medical Sections of this Battalion and the 3d Marine Regiment initiated a MEDCAP Program in the Refugee Centers and the village of CAM LO. On 13 January, Company G was placed under the operational control of the 3d Marines and was assigned to BA LONG Area of Operation. Company G continues to conduct operations in the BA LONG Valley. In an effort to increase the surveillance north of the Camp J. J. CARROLL Complex, Company H established a Platoon Patrol Base in the vicinity of DONG MA Mountain 4,000 meters north of Camp CARROLL on 13 January. This patrol base was maintained until 25 January when it was secured because of additional operational commitments. On 21 January, Company F was placed under the operational control of the 3d Battalion, 4th Marines and provided security for the DONG MA Combat Base. Company F returned to the operational control of this Battalion on 25 January. The 26th of January the 2d Battalion, 3d Marines (-) (rein) commenced a search and destroy operation in the hills northwest of CAM LO. Company M, 3d Battalion, 3d Marines and Companies L and M of the 3d Battalion, 4th Marines were placed under the operational control of this Battalion. Company L, 3d Battalion, 4th Marines provided security for the Camp J. J. CARROLL Complex and Company E (-), 2d Battalion, 3d Marines provided security for the KHE GIA Bridge and the displaced Artillery Battery that was in support of the operation. Company M, 3d Battalion, 4th Marines established blocking positions in the eastern portion of the Area of Operation. Initial search and clear operations were conducted in the western portion of the Area of Operation but the sweep to the east was cancelled and the operation aborted because of new operational commitments on 27 January. All employed units commenced overland movements to return to their parent organization. All units were returned to the operational control of parent organizations by the 28th of January at 0330 hours. No contact with enemy forces resulted and due to the cancellation of the operation it was impossible to search the entire Area of Operation. On 31 January, Company M, 3d Battalion, 3d Marines was again placed under the operational control of this Battalion and provided security for Camp CARROLL while Companies E, F, and H with the Command Group initiated a three day search and clear operation in the CUA Valley area.

Operation PRAIRIE terminated 312400 January. The highlights of the month were the numerous enemy sightings and encounters in the CUA Valley area, the Battalion size search and destroy operations north of the CAM LO River and in the CUA Valley, and the commencement of a Civil Affairs Program in the Village of CAM LO and CUA Valley Refugee Centers.

E. NEW TECHNIQUES EMPLOYED

(1) The dual 40mm guns of Battery C, 1st Battalion, 44th Anti-Aircraft Artillery Regiment were utilized to deliver preparation fires on a helicopter landing zone prior to introduction of a platoon. The large volume of fire delivered completely neutralized the landing zone and the helicopter lift was unopposed.

(2) Small mechanized forces composed of tanks, Ontos, and dual 40mm (SP) guns have been used extensively to patrol the long MSR in the Area of Operation. Infantry mounted on the vehicles provided additional security and established check points for population control along the MSR. These mechanized forces also provided flank security during the CUA Valley operation and delivered preparation fires on Objectives prior to the assault by infantry forces.

(3) During truce periods additional reconnaissance patrols and observation posts were established to report movement of all persons moving through the Area of Operation.

(4) A rallier was used at the County Fair operation in CUA Valley to point out known or suspected Viet Cong that were living in the Refugee Centers.

F. COMMAND RELATIONS

During the period 1-31 January the 2d Battalion, 3d Marines was under the Operational Control of the 3d Marine Regiment and under the Administrative Control of the 3d Marine Division.

Company G was OPCON to the 3d Battalion, 4th Marines from 010730H to 011730H January 1967 and OPCON to the 3d Marine Regiment from 130900H. Company G remains OPCON to 3d Marine Regiment. ADCON of Company G has remained with the 2d Battalion, 3d Marines.

Company F was OPCON to the 3d Battalion, 4th Marines from 211705H to 251530H January 1967. ADCON remained with the 2d Battalion, 3d Marines.

Company M, 3d Battalion, 3d Marines was OPCON to this Battalion from 260800H to 280330H January and from 301500H January to 021630H February 1967. ADCON remained with the 3d Battalion, 3d Marines.

Companies L and N 3d Battalion, 4th Marines were OPCON to this Battalion from 260800H to 271000H January 1967. ADCON remained with the 3d Battalion, 4th Marines.

G. EQUIPMENT

1. General: Monsoon conditions have continued to cause a high percentage of deadlined equipment. High usage parts such as brake shoes for the M22A1, and H-138U hand sets for the AN/IRC-25 are particularly vulnerable to the adverse weather conditions experienced during this period.

2. Individual Clothing and Equipment. Most individual clothing and equipment has withstood the climatic and operational conditions excellently. Exceptions are jungle utility trousers, jungle boots and flak jackets, all of which remain critical items due to high usage rates.

3. Special Equipment.

(a) Eight charcoal space heaters were used throughout the past month. Both wood and local charcoal were burned with excellent results.

(b) Twenty-five M16E1 rifles have been received for training purposes.

(c) Tests of the vehicle mounts for the AN/IRC-47 and AN/IRC-41 were conducted with excellent results.

4. Communication-Electronics. As indicated above, some items of equipment have been in short supply due to a high usage rate. Generators to provide electric power for the Battalion encampment have been furnished by 3d Engineer Battalion.

5. Motor Transport.

(a) All vehicles are on hand except for two M274's that have been on order for several months.

(b) Second echelon repair continues to be a heavy requirement due to monsoon conditions.

6. Mess. Galley equipment continues to perform excellently. Flame heads from "B" pack field ranges were used with excellent results to supplement charcoal stoves in warming tents.

H. LOGISTICS

1. Supply

(a) Battalion Supply has continued to maintain a rear area physically separated from the forward base camp by 15 road miles. The supply rear is located near FLSU. Class I, III, IV and V items have been available at FLSU and transported directly to forward distribution points for the Battalion. Limited Class II has been available from FLSU.

(b) Daily trips to FLSU, as required, were made for the repair of ordnance and office machines.

(c) Requisitions were hand carried to Fleet Stock Account. Priority 02 requisitions were cleared through Division Supply prior to submission.

2. Maintenance

(a) The following quantity of items by category were taken to FLSU for maintenance:

(b) Second echelon repair has remained adequate, although monsoon conditions have been destructive on motor transport parts such as brakes shoes and wheel cylinders.

3. Food Services. A Battalion field mess has been in operation during January. One company and the major part of H & S Company mess at a central facility. Hot rations are transported to one additional company. Messing facilities for the 150 man rear are provided by the 4th Marines mess hall.

4. Cantonment and Camp Facilities Development.

(a) Positions turned-over to the Battalion at Camp CARROLL have been improved and expanded, however, no permanent cantonment facilities have been constructed due to the field role of the Battalion at Camp CARROLL. Extensive wire barriers have been constructed.

(b) The supply and administrative rear have utilized existing tin roof buildings and tents for personnel billeting, storage, and office space.

(c) Additional head facilities, tent flooring, and limited material for bunkers have been requested.



Subj: Sightings within Area of Operation

Encl: (1) Format for Reporting Sightings

1. The anticipated increase in dispersion of units and the requirement for timely and accurate intelligence as a basis for realistic planning and operations requires that units submit all sightings of persons or unusual events immediately. The enemy bases his future infiltrations, attacks, and ambushes upon the intelligence he receives from his reconnaissance forces. These forces may be wearing uniforms and carrying weapons but more likely will be dressed as farmers or in other civilian type clothing. An effective courier service is an integral part of our enemy's intelligence system. Denied this critical means of communication, he will be hard pressed to know our patrol routes, unit locations, and weapons emplacements.

2. In the past, we have reported movements of, and contacts with, armed enemy forces. In an effort to curtail the enemy's intelligence gathering effort, deny him his infiltration routes, and disrupt his courier service, increased emphasis must be placed on population control, reconnaissance patrols, and observation posts.

3. All sightings of, and encounters with, indigenous personnel will be reported to this Headquarters using the format shown in enclosure (1). Spot Report forms will continue to be utilized to report all enemy initiated incidents or contacts.

4. Company Commanders will assign watch standers on all observation posts, and will ensure that these watch standers are informed as to their specific duties, including the requirement to report. Watch standers will be on duty during all daylight hours. Binoculars should be utilized whenever possible.

2. MISSION. Camp J. J. CARROLL Resident Infantry Battalion plans and coordinates the defense of Camp J. J. CARROLL and assigned Area of Operation, providing sufficient forces to defeat and destroy all enemy forces that might assemble, attack, or penetrate the Camp J. J. CARROLL complex or assigned Area of Operation.

3. EXECUTION.

- a. Concept of Operation.
 - (1) Annex B (Operation Overlay)
 - (2) Commanding Officer, Resident Infantry Battalion has been designated the Camp Defense Coordinator to plan and coordinate the defense of Camp J. J. CARROLL.
 - (3) The Camp J. J. CARROLL area is divided into eight sectors each with an appointed Sector Commander.
 - (4) Sector Commanders will conduct the defense of their assigned sector with forces from within their respective sectors.
 - (5) Sector Commanders will provide forces for a Sector Reaction Force to execute Annex C (Counter Attack Plan).

- (1) Responsible for the overall defense of the Camp J. J. CARROLL area.
- (2) Establish and man a Camp J. J. CARROLL Defense Command Post.
- (3) Provide one Rifle Company to occupy and defend assigned sector of the defense perimeter and surrounding key terrain.
- (4) Provide one Rifle Company (-) to occupy area and defend KHE GIA Bridge.
- (5) Provide patrols, ambushes, listening posts and observation posts throughout Area of Operation.
- (6) Organize a Camp Defense Reserve to be used in execution of Annex C (Counter-Attack Plan).
- (7) Direct, supervise, inspect, and approve all Camp Defense fires to include Final Protective Line (FPL) and Principle Directions of Fire (PDF).
- (8) Conduct training programs for, and provide training teams to, those units within the perimeter requesting or requiring such assistance.
- (9) Conduct rehearsals and inspections of camp defense lines as are necessary to maintain a high state of readiness.
- (10) Supervise defensive wire plan in conjunction with the Camp Commander of Camp J. J. CARROLL.

c. Sector Commanders.

- (4) The Tank Unit Commander will furnish the Camp Defense Coordinator timely information regarding the status of vehicles, personnel, and equipment.

e. Anti-Tank Unit.

- (1) Occupy and defend perimeter in assigned sector.

- (14) Establishment and/or relocation of inner defensive perimeter positions will be coordinated and approved by the Camp Defense Coordinator.
- (15) Sector commander's will ensure that all personnel involved in perimeter defense are made aware of preplanned concentrations and barrages in their vicinity. Annex E (Fire Support Plan).
- (16) Protective shelters, bunkers, or trenches will be constructed adjacent to all working and billeting areas.
- (17) Designated defensive perimeters will be manned at all times during hours of darkness and periods of reduced visibility.
- (18) Maintain observation positions along the perimeter during daylight hours.
- (19) Maximum use will be made of defensive wire, trip flares, and observed claymore mines.
- (20) Coordinate fires of all weapons with the Camp Defense Coordinator in order to preclude firing into the Infantry Battalion's operating area and other manned sectors. Positive approval must be granted by the Camp Defense Coordinator prior to commencing fire in any sector of the defensive perimeter.

- (3) Ensure that an adequate supply of all types of ammunitions is readily available to all units manning the defensive perimeter.





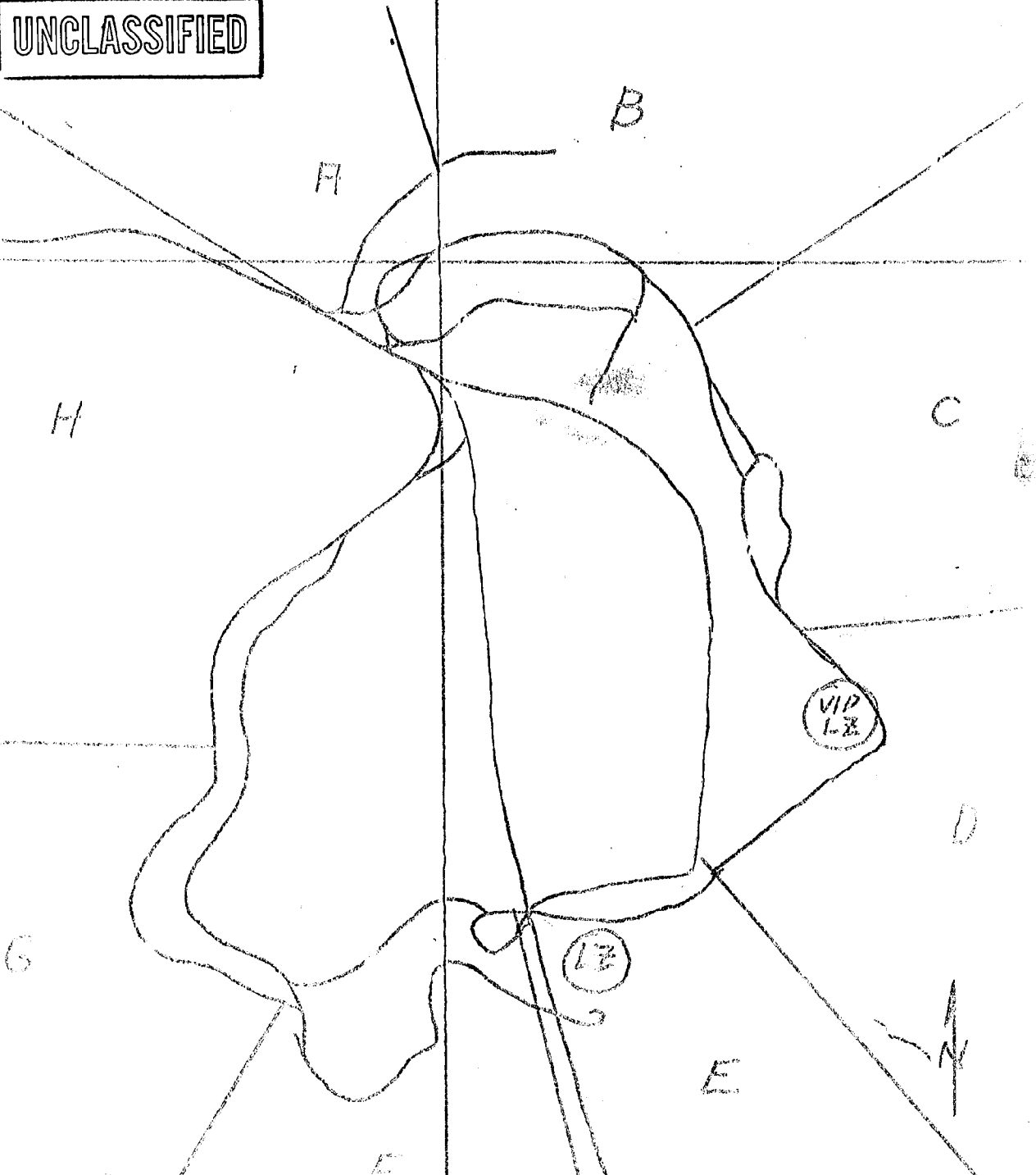

1. SITUATION.

- a. Enemy forces. Refer current INTSUMS
- b. Friendly forces. Annex A (Task Organization) and current SITREPS.
- c. Assumptions.
 - (1) That the enemy has the capability of infiltrating and attacking with guerrilla or main force units of up to Battalion strength.
 - (2) That attacking forces may have both direct and indirect fire weapons in support.
 - (3) That CAS, artillery, mortar, tank, and Ontos support will be available for camp defense.
 - (4) That the forces within Camp J. J. CARROLL are capable of defeating any enemy force that penetrates the defensive perimeter.

2. MISSION. To destroy all enemy forces that attack or penetrate the Camp J. J. CARROLL complex. Destruction of enemy forces will be accomplished by limiting the enemy's advance by strategically placed blocking positions, the coordinated movement of reserve or reaction forces, and proplanned artillery/mortar concentrations.

3. EXECUTION.

- a. Concept of Operations. This plan provides for the rapid movement of friendly forces within Camp J. J. CARROLL to provide physical reinforcements to a sector under attack, and to place troops in designated blocking positions. The Sector under attack will utilize Sector Reaction Forces to contain and destroy the attacking force. If the Camp is under large scale attack and is penetrated or in immediate danger of being penetrated, all reaction forces will assume blocking positions to contain or delay the enemy penetration in order that the Camp Defense Reserve may close with and destroy the enemy.

- (1) Be prepared to defend assigned perimeter against enemy attack.
- (2) Establish blocking positions within Sector A along routes of possible enemy penetration. Be prepared to occupy these positions to contain, delay, and destroy any enemy penetration.

c. Sector B

- (1) Be prepared to defend assigned perimeter against enemy attack.



Annex D (Alert and Readiness Conditions) to Operation Plan 1-67

Alert Conditions

Readiness Status

Condition I

Camp is under attack

100% security on perimeter. All persons man defensive positions. Personnel not actively engaged in execution of this plan will man minimum essential command/control billets, or will take shelter in designated areas.

Condition II

Attack Imminent

100% security on perimeter. All persons man defensive positions except those necessary to maintain communication, command, and fire direction centers in defense of camp.

Condition III

Attack warning

50% security on perimeter. Be prepared to execute Condition II within 15 minutes.

Condition IV

Normal

25% security on perimeter. Be prepared to execute Condition II within 30 minutes.

Alert conditions will be promulgated by the fastest means available. Condition III is always in effect during the hours of darkness and periods of reduced visibility. Conditions I and II will be passed over the Camp J. J. CARROLL Defense Net or Landline.

Rehearsals and Drills

1. Rehearsals and drills may be conducted at any time by Sector Commanders after securing clearance from the Camp Defense Coordinator.
2. Unscheduled Camp defensive drills will be conducted by the Camp Defense Coordinator to realistically evaluate the counter-mortar plan and perimeter defense.

3. Sector Commanders will receive the initial Drill Alert via the Camp Defense Net.

4. The Drill will normally be conducted in two phases:

Phase I: Phase I consists of a live fire test of the counter-mortar plan by both direct and indirect fire weapons. Fire missions for direct fire weapons will be passed over the Camp Defense Net, while the appropriate Conduct of Fire Net will be utilized to request fire missions for indirect fire weapons. All persons not engaged in the conduct of counter-mortar fires will immediately go to bunkers, shelters, or trenches. Sector Commanders will notify the Camp Defense Coordinator via the Camp Defense Net when all persons have taken cover.

Phase II: Phase II provides for the manning of all sector defensive positions and the movement of reaction forces by the Camp Defense Coordinator to reinforce one or more of the sectors. Sector Commanders will notify the Camp Defense Coordinator when all defensive positions are manned.



2. MISSION. To establish a coordinated fire support plan for the defense of Camp J. J. CARROLL and KHE GIA Bridge.

3. EXECUTION.

- (a) Defensive Fires. Permanent defensive targets have been plotted around the Camp and Bridge for artillery, 81mm mortars, and 40mm anti-aircraft weapons. Tanks and Ontos will fire on targets of opportunity.
- (b) Counter-Mortar Fires. Counter-mortar targets have been plotted on likely enemy mortar positions and withdrawal routes for artillery and 81mm mortars. 40mm anti-aircraft weapons, tanks, and Ontos will fire on targets of opportunity and provide reinforcing fires as directed.
- (c) Harrassing and Interdiction Fires. Harrassing and interdiction fires will be delivered on avenues of approach, infiltration and supply routes, harbor sites, assembly areas, trail junctions, and river crossings by artillery, 81mm and 60mm mortars, tanks, Ontos and 40mm anti-aircraft weapons.
- (d) Requests for Fire. Units located in Camp J. J. CARROLL will request supporting fires through their Sector Commanders. Sector Commanders will request these fires through the Camp Infantry Battalion's FSOC.
- (e) Clearance of Fires. All mortar, anti-aircraft, tank, and anti-tank weapons in the Camp must obtain positive clearance from the Camp Infantry Battalion FSOC before firing.
- (f) Illumination. Requests for illumination will be indicated by adding the suffix ZULU to the target concentration number. (Example: TGT AB 646Z).

Annex G (Glossary) to Operation Plan 1-67

1. ASSEMBLY AREA - Is an area where units (personnel) assemble prior to further tactical action. It is used for entrucking or detrucking, feeding, resting, awaiting or issuing orders, and reorganizing and/or making preparations for combat.
2. BLOCKING POSITIONS - Organized to deny the enemy access to a given area or prevent his advance in a certain direction.
3. CAMP COMMANDER - Commanding Officer, Marine Infantry Regiment.
4. CAMP DEFENSE COORDINATOR - As appointed by Commanding Officer, Marine Infantry Regiment, usually the Resident Infantry Battalion Commander.
5. CAMP DEFENSE RESERVE * The reserve forces organized by Camp Defense Coordinator. Utilized for commitment into any sector of the base perimeter to serve in reinforcing the already established defenses, as a counter-attacking force, or as a blocking force.
6. FINAL PROTECTIVE FIRES (FPF) - In the defense, the machinegun fires, barrages of mortars and artillery, the PDF's of automatic rifles, sectors of fire of individual rifles, and the grenadier's sector of fire.
7. FINAL PROTECTIVE LINE (FPL) - Fired by machineguns as a part of the final protective fires (FPF).
8. NIGHT DEFENSIVE FIRE PLAN - During the hours of darkness, the tactical plan for using the weapons of a unit so that their fire missions will be to each automatic rifleman, usually covering a likely avenue of approach or dead space in the FPL.
9. PROVISIONAL RIFLE PLATOON - Consists of personnel not normally assigned an infantry billet.
10. SECTOR OF FIRE - In the defense, assigned to all riflemen, automatic riflemen, machine gunners and grenadiers. Consists of direction of fire with a designated right and left limit.
11. SECTOR REACTION FORCES - The reserve force organized by each Sector Commander, which is readily available in event of attack to assist in reinforcing the already established defensive perimeter or serve as a counter-attacking or blocking force.

12. SPOT REPORT - A standardized report used to pass information. The following format is utilized. Only the letter designation are used to identify paragraph when reporting.



- a. Enemy forces. Refer current INTSUMS.
- b. Friendly forces.
 - (1) 3d Marines continues operations in Operation PRAIRIE Area of Operation.
 - (2) 1st Battalion, 12th Marines, D/S 3d Marines.
 - (3) Company A, 3d Tank Battalion, D/S 3d Marines.
 - (4) Company A, 3d Anti-Tank Battalion, D/S 3d Marines.
 - (5) Battery C (reinf), 1st Battalion, 44th Anti-Aircraft Regiment, D/S 3d Marines.
 - (6) Air Support. Close air, helicopter, aerial observation, and service support available on call.

- d. Assumptions.
 - (1) That forces currently deployed will return to the operational control of this Battalion.

2. MISSION.

- a. Continue presently assigned mission.
- b. With Battalion Command Group and Battalion (-) land H-Hour, D-Day in designated Landing Zone and conduct a two phase search and destroy operation in assigned operating area.

- (1) Operate in Sector ALPHA for a period of about two days.
 - (2) Cross Phase Line BLUE not later than the morning of D + 2.
 - (3) Operate in Sector Bravo for a period of about three days moving west to east to terminate at Final Objective Line.
 - (4) Be prepared to conduct subsequent operations, on order, west of the Area of Operation.
- c. Reconnoiter major trail network in Area of Operation.
 - d. Assume Operational Control of Company M, 3d Battalion, 3d Marines at H-Hour.
 - e. Assume Operational control of two Rifle Companies of the 3d Battalion, 4th Marines 261200 January 1967.
 - f. Provide security for the displaced artillery in support of the operation.

3. EXECUTION.

- a. Concept of Operations. The 2d Battalion, 3d Marines (-) (reinf), at H-Hour, will conduct a helicopter assault with a Command Group and three Rifle Companies in the vicinity of grid square 0665 to seize, occupy and defend Objective A. One Rifle Company will conduct an overland movement and establish blocking positions along the eastern portion of the Area of Operation by H + 4 hours. On order, forces located in Objective A will commence operations to secure Objectives B, C, and D located in Sector ALPHA to destroy or capture all enemy forces, equipment, and supplies. Upon the completion of the search and clear operation in Sector ALPHA the Command Group and three Rifle Companies will cross Phase Line BLUE and conduct a search and destroy operation in Sector BRAVO sweeping along AXIS I, II, and III from west to east. One Platoon (reinf) will provide security for the displaced artillery in the vicinity of grid square 0657.
- b. Company E (reinf).
 - (1) Continue presently assigned mission.
 - (2) Provide security for the displaced artillery in the vicinity of grid square 0657 with one Rifle Platoon (reinf).
 - (3) Be prepared to reinforce the committed elements of the Battalion within 12 hours. This alert status will be modified as the operation progresses.

- (1) On D-Day move by helicopter from Camp J. J. CARROLL Landing Zone in trace of Company H to Objective A.
- (2) Be prepared, on order, to seize, occupy, and defend Objective B.
- (3) After securing Objective B, be prepared to seize, occupy, and defend Objective C.
- (4) On D + 2, be prepared to cross Phase Line BLUE and conduct a search and destroy operation along AXIS II in Sector BRAVO.
- (5) Be prepared to conduct subsequent operations west of the Area of Operation, on order.

d. Company H (reinf)

- (1) At H-Hour conduct a helicopter assault to seize, occupy, and defend Objective A.
- (2) Be prepared to assume the mission of Company F or M/3/3.
- (3) On D + 2, be prepared to cross Phase Line BLUE and conduct a search and destroy operation along AXIS I in Sector BRAVO.
- (4) Conduct extensive patrols, ambushes, and listening posts in the vicinity of Objective A.

(14) Flak jackets will be worn.

(15) Mortar attacks will be a constant threat. Ensure all persons "dig in" at the halt and in defensive positions. Report azimuth and distance from your position any mortar flashes and sounds via Battalion TAC Net ASAP.

(16) Medical supplies and facilities, foodstuffs, religious and cultural buildings will not be intentionally destroyed.

(17) Life lines will be carried and utilized for all stream and river crossings.

(18) This plan is effective for planning on receipt and for execution on order.

4. ADMINISTRATION AND LOGISTICS.

a. Supply

(1) Battalion Supply is the primary source of all classes of supply.

(2) Prescribed loads

(a) Class I

Rations: Three rations, MCI.

Water: Two canteens and halizone/salt tablets for five days.

(b) Class II

(1) Minimum required.

(2) Batteries for three days.

(3) Three pair of socks, wrapped in individual plastic bags.

(4) Two ponchos

(5) One can of foot powder.

(c) Class III. Minimum required.

(d) Class IV. Request as required.

(e) Class V. Basic allowance, plus one day of small arms ammunition.

b. Control and distribution

UNCLASSIFIED

- (1) Control. Battalion S-4 will coordinate request for logistical support.
- (2) Distribution. Unit distribution.

c. Resupply

- (1) Resupply requests will be submitted over the Helicopter Logistical Support Net.
- (2) A block of resupply items will be established by the S-4 for possible emergency resupply.
- (3) Resupply will be accomplished from the Camp J. J. CARROLL Landing Zone.
- (4) Only emergency resupply will be accomplished during the first three days of the operation. Climatic conditions preclude the use of helicopters for normal resupply of units.

d. Evacuation and hospitalization

- (1) Medical evacuation will be requested over the Tactical Air Request Net (TAR). If for any reason the TAR is not available, Battalion Tactical Net will be used.
- (2) Immersion foot is preventable and proper care and supervision will eliminate it as a cause of non-battle casualties. Frequent changes of socks, liberal use of foot powder and exposure of feet to the air will prevent immersion foot. Commanders will ensure that those preventive measures are taken.
- (3) Due to adverse weather conditions helicopter evacuation of casualties will be extremely difficult and at times impossible. Ensure equipment is available for the carrying of casualties if helicopter support is not available.

e. Transportation

- (1) Request for helicopter support will be submitted over the Battalion Tactical Net.

f. Service

- (1) Unserviceable end items will be evacuated and "in kind" replacements will be issued.
- (2) Preventive maintenance will be performed as required.

During this Battalion's participation in Operation PRAIRIE there has been no direct support Battery assigned. Liaison section and FO teams are members of Battery A, 1st Battalion, 12th Marines. Despite the fact that a wide range of Marine, Army, and Navy supporting units have been employed, operating relationships have been excellent. Artillery has been employed heavily by this Battalion. All platoon and company size operations were preceded by heavy preparation fires on objectives which the infantry was to occupy. When such forces were to be helicopter lifted, massive preparation and flak and mortar suppression fires were delivered on and around the Landing Zone. Harassment and interdiction fires were fired around the clock discouraging potential enemy mortar attacks on friendly positions. Observed fire missions on live targets have been few, and the targets small. In many instances, there has been no opportunity for friendly forces to enter a target area to obtain an accurate enemy casualty count before the survivors can remove the bodies. The overall effectiveness of artillery fired in support of this Battalion, however, is attested to by the fact that recent sweeps and patrols have uncovered several graves containing VC/NVA bodies killed by shrapnel.

b. Air Support. During the period 24 October - 24 December this Battalion requested and received the following air support:

All air requests were passed to Regimental TACP via land line or Regimental TACP Local Net. The Regimental TACP passed the requests on to the Direct Air Support Center after screening. The reaction time and effectiveness of this Close Air Support was good. The average time from submission of requests to arrival of the aircraft was 30 minutes. The availability of AO's and TAO (A)'s was excellent, often calling in offering their services without a prior request having been made. UH-1E gunships were very effective against "soft" targets which were extremely close to our lines. All 17 medevacs were of an immediate nature. The senior medical Officer/Corpsman on the scene designated the precedence of the medevac i.e., emergency, priority, or routine. The reaction time for medevacs varied with medevac precedence assigned and weather conditions. Emergency medevacs averaged 15-20 minutes from request to pick-up, and priority requests averaged 25-35 minutes. Flight distance from DONG HA was about 11 miles. Considering that the weather was marginal during most of the reporting period, the above averages were outstanding. All medevacs were conducted on the Regimental TACP Local Net. On all operations, the Battalion TACP was briefed to record the coordinates of VC trenches, fighting holes, heavy travelled jungle trails, etc. Those targets plus others suggested by the Battalion S-2 were passed to Regimental TACP in the form of TPQ - 10 Bombing Requests. The Battalion submitted approximately 25 TPO requests daily.

c. Tank Support. Tanks have been effectively used as part of the perimeter defense of Camp J. J. CARROLL, convoy and engineer mine sweep security, and are included in the reaction/counterattack plans of this unit. Company A (-), 3d Tank Battalion has performed all assigned missions excellently, but the use of tanks has been restricted to the road network because of the poor cross-country trafficability due to the rains that have prevailed during this period.

d. Anti-Tank Support. Ontos have been effectively used as part of the perimeter defense of Camp J. J. CARROLL, convoy security, mechanized patrols along the MSR, security for the KHE GIA Bridge, support of Company E in the CUA Valley, and are included in the reaction/counter-attack plans of this unit. The Ontos cross-country use is not as severely curtailed as the tanks, but their use has been limited in many areas because of the poor trafficability of the terrain. Response to all assigned missions has been excellent.

e. Anti-Aircraft Support. Battery C (-) (reinf) 1st Battalion, 44th Anti-Aircraft Artillery Regiment, U. S. Army has been assigned the primary mission of support of the ground forces and the secondary mission of anti-aircraft defense. In its primary role of support of the ground forces Company C's dual 40mm guns and quad .50 caliber mounts have been positioned around the perimeter of Camp J. J. CARROLL and the KHE GIA Bridge. Other tasks assigned have been convoy security, mechanized patrol along the MSR and in one instance preparation fires were delivered on a landing zone prior to the introduction of a platoon. The fires of the dual 40's completely neutralized the landing zone. Both the dual 40's and the quad 50's have been utilized to deliver night H&I fires. Company C is included in the reaction/counter-attack plans of this unit. The performance of Company C has been outstanding and it has performed all assigned missions competently and professionally.

f. Scout Snipers. The Scout Sniper Squad in direct support of this unit has been employed on all Battalion and Company size operations. In addition, Scout Sniper teams have been employed on the observation posts north of Camp J. J. CARROLL and on the observation post overlooking the CUA Valley. The Scout Snipers have performed well, but low visibility throughout this period has reduced their effectiveness.

7. Intelligence. During the period of 24 October 1966 to 15 November 1966, the 2d Battalion, 3d Marines continued its mission of defending its assigned Tactical Area of Responsibility, south-southwest of DANANG Air Base. On 15 November the 2d Battalion, 3d Marines deployed to DONG HA to assume a defensive posture for the DONG HA Combat Base and the bulk fuel installation, at the mouth of the CUA VIET River, in support of Operation PRAIRIE. Intelligence at that time carried the confirmed 308th Battalion, two confirmed companies, HAI LANG and TRIEU PHONG Companies, two possible unidentified companies and one possible unidentified platoon as enemy units bearing a direct threat to the security of DONG HA Combat Base and the bulk fuel installation. It was estimated that the enemy had the capability of launching a ground assault, mortar attack, combined or separate, against the area as well as to continue acts of harassment and sabotage against USMC and ARVN positions. Encounters with the enemy remained light throughout our employment at DONG HA and the bulk fuel installation. The first significant contact was initiated by an estimated squad of VC/NVA snipers during a Company E sweep north of the SONG VINH PHUOC. The estimated 140 rounds of small arms and automatic weapons fire received from vicinity YD 251552 and YD 255552 was suppressed by friendly small arms fire and an artillery mission that forced the enemy to withdraw. Two caves, four feet wide and approximately six feet deep were observed across the river vicinity YD 195520, capable of providing refuge for the enemy. Incidents of further enemy activity during the period of 18 November to 3 December included the detonation of one undetermined type mine, rigged with a trip wire, by a Company G patrol vicinity YD 237568; 12 to 14 rounds of sniper fire received by convoy shuttling equipment from the LCU ramp to our Command Post, from vicinity YD 249608; Company G, 3d Tank Battalion Command Post, vicinity

YD 235591, received 15 rounds sniper fire from vicinity YD 242585 and an explosion was observed vicinity YD 252596 accompanied with suspected movement. No overt enemy activity was reported within or adjacent to our Area of Operation between 30 November and 4 December.

On 4 December, 2d Battalion, 3d Marines displaced to Camp J. J. CARROLL to assume the mission of providing security for the Camp Complex and initiating offensive search and destroy operations within our Area of Operations. Current intelligence carried three confirmed, two probable and eight possible enemy units within and adjacent to our Area of Operation. The K-5, K-6 and K-7 Companies of the 2d Battalion, 31st Regiment, 341st Division, North Vietnamese Army were, and still are, carried as confirmed enemy forces capable of launching an offensive action, utilizing ground forces, mortar barrages or a combination of both within the Area of Operation PRAIRIE. Although this Battalion was not subjected to any large scale enemy offensive, the outlying Marine positions of CAM LC and the Rockpile were mortared on several occasions. Two unidentified companies, carried as probable enemy units within reinforcing or attacking distance of less than 24 hours, remain unlocated and unconfirmed. Of the eight possible enemy forces, one Regiment, one Battalion, 812 Regiment, 324B Division, North Vietnamese Army and the "YELLOW STAR" Company also remain unconfirmed. All of the above units have the capability of continuing harassment, mining, booby trapping, sniping, mortaring and propaganda activities throughout the QUANG TRI Province, with emphasis being directed toward the Operation PRAIRIE area. The most significant event to be noted after 5 December was the search and destroy operation conducted by Companies E and H in the CUA Valley with blocking elements provided by ARVN for ces at the "D-5" compound. The area swept produced light enemy contact with 15 VC/NVA firing heavy automatic and small arms weapons. Small arms and a UH-1E gunship, forced the enemy to withdraw. Enemy casualties totaled three KIA confirmed and five KIA probable. Two mines were detonated, one by Company E elements, determined to be pressure type mine; the second, a trip wire rigged grenade detonated by elements of Company H vicinity YD 102500. A third mine, CHI COM grenade rigged with a trip wire, was discovered and destroyed by elements of Company E vicinity YD 112313. A total of 500 pounds of rice, assorted medical supplies, documents and two reinforced caves were captured or destroyed. The rice was released to ARVN personnel for redistribution to the refugees. Company G patrol sighted and fired on four VC/NVA vicinity YD 065528. The enemy was armed with small arms and grenades. Friendly small arms claimed two KIA probable. Two automatic and two carbine weapons were discovered in a house as well as assorted medical supplies, clothing, 30 pounds of rice and various eating utensils. Other incidents during the period included many detections of enemy movement by the AN/TPS-21 (Counterintelligence Surveillance Radar). The AN/TPS-21 on the observation post at Hill #250 (YD 0655) registered all of the movement north of the SONG CAM LC in the area bounded by grid squares YD 0357, 0359, 0859 and 0857. Artillery, mortar, and 40mm fire missions neutralized all detected movement. Also noteworthy is the jamming and interference attempts on Battalion Tactical Net and Artillery Conduct of Fire Net. Although most of the transmissions monitored were determined

to be of a Vietnamese language, several interceptions were of an Oriental language other than North or South Vietnamese. Furthermore, perimeter security for Camp J. J. CARROLL reported, on different occasions, sightings of lights and movement immediately adjacent to the perimeter wire.

Weather and terrain conditions during Operation PRATTLE often made patrolling and sweeping difficult. This reporting period included the annual monsoon season. Constant rainfall, interrupted by periods of clear weather, often too brief to be of any value for drying terrain and lowering the height of streambeds, made trafficability of roads and fording of streams often impossible.

8. Mission. During this period two separate missions were assigned to the Battalion.

a. Period 15 November - 4 December 1966

- (1) Execute defense for DONG HA Combat Base and Bulk Fuel Installation at mouth of CAU VIET River.
- (2) Maintain at DONG HA Combat Base a reinforced rifle platoon as reaction force on 15 minute alert.
- (3) Conduct operations in the Area of Operation to the south and southeast of the DONG HA Combat Base.
- (4) Coordinate and conduct the defense of DONG HA Combat Base to include artillery, motor transport, and other installations.
- (5) Be prepared to conduct other operations as directed.

b. Period 4 December - 24 December 1966

- (1) Conduct reconnaissance in force operations to detect, attack, and destroy enemy forces in the Area of Operation.
- (2) Conduct operations to maintain security of the MSR (Route #9) in Area of Operation.
- (3) Conduct operations to defend and ensure security of Camp J. J. CARROLL (YD 0654).
- (4) Conduct operations to defend KHE GIA Bridge (YD 027561).
- (5) Provide security for Camp J. J. CARROLL water point, water source, and water pipes.
- (6) Be prepared, on order, for deployment by air or surface means for operations anywhere in the Operation PRATTLE Area of Operation.

9. Concept of Operation. During the initial period 15 November through 4 December the 2d Battalion, 3d Marines provided one Rifle Company (rein) to defend its assigned sector of the DONG HA Combat Base perimeter; one Rifle Company (rein) provided security for the Bulk Fuel Installation at the mouth of the CAU VIET River; a Rifle Company (-) provided a platoon (rein) as a reaction force on 15 minute alert and conducted limited patrols, ambushes, and listening posts in its assigned sector. One Rifle Company (rein) conducted reconnaissance in force operations in assigned Area of Operation and was made available to other Battalions for operations in the Operation PRAIRIE Area of Operation. During the 4-24 December period one Rifle Company provided security for the assigned sector of Camp J. J. CARROLL perimeter; one Rifle Company provided security for the KHE GIA Bridge and a platoon (rein) as a reaction force. Two Rifle Companies and a Command Group conducted extensive reconnaissance in force operations, patrols, ambushes, and listening posts. One of these companies was made available to other Battalions for operations in the Operation PRAIRIE Area of Operation.

10. Execution. In early November, the 2d Battalion, 3d Marines located in DAI LAC District, DANANG TACR was ordered to commence movement to the Operation PRAIRIE Area of Operation and relieve the 3d Battalion, 7th Marines at DONG HA Combat Base. Initial movement of Company H commenced on 15 November and Company H had, by nightfall of the 15th assumed the mission for the defense of the CAU VIET Bulk Fuel Installation. By the 19th of November all Rifle Companies and the Command Group had displaced to the DONG HA Combat Base and were placed under the operational control of the 4th Marines. The displacement from DAI LAC to DANANG airfield was accomplished by helicopter as the MSR was not trafficable because of bridge washouts caused by the torrential rains. The movement of men, equipment, and supplies from DANANG airfield to DONG HA Combat Base was accomplished by KC-130 aircraft. The movement of Command Group "B" and the "follow up" supplies was completed by 21 November. This element moved by KC-130 aircraft and YFU boats. The 3d Battalion, 7th Marines displaced concurrently with this Battalion and no major problems were encountered. Company G, reinforced with one platoon from Company E, assumed responsibility for the defense of the assigned sector of the defensive perimeter. Company E (-) conducted patrols, ambushes, and reconnaissance in force operations throughout the assigned Area of Operation. Company E also provided a platoon (rein) as a reaction force. On 23 November, Company F was placed under the operational control of the 3d Battalion, 4th Marines and conducted reconnaissance in force operations in the CON THIEN/CAM LC area. Company H in conjunction with the 1st Battalion, 2d ARVN Regiment conducted a search and clear operation on 30 November along the coast north of the CAU VIET River. The 1st of December, the 2d Battalion, 3d Marines (-) continued to provide security for the DONG HA Combat Base and the CAU VIET fuel facility. Company F remained under the operational control of the 3d Battalion, 4th Marines until 4 December. On 2 December, the Battalion initiated displacement to Camp J. J. CARROLL and by nightfall of 4 December

Companies E, F, and G, in addition to Command Group "A", had arrived at Camp J. J. CARROLL and relieved the 2d Battalion, 9th Marines for the defense of the Camp CARROLL Complex at 1100 hours. The 2d Battalion, 9th Marines assumed the mission for defense of the DUNG WA Combat Base at 1600 hours. Company E, 2d Battalion, 9th Marines was placed under the operational control of this Battalion and provided security for the KHE GIA Bridge. Command Group "B" displaced to Camp CARROLL on 5 December. On 8 December, Company G was placed under the operational control of the 3d Battalion, 4th Marines and conducted operations in the CAM LC area. On 11 December, Company H returned to the operational control of this Battalion and Company E, 2d Battalion, 9th Marines returned to the operational control of its parent unit. Company H conducted a reconnaissance in force operation for a three day period commencing on 15 December. Command Group "A" with Companies E and H commenced a two day combined operation with the 1st Battalion, 2d ARVN Regiment in the CUA Valley. The ARVN forces provided the blocking elements along the southern portion of the valley and the forces of this Battalion conducted a search and clear operation initiated from the northern portion of the valley and swooping to the south. Contact was made with an estimated VC squad and the enemy suffered three KIA confirmed and five KIA, probable. The VC command center and living quarters were pointed out by a rallier that accompanied the assault units and were destroyed. 500 pounds of rice were recovered and returned to the D-5 ARVN outpost for redistribution to the refugees in the area.

12. Administrative Matters. Administrative planning for the operation was extensive as the entire Battalion including organic supply and service functions accompanied the Battalion. Due to the short time from the receipt of the order to the move to the Operation PRAIRIE area, no formal written plans were published. The tactical elements of the Battalion were air lifted from the DAI LOC position beginning on 15 November 1966. Due to isolation of the main position by floods and bridge washouts, the final elements were unable to depart DANANG until 21 November 1966 for the Operation PRAIRIE area. Once established in DONG HA, the supply base has remained in that general location with a minimum of support established forward.

a. Supply. After the initial movement phase, ending on 21 December 1966 the Battalion and Company supplies have remained at the DONG HA Combat Base area. A consolidation of supply accountability was effected in mid-December. Supply distribution points were established at both the rear and forward areas. One supply man, one armorer and abbreviated records have handled the distribution of supplies forward, and accomplished basic armory repair and issue.

b. Maintenance. Primary maintenance facilities have been established with the supply rear. Some repair of motor transport, communications, and ordnance gear has been accomplished at the forward base camp. Maintenance support for third echelon and above has been through FLSU, DONG HA to FLSG, DANANG.

c. Treatment of casualties was conducted primarily by Company Company. The Battalion Aid Station was established at the Camp CARROLL base camp. Medical facilities were available from that location, and with the Battalion Command Group in the field. Medical evacuation of all seriously wounded and non-ambulatory personnel was conducted by helicopter to "D" Collecting and Clearing Company at DONG HA. No problems or serious delays resulted with such evacuations. Non-battle casualties were hospitalized at the Battalion Aid Station unless further studies were indicated. All battle casualties were hospitalized at "D" Collecting and Clearing Company unless further treatment was necessary.

3. Transportation. Organic motor transport has been based with the supply rear. Despite a high deadline rate caused by monsoon weather conditions, support of essential tactical and housekeeping functions has been excellent. Organic transport has been supplemented by trucks from 9th Motor Transport Battalion. Two trucks per day have carried rations and general supply from the DONG HA Base to the forward area. The two trucks have performed administrative and house keeping runs for the Battalion.

o. Communications.

(1) General

a. The communications section supported the assigned missions at the DONG HA Combat Base and Camp J. J. CARROLL during this period. At DONG HA few communications problems materialized due to the restricted employment of the Battalion. At the Camp J. J. CARROLL position several problems presented themselves due to the broad, diverse, and independent employment of the Battalion units.

(2) Wire.

a. This capability was hampered by the inadvertent but frequent interdiction by friendly tracked and wheeled vehicles.

b. Enemy interdiction of this capability has been extremely limited.

c. Equipment difficulties created by the monsoon weather was compounded by the repair lag in the established FLSU/FLSG arrangement. Equipment turned into FLSU for repair was dependent upon the availability of transportation between FLSU, DONG HA and FLSG, DANANG where the actual repair takes place.

(3) Radio

a. The continued combat attrition of AN/PRC-25 accessories without replacement through the supply system presented an extremely difficult situation.

b. Employment of the Battalion's subordinate units into widely separated and independent areas created a strain on radio equipment.

(4) Message Center. During Operation PRAIRIE this capability functioned strictly by courier due to the proximity of the Battalion Command Post to the Regimental Headquarters. No electrical or cryptographic devices were employed although the capability was maintained.

(5) Maintenance. The monsoon environment continued to pose the largest problem to communications equipment. Equipment organizational maintenance and waterproofing of equipment was continually stressed and supervised.

(6) Power. During Operation PHALGUE power requirements remained constant. Combat Operations Center, Battalion Aid Station, messhall and electronic repair facility were provided electricity.

(7) Radar. AN/TPS-21 equipment continues to be susceptible to the humid environment. However, when operable the AN/TPS-21 has been extremely effective in detecting enemy movement in the Area of Operation.

13. Special Equipment and Techniques. No special equipment has been used on this operation. Organic Marine Corps issued equipment has proven reliable and satisfactory in all respects. Otters have been effectively utilized during this period for resupply of outlying positions and have been placed in a standby status for medical evacuation if helicopter support was precluded by weather conditions. Balliers have accompanied assault units to point out known minefields, booby traps, and VC command centers and living areas. A joint Command Post was established to include both U. S. Marine Corps and ARVN personnel for fire support coordination of all forces operating in the Area of Operation during the CUA Valley operation. Liaison personnel were exchanged during this operation and resulted in an excellent exchange of information concerning the exact location of forces and the future intentions of units. The Marine liaison team consisted of a Liaison Officer, radio operator with AN/PRC-25, and an interpreter.

14. Commander's Analysis. The most important factor contributing to the success of this operation during this period has been the rapid response and combat readiness of all Marine units. No delays have been encountered due to deadlined equipment or unprepared personnel. The Marines have acted promptly and aggressively in every instance. Missions have been clearly defined, intelligence data accurate, and all assigned tasks have been accomplished in a highly professional manner. No Civil Affairs projects were initiated during this period because of the displacements of the Battalion and the scarcity of civilians in the Area of Operation. Programs have been planned to assist the refugees in the CAM LC and CUA Valley refugee centers. Psychological Warfare Teams, including leaflet drops and broadcasts, have been used extensively throughout the Area of Operation. Combined operations with Republic of Vietnam forces have been well planned and executed.

10. Movement: Tactical movement by forward elements of the Battalion has been accomplished by truck convoy, helicopter, and foot march.

I. CIVIL ACTION.General.

(a) 7 January - A combined County Fair/search and clear operation was conducted in the hamlet of DCC KINH, coordinates YD 098525. The 3d Marine Regimental Surgeon and Battalion personnel conducted a MEDCAP treating 238 people. On 6 January, the District Chief distributed food and several hundred pounds of clothing. Entertainment was provided by the 244th Psychological Operations Company and an Audio-Visual Team. During the operation all persons were screened by a team from 15th CIT and National Police with fair results. A number of persons were marked for further investigation.

(b) 12 January - The Battalion Commander and Operations Officer met with GAN LC District Chief and sub-sector advisor to discuss the capabilities of the Battalion to best support needed Civic Action Projects within this District. Several projects were discussed, principally oriented toward the Refugees in the CUA Valley. These included schools, dispensaries, and sanitation. Requisitions have been submitted for the necessary materials with which to further these programs.

2. Material Distributed. During the period covered by this report, a total of 1085 persons received medical aid from the Battalion medical personnel. In the hamlet of DCC KINH, 250 pounds of clothing were distributed.

3. Special Civic Action Projects. Material has been requisitioned to repair DCC KINH Hamlet school, build a dispensary, playground, and to construct or repair wells.

4. Apparent results of Civil Affairs Programs. Due to operational commitments, the Civil Affairs Program of this Battalion is just getting underway. One of our companies is working closely with Regional and Popular Force personnel in the OUA Valley area. Company corporals are holding daily sick calls. A feeling of mutual trust and confidence is gradually spreading through the valley.

J. ADMINISTRATION

Personnel Accounting. A shortage of consumable supplies still exists.

2. Awards: One Silver Star Medal, Two Bronze Star Medals w/Combat Distinguishing Device, One Navy Commendation Medal w/Combat Distinguishing Device, Four Purple Hearts, One Vietnamese Cross of Gallantry w/Palm, Two Vietnamese Crosses of Gallantry w/Gold Star, One Vietnamese Cross of Gallantry w/Silver Star, One Vietnamese Cross of Gallantry w/Bronze Star.

3. Promotions: One to First Sergeant, one to Gunnery Sergeant, one to Sergeant, 61 to Corporal, 60 to Lance Corporal, and 23 to Private First Class.

4. Postal: Satisfactory.

5. Pay: No problems areas.

6. Post Exchange: The Battalion is being serviced by the Division Post Exchange and the use of sundry packs. Post Exchange supplies continue to be extremely limited.

7. Legal and Discipline: One Summary Court-Martial and one Special Court-Martial conducted. One Special Court-Martial pending. Two cases are pending trial by General Court-Martial. One Pre-trial investigation was completed. One violation of Article 86, one Article 92, and three Article 134, UCMJ, have occurred. There were one Battalion and three Company NJP's.

1. Enemy Situation at Beginning of Period:

- (a) Captured documents confirm the K-6 Company of the 2d Battalion, 31st Regiment, 341st Division, North Vietnamese Army as operating within and adjacent to our Area of Operation vicinity grid square YD 0159, approximately 7000 meters northwest of our Command Post. Reported strength and armament is 120 men with MG's, B-40's, AK's, and individual small arms.
- (b) The K-7 Company of the 2d Battalion, 31st Regiment, 341st Division, North Vietnamese Army is a confirmed unit operating approximately 7000 meters northwest of our Command Post, vicinity grid square YD 0159, with a strength of 110 men armed with three 82mm mortars, AK's, CKC's and individual small arms.
- (c) The K-5 Company of the 2d Battalion, 31st Regiment, 341st Division, North Vietnamese Army is being carried as a confirmed unit, operating 4000 meters southeast of our Command Post, vicinity grid square YD 1151.
- (d) One unidentified Company with Headquarters and Support Company, is being carried as a probable unit (Headquarters and Support Company a possible unit), operating 4000 meters east of our Area of Operation, vicinity grid square YD 1153. The company has a reported strength of 40 men, Headquarters and Support Company strength unknown.
- (e) One unidentified company is being carried as a probable unit, operating 3000 meters east of our Area of Operation, vicinity grid square YD 1052.
- (f) One company designated as the "YELLOW STAR" Company is being carried as a possible unit, operating 5000 meters south-southeast of our Area of Operation, vicinity grid square YD 1049.
- (g) The 6th Battalion of the 812th Regiment, 324B Division, North Vietnamese Army (AKA K.6-D.6, THU BON Battalion or GUA LONG Battalion) is being carried as a possible enemy force operating within our Area of Operation, vicinity grid square YD 0752, 4000 meters south-southeast of our present Command Post. The 6th Battalion has a strength of 520 men armed with 3X82mm mortars, 3X57mm recoilless rifles, 9XB-40's and 12 machine-guns.
- (h) The K-8 Company of the 2d Battalion, 31st Regiment, 341st Division, North Vietnamese Army is carried as a possible unit, operating 5600 meters northwest of our Command Post, vicinity grid square YD 0158.

- (i) One unidentified Company is carried as a possible enemy force, operating within our Area of Operation, vicinity grid square YD 0158.
- (j) One unidentified Regiment is being carried as a possible enemy force operating vicinity grid square YD 0347, approximately 2000 meters south of our Area of Operation.
- (k) One unidentified Battalion is being carried as a possible enemy force operating vicinity grid square YD 9954, approximately 7000 meters west of our Command Post.
- (l) One unidentified Company is carried as a possible enemy force operating within our Area of Operation vicinity grid square YD 0553, approximately 3000 meters south of our Command Post.
- (m) One unidentified Company (Possible) is reported to be operating in the CUA Valley immediately south and southeast of our Area of Operation with a night assembly area vicinity grid square YD 0650.

2. Significant Trends During the Reporting Period:

- (a) During the reporting period it is significant to note that this Battalions' Area of Operation was not subjected to any large scale overt action by enemy forces. Elements of 3d Battalion, 3d Marines, responsible for the security of the "Rockpile", were mortared on several occasions as were elements in the CAM LO area.
- (b) The enemy has the capability of initiating a mortar attack against elements of 2d Battalion, 3d Marines and their assigned areas of responsibility, then withdraw along a preplanned escape route. He also has the capability of using 120mm mortars, coupled with movement during periods of inclement weather, to utilize terrain favorable for defilade fire upon any of numerous targets such as the bridge vicinity YD 036562 and the outpost at the "D"-5 area. Marine and Army counter-mortar fire concentrations from Camp J. J. CARROLL include every ideal mortar position for 60mm mortars, 81/82mm mortars and 120mm mortars, to compensate for these capabilities.
- (c) The enemy has left extensive evidence of his propaganda activities, and conducted harassment and delaying actions in the CUA Valley and surrounding jungles. Operations initiated by Marines and friendly forces have met minimal resistance in most areas. The enemy has attempted to delay our forces and then withdraw, often leaving little evidence of his occupation of the area.

- (d) Recent intelligence reports further substantiate the presence of an undetermined size enemy force directly south and south-east of our Area of Operation. These reports are supported by physical sightings of groups of NVA soldiers numbering from five to twenty, plus discovery and investigation of numerous graves in the area, revealing bodies dressed in NVA uniforms.
- (e) During the reporting period the AN/PS-21 (Counterintelligence Surveillance Radar) detections have decreased from the number recorded during the month of December.
- (f) During a recent battalion size search and destroy operation 9000 meters north-northeast of our Command Post, little evidence was found to substantiate the present or past occupation of reported large enemy forces in this area. Furthermore, existing fortifications found during the operation do not substantiate reported enemy forces carried on enemy Order of Battle.

3. Enemy Initiated Incidents During the Reporting Period:

- 012000H - Battery C, 1st Battalion, 44th Artillery: 40mm gun position on northwest portion of defense perimeter reported sighting moving lights in trash dump. Two trip flares were set off, vicinity YD 058552. Fired three rounds 81mm illumination and observed individuals several times. There were no more than two persons. Unable to determine type of clothing worn and no weapons were sighted. No rounds fired.
- 021140H - Company E: Patrol vicinity YD 104490 received 6 to 8 rounds sniper fire from vicinity YD 109500. 81mm mortar mission expended 10 HE rounds, patrol searched area, found footprints and four empty carbine cartridges.
- 021330H - Company E: Patrol found an M-26 fragmentation grenade under a cement water container vicinity YD 093504. Also found one trip flare approximately 100 meters south of the grenade. Grenade and trip flare were not booby trapped, and were destroyed.
- 021445H - Company E: Reported a grenade or 60mm mortar round exploded vicinity YD 094515 while burning trash.

032030H - Battalion TAC: Radio operator monitored what sounded like a Vietnamese speaking English. The following was clearly understood, however, the initial transmission was garbled: "HELLO, HELLO, MARINE KILL ME MAMA, STUPID MARINE, STUPID MARINE". "WATER" was also heard during subsequent garbled transmission. Division Communication Officer was notified and water point alerted. Water point checked area at first light with negative results.

040038H - Company E: Patrol vicinity YD 109504 received 9-10 rounds small arms fire from vicinity YD 103504. Area searched with negative results.

041820H - Company E: Patrol discovered a freshly dug tunnel vicinity YD 105497. Tunnel had not been there two days ago when patrol checked this same area. Search of tunnel produced 25 pound bag of rice, liberation front newspaper, two personal letters, one pair black PJ's, one leather case, and one 18" length of primer cord. Further search of the area revealed fresh foot prints and approximate 50 pounds of rice in a nearby hole. Captured gear and personnel were forwarded to Regiment. Tunnel was destroyed. N's distributed rice to refugees.

041830H - Company E: Patrol discovered 150 rounds 7.62 Russian made, bolted ammunition vicinity YD 105507. Ammunition was destroyed.

051125H - Company H: Patrol found dud 81mm round and 250 pound bomb vicinity YD 042587. EOD was requested, and destroyed bomb and mortar round. Patrol continued on assigned route.

051223H - Company H: Patrol observed smoke from a campfire vicinity YD 015515. Artillery mission conducted with good target coverage, expending 12 HE 105mm rounds. Results: Unknown.

051230H - Company H: Patrol observed smoke from campfire vicinity YD 015517. Artillery mission conducted with good target coverage, expending 13 HE 105mm rounds. Results: Unknown.

051600H - Company E: Patrol picked up five female VCS, approximately 300 meters southeast of its CP. CIT interrogated VCS. Two are wives of known VC. One is wife of propaganda leader. Regimental S-2 notified. Helicopter picked-up detainees and delivered them to G-2 at 1715 hours.

061140H - Company H: Patrol discovered two camp fires vicinity YD 052578. Both had been used within the past two to three days by three to four men.

061300H - 061430H - Company H: Patrol discovered six water buffalo harnesses vicinity YD 071571, six large logs vicinity YD 077575, three fighting holes 2'X5'X1' vicinity YD 077570, and an observation post vicinity YD 067573. OP offered view of Hill #250 and the Artillery Plateau. Holes appeared to be freshly dug.

06Jan67 - CIT Report: CIT team attached to Company E, recieved information from a covert Vietnamese source. CIT rates F/6: One platoon VC located in BANG SON Hamlet, GS YD 0935. One platoon, (sabotage platoon) armed with 2X60mm mortars and with three rice caches, is located in CAM NGHIA and CAM CHINH Hamlet vicinity YD 068519. Also, a three ton rice cache belonging to VC Headquarters vicinity YD 121529.

071510H - Company E: Discovered 14 fuzes for mines, two booby traps charges made of bamboo, 2X50 caliber rounds, 2X30 caliber rounds, one expended M-79 round, one M-1 carbine grenade launcher sight, one M-14 magazine (unloaded), and one M-1 bayonet scabbard. Material was found YD 098525. Also found at YD 098525 1500 pounds of rice in three houses. Rice was in barrels and bags.

080215H - Company G: OP reported two trip flares were set off vicinity YD 057557. Fired a flare and sighted four people with weapons running in a northwest direction. People were dressed in light trousers and dark shirts. Fired small arms and observed one VC fall. Fired another flare and observed people trying to remove body, fired again and saw another VC fall. 81mm illumination revealed an attempt to drag body into draw northwest of hill, and fired on them again. Not more than four persons were seen at any time. Expended 140 rounds M-14, 30 linked M-60 rounds, and seven M-26 grenades. Two enemy KIA (prob).

081050H - Observation Post located on Hill #250 at YD 068555, heard approximately eight rounds automatic weapons fire vicinity YD 071571. Rounds sounded like they were directed toward a convoy. Convoy continued and no further activity was observed or heard.

081315H - Company E: Patrol apprehended one male DETAINEE vicinity YD 083550. DETAINEE was in a restricted area without permission and was carrying several unknown type pills bearing Chinese characters. Detainee gave the following information about VC activities. Subject stated that 50 VC were in MAI LOC three months ago holding propaganda meetings, then moved south. VC were not from MAI LOC area. DETAINEE also named following personalities: HO TAN of MAI LOC, HOANG THI LIEN age 28 of MAI LOC, HOANG KIM XUY age 35 of MAI LOC, NGUYEN VAN HOANG age 26 of MAI LOC, TAM of SON NAM, KA of SON NAM, NGUYEN THI THO of MAI LOC, a nurse, and HO VAN HIEN of MAI LOC. XUY and HOANG are on black list. Further interrogation to be conducted 9 Jan 1967. DETAINEE held at Company E CP overnight.

090730H - Company E: Patrol discovered 18 fighting holes vicinity YD 119524. Area was completely searched with negative results.

090750H - Company E: Heard two warning shots and received about 12 single shots from vicinity YD 119529. Elements tried to find location of shots. Found and killed one VC vicinity YD 119526. Captured one carbine, 30 caliber. VC dressed in short trousers and old battle jacket. VC had one CHIOM and one American M-26 grenade, medicine, extra clothing, and a small bag of rice. Grenades were destroyed, and sweep continued. Supplies were forwarded to Regiment. One enemy KIA (conf).

091000H - Company E: Received six to eight rounds sniper fire from vicinity YD 124528. Returned small arms fire in general direction, but was unable to pinpoint exact location. Searched area with negative results.

091155H - Company E: Elements spotted three VC in hedgerow, and took VC under fire. One VC observed to fall. Search of area produced blood spots. One KIA (prob).

- (d) One unidentified Company with Headquarters and Support Company is being carried as a probable unit (Headquarters and Support Company a possible unit), operating 5000 meters east of our Area of Operation, vicinity grid square YD 1153. The company has a reported strength of 40 men, Headquarters and Support Company strength unknown.
- (e) The C-56 Company is being carried as a probable enemy force 2000 meters south of our Area of Operation vicinity GS YD 0944.
- (f) One unidentified company is being carried as a probable unit, operating 5000 meters east of our Area of Operation, vicinity grid square YD 1052.
- (g) One Company designated as the "YELLOW STAR" Company is being carried as a possible unit, operating 5000 meters south-southeast of our Area of Operation, vicinity grid square YD 1049.
- (h) The 6th Battalion of the 812th Regiment, 324B Division, North Vietnamese Army, (AKA K.6-D.6, THU BON Battalion or CUU LONG Battalion), is being carried as a possible enemy force operating within our Area of Operation, vicinity grid square YD 0752, 4200 meters south-southeast of our present Command Post. M. COMMUNICATIONS - ELECTRONICS:

1. General. During this period the Battalion continued operations from Camp J. J. CARROLL. Difficulties previously reported in repair and resupply have been alleviated somewhat by the use of couriers to and from the maintenance facility at DANANG. "Down" equipment is transported by a Battalion courier to electronic maintenance at FLSG and repaired equipment is picked-up and returned to this unit. More stocking of repair parts at the Battalion electronic maintenance shop has also reduced the "down" time to some degree.

2. Wire.

(a) Personnel: Recent personnel allocations have greatly enhanced the flexibility of this Battalion in this area. During operations, wire personnel were utilized as radio operators in the rear command post.

(b) Equipment: Switchboards continue to be the main problem in this line packs are being affected by the monsoon weather. Advent of warm dry weather should alleviate this problem.

(c) Wire Lines: Breaks by friendly tracked and wheeled vehicles continue to be a problem.

3. Radio

(a) Personnel: Assignment of additional communications personnel to the Battalion has alleviated the personnel shortages that have existed in the past.

(b) Operations: The dispersion of Battalion units has greatly taxed the available equipment. Companies operating independently have a greater demand for radios than those operating directly for and in conjunction with the Battalion.

(c) Equipment: Monsoon humidity continues to take its toll on radio equipment. Retention of 16 AN/PRC-10's has greatly enhanced the extended operations currently undertaken, and serve to augment the units operating independently so that they may better meet their expanded communications needs. Waterproofing is continually stressed, although waterproofing materials continue to be in short supply.

4. Radio Relay: No radio relay equipment is presently assigned to this Battalion although it is anticipated that a team will be attached when the Battalion rotates to OKINAWA as a Battalion Landing Team.

5. Message Center:

(a) The message center continues to function by courier with Regiment. No electrical machines are employed.

(b) The equipment deficiency previously reported has been rectified by the return of a reproducing machine from repair on OKINAWA.

6. Maintenance: Problems in this area have been improved by direct contact with the repair facility and by the availability of more parts at the Battalion electronic maintenance facility.

N. WEATHER:

1. Weather conditions for the reporting period consisted of a low cloud coverage, with heavy overcast, intermingled with scattered and broken clouds. Average ceiling ranged from 300 to 500 feet. Precipitation was daily with little break in falling rain until the end of the reporting period. Humidity remained approximately 95%. Temperatures ranged from a low of 58° to a high of 83°.
 2. Winds varied from the north to north-northwest at five to 10 knots, gusting to 25 knots. Fog and heavy mist limited visibility to three to seven miles.
- The climatic conditions for this period were normal for this region.

1. Significant Events: The 2d Battalion, 3d Marines was responsible for the security of Camp J. J. CARROLL (YD063551) the entire month of January. During January activities primarily consisted of small unit patrols and two Battalion size operations. Battery B, 1st Battalion, 12th Marines, displaced to YD 06128028 in support of one operation. In January, extensive use was made of Battery C, 1st Battalion (AW) (SP), 44th Anti-Aircraft Artillery, USA and the 5th Section, Battery G, 65th Artillery, USA as well as Batteries A, B, and C of the 1st Battalion, 12th Marines.

P. AIR SUPPORT

1. General.

- a. During the reporting period rotary-winged air support was provided by MAG-16, 1st Marine Air Wing. This Air Support included medical evacuation, tactical troop lifts, and resupply flights.
