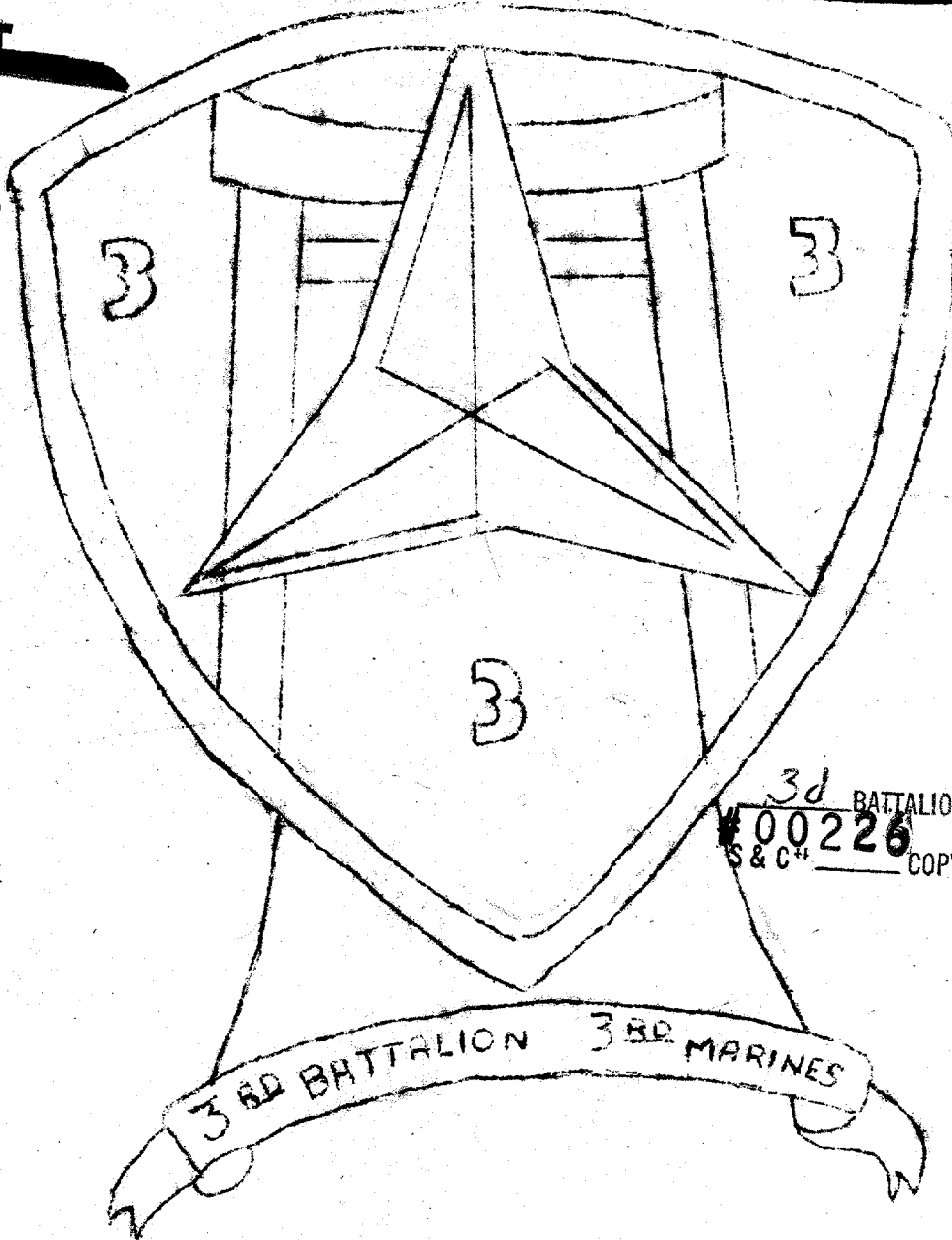

PART II  
NARRATIVE SUMMARY

During the month of July the Battalion conducted operations in the Kentucky, Napoleon/Saline and Lancaster II AO's. The first six days of July was spent in Leatherneck Square under the OPCON of the 9th Marines. Numerous contacts were made with small NVA units during this period.

On 2 July at approximately 0500H Company "K" received automatic and small arms fire from the vicinity of YD 171693. Artillery and 81mm mortar missions were fired and Company "K" returned fire with small arms and automatic weapons, contact was broken and Company "K" swept through the area of contact discovering 21 NVA KIA confirmed, 3 crew served weapons and 7 individual weapons were captured. Approximately a half hour after Company "K" gained contact, the Battalion at YD 168692 received 20 rounds of enemy mortar fire (60mm) which resulted in 20 WIA's. At 0815H a Company "I" unit sighted 8 NVA at YD 169690 and artillery and mortar missions were called, a search of the area resulted in one NVA Prisoner of War. At 1715H the same day, Company "M" sighted two NVA in the open and engaged with small arms fire and artillery, later the size of the NVA unit was estimated at 20-30 personnel. The NVA broke contact and a search of the area revealed 15 NVA KIA confirmed along with weapons and equipment.

A second Prisoner of War was captured on the night of 3 July when a NVA walked into a Company "L" ambush, the NVA was armed with a RPG-2 rocket launcher.

During the period 3-4 July there were other small unit contacts which resulted in one friendly WIA, no NVA casualties could be confirmed.

On 5 July a unit of Company "K" while on a recon mission was taken under fire by an estimated 50-70 NVA fighting from well dug in positions and supported by 60mm mortars. The enemy initiated the contact with a command detonated mine, The Company "K" unit received 60mm mortar and small arms fire which resulted in casualties to the point squad. The other units of Company "K" were deployed and fixed wing air and gunships were requested. Company "K" maneuvered and extracted casualties under the cover of air strikes, gunships and artillery. Contact was broken at 1400H. NVA Casualties were 15 KIA's confirmed, Company "K" suffered 2 KIA's and 8 WIA's med evac.

On 6 July the Battalion rejoined the 3d Marines for a operation in the Napoleon/Saline AO. No contact was made by the Battalion during the operation and on 10 July the Battalion moved to Quang Tri for the S.U.R.E. program, the following day the Battalion was moved by truck to Camp J. J. Carroll and assumed the mission of security for Camp Carroll and convoys on route #9.

On 12 July the Battalion departed Camp Carroll to conduct ambush and anti-infiltration missions, no contact was gained during this period. On three occasions the Battalion was subjected to enemy mortar fires, 4 WIA's were sustained. The Battalion returned to Camp Carroll on 15 July.

On 18 July Company "K" and the Bravo Command group chopped to the OPCON of the 3d Marines and conducted a heliborne assault landing at LZ Cardinal (XD 939610) with the mission of establishing a Company patrol base and observation posts at XD 946624). The landing was made without incident and no resistance was encountered.

On 19 July the Battalion (-) was heli-lifted to conduct a assault landing at LZ Buzzard ( YD 032604 ). The landing was made without resistance. On the evening of 19 July and the morning of 20 July Company "I" while searching bunkers at YD 028599 and YD 027602 discovered two 75mm pack howitzers complete except for one barrel, the second barrel was found later in the day in a bunker at YD 027598. 26 rounds of 75mm howitzer ammunition was also found.

On 22 July the Bravo Command group and Company "K" were chopped to OPCON 1st Bn, 3d Marines and on 23 July were heli-lifted to XD 939605 to establish a fire support base.

No contact was made during the operation and the Battalion returned to Camp Carroll on 26 July leaving a platoon (rein) from Company "M" on Dong Ha Mountain. The other elements of Company "M" were lifted to FSB Joan to join the Bravo Command group. On 27 July the Bravo Company "K" and the Bravo Command group were chopped to the OPCON of the Battalion.

On the afternoon of 27 July Companies "L", "I" and the Alpha Command group were heli-lifted to conduct a assault landing at LZ Margo (XD 903615 ), the landing was without contact and the LZ was consolidated. Three WIA's were sustained on 28 July when a Marine detonated a U.S. type A.P. mine.

Company "M"(-), Company "K" and the Bravo Command group continued the mission of defending Fire Support Base Joan. On the 28th of the month, the platoon from Company "M" was relieved and heli-lifted to FSB Joan.

A U.S type A.P mine was detonated on 29 July resulting in one WIA. The end of the month found the Battalion with two Companies ( "L", "I") and the Alpha Command group at Fire Support Base Margo and the Bravo Command group with two Companies ("K", "M",) at Fire Support Base Joan.

SEQUENTIAL LISTINGS OF SIGNIFICANT EVENTS

1. Combat Missions Assigned.

a. Basic Mission. To conduct missions in assigned area of operations in accordance with 3d MarDiv Operations Order 5-68.

b. Conduct combat operations to seek out and destroy Enemy forces and installations in assigned zone. Reference: 3d Mar FragO 14-68. (Napoleon/Saline)

c. Establish base and provide security for Camp Carroll and road sweeps as directed, provide convoy security. Provide Bald Eagle force on 30 minute notice. Reference: 3d Mar FragO 15-68. (Lancaster II)

d. Conduct ambush/anti-infiltration operations in assigned AO. Reference: 3d Mar FragO 16-68. (Lancaster II)

e. (1) Be prepared to reinforce or assume the mission of either 1/3 or 2/3.

(2) On D+1 or D+2 be prepared to conduct a helicopter borne assault to secure LZ Buzzard and secure Objective #11 on order.

(3) Be prepared to continue to attack and seize Objective #13 on order.

(4) Be prepared to furnish one (1) rifle company (rein) with command group to execute a helicopterborne assault to seize LZ Cardinal and conduct patrols in immediate vicinity. Reference: 3d Marines Operations Order 3-68. (Lancaster II)

f. Conduct Helicopterborne assault to seize LZ Margo commencing 271400H Jul to provide blocking force. Establish LZ and FOB and conduct limited search and destroy operations in TACR. Reference: 3d Mar FragO 24-68. (Lancaster II)

2. Significant Operations Conducted.

a. During the period 1-6 July while under the OPCON of the 9th Marines, the Battalion conducted search and destroy operations in the vicinity of grid squares 1569, 1669, and 1869 in Leatherneck Square.

Contact was gained with the enemy nine times during this period, the majority of these contacts were with squad sized units. The most significant of these contacts occurred on 2 and 5 July 1968.

On 2 July 68 Company "K" at YD 168693 was engaged with automatic and small arms fire from the vicinity of YD 171693, fire was returned with small arms and automatic weapons, artillery and mortar missions were called. Contact was broken and at 0700H Company "K" swept through the area of contact. 21 NVA KIA8s confirmed were counted and 3 crew served and 7 individual weapons were captured along with other equipment and ordnance.

At 0830H on 5 July a platoon of Company "K" gained contact with an estimated NVA platoon at YD 156706. The contact was initiated by the NVA with a command detonated mine, 60mm mortar fire and small arms fire. The remainder of Company "K" deployed to exploit the contact and recover casualties. The NVA unit was estimated at 50-70 personnel fighting from well dug in positions. Movement was limited and artillery gunships and air strikes were used to extract casualties. Contact was broken and Company "K" returned to its position at 1400H. 15 NVA KIA's were confirmed, Friendly casualties were 2 KIA's and 8 WIA's med evac.

While operating in Leatherneck Square 2 prisoners of war, 6 crew served weapons and 8 individual weapons were captured. 59 NVA KIA's were confirmed.

b. On 19 July the Battalion was heli-lifted from Camp Carroll to LZ Buzzard (YD 032604) on Dong Ha Mountain, the LZ was secured without resistance and the Battalion commenced a search and clear mission of the Dong Ha Mountain complex. On the evening of the same day, Company "I" discovered 6 bunkers in the vicinity of YD 028599, one bunker was found to have a false bottom which contained parts of a 75mm pack howitzer. The next day (20 July) while searching a bunker complex at YD 027602 Company "I" again discovered 75mm pack howitzer components. That afternoon a second 75mm barrel was found in a bunker at YD 027598, in all two complete and serviceable 75mm pack howitzers were captured.

No contact was made during this operation, approximately 122 fighting and living bunkers were destroyed. The Battalion (-) returned to Camp Carroll by heli-lift in 28 July.

One member of Mike Co. non-hostile injury due to sprained ankle. 2 members of Kilo Co. KIA due to enemy grenades. One member of Kilo Co. DOW due to wounds inflicted by enemy mortars.

3. On 3 July, one member of Lima Co. WIA due to enemy small arms fire, one member of Mike Co. NBC due to possible malaria, one member of Mike Co. NBC due to appendicitis, one member of Mike Co. NBC due to heat exhaustion.
4. On 5 July, 5 members of Kilo Co. WIA due to enemy grenades, 3 members of Kilo Co. WIA due to enemy small arms fire, 2 members of Kilo Co. KIA due to enemy small arms fire.
5. On 7 July, one member of H&S Co. NBC due to falling from boat and being cut by propellers.
6. On 10 July, one member of Lima Co. and One member of Mike Co. non hostile wounded due to fragmentation grenade detonated by an unknown individual.
7. On 12 July, 6 members of India Co. WIA due to enemy mortars, one member of Mike Co. WIA due to friendly artillery.
8. On 15 July, one member of India Co. non hostile injury due to conex box shifting on a truck and fracturing his pelvis, one member of Mike Co. non hostile wounded due to friendly 155mm air burst.
9. On 19 July, 2 members of H&S Co. NBC due to heat exhaustion, one member of Kilo Co. NBC due to phlebitis, one member of Kilo Co. due to abdominal pain.
10. On 20 July, one member of Lima Co. NBC due to heat exhaustion, one member of Mike Co. NBC due to sprained right knee.
11. On 21 July, one member of Kilo Co. NBC due to sun irritation of the eyes.
12. On 24 July, one member of India Co. NBC due to possible fractured spine.

c. Medical Trends. An increase in the number of cellulitis in the month of July is due largely to the intermittent wet and dry weather. A stronger emphasis has been made on medical personnel to insure that open wounds receive prompt attention.

d. Problem Areas. None.

e. A new and more effective malaria chemoprophylaxis tablet known as DAPSONE is being used, taken daily as prescribed is supposed to be effective against all types of malaria encountered in Vietnam. The effects will be observed and subsequently reported.

(1) General. During the reporting period the Battalion operated in Leatherneck Square, the Cua Viet area and the Camp Carroll area.

During most of the reporting period the Battalion was resupplied via helicopter from LZ Stud and the Dong Ha LSA.

(2) Class I. A daily resupply maintains the regular supply of Class I at a three to five day level. Water, in cans, water bulls and water bladders, were lifted in and out of the Battalion positions by helicopter.

e. Emergency leave for the month of July: 4 USMC enlisted. Twice/thrice wounded or resigned outside RVN due to father/brother in country: 12 USMC enlisted.

f. There were no Hardship Discharges applied for during the past month and none are pending.

g. One administrative Discharge is pending.

h. The R&R program continued to be a major morale factor within this command. There were 87 out of country R&R quotas and 28 in country quotas used during the month.

i. Morale is considered excellent to outstanding.

j. Postal Services during the month have been good.

12. Intelligence.

During the month of July the Battalion participated in operations in the Kentucky, Napoleon/Saline and Lancaster II AOs. There were no major conflicts, but light and medium sized contacts along with enemy mortar attacks were numerous in the early part of the month while operating in the Kentucky AO. (Leatherneck Square). Operations which were run along the eastern coast above the Cua Viet, produced no enemy sightings and no contacts. The Battalion then moved to the Lancaster AO operating out of Camp J. J. Carroll. Little resistance was met while operating in this area, on a few occasions the Battalion was subject to mortar and artillery attacks, but made no ground contact.

The Battalion operated in Leatherneck Square (OPCON to 9th Marines) for the first week in July. There were numerous small unit contacts which produced close to 60 NVA KIA's and two prisoners of war. Captured documents and POW interrogations indicated the enemy had many small units operating in Leatherneck Square with the mission of destroying helicopters.

On 2 July 1968 at 0530H the Battalion at YD 168692 was hit with 15-20 rounds of 60mm mortar fire from YD 155694. The mortar attack was on target and the Battalion suffered 20 WIA's. At 0500H of the same day Kilo Company at YD 168933 received small arms fire from the vicinity of YD 171693, they engaged the enemy with small arms, artillery and 81mm mortars, contact was broken just prior to 0900H. a search of the area

of contact disclosed 21 confirmed NVA dead, numerous weapons and equipment were captured. Also on 2 July at 1705H at YD 155700 Mike Company engaged a small enemy unit with small arms, while checking the area 15 NVA dead were found along with weapons and equipment.

The largest contact of the month occurred on 5 July at 0830H when elements of Kilo Company were taken under fire by an estimated 50-70 NVA. The point squad suffered early casualties as the NVA used command detonated mines, mortars and small arms. An AO and fixed wing were requested. Kilo Company returned fire with small arms, artillery and 81mm mortars. Upon arrival of the AO and air support Kilo Company maneuvered to exploit the contact and recover casualties, this was difficult as the enemy was well dug in and supported by 60mm mortars. The casualties were recovered under the cover of air and supporting arms. Contact was broken and Kilo Company returned to its original position. 15 NVA KIA's were confirmed.

Upon leaving Leatherneck Square the Battalion went OPCON to the 3d Marines and conducted operations in the Napoleon/Saline AO before moving to the Lancaster AO in the middle of the month. The Battalion conducted operations out of Camp Carroll while in the Lancaster AO. There were no ground contacts with enemy forces and the Battalion was subject to only a few mortar rounds. There were many bunkers found especially while operating around Dong Ha mountain. These were were overhauled with false tops or bottoms. Company "I" on 19 and 20 July found two 75mm pack howitzers at YD 028594 and YD 027602 while operating on Dong Ha mountain.

13. Communications. During the month the Battalion was almost always in the field on operations. A relay was maintained at Camp Big John to ensure communications to Dong Ha. On 11 July the Battalion moved to a fixed position at Camp Carroll. Wire was completely installed and normal wire and radio communications returned. A message center was set up to handle traffic through Camp Carroll. Another station on the Battalion Administrative net was set up at LZ Stud for resupply purposes.

The Battalion on 28 July was heli-lifted to LZ Margo to prepare a Fire Support Base, the FSB became operational on the evening of the same day and Battery "C", 1st Bn, 12th Marines was lifted into the base to provide support for elements of the 3d Marines.

1. Situation.a. Enemy Forces.

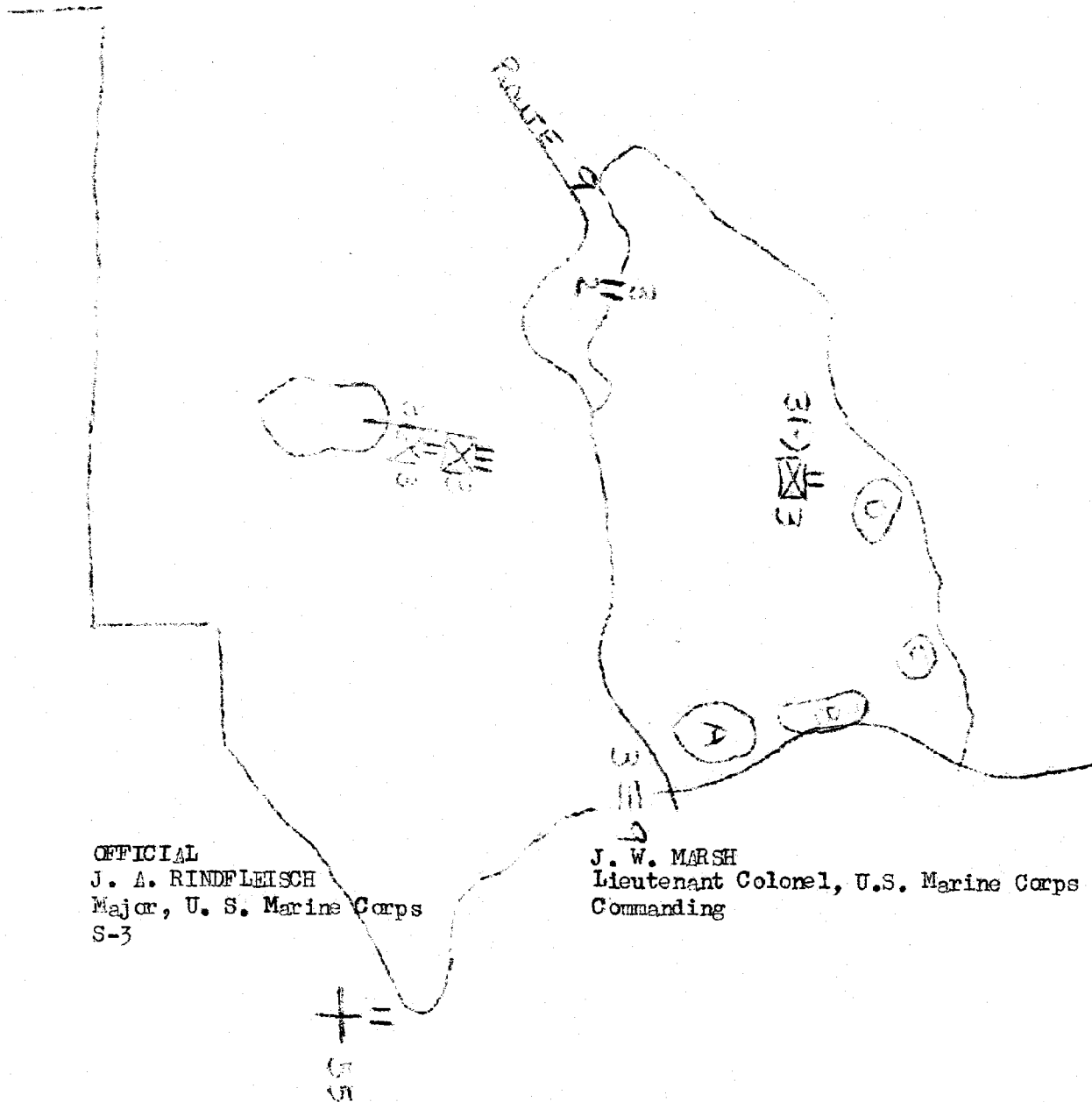

1. Situation.a. Enemy Forces.

- (1) Current intelligence information lists an unidentified NVA Regiment (believed to be the 2nd Regt. 339th Div.) operating in the vicinity of Objective #13.
- (2) Enemy incident experiences of the past few weeks shows 60mm and 82mm mortar capabilities and small groups of enemy interdiction mission of Route #9.
- (3) The enemy can fight a delaying action and attempt to escape through established infiltration routes in the area, probably withdrawing towards the north and northwest while being covered by supporting weapons to include artillery and rear guard/ambush action.

b. Friendly Forces.

- (1) 2/3 conducts search and clear operations between Mutters Ridge and the DMZ from east to west.
- (2) 1/3 conducts search and clear operations along Mutters Ridge and Helicopter valley from east to west.

(c) Be prepared to continue the attack and seize Objective #13 on order.

(d) Be prepared to furnish one (1) rifle company (rein) with Bravo Command group to execute heliborne assault to seize LZ CARDINAL (XD 9461) and establish patrol base in the vicinity of Hill #461.

3. Execution.a. Concept of Operations.

(1) Scheme of maneuver, See Operations Overlay.

(2) On D Day and D+1 the Battalion will be the 3d Marines Reserve. As such, the Battalion will be prepared to reinforce or assume the missions of the 1st or 2nd Battalions.

(3) The Battalion will conduct a heliborne assault landing in LZ CARDINAL (XD 946624) with one (1) rifle company (rein) and a small command group on D+1. This company will secure LZ CARDINAL, establish a company patrol base and conduct patrols and establish observation posts in the immediate vicinity.

(4) On D+2 the Battalion will conduct a heliborne assault landing in LZ BUZZARD (YD 032604) with three (3) rifle companies. The assault company will secure the LZ. The second company to land will move eastward from the LZ and search and clear the eastern portion of the Dong Ha mountain complex. The third company to land will move westward from the LZ to search cut approaches to Regimental Objective #11. On D+2 the Battalion will seize Regimental Objective #11 and be prepared to seize and occupy Regimental Objective #13.

b. Company "I". At L-hour on D+2 land in LZ Buzzard. Secure LZ BUZZARD. Be prepared to support, reinforce or assume the missions of Company "L" and/or Company "M".

- f. 81mm Mortar Platoon. At 171600H July 68, attach one (1) section of 81's to Company "K" for employment in LZ Cardinal and hill #461. On D+2, move remaining two (2) sections and FDC to LZ Buzzard to support operations on the Dong Ha Mountain complex.
- g. 106 RR Platoon. Effective at 0700H on D+1, one (1) section will be on a 30 minute alert to be heli-lifted to LZ Cardinal/Hill #461. On D+2 the alert will be expanded to two (2) sections, the second section to be lifted to LZ Buzzard if required.
- h. Engineers. Engineer Platoon will be attached to Company "K" and carry out assigned missions in LZ Cardinal as prescribed by Co, Bravo Command group.

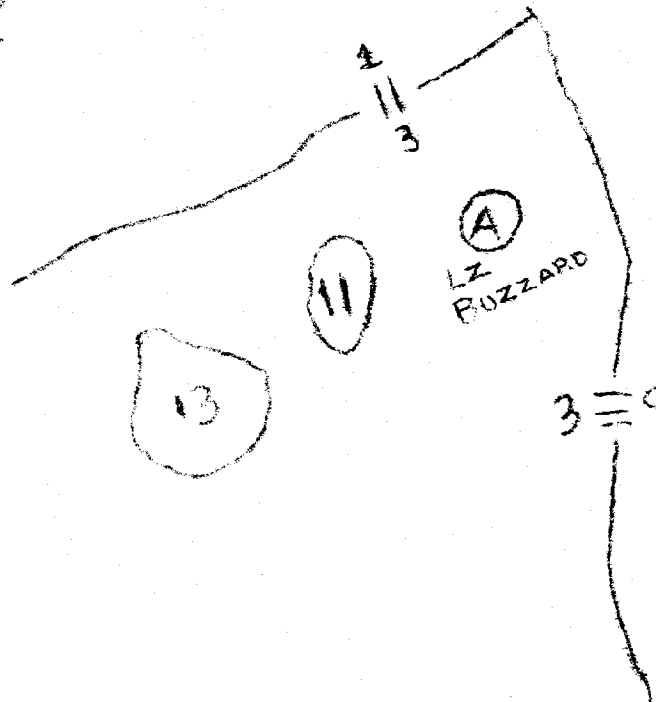

1. Situation.

a. Enemy Forces.

(1) Current intelligence reports an unidentified NVA Battalion operating in the western portion of the Cam Lo River valley. Current intelligence also reports the possibility of the NVA 308th Division Headquarters being located somewhere in the Cam Lo River valley.

(2) Enemy initialed incidents of the past few weeks in the 3d Marine AO shows 82mm and 60mm mortar capabilities and small groups of enemy indicating interdiction missions against Route #9.

(3) Experiences of the 9th and 4th Marines and the 2nd ARVN regiments operating to the east and south of the 3d Marines AO respectively show sizeable enemy forces capable of offensive action or determined resistance. It is anticipated the enemy will fight a delaying action and attempt to escape through established infiltration routes in the area, probably withdrawing towards the north or south while being covered by supporting weapons to include artillery and rear guard/ambush actions.

b. Friendly Forces.

(1) 1/3 conducts a heliborne assault commencing 270700H to seize LZ Becky. Establish a possible FSB at LZ Becky. Conduct search and destroy operations in and along the Cam Lo River Basin and effect link-up with 3/3 at LZ Margo on order.

(2) 2/3 will be 3d Marines reserve effective 271400H and continues present mission of Route #9 security in 3d Marines AO.

(3) Artillery.

(a) 3/12 will provide direct support of 3d Marines from FSB Joan, Margo and Camp Carroll.

(b) Det. 3/12 will provide direct support fires from FSB Joan.

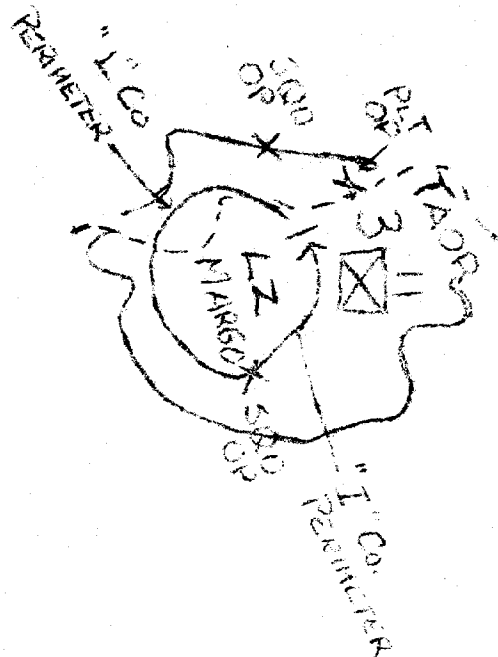
