1. BRIGADE AWARDS OFFICE:

a. During the month of May the Brigade Awards Office processed 1133 Award Recommendations, 14 Purple Hearts, 186 Foreign Awards for Redeploying Units in RVN, 2 Posthumous Awards and 2 Heroic Awards.

2. PUBLIC AFFAIRS OFFICE:

a. A total of 4 civilian news correspondents were escorted by Public Affairs Office Personnel. 3 to 2d CAG hamlets and stand down/redeployment activities and 1 to the Headquarters area.

b. Public Affairs Office personnel prepared and released 16 stand down/redeployment messages and press releases.

c. Public Affairs Office personnel covered a total of 25 stand down/redeployment activities.

d. Photo coverage was provided by PAO personnel for the Assistant Commandant of the Marine Corps and the Commanding General, Fleet Marine Force, Pacific. In addition to the taking of photographs, all negatives were ID'd and forwarded to the respective headquarters.

e. PAO personnel provided photographic coverage for 8 G-4 Real Estate activities.

f. PAO took and processed 173 ID card photos for Marine Corps, Navy and Army personnel.

3. SPECIAL SERVICES OFFICE:

a. There were 80,488 free issues of the Stars and Stripes newspapers distributed to 3d MAB personnel during the month of May 1971.

b. The total number of R&R quotas allocated to 3D MAB for the month of May was 562. The MACV percentage of utilization figure for the month of May is not available at this time. There were 140 quotas allocated for Okinawa R&R and that site had a utilization figure of 63%. For update information the MACV percentage of utilization figure for the month of April was 97.9%.

c. There were 14 officers quotas and 220 enlisted quotas allocated 3d MAB by USARV for China Beach In-Country R&R. The utilization figure for the month was 86% for officers and 91% for enlisted.

d. Two round-trip Hong Kong Special Services flights were made during the month utilizing a total of 116 seats.

4. POSTAL OFFICE:

a. During the month of May 1971, the Brigade Post Office received 91,130 pounds of U. S. Mail and dispatched 88,341 pounds of U. S. Mail for a total of 179,471 pounds.

b. During the month the Brigade Post Office sold postal money orders in the amount of \$479,821.03 and cashed postal money orders in the amount of \$13,456.41. Stamps and stamp paper were sold in the amount of \$22,500.00.

c. During the month of May 1971, the Brigade Post Office conducted inspections of 20 mailrooms.

INTELLIGENCE SECTION

1. (C) COLLECTION UNIT

a. General. During the period 1-7 May 1971, efforts were directed toward preparing for standdown, which included cleaning equipment, conducting preventive maintenance on equipment prior to packing in mount out boxes and preparing personnel for redeployment. On 1 May 1971, elements of the 196th Infantry Brigade assumed responsibility for all sensor equipment and read-out sites formerly under control of SCAMP. The Aerial Observers also terminated pre-fragged visual reconnaissance missions on 1 May, with one OV-10A aircraft on five minute standby to launch if necessary. The UH-1E aircraft, under the control of the 11th Marines, continued visual reconnaissance of the rocket belt until standdown on the 7th of May. No documents, interrogation reports or detainees were processed by the 3d ITT or the 1st IT during this period.

b. Ground Reconnaissance. During the period 1-7 May 1971, there were no reconnaissance teams employed within the Brigade TAOR. Company "A", 1st Reconnaissance Battalion, stood down on 7 May and prepared to return to its parent organization at Camp Pendleton, California, as part of Increment VII redeployment.

c. Photo Imagery Interpretation Team. During the period 1-7 May 1971, the Photo Imagery Interpretation Team completed preparations for turn-in of all excess equipment prior to standdown on 7 May. One photo imagery interpretation unit set, one mirror stereoscope and one set of drafting templates were turned in to 3d MAB Supply.

d. Aerial Observation Unit

(1) During the subject period, the Aerial Observation Unit conducted 10 sorties for a total of 17.2 hours of visual reconnaissance and supporting arms control.

(4) All aircraft support for the subject period was provided by Marine Observation Squadron Six Detachment, Headquarters and Maintenance Squadron Eleven. Total sorties and hours are indicated in sub-paragraph (1).

e. Interrogation- Translation

(1) During this period, the 1st Interpreter Team remained in a standdown status and is scheduled to redeploy on 12 May to Camp Pendleton.

(a) No interrogation reports or documents were processed.

(2) The 3d Interrogation Translation Team and the 3d MAB Document Translation Center prepared for standdown during this period.

(a) No detainees were processed during this period.

(b) Significant events:

1 During this period the 3d Interrogation Translation Team departed from Camp Perdue and became non-operational. The sub-teams at the 95th Evacuation Hospital and at Quang Nam Province Headquarters, in Hoi An City, also departed from their respective areas. The 3d Interrogation Translation Team officially stood down on 7 May 1971.

f. Sensor Control and Management Platoon

(1) The 196th Infantry Brigade, Target Mission Force personnel, assumed control of all SCAMP sensors, sensor related equipment, the monitoring site on Hill 327, relay equipment on Monkey Mountain and the SCAMP Operations Center (SOC), as of 0001, 1 May 1971.

(2) SCAMP began its standdown on 1 May and prepared to rotate to its parent unit, Headquarters Battalion, 1st Marine Division, at Camp Pendleton, California. Four personnel along with the vehicles and communications equipment belonging to SCAMP were prepared for embarkation on 12 May. On 7 May, following inspection by Colonel HUNT, Assistant Chief of Staff, G-2, 20 personnel from SCAMP boarded MAC aircraft and returned to Camp Pendleton as a unit.

g. Target Intelligence

(1) During 1-7 May, there were no intelligence targets developed.

(2) There were no infrared targets requested and no missions flown.

2. (C) STAFF COUNTERINTELLIGENCE UNIT

a. Normal active and passive Counterintelligence measures against the enemy's collection effort continued during the period. The 3d and 5th Counterintelligence Teams participated in 5 operations during the period 1-7 May. During the operations 306 Vietnamese were screened against existing wanted lists resulting in 5 detainees.

b. During the period, the 3d Counterintelligence Team conducted 4 vacated command post inspections of redeploying Marine Corps Units.

c. The 3d MAB C&CI Fund Custodian closed out the 3d MAB C&CI Account which included all VIP Funds. Turn-in to MACJ 252 consisted of 598,423 Piasters in cash, 134,710 Piasters in Vouchers; also \$71.13 (MPC) in cash and \$162.90 (MPC) in paid Vouchers. Total accountability for the 3d MAB C&CI Fund Account is Zero (0) balance and the account is closed out.

b. Briefings

(1) Briefings were presented to the Commanding General, General Staff and visiting Flag Officers.

c. Enemy

(1) During the period 1-7 May, the enemy concentrated his efforts toward the continuation of Phase II, K850, which was primarily directed against GVN functions and forces. Therefore, his activity within the Brigade's TAOB (HOA VA G, District) remained at a very low level. This period of

activity consisted of scattered harassing mortar and rocket attacks with some limited ground and sapper attacks, most of which took place in the southern lowlands.

(3) Estimate of the Enemy Situation. The enemy's major forces in Quang Nam Province are thought to be presently withdrawing to the base areas. They are, for the most part, expected to be engaged in refitting, indoctrination and reconsolidation for possibly another offensive surge in the latter part of May. His offensive surges are expected to remain harassing in nature and continue to be directed primarily against GVN forces and functions.

d. Weather

(1) The maximum and minimum temperatures for the period 1-7 May were 92 and 73 degrees, respectively, with a mean temperature of 82 degrees.

(2) Weather during the period had no appreciable effect on ground operations. Low ceilings and rain had a moderate effect on observation and helicopter operations during the period.

GROUND OPERATIONS

1. (C) The month of May continued the standdown and redeployment from combat operations of elements of the 3D MAB. With the standdown of the 1st Bn, 1st Marines on 1 May 1971, the area of operation of the Brigade was reduced in size, to coincide with the boundaries of HOA VANG District, RVN, less the area of the HAI VAN Pass. Ground combat operations were terminated on 7 May 1971, upon the standdown of the last infantry battalion of the MAB, the 2d Bn, 1st Marines. Responsibility for operations in HOA VANG District was resumed by Provincial Forces of Quang Nam Province, headquartered in HOI AN, RVN, with the 196th Light Infantry Brigade, 23d Infantry Division, U.S. Army, Vietnam, assigned an area of operation covering the mountainous portion (and Brigade ridge) formerly assigned to the 3D MAB. (Overlays of the reduced TAORS may be found in the 3D MAB Command Chronology for the period 14-30 April 1971, TAB A.) Operation IMPERIAL LAKE, a Category III operation, was the only named operation under control of the 3D MAB during the reporting period, and was terminated on 7 May 1971. This operation, initiated by the 1st Marine Division on 31 August 1970, was continued by the 3D MAB until the termination of all ground combat by Marine forces in RVN. An exceptionally lucrative operation, IMPERIAL LAKE inflicted heavy losses on NVA and VC personnel and material in the QUE SON Mountains and denied the enemy a former sanctuary within a short distance of the DaNang Vital Area. While under Brigade control, Operation IMPERIAL LAKE was conducted in the mountainous area of the northeastern portion of the Brigade AO. Responsibility for the defense of the DaNang Air Field was passed to the 104th R.F. Battalion reinforced with the 796th R.F. Company on 7 May 1971. The 1st M.P. Battalion continued to give limited technical assistance to the R.F. units. Upon relief Company D(Rein), 1st M.P. Battalion was freed for assignment to Force Logistic Command for employment in security role. An area of operation extending 1,500 meters around the F.L.C. perimeter wire was granted by HOA VANG District, thus providing deeper security for F.L.C. On 3 May 1971, the Land Mine Warfare School was terminated with facilities and curriculum turned over to the 196th Brigade.

a. At 050400H May 1971, the DaNang Air Base received three 122mm rockets. The rockets impacted at (BT 016761), (BT 036762) and (BT 003767). The rockets caused negative damage or casualties at (BT 016761), one Vietnamese was slightly wounded by the rocket that impacted at (BT036762) and the final rocket caused negative casualties, but did extensive damage to a OV-10 aircraft when it impacted at (BT 003767).

b. At 052300H May 1971, for the second time in less than 24 hours, the DaNang Air Base came under 122mm rocket attack. A total of six rockets were received, the first of which impacted at (BT 015768), an ARVN cantonement; the second impacted at (BT 032766), an oil tank farm; the other four rockets impacted in and around DaNang City at (BT 020750), (BT 029770) and (BT 027773). The total results of the attack are: six Vietnamese civilians KIA, three ARVN WIA, four Vietnamese civilians WIA(E), two Vietnamese civilians WIA(M), one water tower damaged, one shell oil tank destroyed, two ARVN trucks 100% destroyed, and two ARVN trucks 20-50% damaged.

c. At 300330H May 1971, eleven 122mm rockets impacted in and around the DaNang Air Base. Six rockets impacted at (BT 017747), (BT 017755), (BT 009768), (BT 011746), (BT 011758), and (BT 013757). There were no casualties or significant damage caused by these six rockets. The remaining five rockets impacted in the vicinity of (BT 031789)-(BT031787), killing 12 Vietnamese civilians, wounding 11 Vietnamese civilians and causing heavy damage to six Vietnamese houses.

2. (S) Major Operations.

a. Operation IMPERIAL LAKE, a Category III operation, which commenced on 31 August 1970, terminated at 071200H May 1971. After a period of over eight months this operation was responsible for the capture of significant amounts of enemy foodstuffs, equipment and ordnance which greatly hampered enemy operations within the DaNang area. There were also significant casualties inflicted on enemy forces throughout the operation. AIR OPERATIONS

1. (S) The 3d Marine Amphibious Brigade continued to fly in support of operations conducted throughout Military Region I. Fixed wing aircraft flew 80 sorties and dropped 128.7 tons of ordnance. Helicopters flew 3,691 sorties and carried 5,691 tons of cargo and 6,563 passengers.

Part IINarrative SummaryG-4 Section1. (C) LOGISTICS.

a. (C) General. Logistic responsibilities for the MAB remained essentially the same during the reporting period. Execution of plans concerning Increment VII (Keystone Oriole) redeployment continued throughout the month. Stand down and redeployment of MAB units resulted in the orderly phase down of logistic requirements.

b. (C) G-4.(1) (C) Redistribution Program.

(a) (U) Although the program for redistribution of excesses was officially suspended on 30 April 1971, final statistical data was not accumulated and compiled until 24 May 1971. The complete summarization, from inception of the program in May 1970 through suspension in May 1971, shows 327,655 items of equipment have been redistributed at a dollar value of approximately 50.4 million dollars.

(b) (C) 20 May 1971 brought an end to active Marine Corps participation in "Project 805"; transfer of equipment in support of the Vietnamization Program. Units redeploying during Increment VII of Keystone Oriole offered 1,206 items for transfer of which 1,119 were accepted. The dollar value of these transfers was \$774,160.34. The cumulative totals for transfers in support of the Vietnamization Program since the commencement of "Project 805" in July 1970 are as follows:

(c) (U) The month of May proved to be the most active for Marine participation in the Interservice Transfer of Principle Items Program. During the month 595 items of equipment were transferred to U. S. Army units. The dollar value of these transfers amounted to over \$750,000.00.

f. (U) Supply Summary.

(1) During the period 1 - 31 May the overall supply support to Brigade units was considered satisfactory. During the month all units preparing for redeployment were visited periodically by members of the Brigade Supply Office. The majority of CONEX's have been returned to the transportation system with the exception of those required by units for retrograde of material and a few which are still being utilized as essential. The agreement with the U. S. Army for loan of the integrated observation systems has been completed.

(a) During the period all redeploying units were visited on a continuing basis by members of the Brigade Supply Office to ensure a smooth redeployment and to lend assistance as needed. Due to the emphasis being placed on ensuring no contraband is being taken out of country via organic supplies, there was a requirement for additional banding material, part of which was obtained from the U.S. Army Depot. Any additional requirement will be air shipped from Okinawa.

(b) As a result of the MAGV Conex Control Officer request that 10% of all CONEX be returned to the transportation system monthly, this Headquarters directed all units to return all CONEX except those required for retrograde by 15 May 1971. Most CONEX not being retrograded have been returned except a few which units have requested to leave in place as part of defensive perimeters and a few which units still require for essential storage. It is expected that all CONEX used for essential storage will be returned to the transportation system by 15 June 1971.

(c) The Assistant Brigade Supply Officer and Assistant Operations Officer went to Saigon with the temporary loan agreement for the Integrated Observation Systems and secured the signature of the Army representative in the USARV Office of the Deputy Chief of Staff, Logistics. The original of this agreement will be forwarded to CG, MCDEC. File copies will be sent to CG, 1st Marine Division and CMC (Code AO4F).

g. (U) Motor Transport Summary.

(1) During the period 1 - 31 May 1971 a total of thirteen convoys were conducted. These included two to Hoi An conducted by Company A, 1st Motor Transport Battalion, eleven to Deep Water Pier and Tien Sha LST Ramp conducted by units of the Brigade embarking for redeployment.

(2) During this period, Company A, 1st Motor Transport Battalion traveled 18,674 miles, transported 9,988 passengers and 1,185 tons of cargo.

h. (U) Food Services Summary.

(1) The variety and availability of subsistence items were in sufficient supply during May to provide adequate menu support; however, due to the large number of "B" ration meats on hand at FLC Ration Dump, a 15 day "B" ration menu was adopted on 3 May 1971. This menu was again utilized for the period 19-31 May 1971.

(2) All messes operated by units of the Third Marine Amphibious Brigade utilized "B" ration meats during the entire period covered by this report in order to consume excess stocks on hand in the FLC Ration Dump. Monetary saving realized by the government was approximately \$200,000.00.

i. (U) Dental Summary.

(1) The detachment, 11th Dental Company provided dental support to all elements of the 3d Marine Amphibious Brigade, the 1st Marine Aircraft Wing Detachments and the Force Logistic Command through 26 May when the dental facilities were closed.
