

Summary. The Battalion spent all but two days this month in the field West of Cam Lo participating in Operation PRAIRIE. Besides the rear administration at Phu Bai, there was also an administration set up at the Dong Ha Combat Base.

B. Significant Events.

6 September- The Battalion returned to Dong Ha from the field subsequent to a reconnaissance in force in the area West of Cam Lo.

8 September- The Battalion moved to the field from Dong Ha to conduct a reconnaissance in force in the area West of Cam Lo.

C. Problem-Areas/New Developments

1. The continued shortage of Officers still exists with seventeen required to bring the Battalion up to T/O. There is an Enlisted shortage in the C1 field with ten need to bring the Battalion up to T/O. With the formation of the 106 Recoiless Rifle Platoon there is a shortage in MOS 0351 with 64 needed to bring up to T/O.

2. On 27 September the rear administration at Phu Bai moved to the Dong Ha Combat Base. The Battalion administration offices were moved into Ely hutSat this time.

SECTION III

A. General. (Period covered 1 September 1966 - 30 September 1966). The Battalion was actively engaged with VC/NVA elements during the reporting period.

During the period 1-5 September contact was negative. Several Artillery fire missions were called on suspected VC/NVA OP's and harboring sites. Results were unknown.

During the period 6-15 September contact was generally light and usually involved small groups of VC, with the VC breaking contact and withdrawing. One exception occurred on 19 September, when 1/4 elements at XD973566 received 40-60 rounds 105mm and 5 rounds 120mm mortar fire. Another item of significance during this period occurred on 14 September when a Company "A" patrol at XD994569 fired on 1 VC filling his canteen at a stream in the same vicinity. Patrol then received 30 rounds small arms fire from an estimated 10 VC in same vicinity. Patrol returned small arms fire and called mortar and tank fire and a airstrike at XD995571, VC broke contact and withdrew to the Southeast. Patrol swept area finding 7 VC KIA (Confirmed). Also during this period 2 incidents involving sniper fire occurred on Route 9 between DONG HA and CAM LO. No casualties or damage to vehicles occurred in either incident.

During the period 16-20 September contact with VC/NVA units was heavy. On 16 September Company "D", on a Search and Destroy operation was ambushed. Company "B" moved to link up and reinforce Company "D". Both units then became surrounded and unable to move. All attempted movements by friendly units resulted in heavy enemy contact with an NVA unit estimated to be of Regimental size. While maintaining defensive positions both units came under heavy mortar fire and semi and automatic weapons fire, in addition "B" and "D" received an undetermined amount of grenades and on occasions the enemy attempted to penetrate "B" and "D" defensive positions. "B" and "D" utilized all organic weapons, numerous artillery, airstrikes and mortar fire missions were called on enemy positions resulting in 171 VC/NVA KIA (Confirmed) and 356 VC/NVA KIA (Probable) during this period. At 161547H elements of 2/7 linked up with "B" and "D" to relieve them. Also during this period the 1/4 CP received several incoming mortar rounds. Of other significance during this period was the large amount of foreign voices on the Battalion TAC net. Also extensive jamming was reported. Voices heard on radios were identified by the interpreter as being Chinese.

During the period 21-30 September enemy contact was light. On 25 September 1/4 CP received 50 rounds of enemy 57mm Recoilless Rifle fire. Artillery and airstrikes were called on suspected enemy positions. On 27 September a "D" Company patrol found enemy 57mm Recoilless Rifle position at XD974594. Enemy losses were 11 KIA Confirmed and 18 KIA Probable. Enemy position was covered to the extent that no weapons or equipment were salvagable.

During the reporting period 1/4 units came under mortar attacks on 9 different occasions. Also 1/4 units came under 57mm Recoilless Rifle fire twice during the reporting period.

1. At 020845H, Company "D" at XD986593 called Artillery Mission on suspected VC OP site at XD999613. "W" Battery, 3/12 fired 8 rounds 4.2 mortar. Results unknown.

2. At 031500H, H&S Company enroute to CP found numerous fighting holes (L-shaped) and foxholes and remains of hooches and earthen stoves along the trail in GS YD0361. All appeared to be old and unused.
3. At 061045H, H&S Company Battalion FSCC personnel at YD212599 enroute to CAM LO YD1259 received 4 rounds carbine fire from an unknown number of VC located on south side of SONG HIEU GIANG at YD211601. Personnel continued on to CAM LO. No casualties or damage to vehicles reported.
4. At 062110H, Company "D" defensive positions at YD244597 received approximately 5 rounds small arms fire from an unknown number of VC vicinity YD244600. Defensive positions returned approximately 20 rounds small arms fire and VC broke contact withdrawing in an undetermined direction.
5. At 070830H - 070845H, Company "B" located at YD245594 received Vietnamese National transmissions on the Company TAC net. It is unknown if transmissions were VC or ARVN.
6. At 070830H, 4 Marines in 81's platoon vehicle enroute to CAM LO at YD163586 received 4 rounds carbine fire from an unknown number of VC located at YD163588. Vehicle accelerated speed to move out of range. No casualties or damage to the vehicle was reported.
7. At 101535H, Battalion elements at XD973566 received an estimated 40-60 rounds 81/82mm and possible 120mm mortar rounds from an unknown number of VC located vicinity XD965593. Battalion elements returned approximately 125 rounds 81mm mortar HE and an undetermined number of 90mm tank fire. VC firing ceased with enemy casualties unknown.
8. At 101625H, Company "D" OP at XD975969 received 4 rounds 81/82mm mortar fire which bracketed OP position from an unknown number of VC believed located at XD965593. 81mm mortar fire returned; results unknown.
9. At 101630H, Company "D", 1st platoon patrol at XD970573 received approximately 8 rounds small arms fire from an unknown number of VC located on a ridgeline in GS XD9657. Patrol returned small arms fire and machinegun fire on suspected enemy position and VC broke contact withdrawing in an unknown direction.
10. Circumstances surrounding discovery of 120mm mortar rounds: At 101535H, Battalion elements received 40-60 rounds mortar fire. Mortar rounds were estimated to be 81/82mm with possible 120mm mortar rounds mixed. After attack, craters were examined and some appeared to be much larger than those of 81/82mm. One piece of shrapnel was found which was believed to have been of 120mm mortar. An EOD team was requested and arrived on 11 September. EOD removed and disarmed one 120mm dud located in "W" Battery 3/12 area. EOD returned to 4th Marines position with dud and any technical information acquired.
11. At 121830H, Company "B", 2nd platoon patrol at XD962566 detonated a pressure type mine/booby trap. Explosion which occurred was similar to that of a M-26 grenade.
12. At 131715H, 1/4 CP radio operators received foreign voices on frequency designator M-528. Battalion interpreter identified voices as Chinese. Subject of transmission unknown.

At 140930H, Company "B" patrol at XD982530 called an airstrike and artillery mission on suspected VC harbor site at XD992527. Patrol checked area and found Vietnamese type ration containers and empty cigarette packs. Area appeared to have been occupied within the last 3-4 days by an estimated 30-40 troops. At 140810H, Company "D" patrol at XD963582 fired on 3 VC observing patrol. VC did not return fire. Patrol called mortar and tank fire on enemy position, with negative results.

14. At 151315H, Company "A" patrol at XD994569 fired on 1 VC filling his canteen at stream in same vicinity. Patrol then received approximately 30 rounds small arms fire from an estimated 10 VC in same vicinity. Patrol returned small arms fire and called mortar and tank fire and an airstrike on hill at XD995571. VC broke contact withdrawing to the Southeast. Patrol swept area finding 7 VC KIA (Confirmed).
15. At 161230H, S-3A sighted 4 VC at XD989593. Tank fired 6 rounds HE. Good coverage of target. Results unknown.
16. At 161330, Company "A" located caves at XD968563. Captured equipment as following: 1 AK-47 serial number 011409, 5 AK-47 magazines, 1 magazine pouch, 1 first aid kit containing medical supplies and equipment, 1 pack, 1 sleeping bag, 2 bags food, 1 can food, 1 poncho, 1 pair scandals, assorted medical supplies and equipment.
17. At 170830H, Company "D" reported heavy probing of their defensive lines in addition to probing, enemy voices and activity were heard. Small arms and grenades were returned.
18. At approximately 170900H, Battalion CO's OP received incoming mortar rounds. Number of rounds received were 10. Believe mortar rounds came from XD979611. At 170915H AO observed a possible 120mm mortar position at XD979611. AO directed an artillery fire mission into the same area. Enemy fled position.
19. At 171030H, Company "A" point sighted 2 VC at XD967584. Took VC under fire with small arms. VC did not return fire. VC fled in an undetermined direction.
20. At 171215H, 1/4 CP received 2 incoming 81/82mm mortar rounds. Rounds hit at XD978568 and at XD977566. Enemy mortar position was undetermined.
21. At 171230H, a resupply/Med Evac helicopter was shot down within "D" Company defensive position.
22. At 171300H, The Battalion CP radio operators heard possible Chinese voices on M-601. At 171500H this position continued to hear Chinese voices. It appeared that they were 2 different stations transmitting and receiving back and forth. Also on M-436 effective jamming was experienced.
23. At 171300H, 1/4 CP observed 25-30 VC at XD973563. Took VC under fire and called in 81's on enemy position. Negative results.
24. At 171535H, Company "B" reported incoming grenades. Returned small arms and grenades. Negative results.

25. At 171800H, 1/4 OP received six 81/82mm incoming mortar rounds from XD963975. 81's, 106's, and 2 airstrikes called in from enemy position. Results unknown.

26. At 171800H, heavy enemy contact regained with "B" and "D" Companies.
27. At approximately 171800H, Company "D" tried to remove their KIA's and made heavy enemy contact at XD962600. 6 VC KIA Confirmed. 2 weapons captured.
28. At 180200H, S-2A sighted 1 VC crossing river into bushes at XD989560. 12 rounds of 82mm mortar were fired with good coverage of target. Results unknown with no further VC observations.
29. At 190100H, 1/4 OP observed 5 VC in river bed at XD989562 moving towards XD99156. 25 rounds of 82mm mortar fired with good coverage of target. Results unknown with no further VC observations.
30. At 182000H, Company "B" heard NVA voices on M-679. An interpreter confirmed voices as NVA. NVA voices made reference to a 555th unit. The 555th unit was reporting 6 casualties to an unknown station. It appears that there were 3 different NVA stations on net.

 D: All attempted movements by friendly units have resulted in heavy enemy contact with an NVA unit estimated to be of Regimental strength. While maintaining present defensive positions have come under mortar fire, and automatic weapons fire, in addition have received an undetermined amount of grenades and on occasions the enemy has attempted to penetrate "B" and "D" defensive positions.

32. At 191700H, H&S Company received approximately 3-4 incoming mortar rounds. Possible enemy position located at XD966600. Counter mortar fire and 90mm fired on suspected enemy position. 102 rounds of 82mm mortar fired.
33. At 192300H, 1/4 OP reported movement at XD988558 and fired 9 rounds M-79. At 192340H requested 82mm mortar fire mission on 8 VC spotted at same coordinates. 20 rounds were fired with good coverage. 6 VC KIA (Probable). At 200017Z 2 VC were observed in same area, 50 meters apart. They were believed to be searching for bodies. 10 rounds 82mm fired. At 0050H 1 VC was spotted in same area. Another 10 rounds fired with good effect.

UNCLASSIFIED 1900H, H&amp;S Company received foreign language interference on M-824.

35. At 201320H, Company "B" sighted 1 VC going up stream wearing black PJ's without a weapon. Pursued with negative results.
36. At 201400H, S-3A observed an undetermined amount of fresh foot prints at XD984556. Possible route used by the VC from the southeast. Then prints led northeast and to the southwest. H&I's were fired on area.
37. At 210345H, Company "A" IP heard movement to their left and rear flanks at coordinates XD958498. Threw 2 grenades and called for artillery illumination with negative results.
38. At 210345H, 1/4 OP received 1 incoming grenade and a 81mm position received a total of 7 grenades. All grenades came from approximately XD977557. Returned fire with 5 grenades, 2 claymores, and 40 rounds 7.62.
39. At 211445H, Company "B" patrol made contact with an estimated VC squad. VC were wearing black PJ's. VC fired small arms at patrol. Marines returned fire and VC broke contact fleeing west. Contact made at XD967568.
40. At 211530H, H&S patrol were taken under fire by 3 VC at XD966558. VC fired 15-20 rounds small arms fire. Marines returned 100-150 rounds small arms fire and VC broke contact and fled in an undetermined direction.
41. Between 211445H and 211600H the 1/4 OP received an approximate total of 32 rounds of 81/82mm mortar fire. Before exact enemy position was located counter mortar fire was returned with 81's (Approximately 175 rounds), 90mm (which observed secondary explosion at XD961579), and artillery. With the assistance of the AO and recon patrol the enemy mortar position was located. Counter mortar fire was continued and an airstrike was called. AO reported 95% of target covered by airstrikes, 14 VC KBMA, 3 Probable.
42. At 221300H, Company "B" patrol located 2 caves at XD967563. At XD968564 a cave 91x9' was located that had been used recently. At XD968565 a cave 15' x 20' was located. Also between XD969565 and XD968573 6-8 sniper trees were located. Trees had good view of our position.
43. At 221500H, Company "A" patrol located 6 shell casings, 1 left tennis shoe, and 3 bandages, at XD0056. In the same vicinity fresh trails, leading to the high ground were found. 1 well used trail going southeast from XD003558 was located.
44. At 221530H, Company "B" sighted 2 VC without weapons, at XD967564. VC were near a cave entrance. Snipers fired 4 rounds and VC went into cave. 106's were fired with unknown results.
45. At 241650H, H&S Company received 22 rounds of 81/82mm mortar, 57mm Recoilless Rifle. Fire returned with 81's, artillery, and 90mm. A 57mm Recoilless Rifle position at XD983588 was fired on by 90mm and Company "A" observed 20 secondary explosions.
46. At 250930H the LZ for 1/4 OP received 2 rounds of mortar fire as a helicopter was trying to land at XD986593. Helicopter took 1 hit.

47. At 251335H, H&S Company received 50 rounds of 57mm Recoilless Rifle fire. Fired 81's, 106's, 90mm, and called artillery and airstrikes on suspected enemy position. A large secondary explosion was observed by AD at XD978592 due to artillery mission.

48. At 261500H, Company "A" patrol found a 81/82mm mortar round boobytrapped. Patrol unable to destroy round.

49. At 271540H, Company "D" patrol located an enemy 57mm Recoilless Rifle position which had been fired on by 106's and artillery at approximately 251840H. Blood spots, bandages, dragmarks, and pieces of web gear were found. Enemy position was covered to the extent that no weapons or equipment were salvageable. No means of enemy unit identification were found. Enemy position found at XD974594. Enemy personnel and equipment losses were 7 NVA KIA (Confirmed), 18 NVA KIA (Probable).

50. At 290245H, Company "B", 2nd platoon patrol detonated an AP mine at XD963556.

C. Weather and Terrain.

1. Terrain encountered during the reporting period consisted primarily of dense jungle and rolling hills. There were two prominent terrain features, the THON KRE THI (The Rock Pile) at XD979559, which rose 220 meters from the valley floor; the second terrain feature was a rock mass (The Razor Back) which ran in a northwesterly direction. The rock mass consisted of enumerable caves. It stretched 3,000 meters in length from XD969564 to XD955587.

## SECTION IV

MISSION

During the period 1-30 September, 1st Battalion, 4th Marines participated in Operation PRAIRIE. Missions assigned were as follows:

1 Sept - 5 Sept	Conduct Reconnaissance in Force in area North of Highway 9 and West of Cam Lo to Thon Son Lam. (See page <u>14</u> this chronology).
6 Sept - 7 Sept	(1) Defend Dong Ha Combat Base. (2) Coordinate defensive effort of all U. S. Forces within Dong Ha perimeter. (3) Provide one reinforced rifle company to be used as a reaction force.
8 Sept - 30 Sept	Conduct operations to prevent enemy movement into or through Thon Son Lam area (Vicinity XD 9756).

OPERATIONS

From 1 to 5 September, the Battalion continued a Reconnaissance in Force which had begun on 29 August. Throughout this period there was negative enemy contact.

On 5 September at 1000H, all companies returned to the Dong Ha Combat Base, and reassumed the mission of defense of the perimeter. The Battalion remained for 3 days, having one small enemy contact on the lines during this period.

On 8 September Companies A, B, and D, plus H&S, moved from Dong Ha to the Thon Son Lam (Vicinity 9756). Upon arrival and relief of 2nd Battalion 7th Marines, the Battalion established a defensive perimeter, and prepared to execute the mission of preventing enemy movement through the area.

On 10 September at 1535H the first of what was to be many mortar attacks was launched against the Battalion defensive perimeter. This attack consisted of 40-60 mortar rounds, both 81/82mm and 120mm, which appeared to be directed primarily against the Howitzer positions within the perimeter. Friendly casualties were light. With the assistance of an AO, mortar and artillery fire was returned at the located enemy position with "good coverage of target". Later in the afternoon, at 1625H, Company D OP was bracketed by 4 rounds of 81/82mm mortar fire. 81mm fire was returned at the enemy position located earlier, and no further incoming was received.

A 120mm mortar crud was located inside the perimeter on 11 September it was recovered by FOD personnel and returned to the 4th Marines CP at Dong Ha. This was allegedly the first 120mm round recovered in VIETNAM.

On the 12th and 14th patrols from Company B and Company D encountered the first booby traps found in the operating area. These incidents resulted in four (4) WIA and one (1) KIA.

At 1200H on 15 September, Companies B and D departed the Battalion perimeter for a Reconnaissance in Force to a ridge line located 4,000 meters north. These companies made no contact throughout the rest of the day. However, at 1315H a patrol from Company A, operating east of the Battalion, discovered VC in a stream filling canteens. The patrol fired at the VC, and fire was returned by an estimated 10-20 VC hidden in the brush. After a brief fire fight, the patrol swept the area finding 7 VC KIA (Confirmed).

The next day, 16 September, at 1125H, the lead elements of Company D received S/A automatic weapons fire from an unknown number of enemy at XD 961601, a position 1,000 meters south of their objective. This was the beginning of a fierce, hand-to-hand struggle which would last for 48 hours. At 1425H, Company B, in trace of Company D began to maneuver to consolidate, a common position, and to clear a landing zone in the thick jungle vegetation for evacuation of casualties. This task was accomplished prior to sundown, but helos were unable to land because of enemy S/A fire. Close-in night defensive fires were plotted and fired continuously; a flare ship was utilized throughout the night.

At 0630H on 17 September, the first attempt at helo evacuation failed when helos once again received heavy automatic weapons fire in the LZ. By 0715H, both companies were again receiving a heavy volume of S/A fire, and at 0750H they began receiving 81/82mm mortar fire. The companies were unable to move. Continuous air, artillery and mortar missions were completed throughout the day with excellent results; on several occasions, fires were called to within 100 meters of the lines. By 1200H a few helos had landed supplies and picked up Med-evacs. But at 1250H, a helo was disabled in the LZ by enemy S/A fire, but ~~turning~~ helo activity into this area continued.

Meanwhile at 0920H the Battalion CO's OP, located on a hill 2,000 meters southeast of Companies B and D, received 10 rounds of 81/82mm mortar fire. Enemy position was spotted by AO, and 81mm fire was called in with good coverage of the target.

The Battalion CP received 2 rounds of incoming mortar fire at 1215H, and 6 rounds at 1630. Fire was returned by mortars at a suspected enemy mortar position, but results were unknown.

By night fall on 17 September, Companies B and D were well established within their perimeter. Night defensive fires had been requested and fire plotted throughout the inside of the perimeter, and Marines of both companies were dug "in and wide;" for maximum protection in the event these fires were called. Helos had been able to bring in sufficient supplies of ammo, water and chow; and to evacuate most casualties requiring evacuation. A flareship was once again on station, and was utilized throughout the night.

At 0630H on 18 September, lead elements of 2d Battalion, 7th Marines departed their overnight position surrounding 1st Battalion, 4th Marines OP, and moved forward to attempt a link up with Companies B and D. By 1600H this maneuver had been successfully completed, and all units consolidated defensive positions for the night. Once again night defensive fires were utilized, as was the flare ship on station.

On the morning of 19 September, Companies B and D began their movement back to the Battalion perimeter. By 1630H, all personnel had returned. At 1700H the Battalion CP received 4 to 6 rounds of 81/82mm mortar fire. Fire was returned with artillery and mortars at a suspected enemy mortar position; results were unknown.

At the debriefing of key personnel from Companies B and D, at 1900H on the 19th, it was determined that enemy (NVA) casualties to date were 259 KIA (Confirmed), 369 KIA (probable), 1VCC, and 1 VCS.

At 0345H on 21 September, the Battalion OP on "The Rock" (XD 978558) was probed by an unknown number of VC firing automatic weapons and throwing grenades. Marines returned A/W fire and grenades with unknown results. Due to the extreme nature of the terrain, the area could not be swept.

From 1445H to 1600H that afternoon, the Battalion perimeter received approximately 30 rounds of 81/82mm mortar fire. Enemy mortar positions were located by Marines on "The Rock", and an airstrike was requested. TAC(A) controlling reported the enemy position was 95% destroyed.

At 1700H on 24 September the Battalion positions received 8 to 10 rounds of 57mm recoilless rifle fire. Tanks, mortars and 106's returned fire at suspected positions with unknown results.

On the 25th at 0930 a helo carrying lead elements of the Battalion OP group to Hill 188 (XD 987593) to assist 3d Battalion, 4th Marines with direct fire support, received hits from 2 81/82mm mortar rounds impacting in LZ just prior to touchdown. No casualties were sustained, and the helo returned to the CP LZ without incident.

In the early evening, at 1835H, Battalion lines received approximately 50 rounds of 57mm RR fire. Tanks, mortars and 106's returned fire at enemy positions, spotted by Marines on "The Rock", resulting in one large secondary explosion.

On 28 September at 1600H, 1st Battalion assumed OPOON of Company G, 2nd Battalion, 7th Marines. At 0700H the next morning, Company G departed the Battalion area to search for, and recover, 7 MIA's west of the "Razorback" (XD 9656 to XD 9558). The Company moved over the "Razorback", and successfully recovered 6 MIA's. Upon evacuation of the MIA's by helo, the company returned to the Battalion area after linking up with one platoon of Company B manning a blocking position. Both units were inside the lines by 2330H. Neither unit had enemy contact. However, Company B's platoon suffered two (2) WIA's from a booby-trapped CHICOM grenade while moving to the blocking position.

Company G departed the Battalion area at 1000H on 30 September; OPOON was changed to 2d Battalion, 7th Marines. 1st Battalion, 4th Marines began making preparations for a return to Dong Ha Combat Base scheduled for 1 October.

## CHRONOLOGICAL ACCOUNT OF SIGNIFICANT EVENTS

1-5      1st Battalion continued to conduct a Reconnaissance in Force in area bounded by Grid Lines XD 98 (West), 63 (North), 56 (South), 1D 10 (East). Returned to Dong Ha Combat Base as 051000H. Negative enemy contact throughout this period.

6      At 2110H, Company D patrol received 5-6 rounds S/A from vicinity XD 244597. Patrol returned 20 rds. 7.62mm. Enemy broke contact and withdrew in unknown direction.

8      At 1230H, Companies A, B, D, and H&S established Battalion perimeter in Grid Square XD 9756. Battalion will conduct patrols, establish ambushes, and will prevent enemy movement into or through area of operations.

10     At 1535H, Battalion CP (XD 973566) received 40-60 rounds 81/82mm and 120mm mortar fire. Enemy mortar position located at XD 965593; artillery and 81mm mortar fire was returned. AO reported good coverage of target. At 1625H, Company D OP was bracketed by 4 rds. 81/82mm mortar fire, believed to be from mortars located at XD 965593. 81mm mortar returned fire; results unknown. At 1630H, Company D patrol received approximately 8 rounds S/A fire from XD 970573. Patrol returned fire; results unknown.

11     At 1000H, 1st Battalion, 4th Marines assumed OPOON of the Howtar Battery, 3rd Battalion, 12th Marines, located within Battalion perimeter. At 1230H, 120mm mortar dud was discovered near Battery position. EOD personnel recovered dud and returned it to 4th Marines OP.

12     At 1820H, a Company B patrol detonated a mine/booby trap at XD 962566. Two (2) USMC WIA's were evacuated by helo. Patrol continued mission, returned 20 rds. 7.62mm.

15     At 1200H, Companies B and D departed Battalion perimeter to conduct a Reconnaissance in Force along ridge line in grid square XD 9661, 9761, 9861, 9961. At 1315H, Company A patrol discovered one VC filling canteen in stream at XD 994569. Patrol initiated fire fight; swept area finding 7 VC KIA (confirmed).

16     At 1125H, Company D rec'd S/A AW rds. from unknown number of NVA at XD 961601. Marines returned fire. At 1410H Company B received S/A fire while clearing LZ for Med-Evac's. LZ cleared at XD 960599. Companies B and D consolidated position and established a perimeter at XD 962605.

At 0630H, Med-Evac holds, attempting to land in LZ at XD 961601, rec'd S/A AW fire. Artillery missions and air strikes were called in; results unknown. At 0715H, Companies B and D began receiving S/A AW fire. At 0750H, they rec'd 81mm/82mm mortar fire. Companies were unable to move. Continuous air and artillery missions were called. At 0920H, Battalion CO's OP, at XD 978588, received 10 incoming 81mm/82mm mortar fire. AO in area spotted mortar position at XD 979611; 30 rds 81mm mortar fired as counter-mortar mission; enemy mortar fire ceased. AO reports good coverage of target area. At 1215H, Battalion CP received 2 rds. 81mm/82mm mortar rounds from unknown location. At 1230H, a resupply helo was disabled in LZ XD 960599 by enemy S/A AW fire; no casualties to the crew. At 1630H, Battalion CP received 6 81mm/82mm mortar rounds. Fire was returned with 81's, 106's and two (2) air strikes against suspected enemy position XD 966586 with unknown results.

At 1547H, lead elements of 2nd Battalion, 7th Marines linked up with Companies B and D. Units will join in night defensive perimeter.

19

At approx 1630H, Companies B and D returned to Battalion perimeter. At 1700H, Battalion CP rec'd 4-6 rounds 81/82mm mortar. Artillery and mortars returned fire at suspected enemy mortar position; results unknown. At 1900H debriefing of unit commanders, following cumulative enemy casualty figures were determined: 259 KIA (confirmed), 369 KIA (probable), 1 VCC, 1 VCS.

21

At 0345H, Battalion OP at XD 979559 rec'd 3 incoming grenades and AW fire from XD 978558. Grenades and AW fire returned; results unknown. At 1530H H&S Company patrol made contact with 3 VC at XD 965558, VC fired 15-20 rounds S/A; patrol returned 100-150 rounds S/A. VC broke contact. Patrol swept area with negative results. From 1445H to 1600H Battalion CP rec'd approx. 32 rounds 81/82mm mortar fire. Enemy position was located at XD 954585. Air strike was requested and controlled by AO; position was 95% destroyed.

22

At 1830H, Company B lines sighted 2 VC at XD 967564. VC taken under fire by sniper; VC withdrew to cave. Cave taken under fire by 106's; results unknown.

24

At 1705H, Battalion CP rec'd 8-10 rds. of 57mm Recoilless Rifle Fire. 106's, tanks and mortars returned fire at suspected enemy location. Results unknown.

25 At 0930H, helo carrying lead elements of Battalion OP group rec'd 2 rds. 81/82mm mortar fire while attempting to land. Helo was hit by fragments, but returned to CP position. At 1835H, Battalion perimeter rec'd approx. 50 rds 57mm Recoilless Rifle Fire. 106's, tanks and mortars returned fire at suspected positions, resulting in one large secondary explosion.

28 At 1600H, 1st Battalion, 4th Marines assumed OPCON of Company G, 2nd Battalion, 7th Marines.

29 At 0700H, Company G departed Battalion perimeter to recover 7 MIA's vicinity XD 952578. At 2330H, Company G returned to perimeter. 6 MIA's were recovered and evacuated from the patrol area by helo.

30 At 1000H, Company G departed Battalion perimeter to return to Dong Ha; handed OPCON to 2nd Battalion, 7th Marines.

1. During the month of September the Battalion continued operation PRAIRIE. (See Section IV).
2. Several requests for emergency resupply were initiated with good to outstanding results.
3. Resupply averaged approximately 10 to 12 tons per day.

B. SUPPLY

1. Class I - Over 48,000 MCI's issued. Fruit juice and fresh fruit were also provided when available. One issue of steak and one issue of fried chicken were provided to all personnel. Water was provided on the basis of gallon/man day. Sundries packs were issued as appropriate.

2. Class II - Clothing, (except boots) and repairs and repair parts provided with excellent lead-time requirements.

3. Class III - Approximately 1,300 gallons of Diesel provided for attached tanks.

4. Class IV - Limited quantities of class IV were provided during the reporting period. (50,000 sandbags, 140 rolls concertina).

5. Class V - B/A's and DDA's were maintained as appropriate (See Paragraph E.2., below).

C. TRANSPORTATION. Helicopter resupply, Med Evacs and recons have been provided as requested.

D. SANITATION. Elements of the Battalion located at Dong Ha have sanitation problems due to low area and cramped facilities provided.

A. Operations. The communications platoon supported battalion operations conducted in conjunction with operation PRAIRIE throughout the month. During the period 1-6 September 1966, while on sweep operations in the vicinity of Dong Ha mountain, intra battalion communications and external communications were via radio exclusively. From 8 September to 1 October 1966 as the battalion occupied a command post in the vicinity of the "Rock" Thon Son Lam RVN (Coord 976567), external communications to higher headquarters and other units operating in the area were via VHF radio. Intra battalion communications were provided by VHF radio and wire. Communications between the battalion rear echelon located at Dong Ha, RVN and the battalion command post were via VHF radio during the entire period.

On 24 September 1966, Capt. Thomas P. DONNELLY, USMC was relieved as battalion communications officer by Capt. Fredrick E. BOONE USMC.

1. Radio. The nature of battalion operations dictated the use of VHF radio for support of combat operations. Radio communications were considered very good and no significant outages were experienced. Although a relay station was established to ensure communications to regimental headquarters, it was seldom necessary to use its services. Occassionally, during the early evening hours 1900-2100, direct communications with regiment became somewhat marginal due to atmospherics. Also some apparently unintentional interference was experienced. However it was sporadic, of short duration, and never disrupted communications. The RG-292 antenna was employed on all nets. Local battalion operations were relatively short range which presented no communication problems. Direct radio communications was maintained to subordinate elements of the battalion at all times.

2. Wire. Wire communications was provided for the battalion command post and the battalion rear echelon. The rear echelon was provided local service and entry into the III MAT telephone system. The fixed location of the battalion command post permitted the installation of a local telephone system to service the battalion within the perimeter. This resulted in a considerable reduction in administrative traffic over radio.

3. Message Center. Battalion message center personnel were assigned to augment the regimental message center the entire month.

B. Equipment. No significant equipment problems were encountered during the month. The AN/PRC-25 continues to prove an excellent field radio. Of seven radios returned for maintenance only three required module replacement. The remainder required only minor adjustments and all were returned to the field except one which was forwarded to FLSU for repair. Twelve handsets (H-138/U), components of the AN/PRC-25, became inoperative mainly due to defective transmitter elements and switches. This is considered well within acceptable limits in view of the utilization of the equipment. Of three rated AN/PRC-41 radios only one was available for operations at the end of the month. One complete AN/PRC-41 and replacement parts for the inoperative one on hand have been placed on priority two requisition.
